

## California Area Office Indian Health Service Users

California has a diverse population of American Indians/Alaska Natives (AIAN). There are 109 federally recognized Tribes in California and approximately 40 unrecognized Tribes seeking recognition. Additionally, there are members of federally recognized Tribes located outside of California who reside here due to various historical federal policies, such as the relocation movement. The Indian Health Service (IHS) restricts services to members of federally recognized Tribes, except in California where descendants of Indians residing in California in 1852 are also eligible for health services provided by IHS-funded facilities. California has 32 Tribal health programs owned and operated by California Indian tribes and 8 Indian primary care centers that serve urban areas.


Active users of Tribal and urban Indian health programs in California include AIAN and non-AIAN who attended at least one medical visit from October 1, 2012 through September 30, 2015. See Table 1 and Figure 1.

Overall, the data show that 39% (n=99,471) of health program users are AIAN, while 61% (n=155,414) are non-AIAN.





Among the 99,471 AIAN health program users, the majority (65%) are California AIAN from federally and non-federally recognized Tribes. Nearly 30% are from out-of-state federally recognized tribes.

Table 2 on the following page shows active user data for individual Tribal and urban Indian health programs. Northern Valley Indian Health, Inc. serves the most patients, with 22,512 patients having attended at least one medical visit from October 1, 2012 through September 30, 2015. The Native American Health Center is the urban Indian health program serving the highest number of patients (n=16,066).
