DAILY HIGHLIGHTS

Globally COVID-19 cases have surpassed 724,000 with more than 34,000 deaths.

President Trump on Sunday, 3/29/2020 extended federal social distancing guidelines until 04/30/2020.


U.S. Food and Drug Administration issued an emergency use authorization on Saturday, 3/28/2020, for chloroquine and hydroxychloroquine to treat patients hospitalized with Coronavirus.

The California Area Indian Health Service (IHS) has reported that 13 California IHS patients have tested positive for COVID-19.

The total number of cases in the U.S. increased from 85,356 as reported on Friday, 3/27/2020 to 140,904 reported today. The number of deaths increased from 1,246 to 2,405.

- * Data include both confirmed and presumptive positive cases of COVID-19 reported to CDC or tested at CDC since January 21, 2020, with the exception of testing results for persons repatriated to the United States from Wuhan, China and Japan. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

Public Health Laboratory Testing

As of the evening of March 29, the total number of public health laboratories (PHL) that have completed verification and are offering testing is 94. This includes one or more PHL in 50 states plus DC, Guam and Puerto Rico.

CALIFORNIA

As of March 29, 2020, 2 p.m. Pacific Daylight Time, there are a total of 5,763 positive cases and 135 deaths in California (including one non-California resident).

Ages of all confirmed positive cases:

• Age 0-17: 65 cases

• Age 18-49: 2,973 cases

• Age 50-64: 1,447 cases

Age 65 and older: 1,252 cases

• Unknown: 26 cases

Gender of all confirmed positive cases:

Female: 2,581 casesMale: 3,083 casesNon-binary: 0 cases

Unknown: 99 cases

In order to better focus public health resources on the changing needs of California communities, beginning on March 18, the state is no longer collecting information about California travelers returning from countries that have confirmed COVID-19 outbreaks. Community transmission of COVID-19 has been identified in California since late February, and since early March, most of the confirmed cases in the state were not related to travel outside of the United States.

Twenty-two public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Contra Costa, Humboldt, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Or-



ange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.


INDIAN HEALTH SERVICE CALIFORNIA AREA

The Indian Health Service (IHS) California Area as of 7:00pm EDT 03/29/2020 reports that 307 IHS patients in the California Area have been tested for COVID-19. Of these 8 patients have tested positive for COVID-19 and 156 have tested negative for COVID-19.


