

CORONAVIRUS DISEASE 2019 (COVID-19) SITUATIONAL REPORT #43 MAY 12, 2020



Globally, COVID-19 cases have surpassed 4.09 million with more than 283,000 deaths.

The total number of cases in the U.S. increased from 1,324,488 as reported on Monday 5/11/2020 to 1,342,594 reported today. The number of deaths increased from 79,756 to 80,820.

The California Area Indian Health Service (IHS) has reported that 75 California Tribal or Urban Indian Health Program patients have tested positive for COVID-19 as of 5/10/2020.

On Monday, May 11, President Trump announced additional actions to ensure States, Territories, and Tribes have the resources they need to meet their testing goals. These additional resources include \$11 billion in combined stimulus funding as well as approximately 12 million swabs to supplement private sector resources.

The Tribal Emergency Preparedness and Response Program (TEPRP) provides technical assistance and training to Tribas and Tribal Health Programs on hazard emergency preparedness planning and response. Tribal leaders and clinic administrators may contact Corinne.Chavez@ dhcs.ca.gov.

National Indian Council on Aging (NICOA) is convening weekly calls with all Title VI grantees about COVID-19 to provide updates to tribal programs and provide an opportunity for tribes to discuss the impact of COVID-19 in communities. 



This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020. The position statement included a case

definition and made COVID-19 a nationally notifiable disease.





State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.





As of the evening of May 11, the total number of public health laboratories (PHL) that have completed verification and are offering testing is 97. This includes one or more PHL in 50 states plus the District of Columbia, Guam and Puerto Rico.



CALIFORNIA

As of May 11, 2020, there are a total of 69,382 positive cases and 2,847 deaths in California.

Ages of all confirmed positive cases:

• Age 0-17: 2,549 cases

• Age 18-49: 34,573 cases

• Age 50-64: 17,322 cases

• Age 65 and older: 14,845 cases

• Unknown/Missing: 93 cases

Gender of all confirmed positive cases:

• Female: 33,992 cases

• Male: 34,955 cases

• Unknown: 435 cases

In order to better focus public health resources on the changing needs of California communities, beginning on March 18, the state is no longer collecting information about California travelers returning from countries that have confirmed COVID-19 outbreaks. Community transmission of COVID-19 has been identified in California since late February, and since early March, most of the confirmed cases in the state were not related to travel outside of the United States.

Twenty-two public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Contra Costa, Humboldt, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.

INDIAN HEALTH SERVICE CALIFORNIA AREA

2,046 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 5/10/2020.

Of these, 75 patients have tested positive for COVID-19 and 1,524 have tested negative for COVID-19.




New Confirmed Cases in California by Date of Lab Confirmation



RACIAL DISTRIBUTION OF CONFIRMED COVID-19 CASES AND DEATHS IN CALIFORNIA

American Indians and Alaska Natives account for 0.5% percent of the population, 0.2% of COVID-19 cases, and 0.3% of deaths in California. These include 89 cases and 9 deaths among American Indian and Alaska Native people in California.




CHARACTERISTICS OF CALIFORNIA COVID-19 POSITIVE CASES

In California:


- 4.7% of confirmed cases have been admitted to a hospital

Racial disparities:

- For all adults ages 18+, Latinos, African Americans, and Native Hawaiians and Pacific Islanders are dying at disproportionately high rates.
- For Native Hawaiians and Pacific Islanders, overall numbers are low, but the proportion of COVID-19 deaths is roughly 3 times their population representation.
