

## CORONAVIRUS DISEASE 2019 (COVID-19) SITUATIONAL REPORT #67 JUNE 16, 2020



#### DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 7.94 million with more than 434,800 deaths.

The total number of cases in the U.S. increased from 2,085,769 as reported on Monday 6/15/2020 to 2,104,346 reported today. The number of deaths in the U.S. increased from 115,644 to 116,140.

The California Area Indian Health Service (IHS) has reported that 143 California Tribal or Urban Indian Health Program patients have tested positive for COVID-19 as of 6/14/2020.


### COVID-19: U.S. at a Glance\*

• Total cases: 2,104,346

Total deaths: 116,140

Jurisdictions reporting cases: 55 (50 states, District of Columbia, Guam, Puerto Rico, the Northern Mariana Islands, and the U.S. Virgin Islands)

\*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020. The position statement included a case definition and made COVID-19 a nationally notifiable disease. A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.



A probable case or death is defined by:

- i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or
- ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID19. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

**Public Health Laboratory Testing** 


As of May 14, the total number of public health laboratories (PHL) that have completed verification and are offering testing is 97. This includes one or more PHL in 50 states plus the District of Columbia, Guam and Puerto Rico. As of May 20, over 12 million tests have been performed nationwide, with 13% of those tests being positive.

### **CALIFORNIA**

As of June 14, 2020, there are a total of 153,560 positive cases and 5,121 deaths in California.

Ages of all confirmed positive cases:

• Age 0-17: 10,702 cases

• Age 18-49: 83,254 cases

• Age 50-64: 34,290 cases

• Age 65 and older: 25,109 cases

• Unknown/Missing: 205 cases

Gender of all confirmed positive cases:

• Female: 75,416 cases

• Male: 77,466 cases

• Unknown: 678 cases

In order to better focus public health resources on the changing needs of California communities, beginning on March 18, the state is no longer collecting information about California travelers returning from countries that have confirmed COVID-19 outbreaks. Community transmission of COVID-19 has been identified in California since late February, and since early March, most of the confirmed cases in the state were not related to travel outside of the United States.

Twenty-two public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Contra Costa, Humboldt, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.

### INDIAN HEALTH SERVICE CALIFORNIA AREA

3,437 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 6/14/2020.


Of these, 143 patients have tested positive for COVID-19 and 2,782 have tested negative for COVID-19.








#### New Confirmed Deaths in California by Date



### RACIAL DISTRIBUTION OF CONFIRMED COVID-19 CASES AND DEATHS IN CALIFORNIA






Two sources for tracking American Indian and Alaska Native (AIAN) Cases reported in California

Data from the Indian Health Service (IHS) include positive cases reported by Tribal and Urban Indian Health Programs.


Data from California Department of Public Health (CDPH) include all positive cases of AIAN diagnosed in California.





### In California:

- **2.2**% of confirmed cases have been admitted to a hospital
- **0.7%** of confirmed cases have been admitted to an Intensive Care Unit
- 3.3% of cases have died


### Racial disparities:

- For all adults ages 18+, Latinos and African Americans are dying at disproportionately high rates. The proportion of COVID-19 deaths in Latinos is more than 1.5 times their population representation across all adult age categories.
- Almost half of all deaths continue to be in the 80+ age category.


