

# CORONAVIRUS DISEASE 2019 (COVID-19) SITUATIONAL REPORT #68 JUNE 17, 2020



#### **DAILY HIGHLIGHTS**

Globally, COVID-19 cases have surpassed 8.06 million with more than 440,200 deaths.

The total number of cases in the U.S. increased from 2,104,346 as reported on Tuesday 6/16/2020 to 2,132,321 reported today. The number of deaths in the U.S. increased from 116,140 to 116,862.

The California Area Indian Health Service (IHS) has reported that 148 California Tribal or Urban Indian Health Program patients have tested positive for COVID-19 as of 6/15/2020.

The National Indian Health Board is hosting a webinar focused on suicide in Indian Country; intervention, and prevention; what is unique about COVID-19 that may contribute to suicide risk; resources and suggestions that may help during these extraordinary and stressful times; as well as time for questions and answers with all attendees. 
#### COVID-19: U.S. at a Glance\*

Total cases: 2,132,321Total deaths: 116,862

• Jurisdictions reporting cases: 55 (50 states, District of Columbia, Guam, Puerto Rico, the Northern Mariana

Islands, and the U.S. Virgin Islands)

\*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020. The position statement included a case definition and made COVID-19 a nationally notifiable disease. A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.



#### A probable case or death is defined by:

- i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or
- ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID19. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

#### Public Health Laboratory Testing


As of May 14, the total number of public health laboratories (PHL) that have completed verification and are offering testing is 97. This includes one or more PHL in 50 states plus the District of Columbia, Guam and Puerto Rico. As of May 20, over 12 million tests have been performed nationwide, with 13% of those tests being positive.

#### **CALIFORNIA**

As of June 16, 2020, there are a total of 157,015 positive cases and 5,208 deaths in California.

Ages of all confirmed positive cases:

• Age 0-17: 11,064 cases

• Age 18-49: 85,325 cases

• Age 50-64: 34,922 cases

• Age 65 and older: 25,503 cases

• Unknown/Missing: 201 cases

Gender of all confirmed positive cases:

• Female: 77,199 cases

Male: 79,128 cases

• Unknown: 688 cases

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.

3,473 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 6/15/2020.


Of these, 148 patients have tested positive for COVID-19 and 2,818 have tested negative for COVID-19.





#### New Confirmed Cases in California by Date of Lab Confirmation




#### New Confirmed Deaths in California by Date




#### RACIAL DISTRIBUTION OF CONFIRMED COVID-19 CASES AND DEATHS IN CALIFORNIA






Two sources for tracking American Indian and Alaska Native (AIAN) Cases reported in California








#### In California:

- **2.2**% of confirmed cases have been admitted to a hospital
- **0.7%** of confirmed cases have been admitted to an Intensive Care Unit
- 3.3% of cases have died


#### Racial disparities:

- For all adults ages 18+, Latinos and African Americans are dying at disproportionately high rates. The proportion of COVID-19 deaths in Latinos is more than 1.5 times their population representation across all adult age categories.
- Almost half of all deaths continue to be in the 80+ age category.


