

CORONAVIRUS DISEASE 2019 (COVID-19) SITUATIONAL REPORT #68 JUNE 17, 2020



DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 8.24 million with more than 445,500 deaths.

The total number of cases in the U.S. increased from 2,132,321 as reported on Wednesday 6/17/2020 to 2,155,572 reported today. The number of deaths in the U.S. increased from 116,862 to 117,632.

The California Area Indian Health Service (IHS) has reported that 148 California Tribal or Urban Indian Health Program patients have tested positive for COVID-19 as of 6/16/2020.

The National Indian Health Board is hosting a webinar focused on suicide in Indian Country; intervention, and prevention; what is unique about COVID-19 that may contribute to suicide risk; resources and suggestions that may help during these extraordinary and stressful times; as well as time for questions and answers with all attendees. 
COVID-19: U.S. at a Glance*

Total cases: 2,155,572Total deaths: 117,632

• Jurisdictions reporting cases: 55 (50 states, District of Columbia, Guam, Puerto Rico, the Northern Mariana

Islands, and the U.S. Virgin Islands)

*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020. The position statement included a case definition and made COVID-19 a nationally notifiable disease. A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.



A probable case or death is defined by:

- i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or
- ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID19. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.



CALIFORNIA

As of June 17, 2020, there are a total of 161,099 positive cases and 5,290 deaths in California.

Ages of all confirmed positive cases:

• Age 0-17: 11,582 cases

• Age 18-49: 87,796 cases

• Age 50-64: 35,609 cases

• Age 65 and older: 25,911 cases

• Unknown/Missing: 201 cases

Lab tests reported statewide: 3,074,530

Gender of all confirmed positive cases:

• Female: 79,243 cases

• Male: 81,212 cases

• Unknown: 644 cases

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.

3,512 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 6/16/2020.


Of these, 148 patients have tested positive for COVID-19 and 2,841 have tested negative for COVID-19.





New Confirmed Cases in California by Date of Lab Confirmation




New Confirmed Deaths in California by Date



RACIAL DISTRIBUTION OF CONFIRMED COVID-19 CASES AND DEATHS IN CALIFORNIA


American Indians and Alaska Natives account for 0.5% percent of the population, 0.2% of COVID-19 cases, and 0.3% of deaths in California. These include 216 cases and 15 deaths among American Indian and Alaska Native people in California.




Two sources for tracking American Indian and Alaska Native (AIAN) Cases reported in California

Data from the Indian Health Service (IHS) include positive cases reported by Tribal and Urban Indian Health Programs.


Data from California Department of Public Health (CDPH) include all positive cases of AIAN diagnosed in California.





In California:


- **2.1%** of confirmed cases have been admitted to a hospital
- **0.7%** of confirmed cases have been admitted to an Intensive Care Unit
- 3.3% of cases have died

Racial disparities:

- For all adults ages 18+, Latinos and African Americans are dying at disproportionately high rates. The proportion of COVID-19 deaths in Latinos is more than 1.5 times their population representation across all adult age categories.
- Almost half of all deaths continue to be in the 80+ age category.


