



DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 8.86 million with more than 465,700 deaths. The World Health Organization on Sunday reported the largest single-day increase in COVD-19 cases by its count, at more than 183,000 new cases reported within 24 hours.

The total number of cases in the U.S. increased from 2,178,710 as reported on Friday 6/19/2020 to 2,275,645 reported today. The number of deaths in the U.S. increased from 118,365 to 119,923.

The California Area Indian Health Service (IHS) has reported that 153 California Tribal or Urban Indian Health Program patients have tested positive for COVID-19 as of 6/20/2020.



COVID-19: U.S. at a Glance*

- Total cases: 2,275,645
- Total deaths: 119,923
- Jurisdictions reporting cases: 55 (50 states, District of Columbia, Guam, Puerto Rico, the Northern Mariana Islands, and the U.S. Virgin Islands)

*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020. The position statement included a case definition and made COVID-19 a nationally notifiable disease. A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.



A probable case or death is defined by:

i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or

ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID19. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.



CALIFORNIA

As of June 21, 2020, there are a total of 178,054 positive cases and 5,515 deaths in California.

Ages of all confirmed positive cases:

- Age 0-17: 13,346 cases
- Age 18-49: 98,269 cases
- Age 50-64: 38,795 cases
- Age 65 and older: 27,456 cases
- Unknown/Missing: 188 cases

Lab tests reported statewide: 3,411,686

Gender of all confirmed positive cases:

- Female: 87,641 cases
- Male: 89,690 cases
- Unknown: 723 cases

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.



INDIAN HEALTH SERVICE CALIFORNIA AREA

3,624 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 6/20/2020. Of these, 153 patients have tested positive for COVID-19 and 2,935 have tested negative for COVID-19. 






New Confirmed Cases in California by Date of Lab Confirmation




RACIAL DISTRIBUTION OF CONFIRMED COVID-19 CASES AND DEATHS IN CALIFORNIA

American Indians and Alaska Natives account for 0.5% percent of the population, 0.2% of COVID-19 cases, and 0.3% of deaths in California. These include 229 cases and 16 deaths among American Indian and Alaska Native people in California.



In California:

2.1% of confirmed cases have been admitted to a hospital


0.7% of confirmed cases have been admitted to an Intensive Care Unit

3.1% of cases have died

Racial disparities:

- For all adults ages 18+, Latinos and African Americans are dying at disproportionately high rates. The proportion of COVID-19 deaths in Latinos is more than 1.5 times their population representation across all adult age categories.
- Almost half of all deaths continue to be in the 80+ age category.




