DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 12.75 million with more than 566,000 deaths.

The total number of cases in the U.S. increased from 3,047,671 as reported on Friday 7/10/2020 to 3,296,599 reported today. The number of deaths in the U.S. increased from 132,056 to 134,884.

The California Area Indian Health Service (IHS) has reported that 233 California Tribal or Urban Indian Health Program patients have tested positive for COVID-19 as of 7/11/2020.

The Network for Public Health Law is hosting a webinar on July 15, at 10:00 am (PST) to address what states should consider to ensure that everyone can safely and securely vote in the 2020 election cycle. They will discuss the challenges and solutions to the voting process in the midst of the pandemic, including legal barriers to turnout, election protection, and mitigating the public health risks. The COVID-19 pandemic has created challenges for us all. Effective immediately, California closes some indoor business operations statewide and additional indoor operations in counties on Monitoring List for 3 consecutive days. Statewide indoor closures include restaurants, bars and breweries, wineries & tasting rooms, movie theaters, family entertainment centers, zoos and museums, and card-rooms. County indoor closures include fitness centers, places of worship, indoor protests, offices for non-critical infrastructure sectors, personal care services, hair salons and barbershops, and malls. 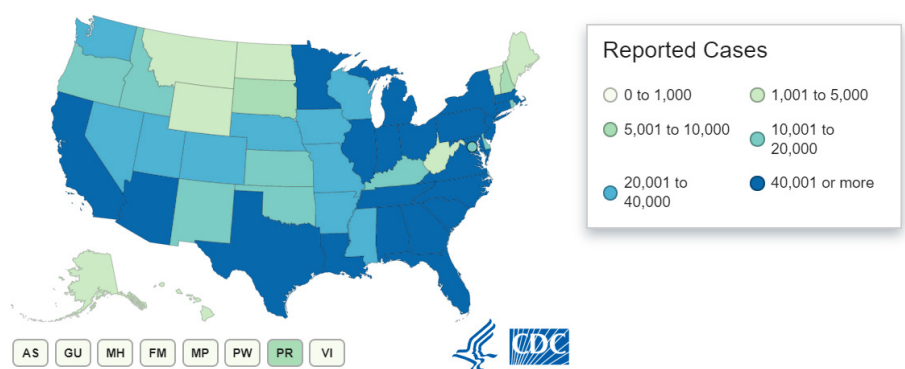
*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020. The position statement included a case definition and made COVID-19 a nationally notifiable disease.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

- meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or
- meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or
- meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.

State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

CALIFORNIA

As of July 12, 2020, there were a total of 329,162 positive cases and 7,040 deaths in California.

Ages of all confirmed positive cases:

- Age 0-17: 27,415 cases
- Age 18-49: 195,752 cases
- Age 50-64: 65,134 cases
- Age 65 and older: 40,473 cases
- Unknown/Missing: 388 cases

Gender of all confirmed positive cases:

- Female: 162,718 cases
- Male: 164,635 cases
- Unknown: 1,809

Lab tests reported statewide: 5,544,365

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.

INDIAN HEALTH SERVICE CALIFORNIA AREA

5,371 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 7/11/2020.

Of these, 233 patients have tested positive for COVID-19 and 4,301 have tested negative for COVID-19.

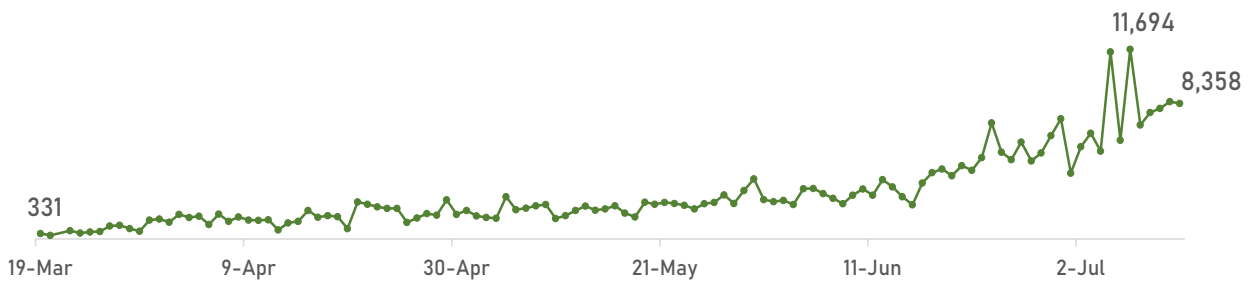

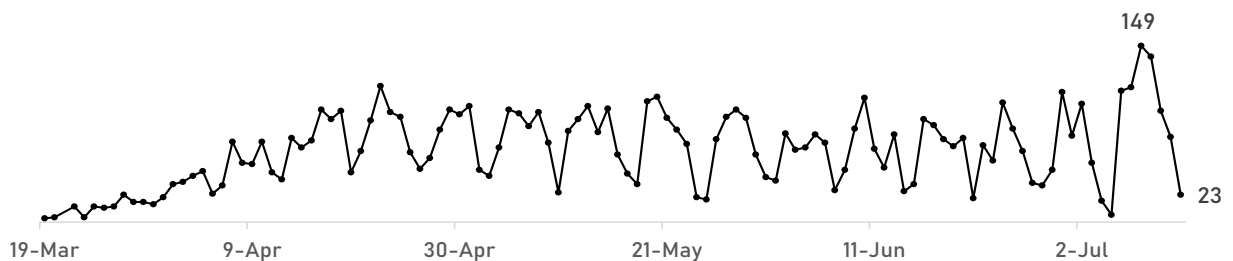

New Confirmed Cases in California by Date of Lab Confirmation

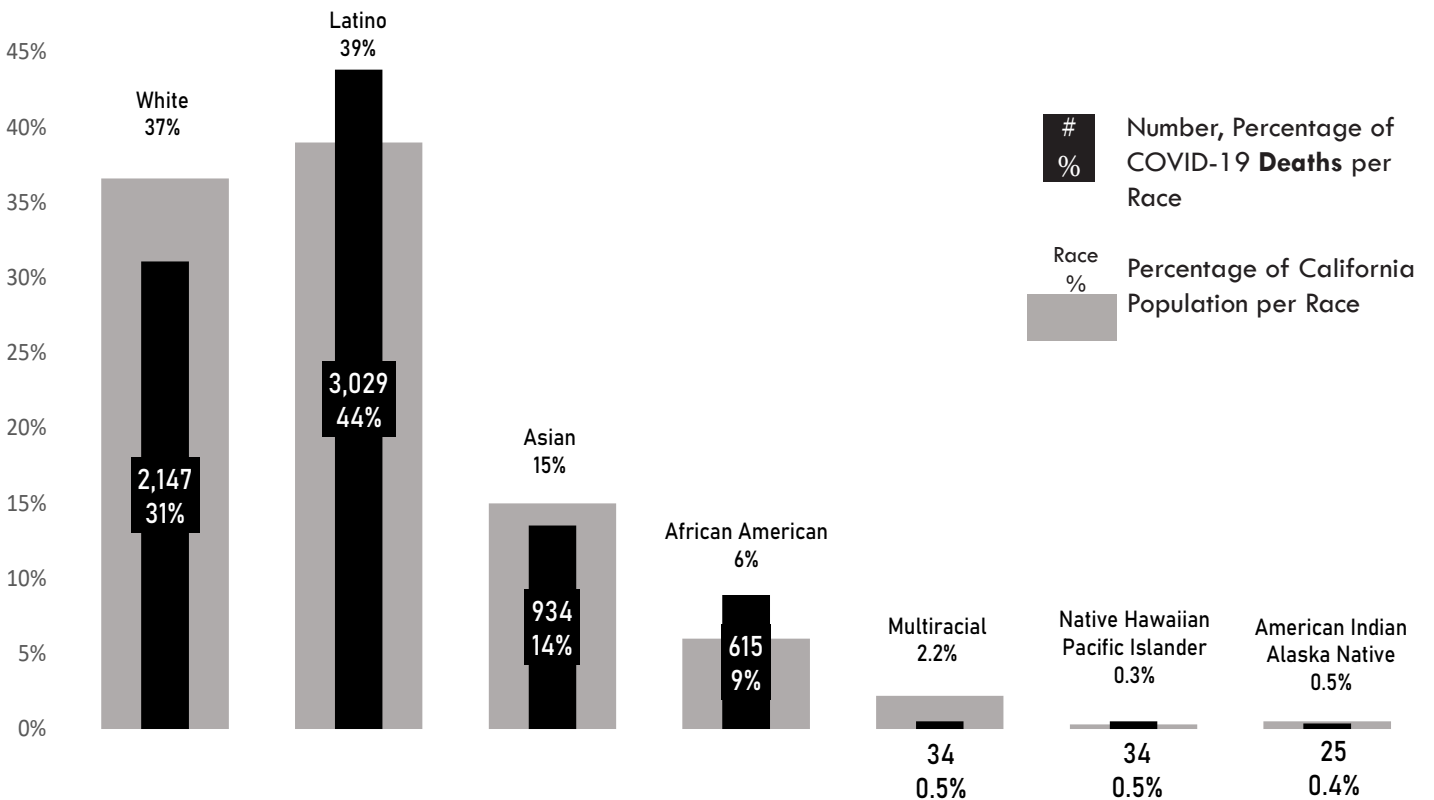
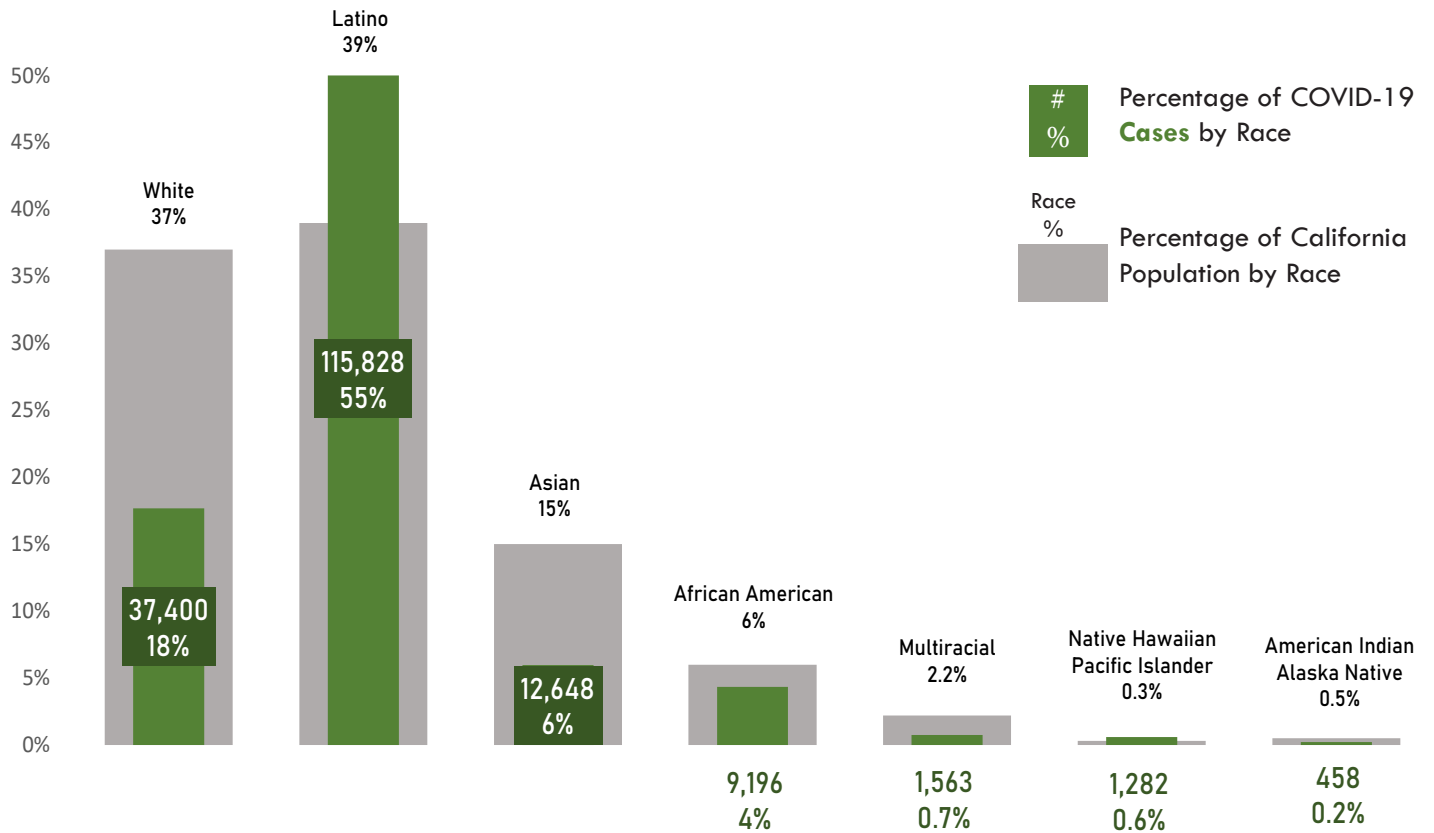


New Confirmed Deaths in California by Date



RACIAL DISTRIBUTION OF CONFIRMED COVID-19 CASES AND DEATHS IN CALIFORNIA

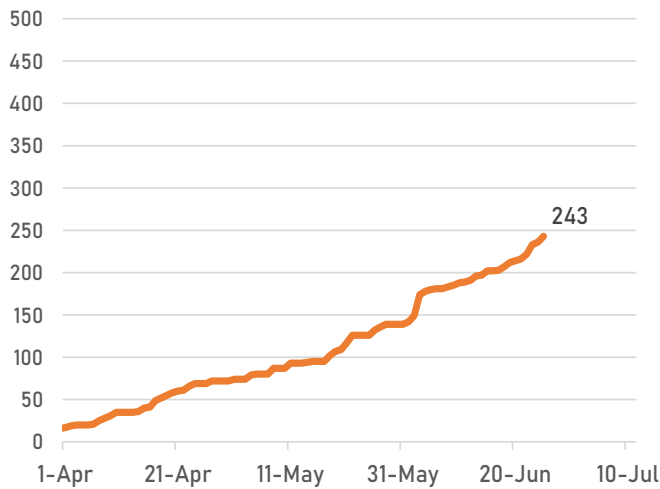

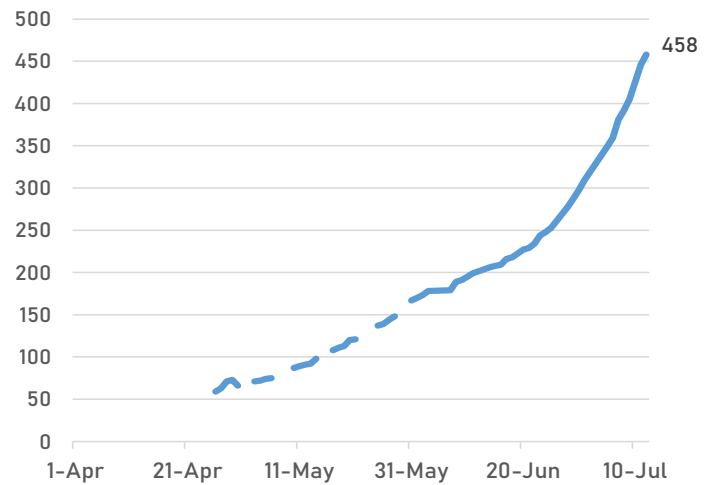

Data from the **Indian Health Service (IHS)** include positive cases reported by Tribal and Urban Indian Health Programs.

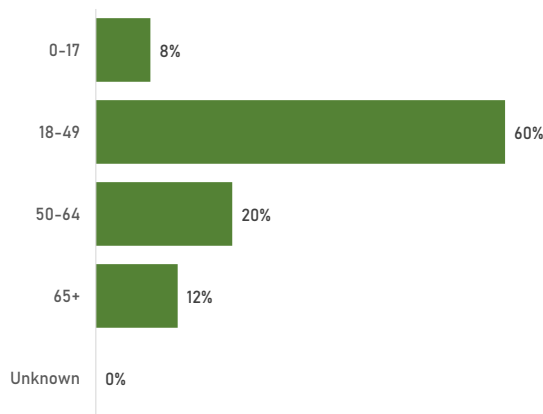


Data from **California Department of Public Health (CDPH)** include all positive cases of AIAN diagnosed in California.

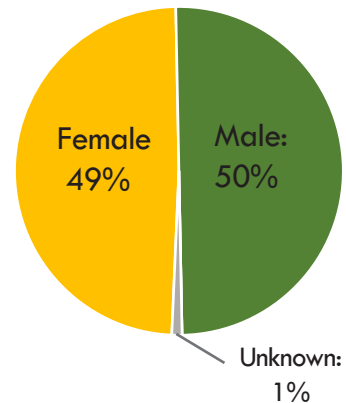

In California:

Racial disparities:

- For all adults ages 18+, Latinos and African Americans are dying at disproportionately high rates. The proportion of COVID-19 deaths in Latinos is more than 1.5 times their population representation across all adult age categories.
- Almost half of all deaths continue to be in the 80+ age category.

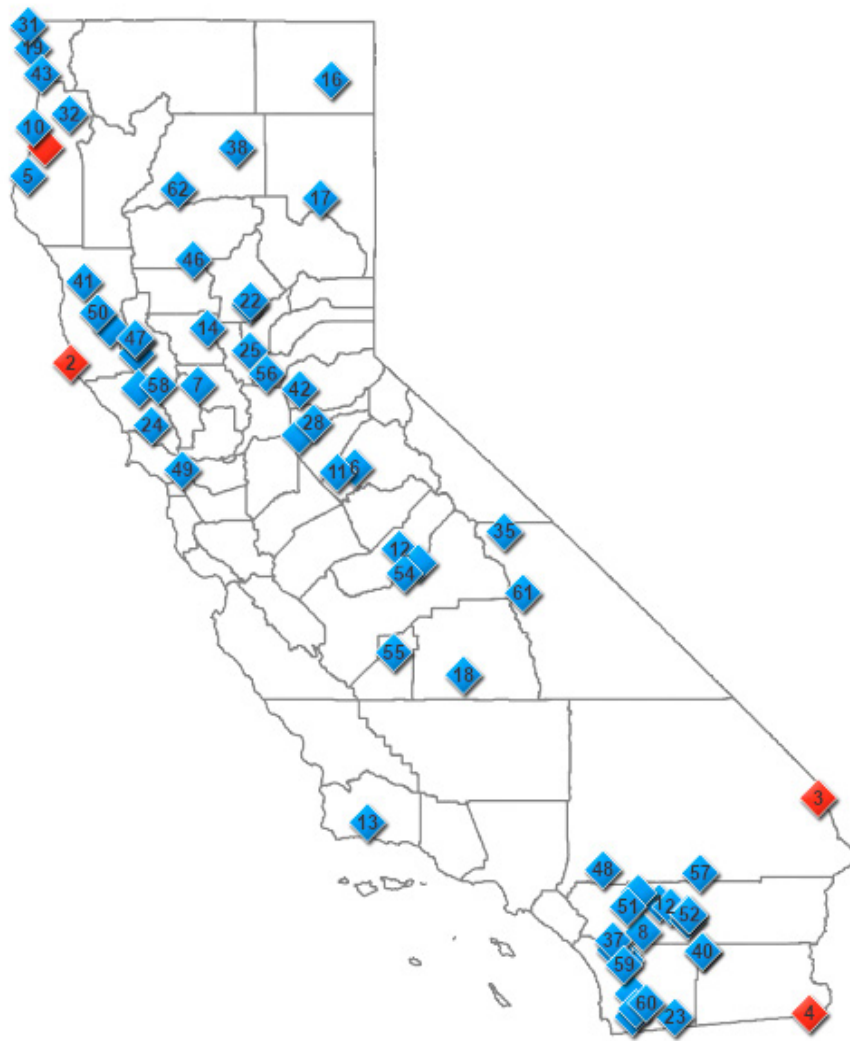

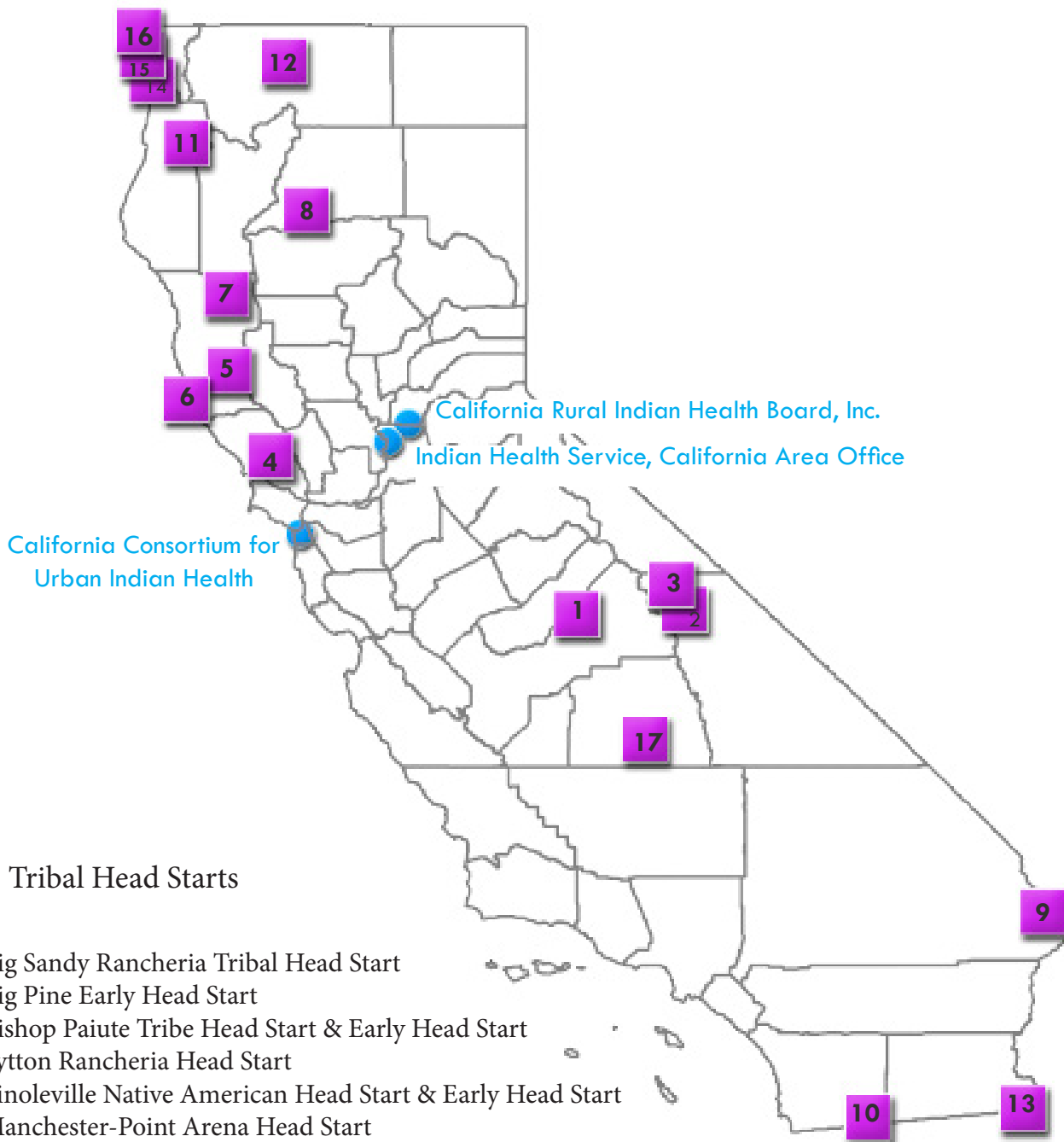

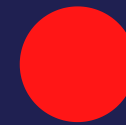
