DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 12.96 million with more than 570,000 deaths.

The total number of cases in the U.S. increased from 3,296,599 as reported on Monday 7/13/2020 to 3,355,457 reported today. The number of deaths in the U.S. increased from 134,884 to 135,235.

The California Area Indian Health Service (IHS) has reported that 233 California Tribal or Urban Indian Health Program patients have tested positive for COVID-19 as of 7/12/2020.

The Network for Public Health Law is hosting a webinar on July 15, at 10:00 am (PST) to address what states should consider to ensure that everyone can safely and securely vote in the 2020 election cycle. They will discuss the challenges and solutions to the voting process in the midst of the pandemic, including legal barriers to turnout, election protection, and mitigating the public health risks. 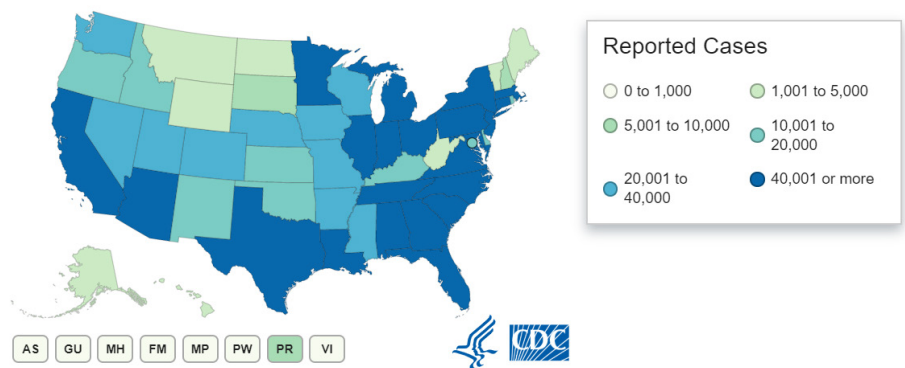
*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020. The position statement included a case definition and made COVID-19 a nationally notifiable disease.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

- meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or
- meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or
- meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.

State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

CALIFORNIA

As of July 13, 2020, there were a total of 336,508 positive cases and 7,087 deaths in California.

Ages of all confirmed positive cases:

- Age 0-17: 28,108 cases
- Age 18-49: 200,437 cases
- Age 50-64: 66,427 cases
- Age 65 and older: 41,080 cases
- Unknown/Missing: 456 cases

Gender of all confirmed positive cases:

- Female: 166,525 cases
- Male: 168,074 cases
- Unknown: 1,909

Lab tests reported statewide: 5,674,955

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.

INDIAN HEALTH SERVICE CALIFORNIA AREA

5,371 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 7/12/2020.

Of these, 233 patients have tested positive for COVID-19 and 4,309 have tested negative for COVID-19.

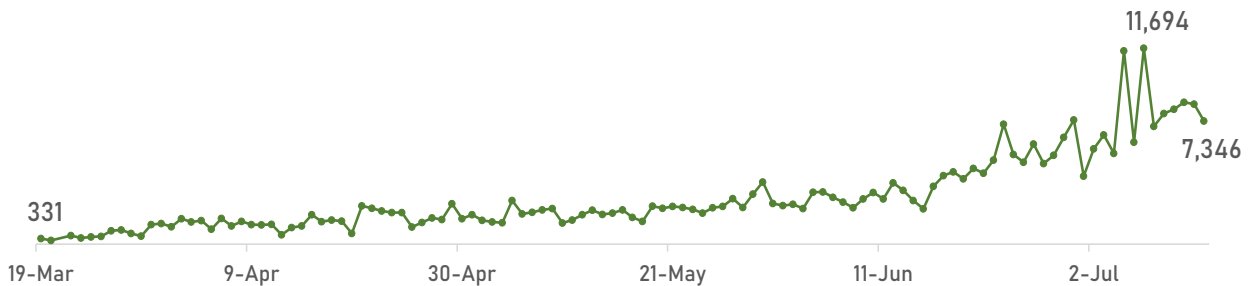

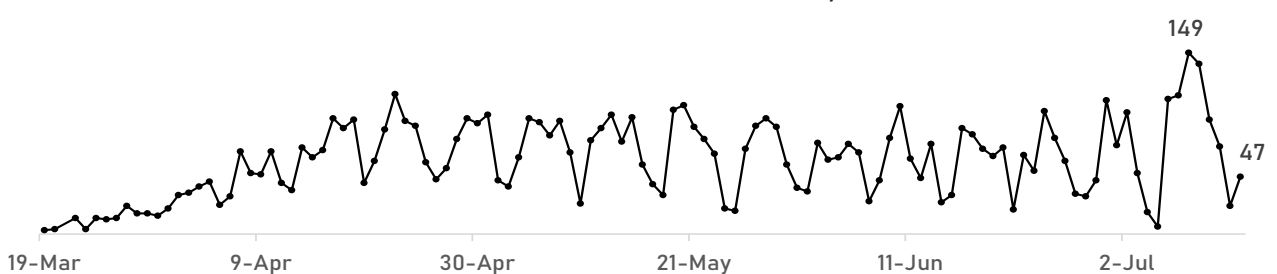

New Confirmed Cases in California by Date of Lab Confirmation



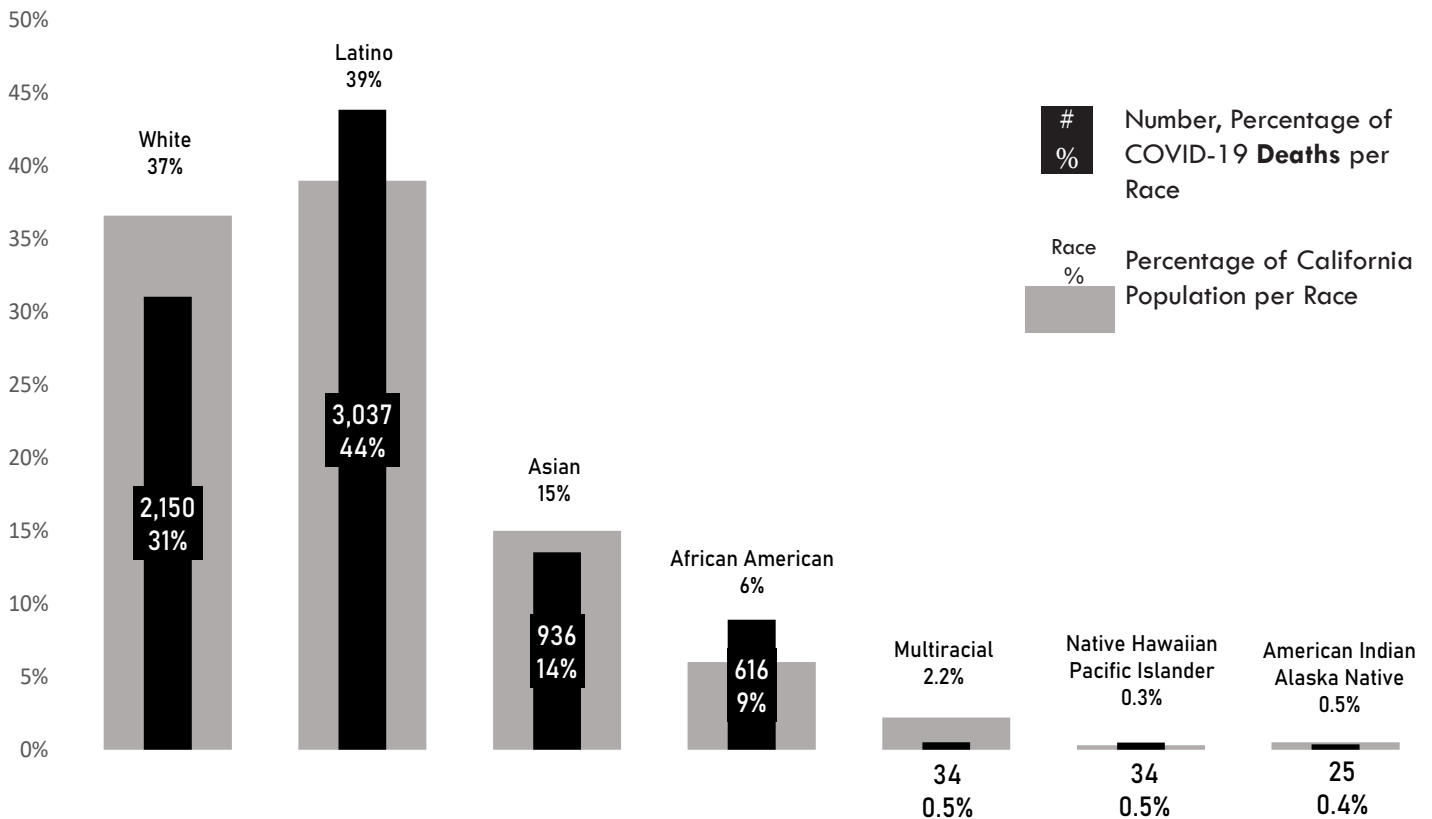
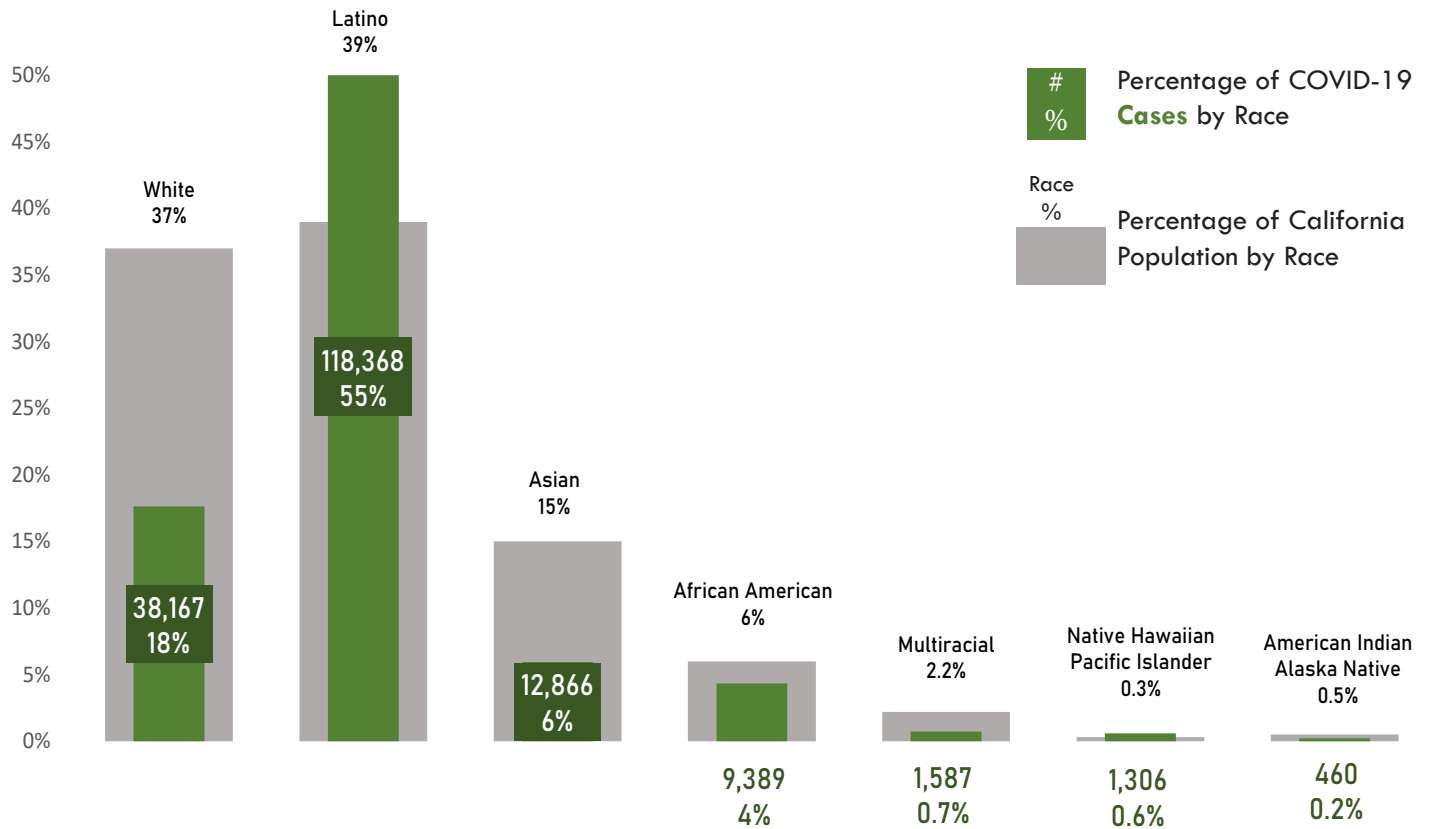
New Confirmed Deaths in California by Date

RACIAL DISTRIBUTION OF CONFIRMED COVID-19 CASES AND DEATHS IN CALIFORNIA

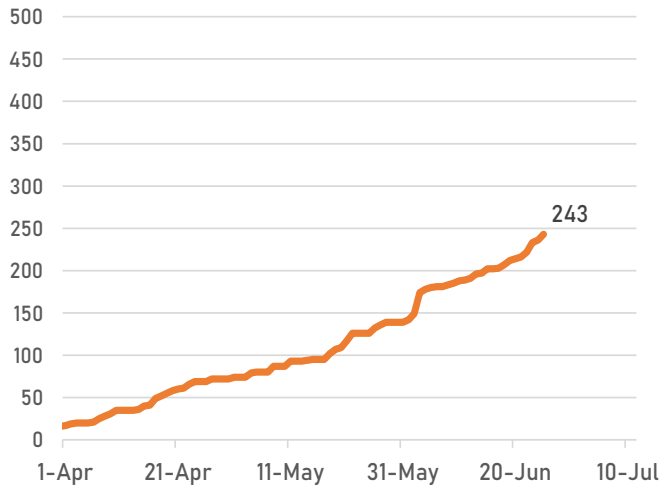
American Indians and Alaska Natives account for 0.5% percent of the population, **0.2% of COVID-19 cases**, and **0.4% of deaths** in California. These include **460 cases** and **25 deaths** among American Indian and Alaska Native people in California.



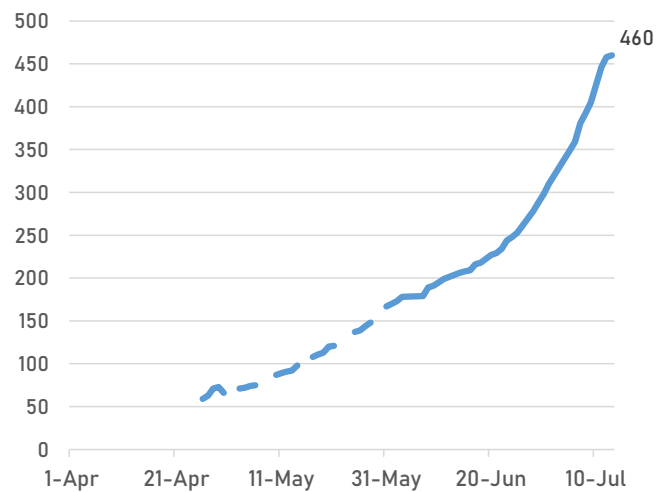

Data from the **Indian Health Service (IHS)** include positive cases reported by Tribal and Urban Indian Health Programs.

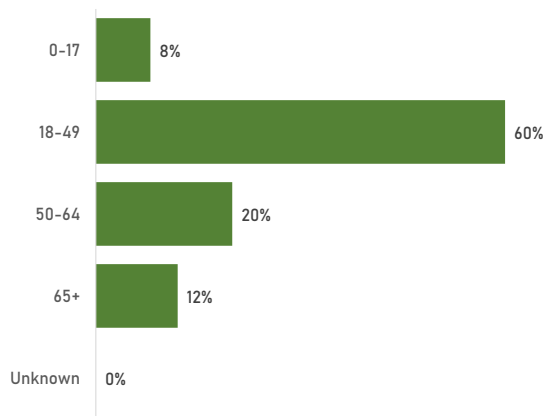


Data from **California Department of Public Health (CDPH)** include all positive cases of AIAN diagnosed in California.

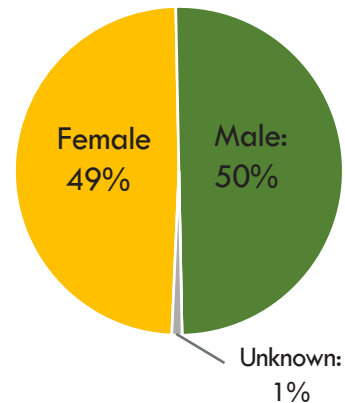

In California:

2.0% of confirmed cases have been admitted to a hospital

0.6% of confirmed cases have been admitted to an Intensive Care Unit

2.1% of cases have died

Racial disparities:

- For all adults ages 18+, Latinos and African Americans are dying at disproportionately high rates. The proportion of COVID-19 deaths in Latinos is more than 1.5 times their population representation across all adult age categories.
- Almost half of all deaths continue to be in the 80+ age category.

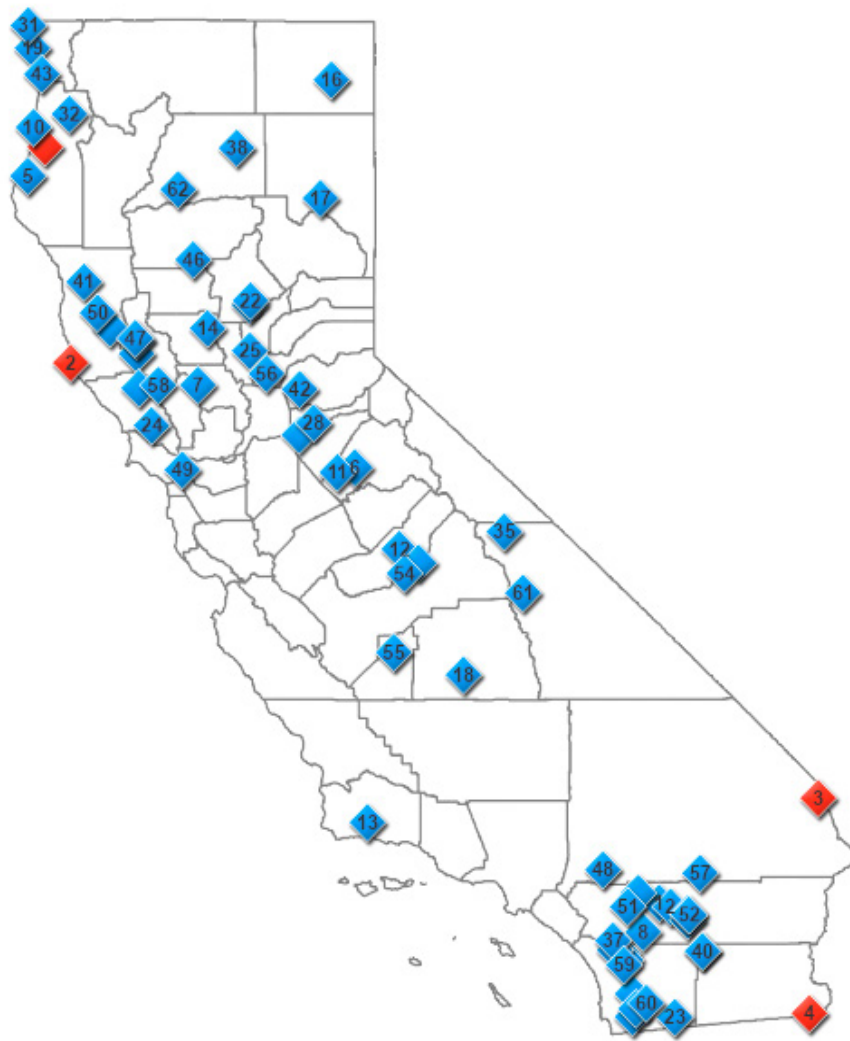

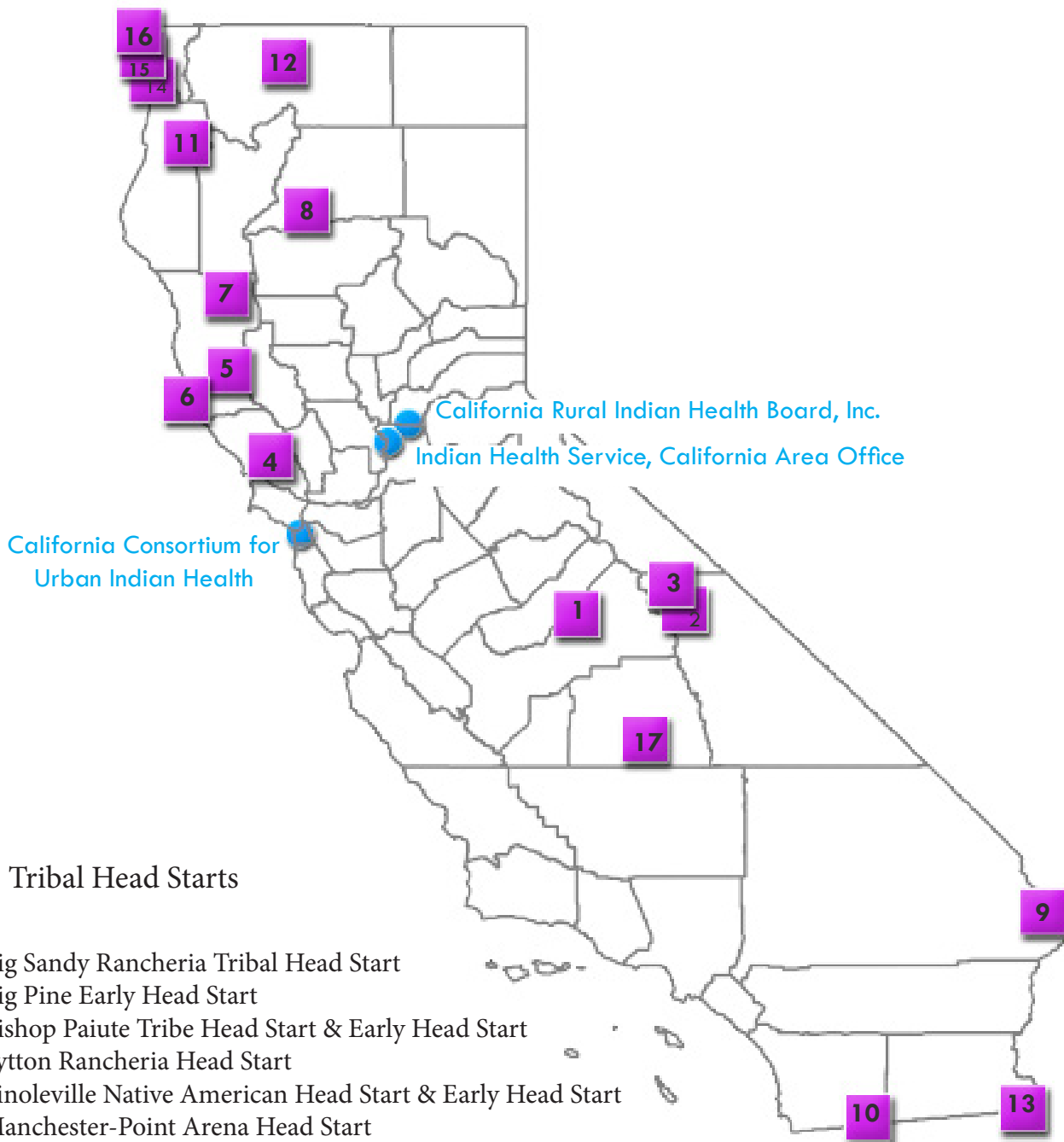

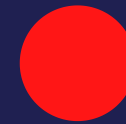
