



# CORONAVIRUS DISEASE 2019 (COVID-19) SITUATIONAL REPORT #87 JULY 15, 2020



## DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 13.15 million with more than 574,000 deaths.

The total number of cases in the U.S. increased from 3,355,457 as reported on Tuesday 7/14/2020 to 3,416,428 reported today. The number of deaths in the U.S. increased from 135,235 to 135,991.

The California Area Indian Health Service (IHS) has reported that 241 California Tribal or Urban Indian Health Program patients have tested positive for COVID-19 as of 7/13/2020.

The California Department of Public Health released updated Testing Guidance for testing prioritization. The state is working collaboratively with health insurers to provide reimbursement for testing. The state is working with private health care providers to create additional in-office testing capacity. To learn more click [HERE](#).

The National Indian Health Board (NIHB) and the Centers for Disease Control and Prevention (CDC) are collaborating on an infection prevention and control (IPC) training initiative for frontline Tribal healthcare facility personnel. In order for this initiative to be as responsive to the needs of Tribal healthcare workers and the Tribal health system as possible, NIHB will be holding a series national listening sessions with front line Tribal healthcare workers. The purpose of the listening sessions is gather feedback from frontline workers and relevant stakeholders, for frontline staff to share their experience and opinions on what types of IPC trainings would be valuable, how best to host those trainings, as well other types of training materials would be useful. Input from the listening sessions will be used to inform the content and delivery of core trainings, products, and outreach. The first session is held on July 22, at 11:00 am (PST) click [HERE](#).

- Jurisdictions reporting cases: 55 (50 states, District of Columbia, Guam, Puerto Rico, the Northern Mariana Islands, and the U.S. Virgin Islands)

\*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020. The position statement included a case definition and made COVID-19 a nationally notifiable disease.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

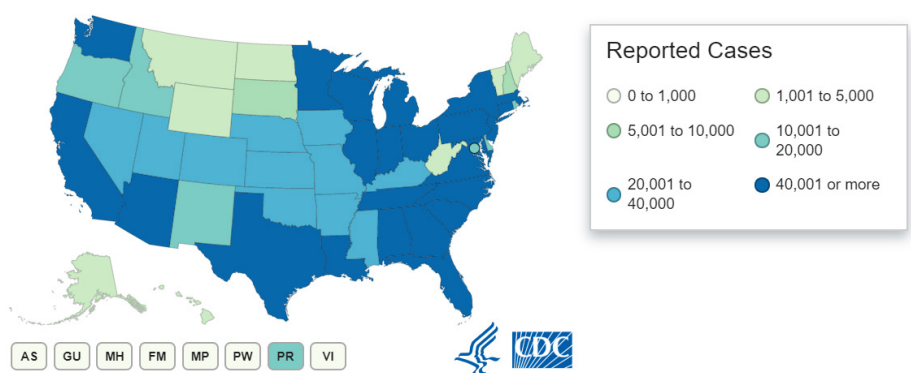
- meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or
- meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or

iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.

State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

## CALIFORNIA

As of July 14, 2020, there were a total of 347,634 positive cases and 7,227 deaths in California.

Ages of all confirmed positive cases:

- Age 0-17: 29,156 cases
- Age 18-49: 207,574 cases
- Age 50-64: 68,493 cases
- Age 65 and older: 42,007 cases
- Unknown/Missing: 404 cases

Gender of all confirmed positive cases:

- Female: 172,288 cases
- Male: 173,454 cases
- Unknown: 1,892

Lab tests reported statewide: 5,793,276

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.

5,478 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 7/13/2020.

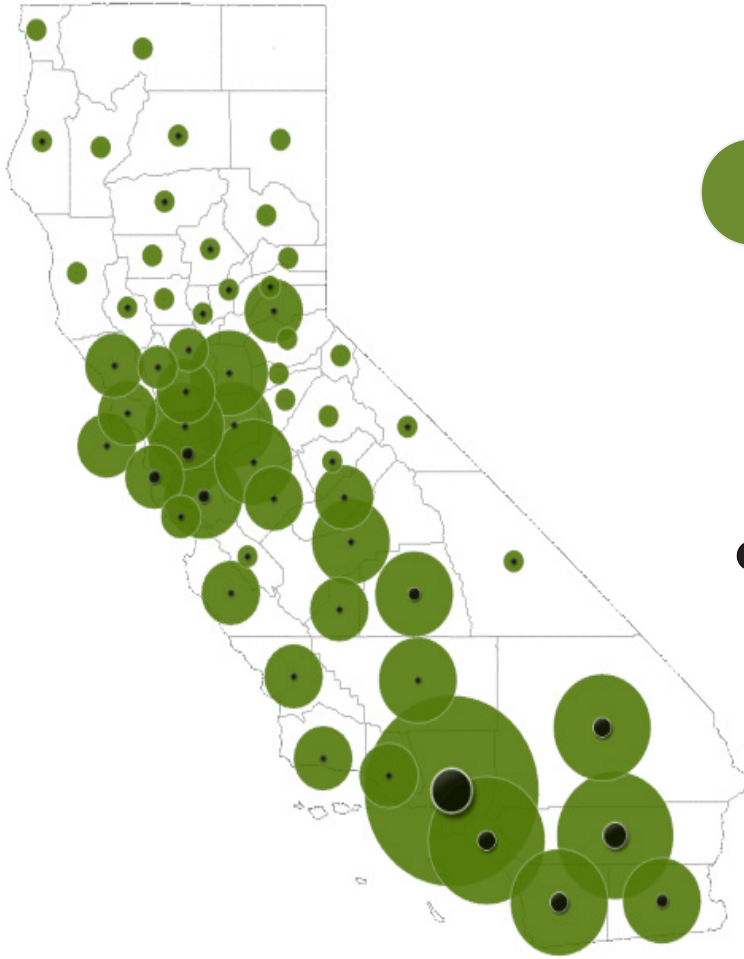
Of these, 241 patients have tested positive for COVID-19 and 4,378 have tested negative for COVID-19.

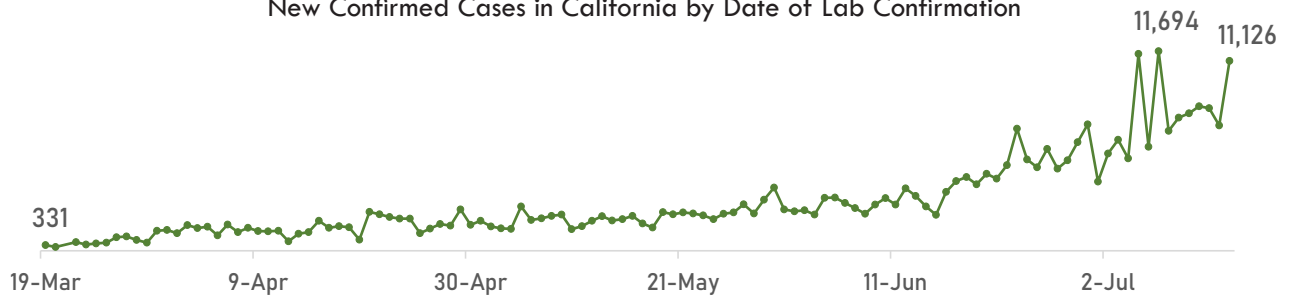

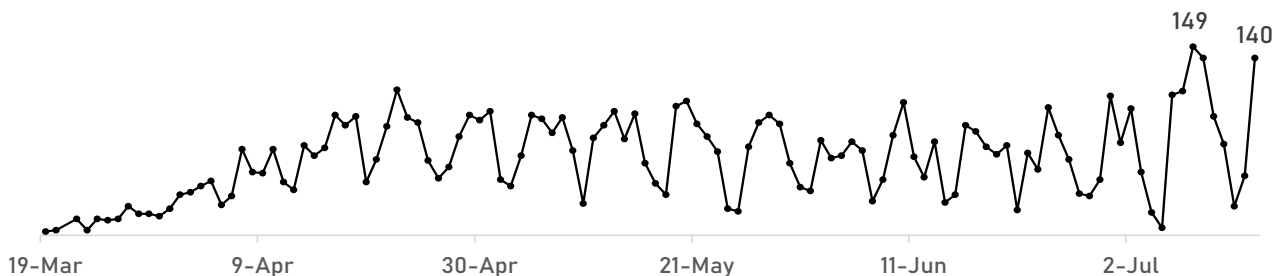

New Confirmed Cases in California by Date of Lab Confirmation



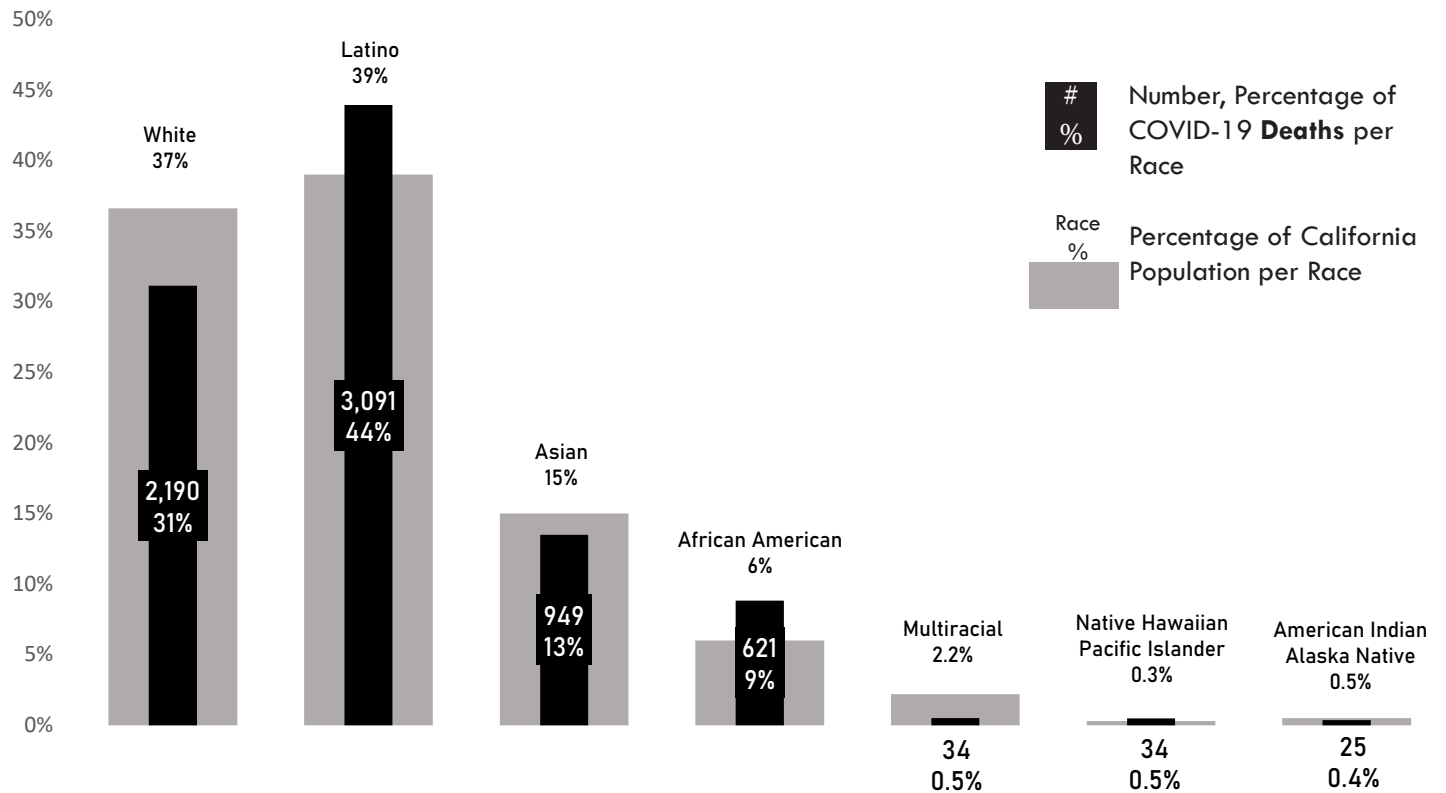
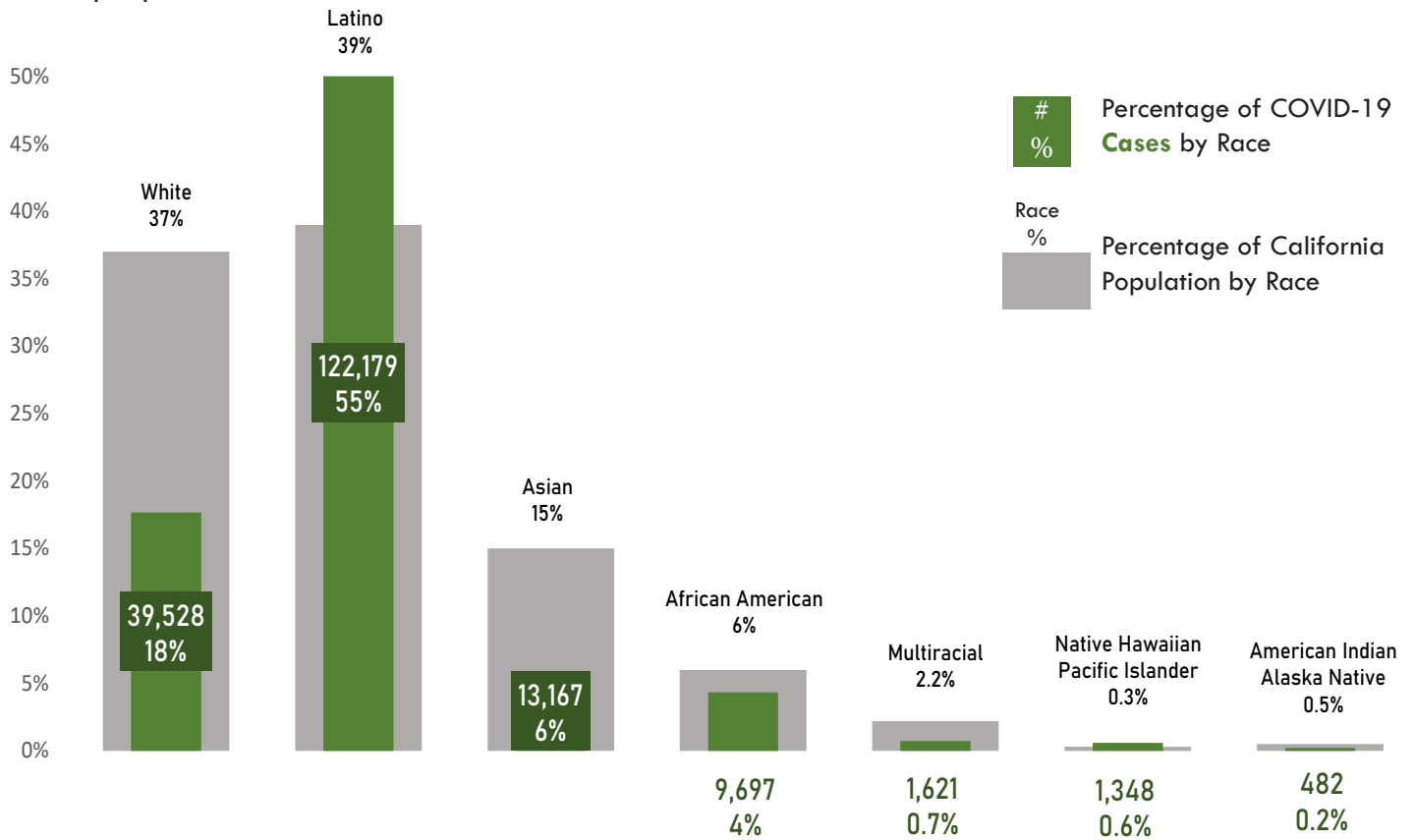
New Confirmed Deaths in California by Date

## RACIAL DISTRIBUTION OF CONFIRMED COVID-19 CASES AND DEATHS IN CALIFORNIA

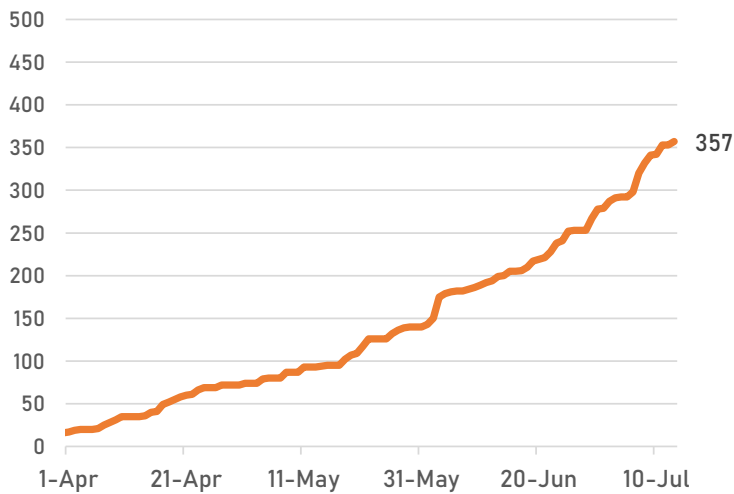
American Indians and Alaska Natives account for 0.5% percent of the population, **0.2% of COVID-19 cases**, and **0.4% of deaths** in California. These include **460 cases** and **25 deaths** among American Indian and Alaska Native people in California.



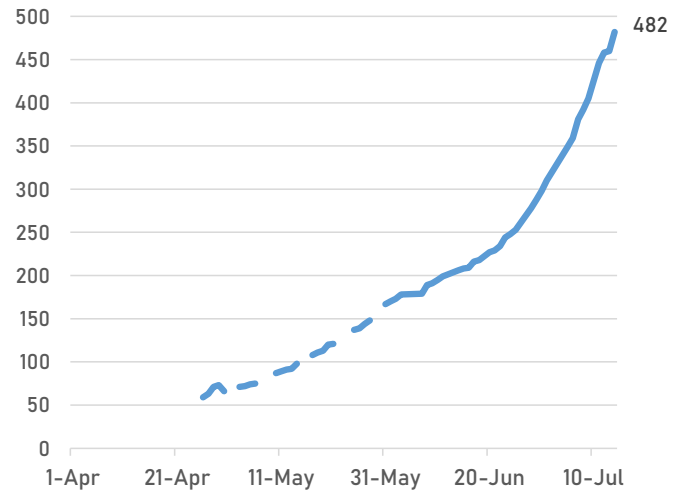

Data from the **Indian Health Service (IHS)** include positive cases reported by Tribal and Urban Indian Health Programs.

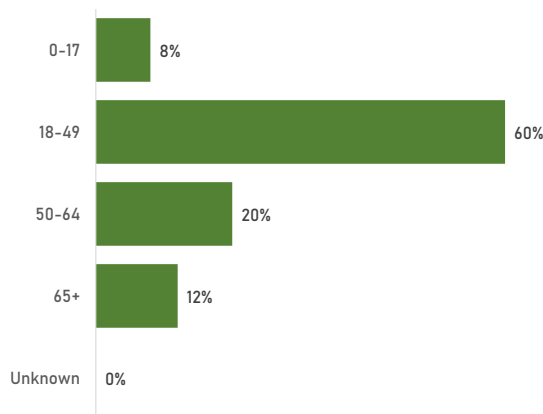


Data from **California Department of Public Health (CDPH)** include all positive cases of AIAN diagnosed in California.

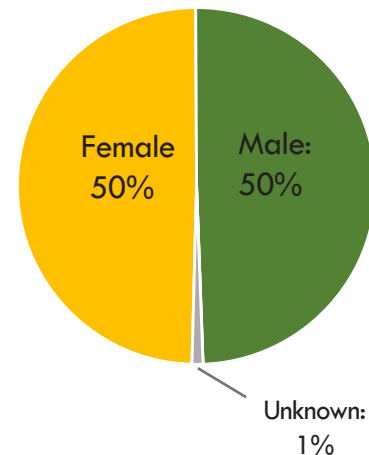

### In California:

**2.0%** of confirmed cases have been admitted to a hospital

**0.6%** of confirmed cases have been admitted to an Intensive Care Unit

**2.1%** of cases have died

### Racial disparities:

- For all adults ages 18+, Latinos and African Americans are dying at disproportionately high rates. The proportion of COVID-19 deaths in Latinos is more than 1.5 times their population representation across all adult age categories.
- Almost half of all deaths continue to be in the 80+ age category.

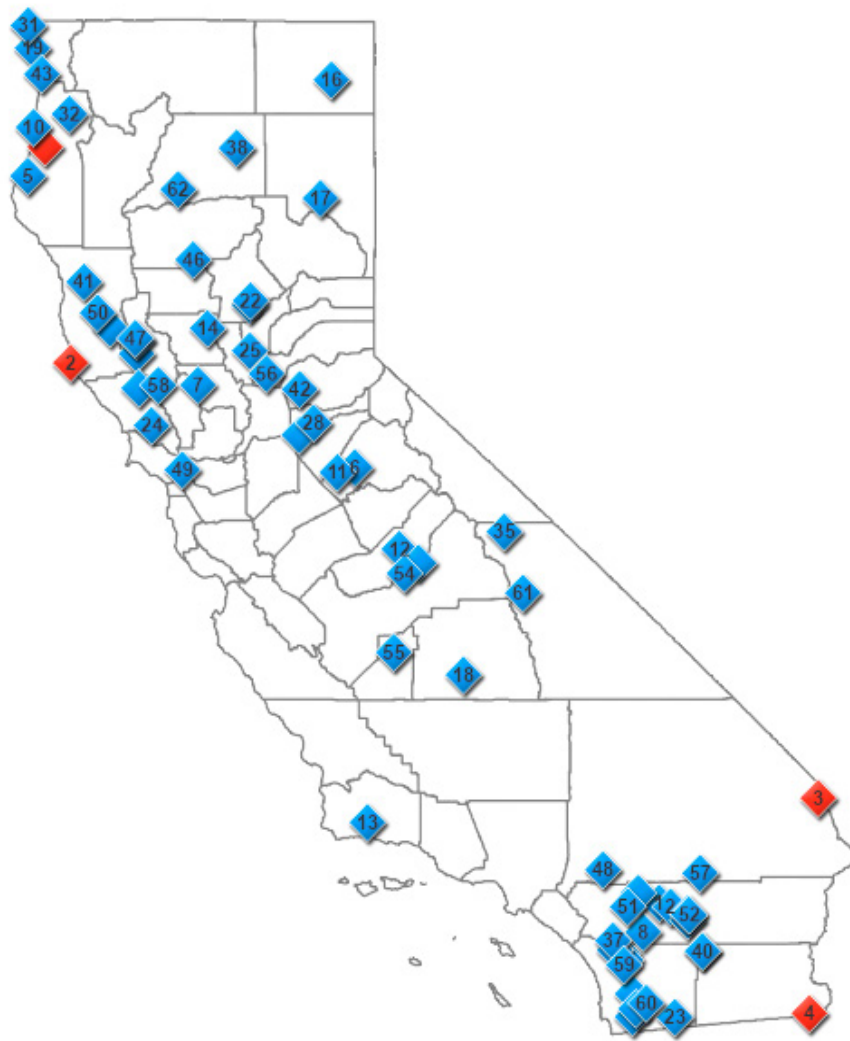

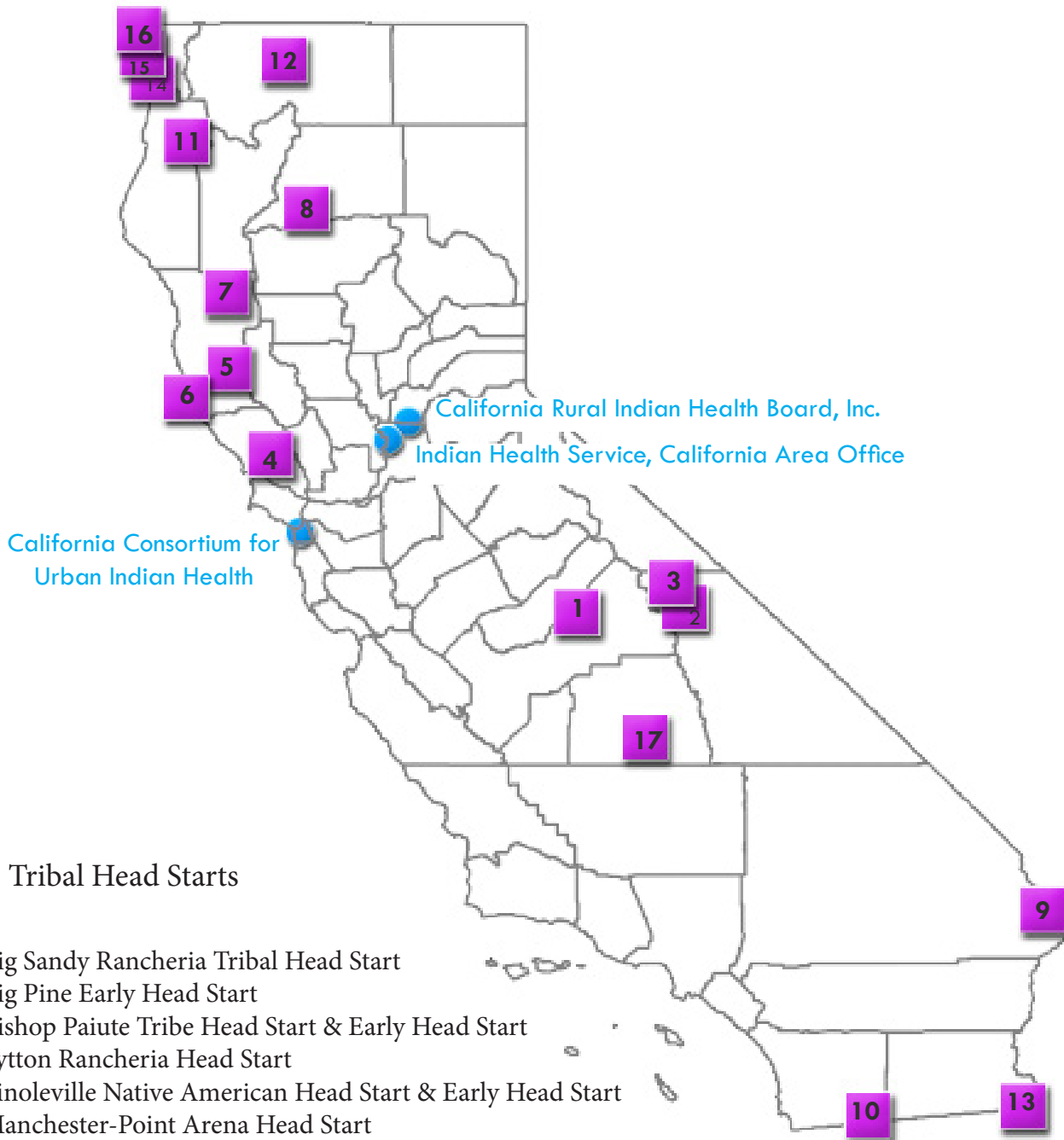

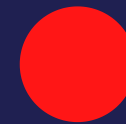
