



CORONAVIRUS DISEASE 2019 (COVID-19) SITUATIONAL REPORT #91 JULY 21, 2020



DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 14.56 million with more than 607,000 deaths.

The total number of cases in the U.S. increased from 3,761,362 as reported on Monday 7/20/2020 to 3,819,139 reported today. The number of deaths in the U.S. increased from 140,157 to 140,630.

The California Area Indian Health Service (IHS) has reported that 325 California Tribal or Urban Indian Health Program patients have tested positive for COVID-19 as of 7/19/2020.

State and local governmental entities, certain nonprofit organizations, and federally recognized Indian tribes that have elected the reimbursable method of paying for unemployment benefits will receive partial reimbursements (generally 50 percent) for UI benefits authorized for the weeks between March 13, 2020 and December 31, 2020. This emergency relief is provided by the federal CARES Act.

In order to qualify for the CARES Act 50% federal reimbursement for UI benefits authorized between March 13, 2020 and December 31, 2020, the entity must pay in full the reimbursable charges shown on their Notice of Amount Due (DE 6601) or Statement of Account (DE 2176). Once EDD receives the payment in full, EDD will issue the 50% reimbursement to the reimbursable employer. For example, if the reimbursable employer paid 100% of their charges for the 1st quarter 2020, the next step is to issue the reimbursement for 50% of their charges for the last two weeks of March. We anticipate that the 50% reimbursement for the 1st quarter 2020 will be transmitted to the State Controller's Office (SCO) starting in mid-July and it will take 4-6 weeks for employers to receive the reimbursement from SCO. For the 2nd -4th quarter of 2020, once they pay 100% of their charges, we would reimburse them 50% of the charges. Additional information is available on EDD's website at COVID-19 Resources. 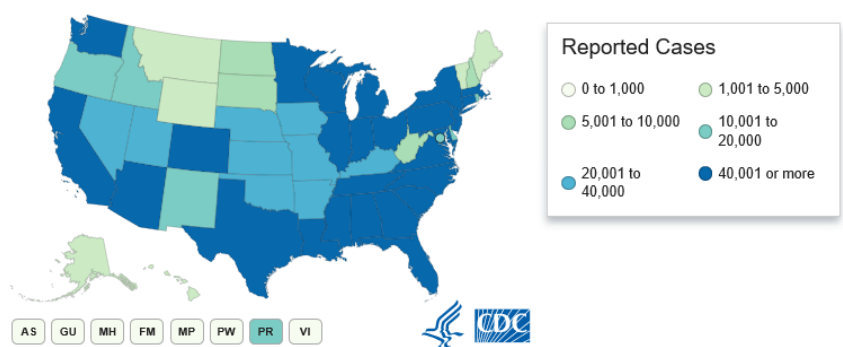
*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020. The position statement included a case definition and made COVID-19 a nationally notifiable disease.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19. A probable case or death is defined by:

- meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or
- meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or
- meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.

CALIFORNIA

As of July 20, 2020, there were a total of 400,769 positive cases and 7,755 deaths in California.

Ages of all confirmed positive cases:

- Age 0-17: 34,617 cases
- Age 18-49: 241,406 cases
- Age 50-64: 77,787 cases
- Age 65 and older: 46,495 cases
- Unknown/Missing: 464 cases

Gender of all confirmed positive cases:

- Female: 199,561 cases
- Male: 199,097 cases
- Unknown: 2,111 cases

Lab tests reported statewide: 6,536,932

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.

6,033 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 7/19/2020.

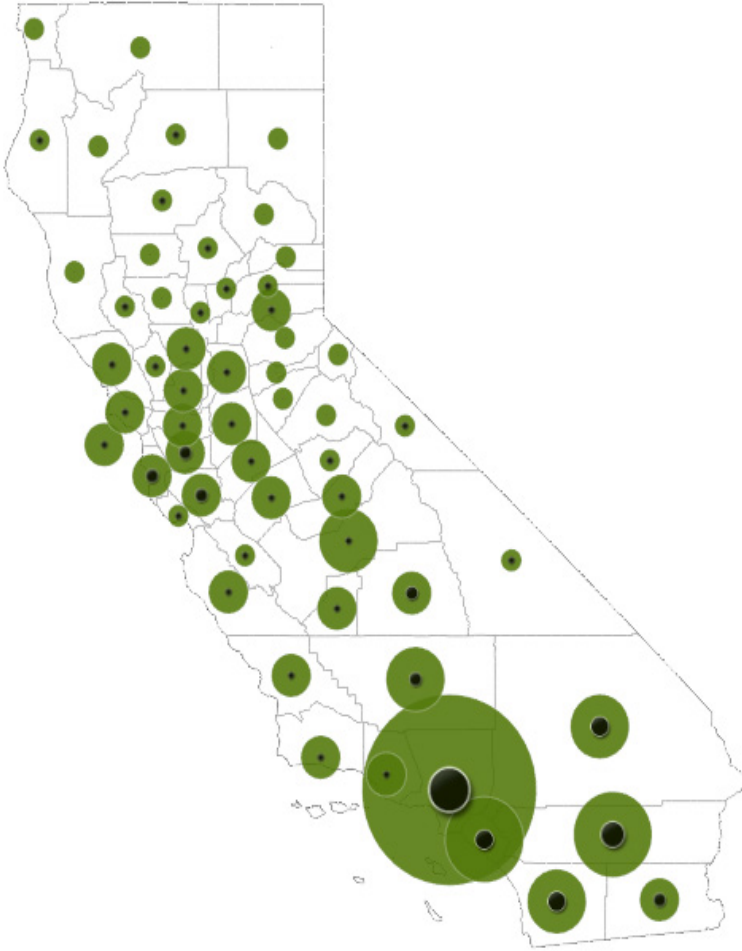
Of these, 325 patients have tested positive for COVID-19 and 4,632 have tested negative for COVID-19.

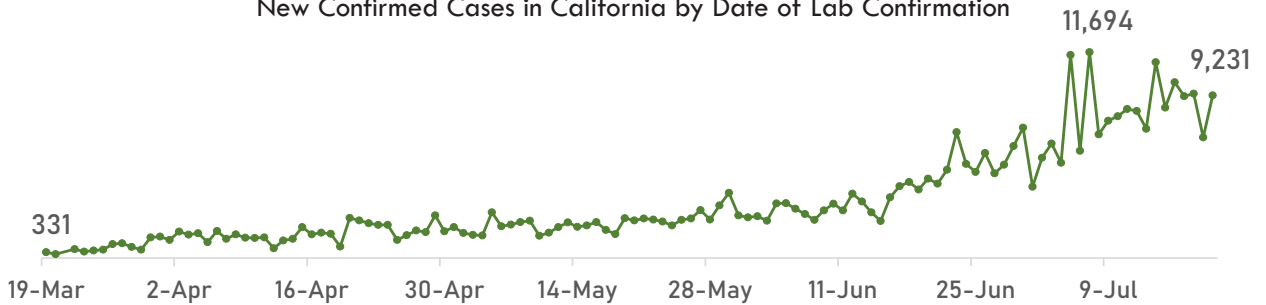

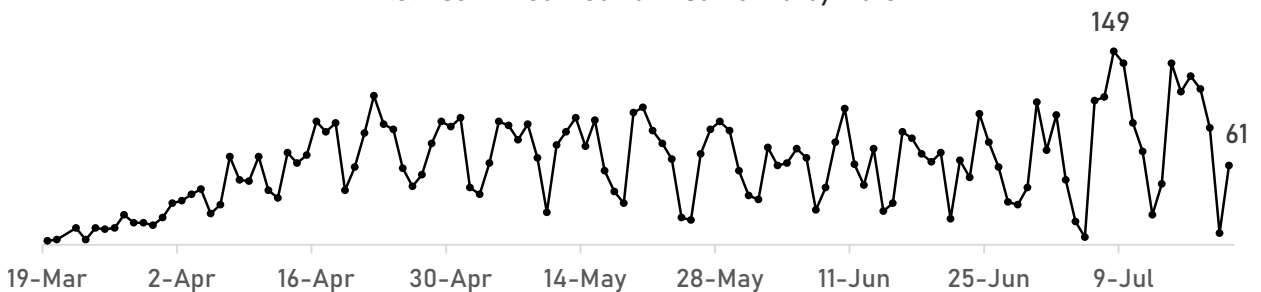

New Confirmed Cases in California by Date of Lab Confirmation



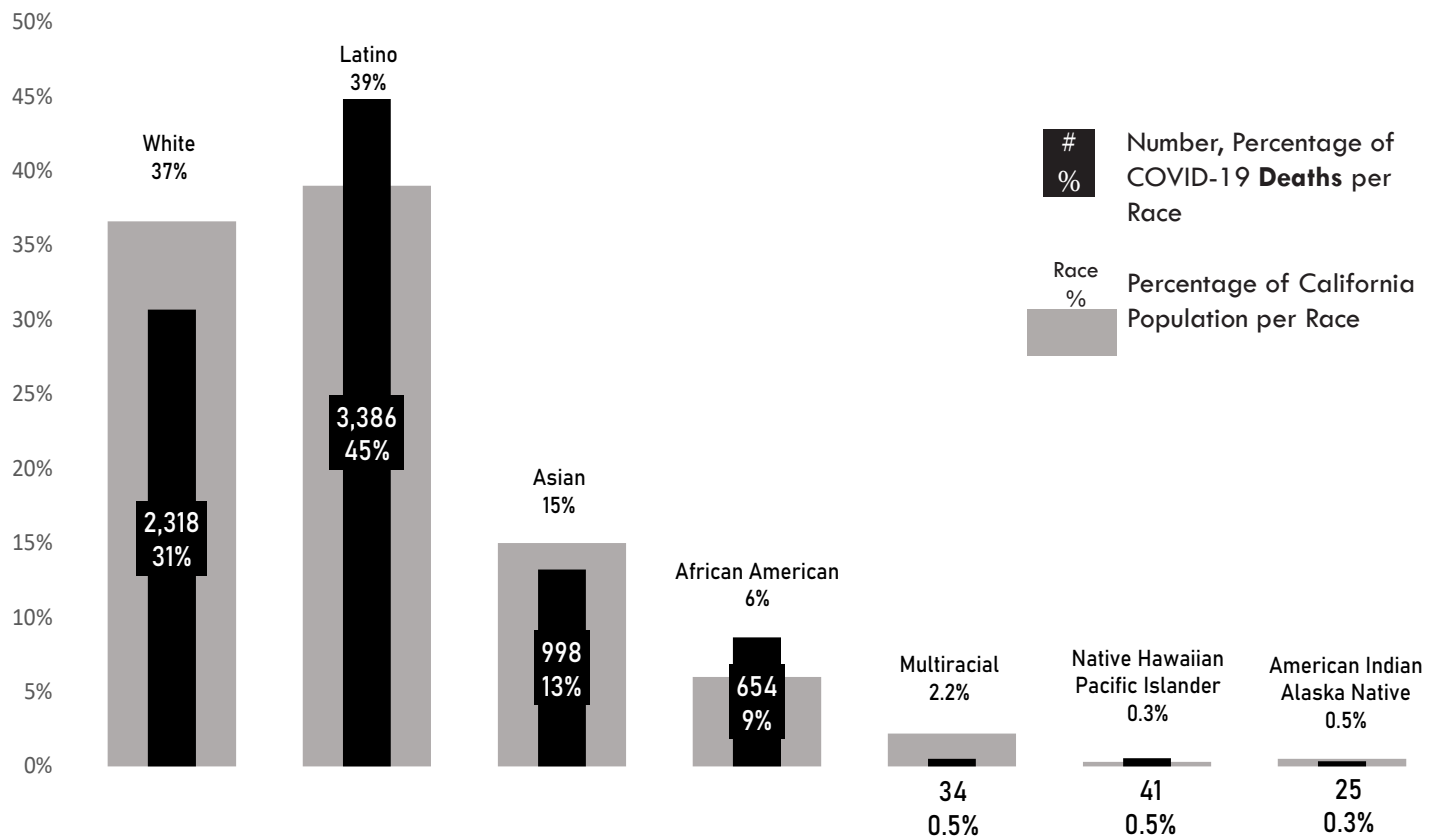
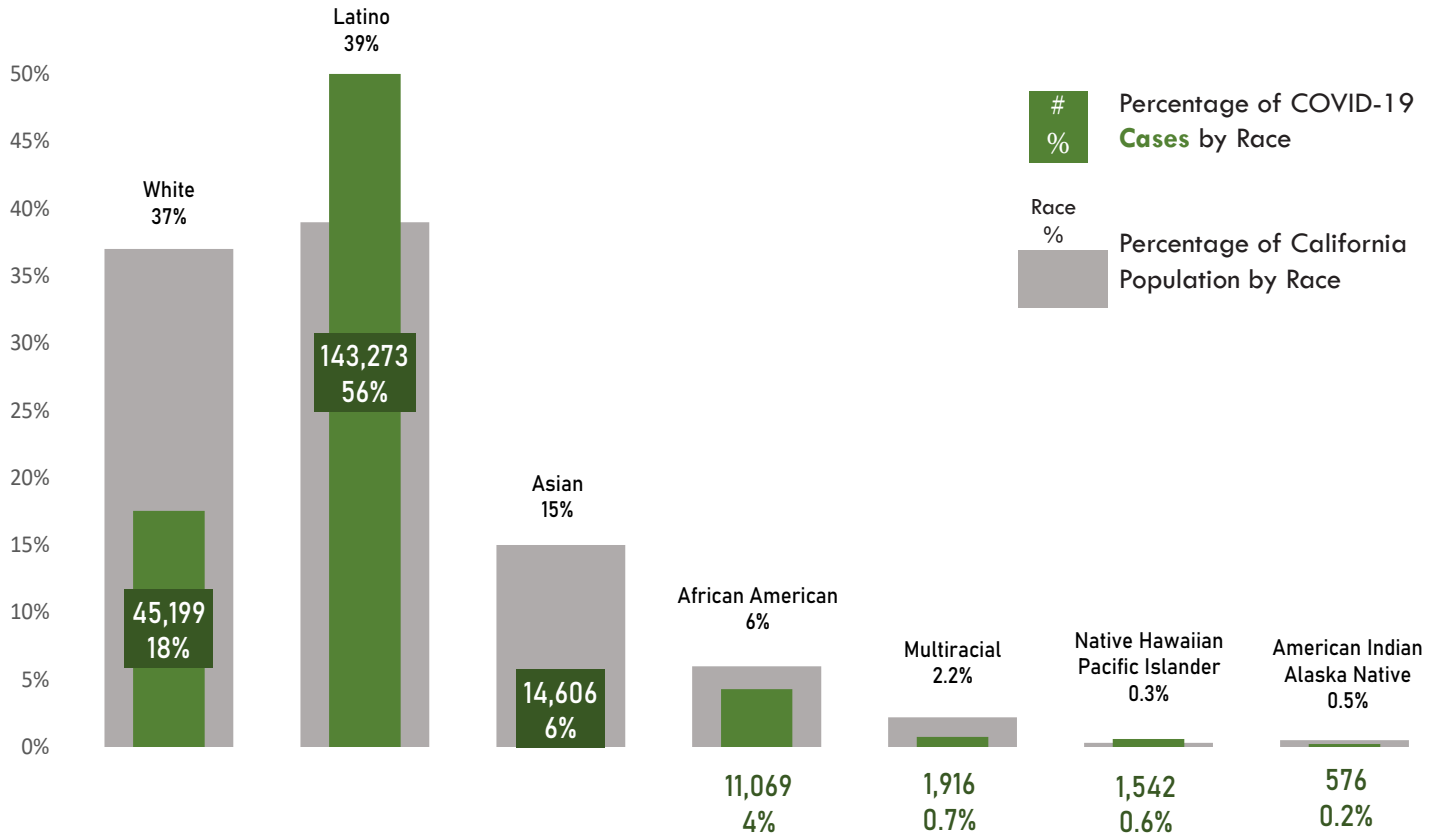
New Confirmed Deaths in California by Date

RACIAL DISTRIBUTION OF CONFIRMED COVID-19 CASES AND DEATHS IN CALIFORNIA

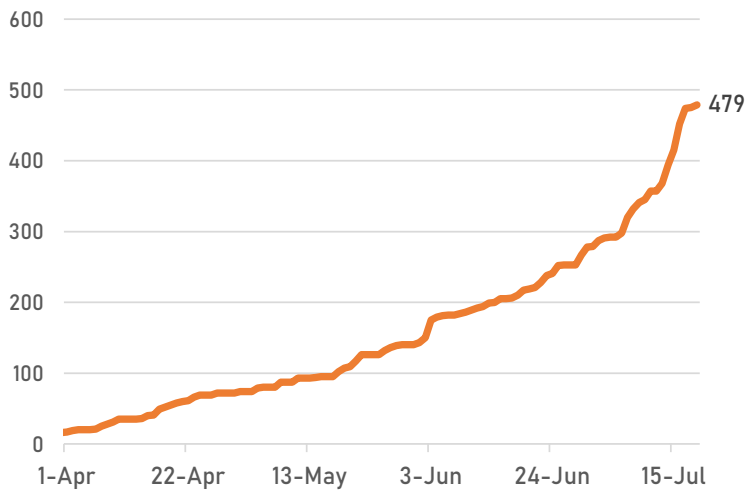
American Indians and Alaska Natives account for 0.5% percent of the population, **0.2% of COVID-19 cases**, and **0.3% of deaths** in California. These include **576 cases** and **25 deaths** among American Indian and Alaska Native people in California.



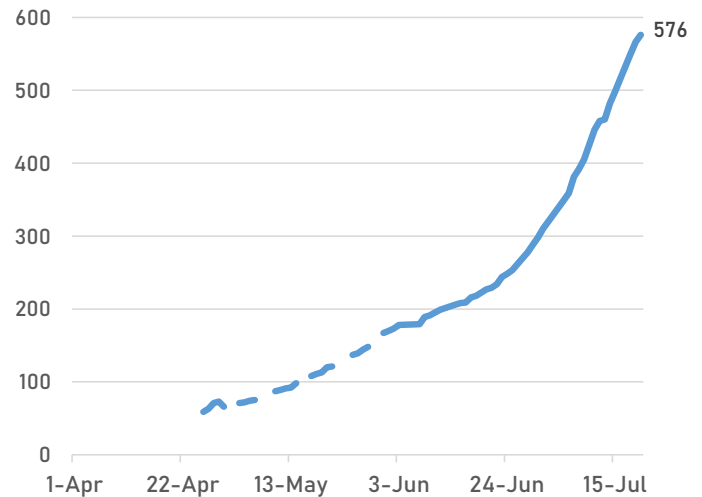

Data from the **Indian Health Service (IHS)** include positive cases reported by Tribal and Urban Indian Health Programs.

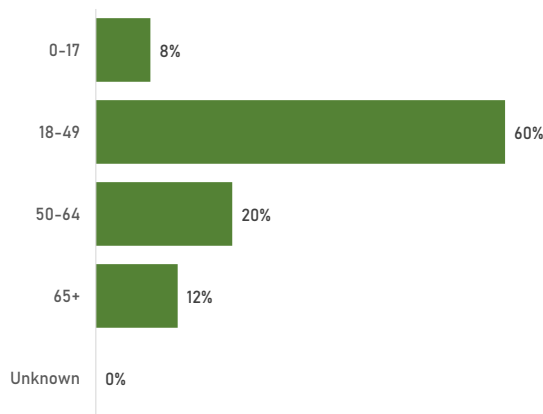

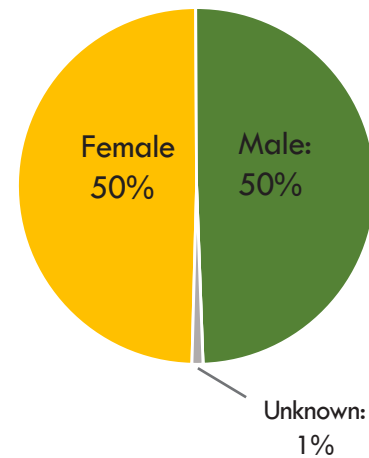

In California:

Racial disparities:

- For all adults ages 18+, Latinos and African Americans are dying at disproportionately high rates. The proportion of COVID-19 deaths in Latinos is more than 1.5 times their population representation across all adult age categories.
- Almost half of all deaths continue to be in the 80+ age category.

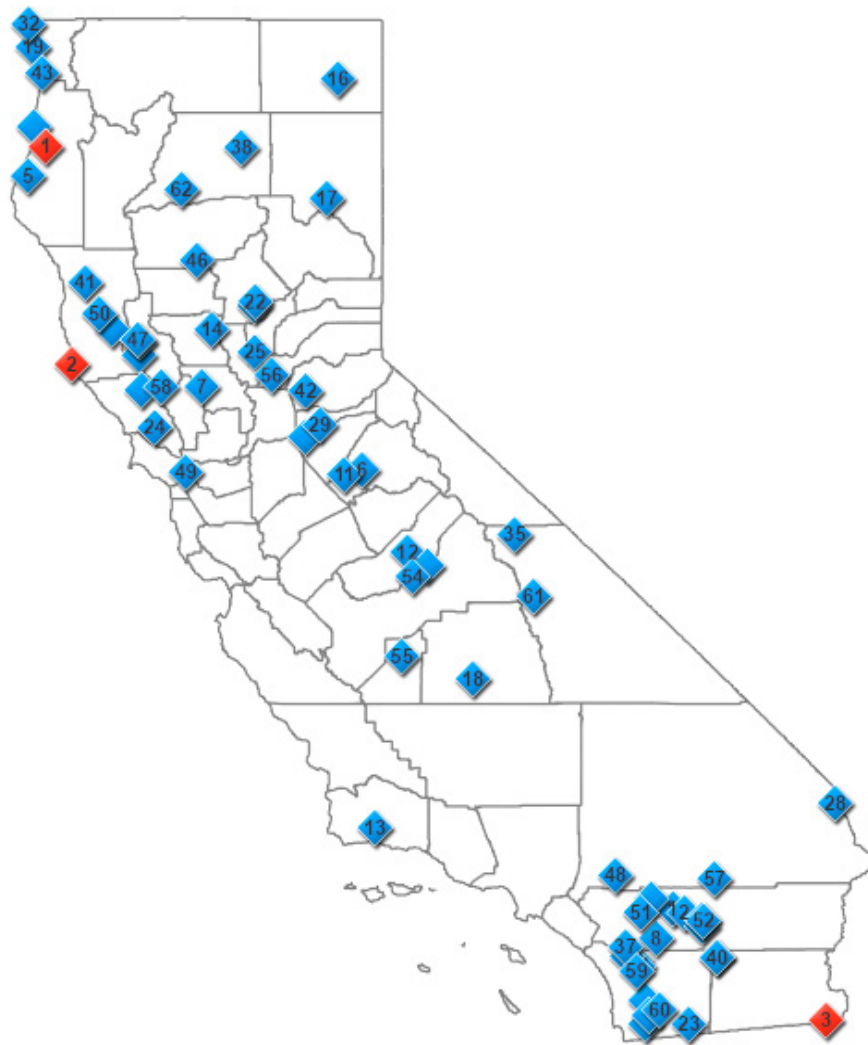

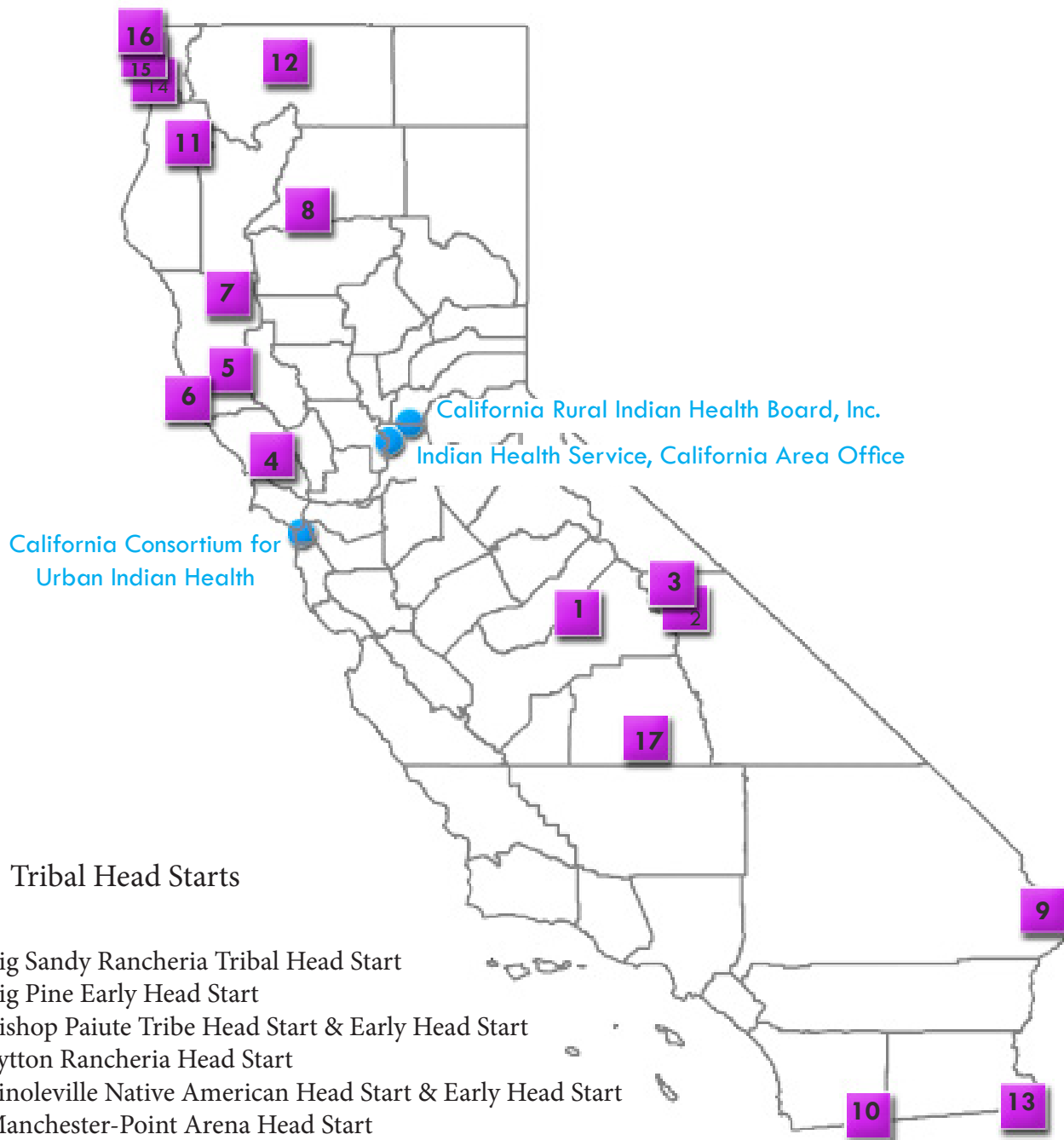

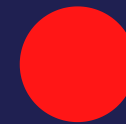
