DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 15.29 million with more than 628,000 deaths.

The total number of cases in the U.S. increased from 3,952,273 as reported on Thursday 7/23/2020 to 4,024,492 reported today. The number of deaths in the U.S. increased from 142,755 to 143,868.

The California Area Indian Health Service (IHS) has reported that 357 California Tribal or Urban Indian Health Program patients have tested positive for COVID-19 as of 7/22/2020.

Governor Gavin Newsom announced new supports for California's workforce, including preventative measures, employer education and long-lasting worker protections. The latest forecast from the Institute of Health Metrics and Evaluation suggests that 33,000 deaths could be avoided by October 1 if 95 percent of people wore masks in public. The CDC recommends that people wear cloth face coverings in public settings when around people outside of their household, especially when other social distancing measures are difficult to maintain. Cloth face coverings should NOT be worn by children under the age of 2 or anyone who has trouble breathing, is unconscious, incapacitated, or otherwise unable to remove the mask without assistance. 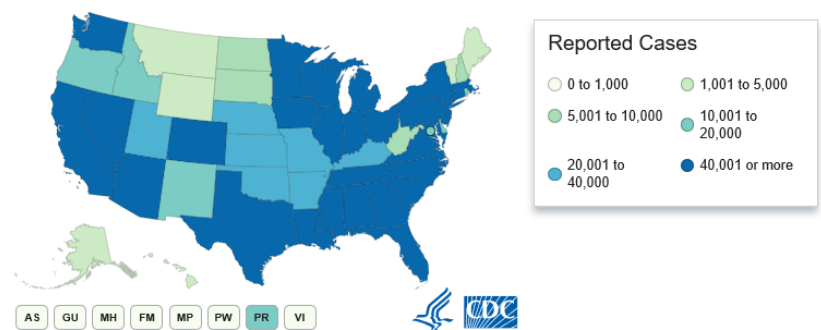
*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020. The position statement included a case definition and made COVID-19 a nationally notifiable disease.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

- meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or
- meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or
- meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.

State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

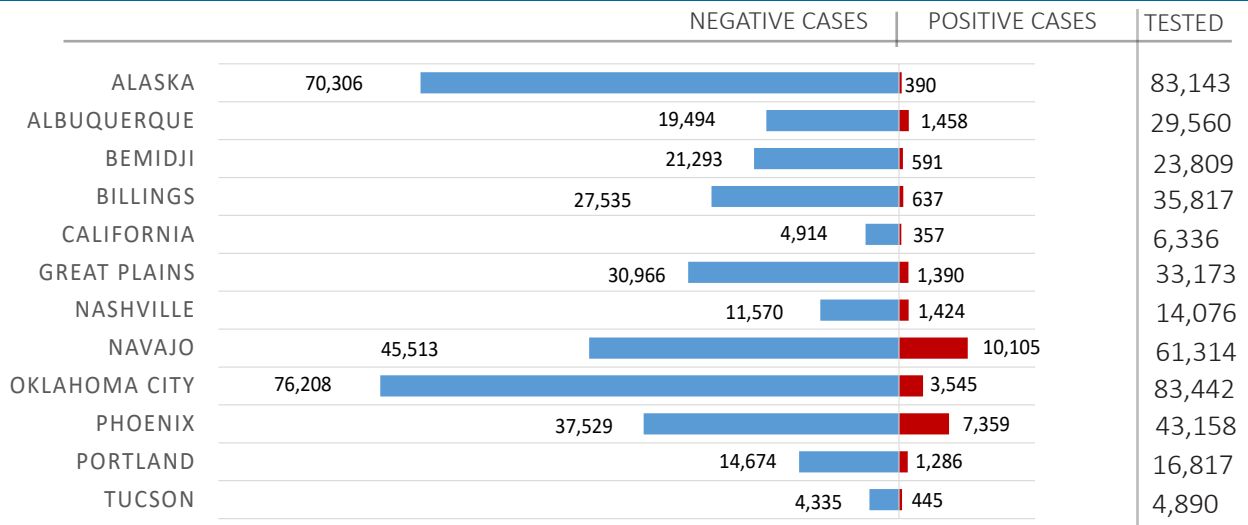

CALIFORNIA

As of July 23, 2020, there were a total of 435,334 positive cases and 8,186 deaths in California.

Ages of all confirmed positive cases:

- Age 0-17: 38,301 cases
- Age 18-49: 262,780 cases
- Age 50-64: 84,114 cases
- Age 65 and older: 49,648 cases
- Unknown/Missing: 491 cases

Gender of all confirmed positive cases:

- Female: 217,370 cases
- Male: 215,652 cases
- Unknown: 2,312 cases

Lab tests reported statewide: 6,915,876

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.

INDIAN HEALTH SERVICE CALIFORNIA AREA

6,336 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 7/22/2020.

Of these, 357 patients have tested positive for COVID-19 and 4,914 have tested negative for COVID-19.

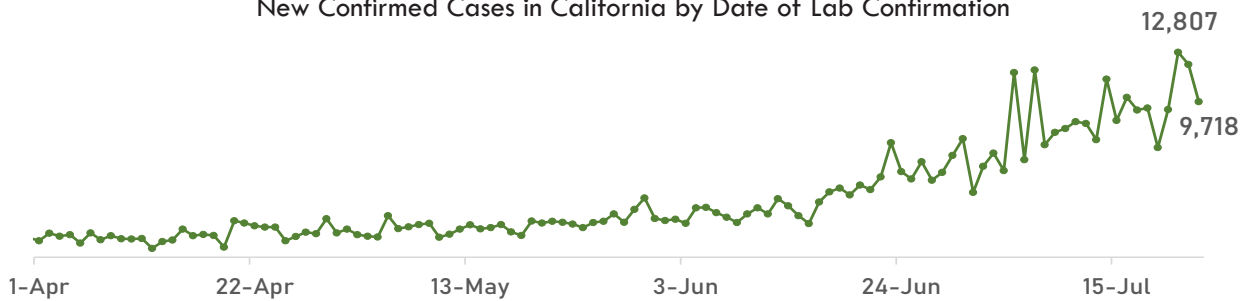

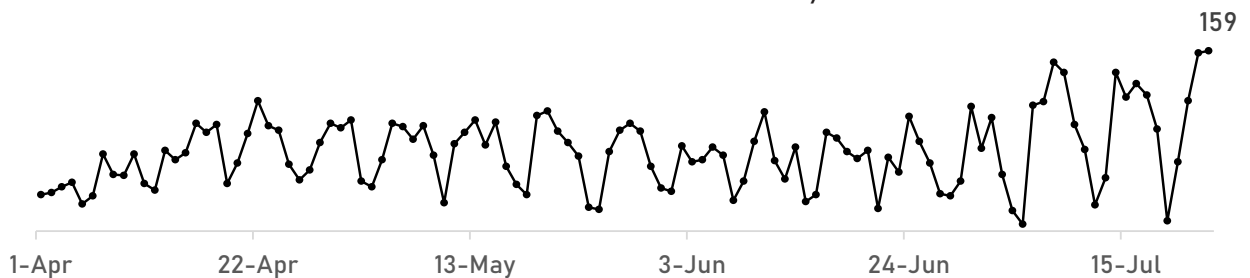

New Confirmed Cases in California by Date of Lab Confirmation



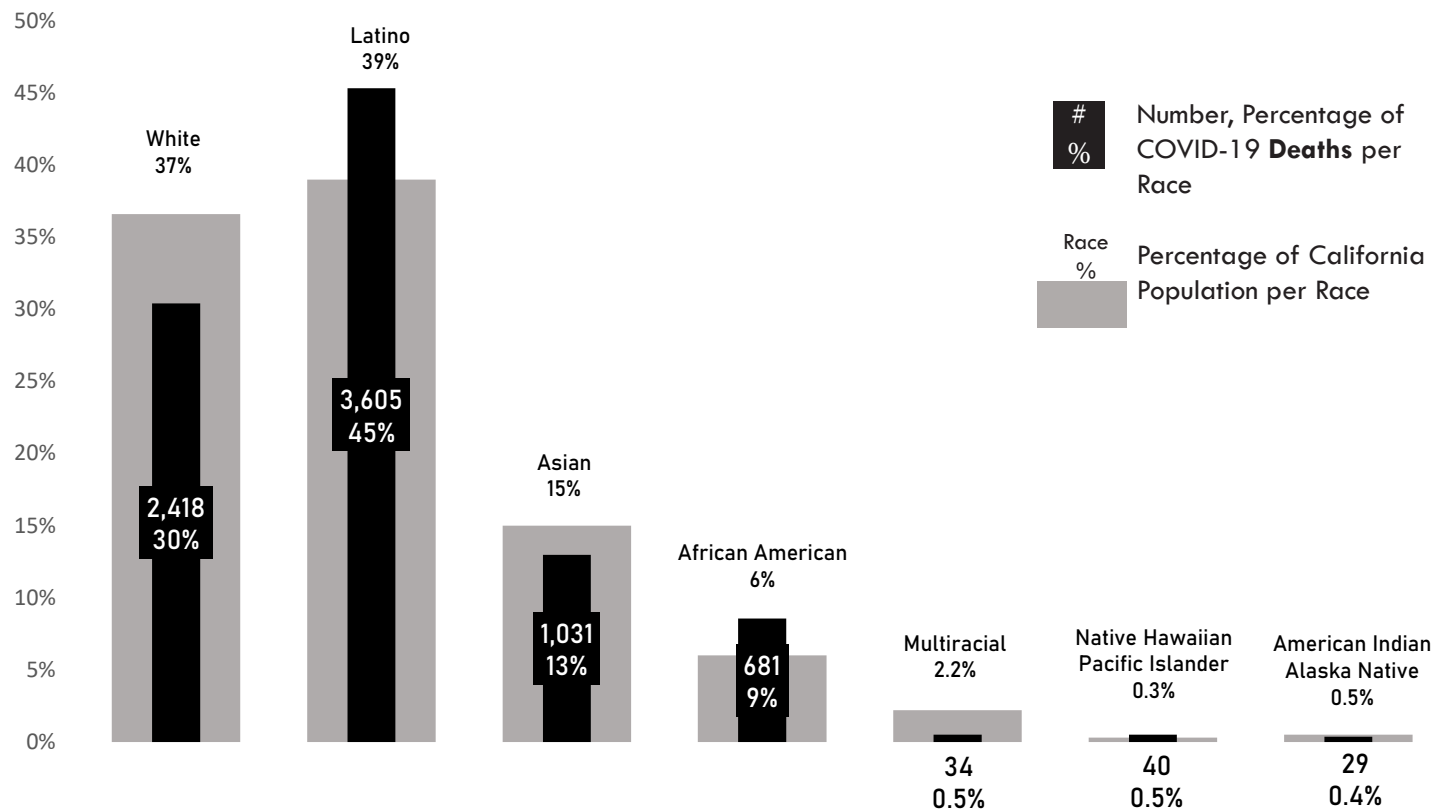
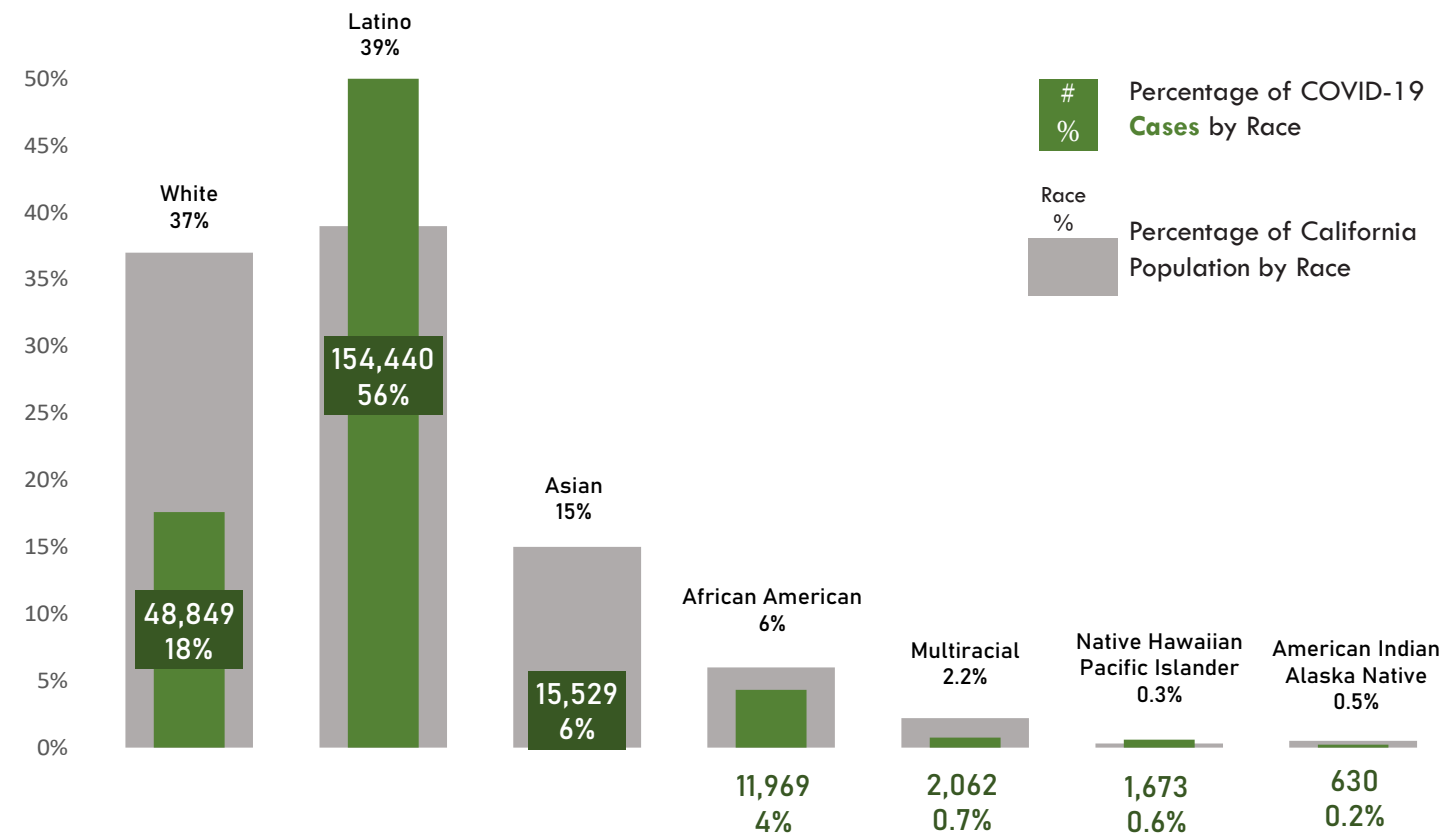
New Confirmed Deaths in California by Date

RACIAL DISTRIBUTION OF CONFIRMED COVID-19 CASES AND DEATHS IN CALIFORNIA

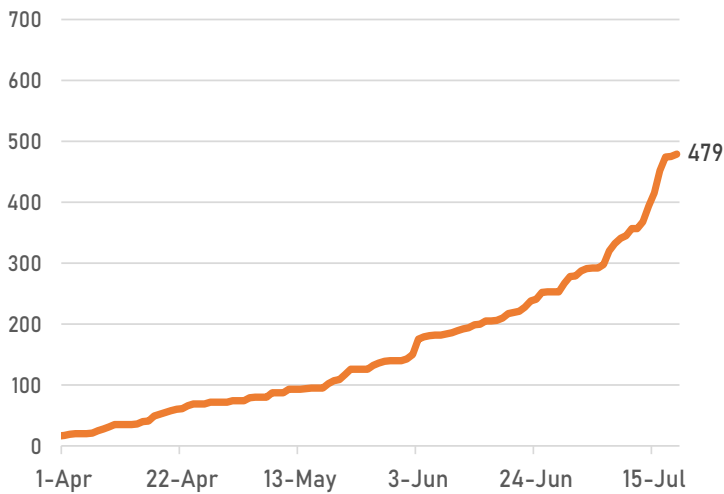
American Indians and Alaska Natives account for 0.5% percent of the population, **0.2% of COVID-19 cases**, and **0.4% of deaths** in California. These include **630 cases** and **29 deaths** among American Indian and Alaska Native people in California.



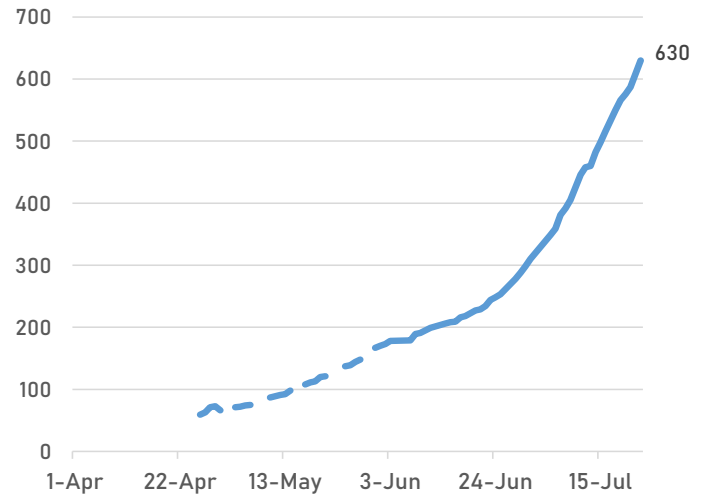

Data from the **Indian Health Service (IHS)** include positive cases reported by Tribal and Urban Indian Health Programs.

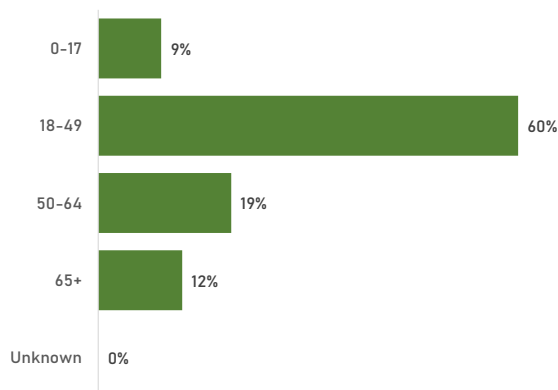


Data from **California Department of Public Health (CDPH)** include all positive cases of AIAN diagnosed in California.

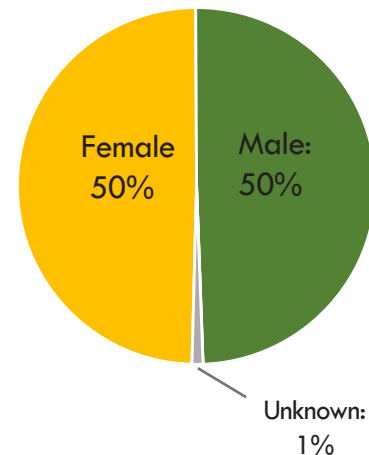

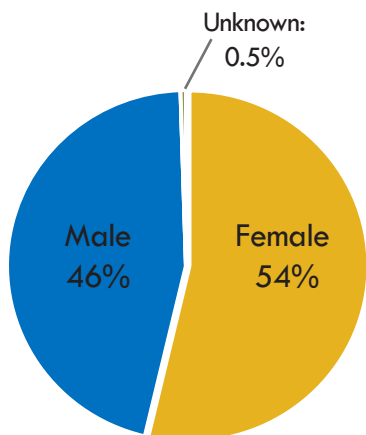
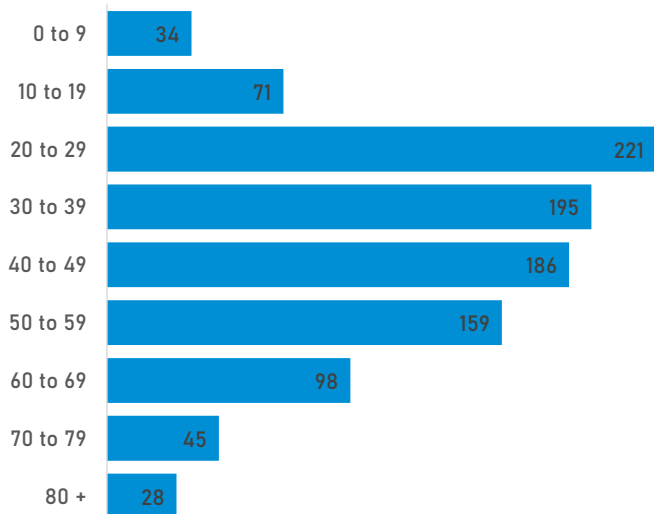
Racial disparities:

- For all adults ages 18+, Latinos and African Americans are dying at disproportionately high rates. The proportion of COVID-19 deaths in Latinos is more than 1.5 times their population representation across all adult age categories.
- Almost half of all deaths continue to be in the 80+ age category.

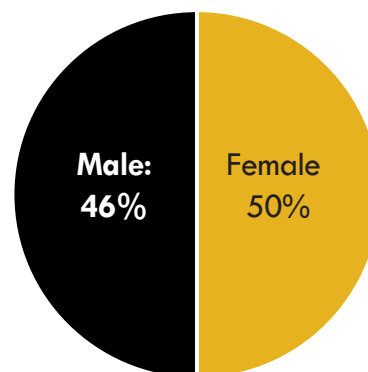
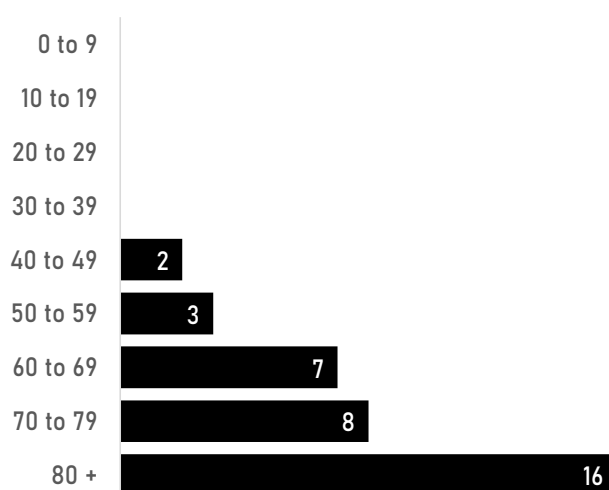

Positive COVID-19 cases among AIAN people in California by Age Group and Gender

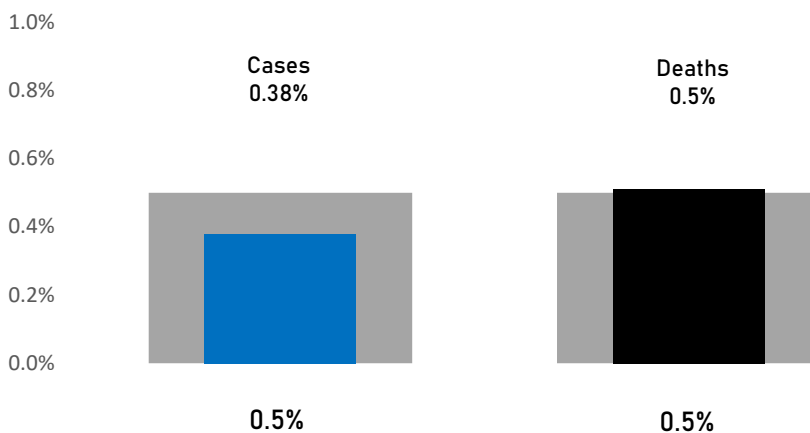


COVID-19 deaths among AIAN people in California by Age Group and Gender

1,028 cases, and 36 deaths.

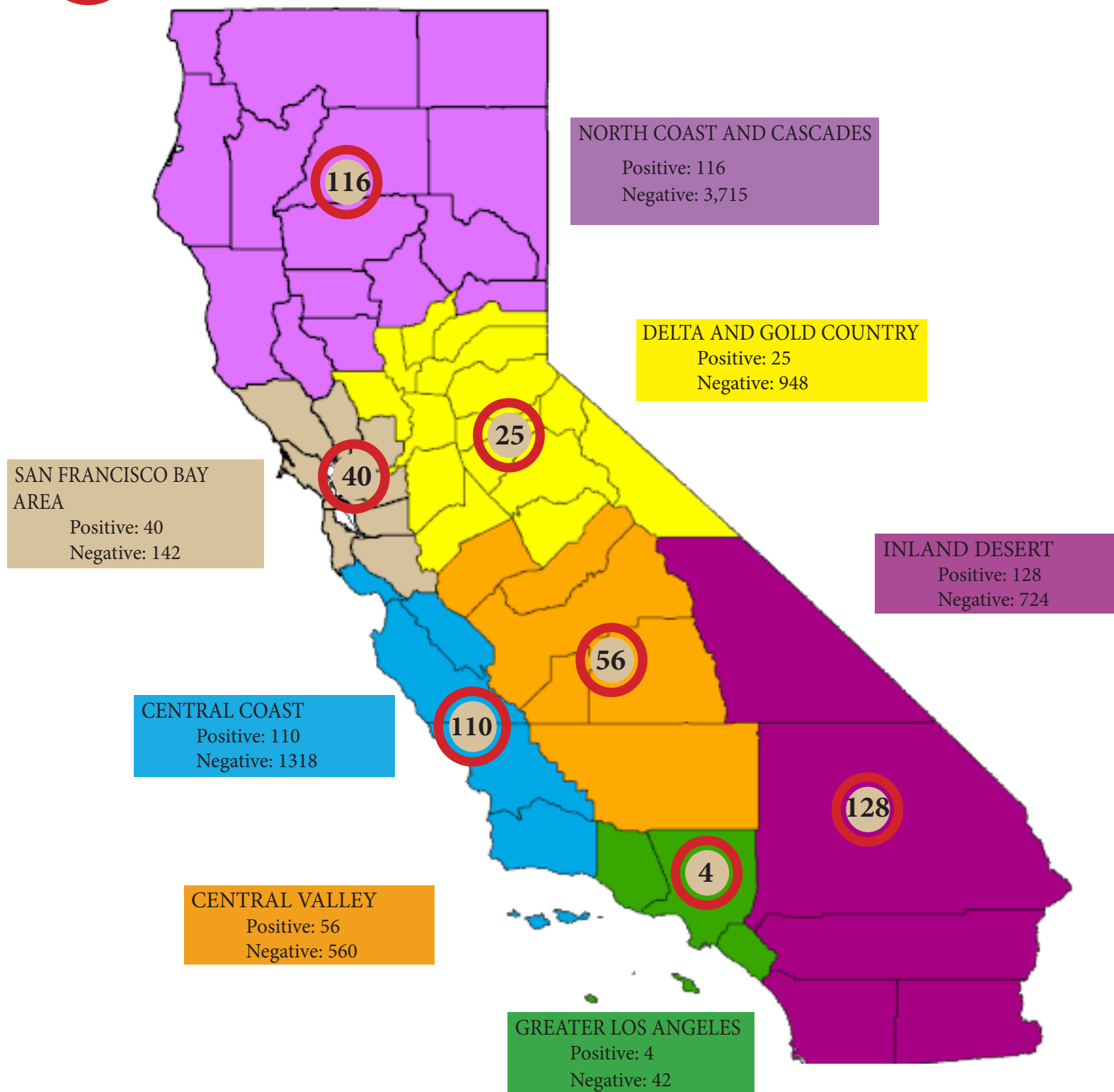


COVID-19 Testing Information from Patients Seen at a Tribal or Urban Indian Health Program in California.

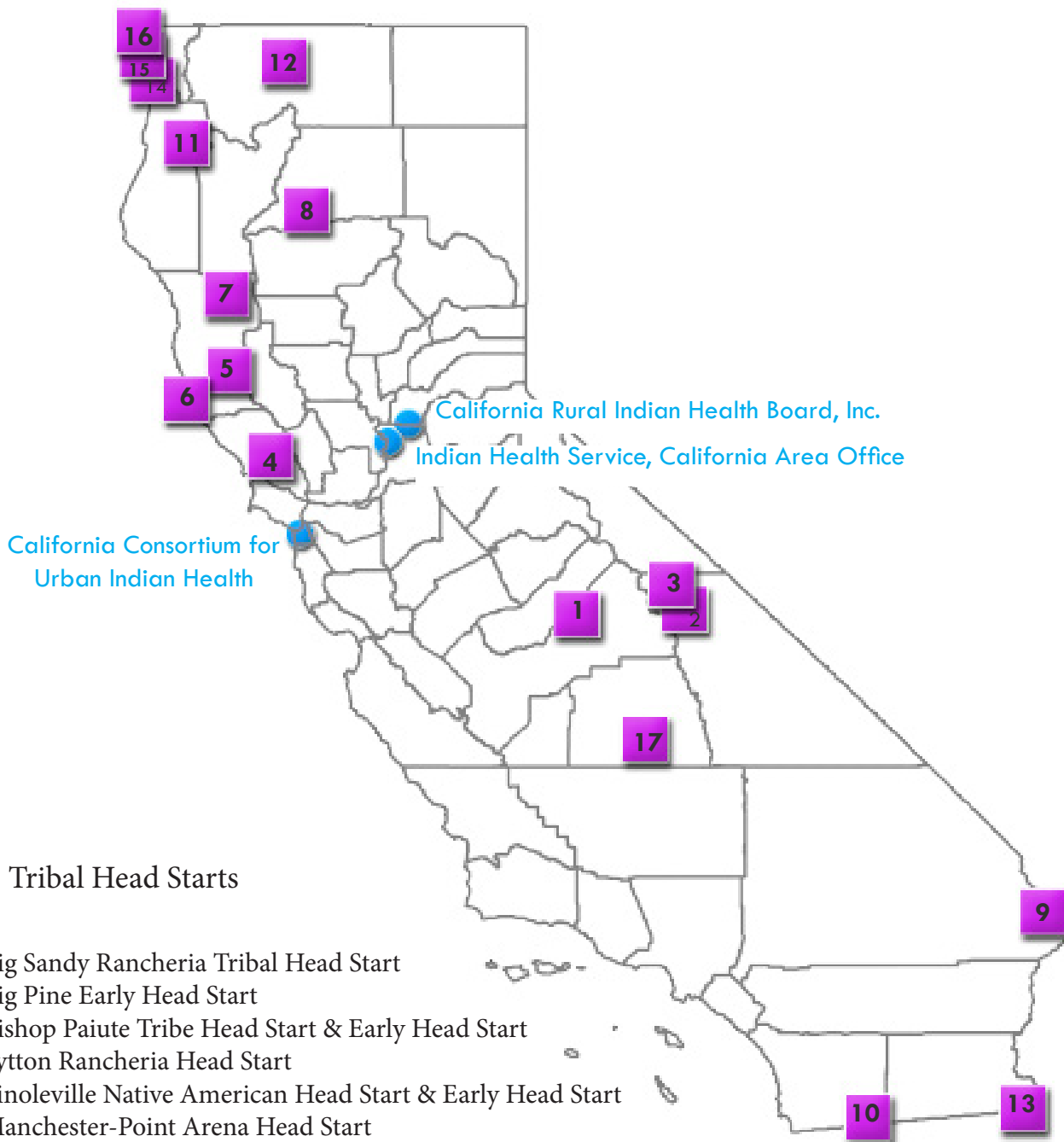

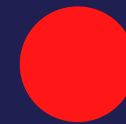
