



CORONAVIRUS DISEASE 2019 (COVID-19) SITUATIONAL REPORT #96 JULY 28, 2020



DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 16.34 million with more than 650,000 deaths.

The total number of cases in the U.S. increased from 4,225,687 as reported on Monday 7/27/2020 to 4,280,135 reported today. The number of deaths in the U.S. increased from 146,546 to 147,672.

The California Area Indian Health Service (IHS) has reported that 369 California Tribal or Urban Indian Health Program patients have tested positive for COVID-19 as of 7/26/2020.

The Centers for Medicare & Medicaid Services today released its first monthly update of data that provides a snapshot of the impact of COVID-19 on the Medicare population. For the first time, the snapshot includes data for American Indian/Alaskan Native Medicare beneficiaries. The new data indicate that American Indian/Alaskan Native beneficiaries have the second highest rate of hospitalization for COVID-19 among racial/ethnic groups after Blacks. Previously, the number of hospitalizations of American Indian/Alaskan Native beneficiaries was too low to be reported. The updated data confirm that the COVID-19 public health emergency is disproportionately affecting vulnerable populations, particularly racial and ethnic minorities.

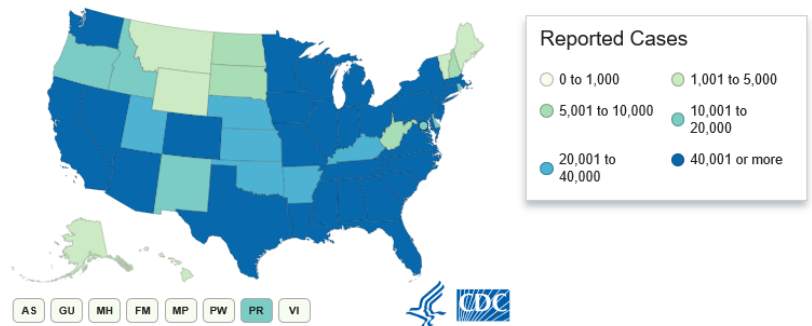
*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020. The position statement included a case definition and made COVID-19 a nationally notifiable disease.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

- meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or
- meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or
- meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.

State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

CALIFORNIA

As of July 26, 2020, there were a total of 460,550 positive cases and 8,445 deaths in California.

Ages of all confirmed positive cases:

- Age 0-17: 41,148 cases
- Age 18-49: 278,296 cases
- Age 50-64: 88,800 cases
- Age 65 and older: 51,772 cases
- Unknown/Missing: 535 cases

Gender of all confirmed positive cases:

- Female: 230,423 cases
- Male: 227,545 cases
- Unknown: 2,582 cases

Lab tests reported statewide: 7,296,578

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.

INDIAN HEALTH SERVICE CALIFORNIA AREA

6,539 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 7/26/2020.

Of these, 369 patients have tested positive for COVID-19 and 5,098 have tested negative for COVID-19.

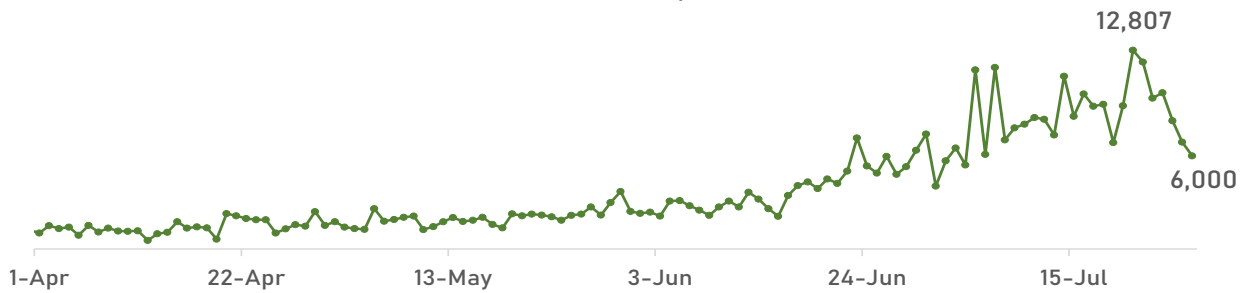

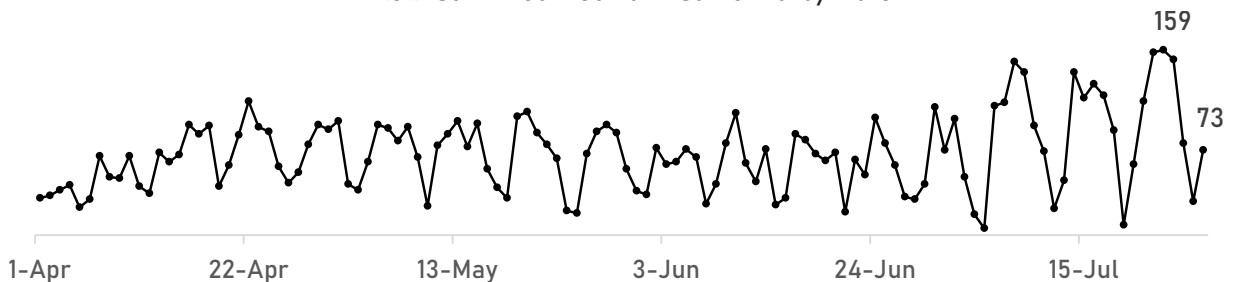

New Confirmed Cases in California by Date of Lab Confirmation



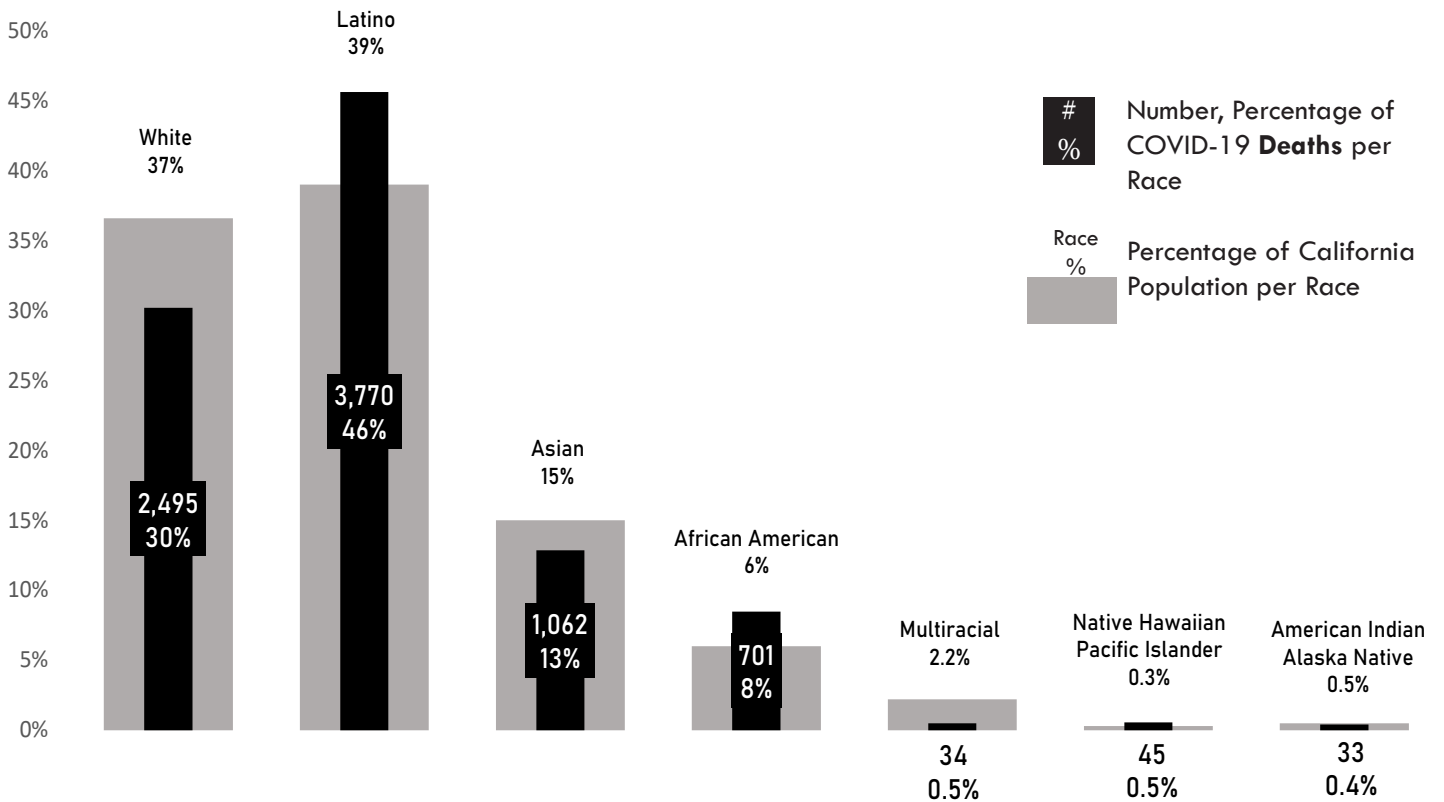
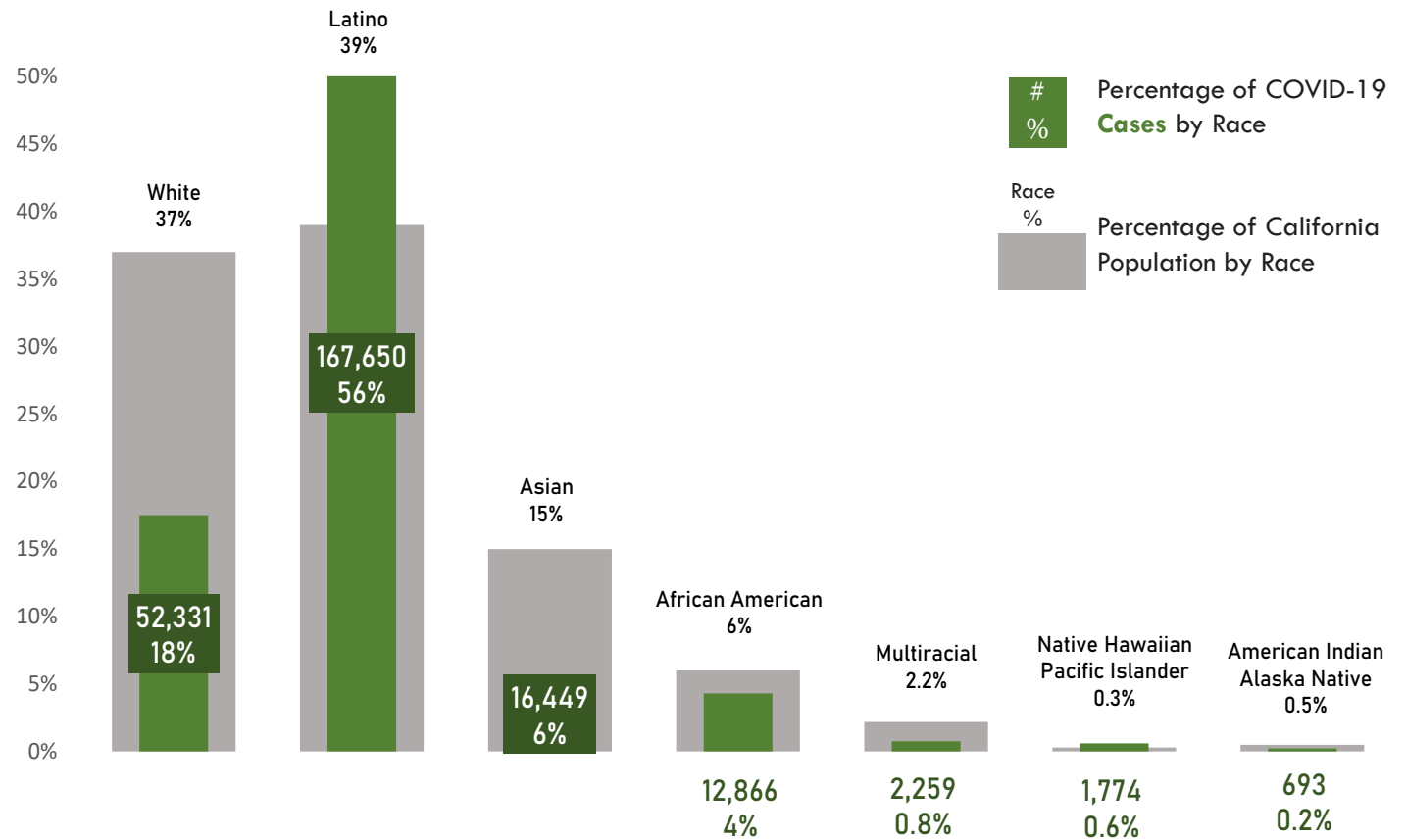
New Confirmed Deaths in California by Date

RACIAL DISTRIBUTION OF CONFIRMED COVID-19 CASES AND DEATHS IN CALIFORNIA

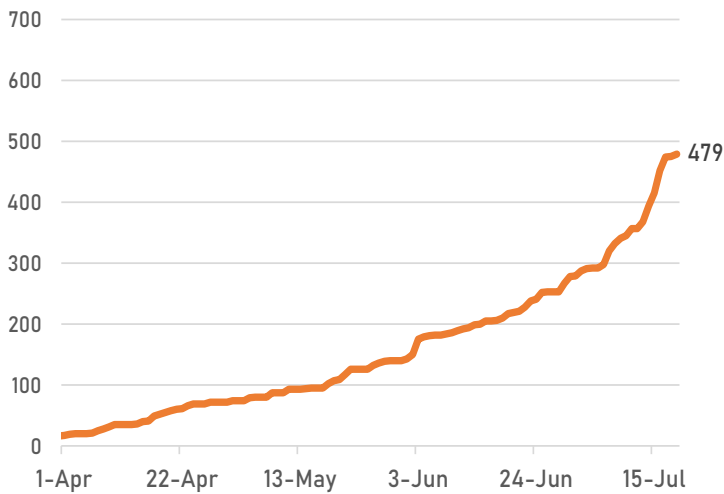
American Indians and Alaska Natives account for 0.5% percent of the population, **0.2% of COVID-19 cases**, and **0.4% of deaths** in California. These include **693 cases** and **33 deaths** among American Indian and Alaska Native people in California.



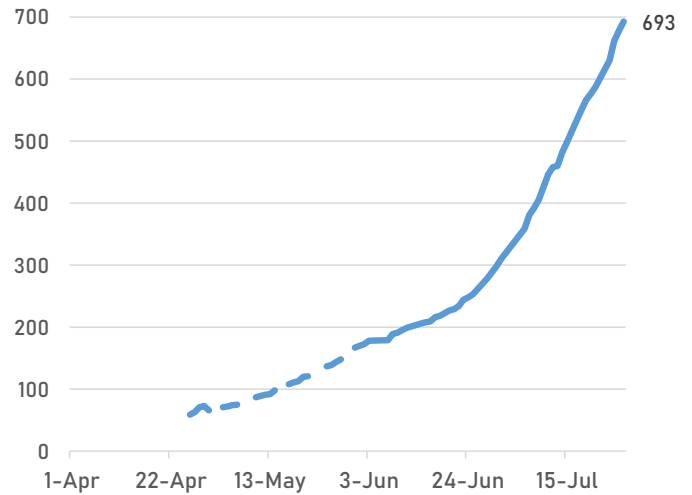

Data from the **Indian Health Service (IHS)** include positive cases reported by Tribal and Urban Indian Health Programs.

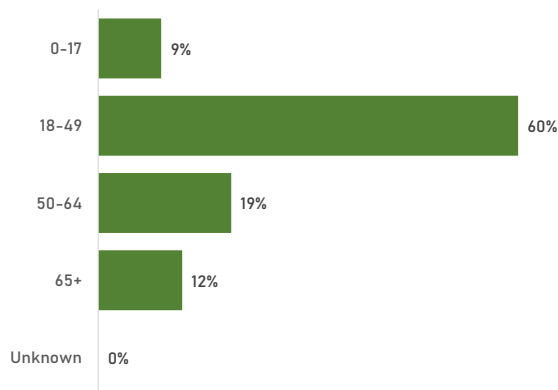


Data from **California Department of Public Health (CDPH)** include all positive cases of AIAN diagnosed in California.

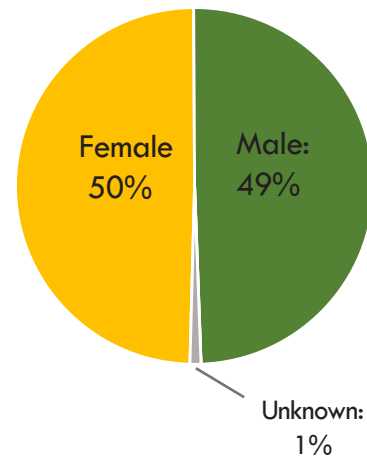

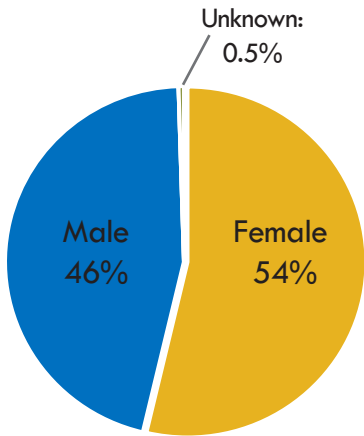
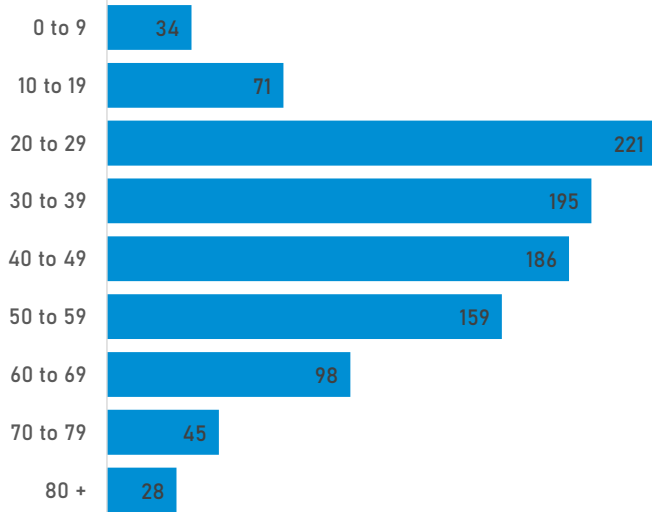
Racial disparities:

- For all adults ages 18+, Latinos and African Americans are dying at disproportionately high rates. The proportion of COVID-19 deaths in Latinos is more than 1.5 times their population representation across all adult age categories.
- Almost half of all deaths continue to be in the 80+ age category.

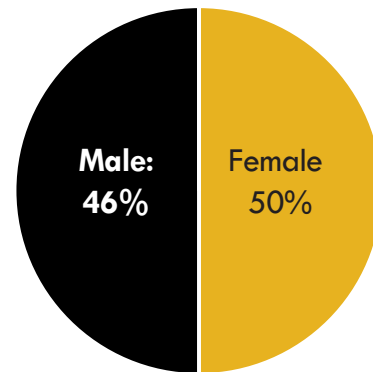
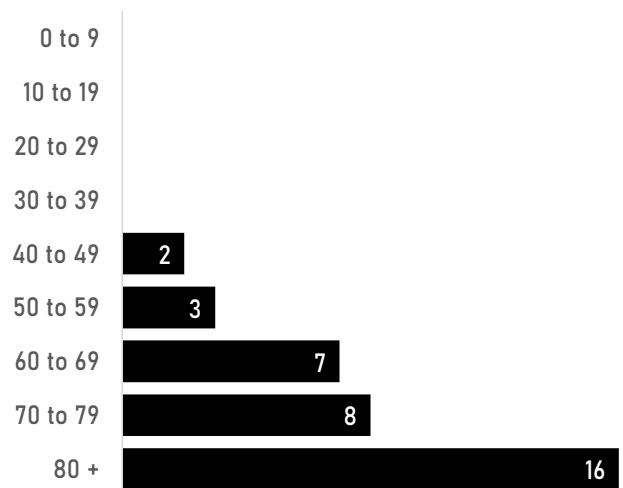

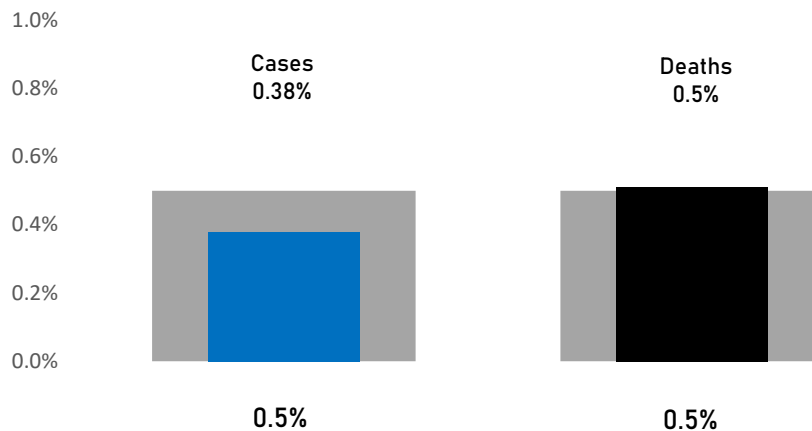
Positive COVID-19 cases among AIAN people in California by Age Group and Gender

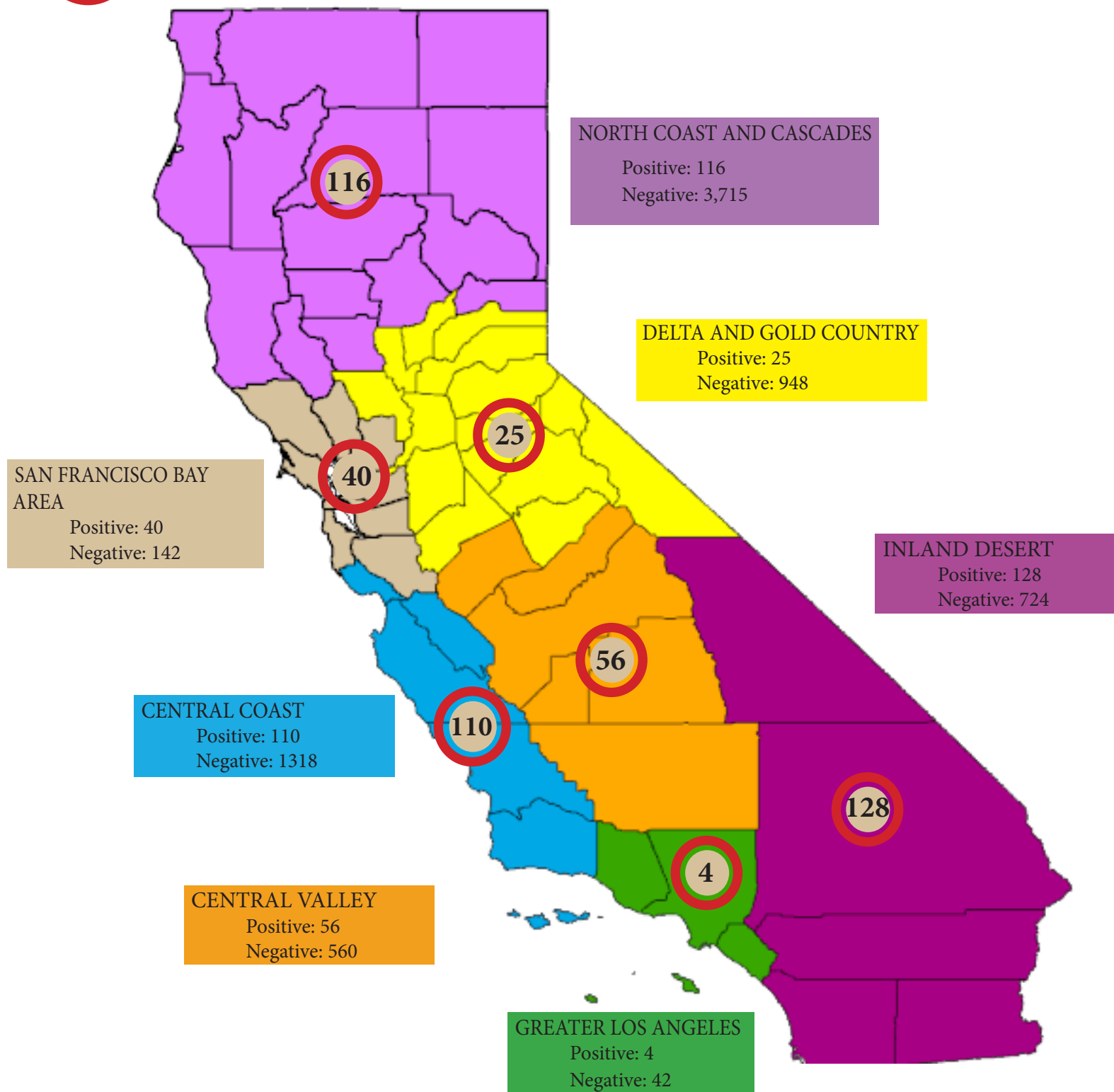


COVID-19 Testing Information from Patients Seen at a Tribal or Urban Indian Health Program in California.

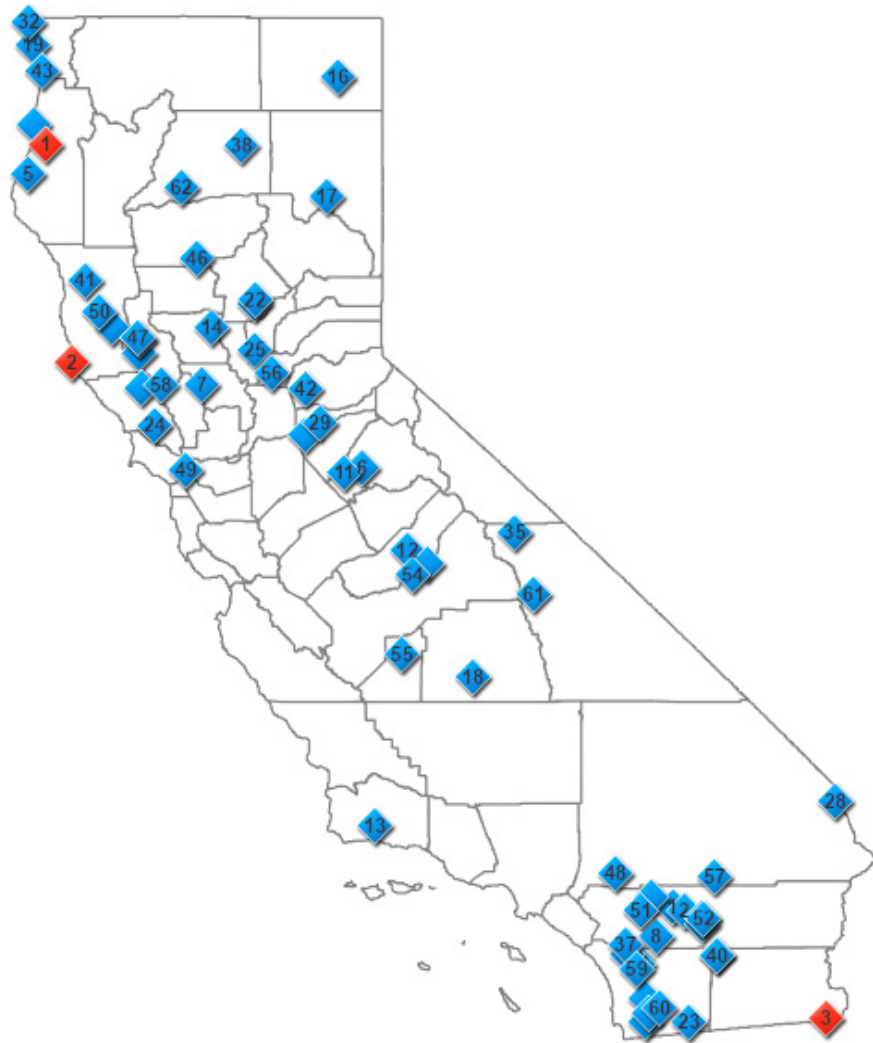

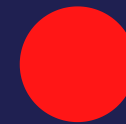


California Counties COVID-19 Response
