DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 20.43 million with more than 744,000 deaths.

The total number of cases in the U.S. increased from 5,119,711 as reported on Wednesday 8/12/2020 to 5,176,018 reported today. The number of deaths in the U.S. increased from 163,651 to 165,148.

The California Area Indian Health Service (IHS) has reported that 550 California Tribal or Urban Indian Health Program patients have tested positive for COVID-19 as of 8/11/2020.

The Indian Health Service (IHS) is hosting a webinar about childhood and adult immunizations during the COVID-19 pandemic. Childhood and adult vaccinations have been impacted as clinics focus efforts on COVID-19. As everyone prepares for the upcoming school year and quickly approaching flu season, CAPT Thomas Weiser, MD, MPH, along with other presenters will discuss the IHS flu data as well as strategies for ensuring that Native communities are protected against vaccine-preventable diseases. With funding from the Indian Health Service, the National Indian Health Board (NIHB) is offering a funding opportunity for Tribes and Tribal Organizations seeking to strengthen school preparation and readiness for safe operations during the COVID pandemic. This funding is intended to fulfill immediate Tribal school readiness needs. NIHB will provide mini-grants to a maximum of 15 Tribes or Tribal organizations in amounts up to \$2,000 each. The completed application is due by 11:59 PM EDT on Friday, August 28, 2020. The project period will run from approximately September 1 through October 31, 2020. NIHB will offer an optional pre-application webinar on Tuesday, August 18, 2020 at 3:30 PM Eastern Time. Register for the webinar here. 

The position statement included a case definition and made COVID-19 a nationally notifiable disease.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.






State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

CALIFORNIA

As of August 12, 2020, there were a total of 593,141 positive cases and 10,808 deaths in California.

• Unknown/Missing: 838 cases

Lab tests reported statewide: 9,445,493

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.

8,298 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 8/11/2020.


Of these, 550 patients have tested positive for COVID-19 and 7,154 have tested negative for COVID-19.





New Confirmed Cases in California by Date of Lab Confirmation






RACIAL DISTRIBUTION OF CONFIRMED COVID-19 CASES AND DEATHS IN CALIFORNIA

American Indians and Alaska Natives account for 0.5% percent of the population, 0.2% of COVID-19 cases, and 0.4% of deaths in California. These include 913 cases and 41 deaths among American Indian and Alaska Native people in California.






- 1.0% of confirmed cases have been admitted to a hospital

- 1.8% of cases have died

Case and death disparities:


- For all adults ages 18+, Latinos and African Americans are dying at disproportionately high rates. The proportion of COVID-19 deaths in Latinos is more than 1.5 times their population representation across all adult age categories.
- More males (57%) are dying from COVID-19 than females (43%).

American Indian and Alaska Native (AIAN) data reported by California to the Centers for Disease Control and Prevention (CDC)



CDC Data show that AIAN in California are testing positive for COVID-19 at rates just below their proportion of California's population and dying at slightly higher than expected rates. This includes a total of 1,559 cases and 49 deaths.




COVID-19 Testing Information from Patients Seen at a Tribal or Urban Indian Health Program in California.




