



# CORONAVIRUS DISEASE 2019 (COVID-19) SITUATIONAL REPORT #140 SEPTEMBER 30, 2020



## DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 33.50 million with more than 1 million deaths.

The total number of cases in the U.S. increased from 7,129,313 as reported on Tuesday 9/29/2020 to 7,168,017 reported today. The number of deaths in the U.S. increased from 204,598 to 205,372.

On the CRIHB hosted statewide COVID-19 Call, the California Department of Public Health (CDPH) will be discussing plans for vaccine distribution for AIAN communities. CDC has released the interim “playbook” for vaccine distribution. CDPH’s vaccine allocation plan is due to CDC by October 16, 2020. This would be an opportunity to provide feedback and input to CDPH. With more than a million deaths worldwide, the COVID-19 death toll has surpassed the 1968 H3N2 flu pandemic’s death toll, making it one of the top 10 deadliest pandemics of all time.

On Thursday, September 24, U.S. Department of Health and Human Services (HHS) Deputy Secretary Hargan sent a Dear Tribal Leader Letter (DTLL) announcing the initiation of Tribal Consultation to seek input from Tribal Leaders on COVID-19 vaccination planning for Indian Country. This Tribal Consultation complements the state planning process that began last week with the publication of the CDC’s COVID-19 Vaccination Program Interim Playbook for Jurisdiction Operations. Tribal Leaders will have several forums to discuss vaccination planning for distribution and allocation. ### COVID-19: U.S. at a Glance\*

\*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020. The position statement included a case definition and made COVID-19 a nationally notifiable disease.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

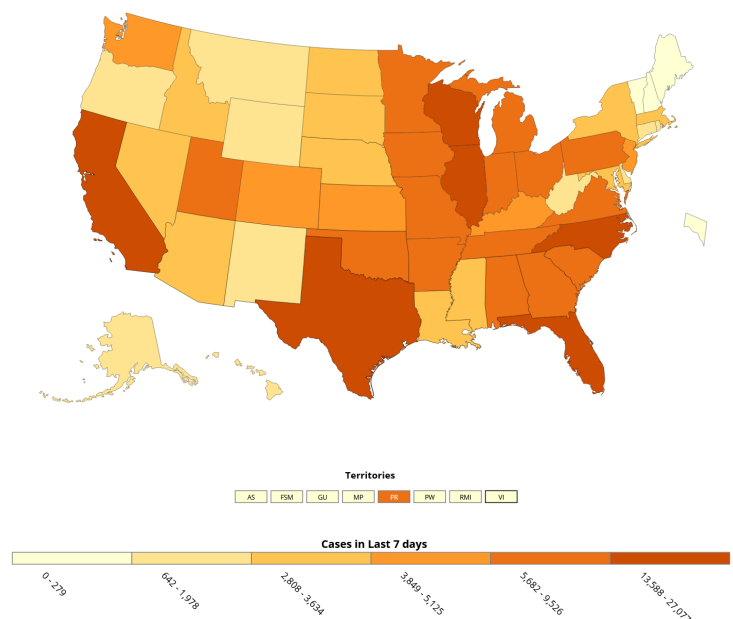
- i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.

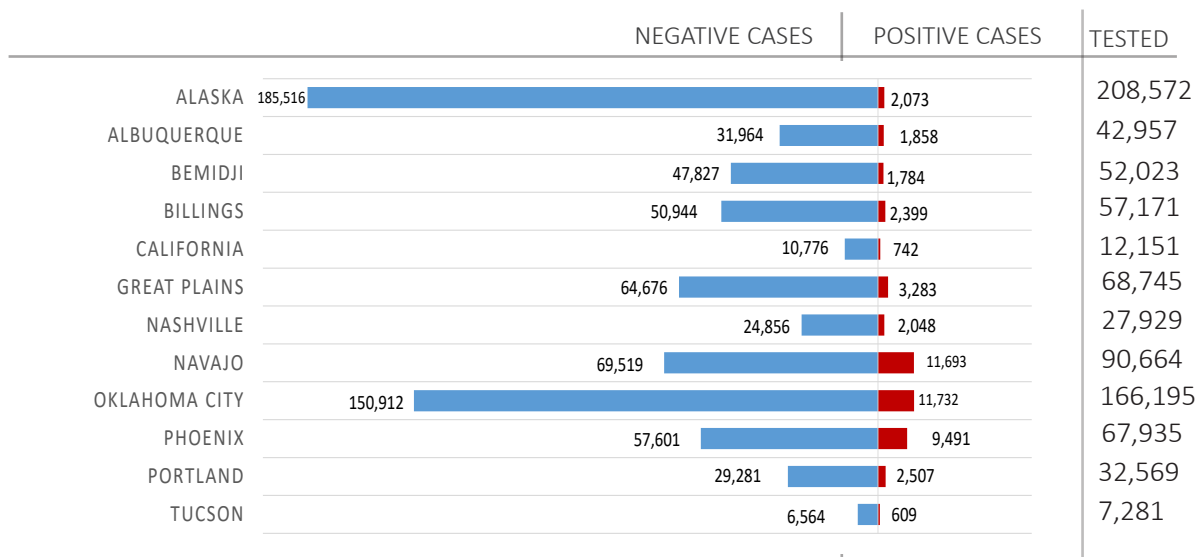
State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

## CALIFORNIA

As of September 29, 2020, there were a total of 810,625 positive cases and 15,792 deaths in California.

Ages of all confirmed positive cases:

- Age 0-17: 84,064 cases
- Age 18-49: 485,990 cases
- Age 50-64: 153,030 cases
- Age 65 and older: 86,652 cases
- Unknown/Missing: 889 cases

Gender of all confirmed positive cases:

- Female: 408,908 cases
- Male: 395,012 cases
- Unknown: 6,705 cases

Lab tests reported statewide: 14,705,202

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health’s Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.

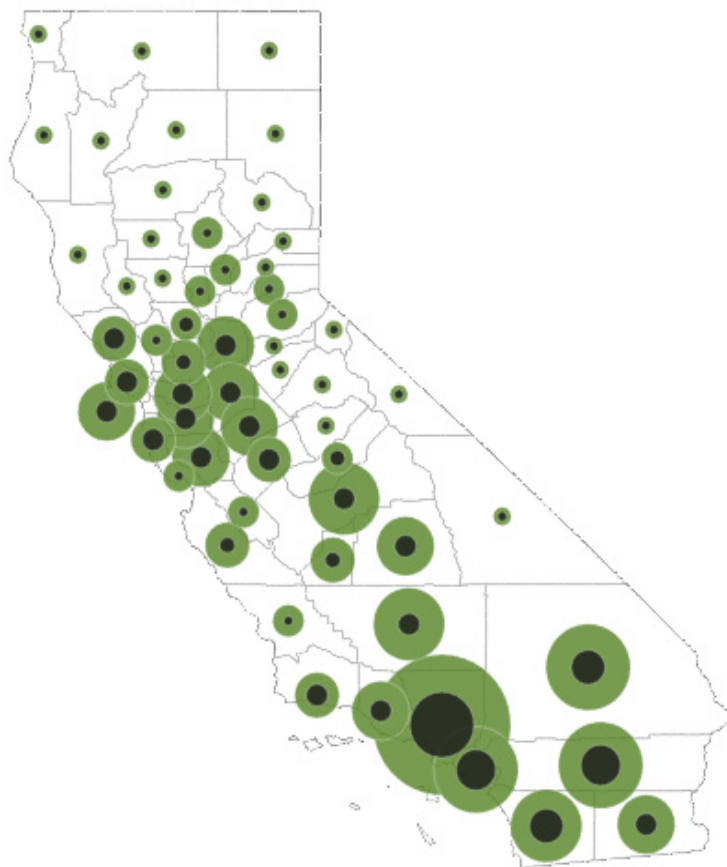

## INDIAN HEALTH SERVICE CALIFORNIA AREA

12,151 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 9/28/2020.

Of these, 742 patients have tested positive for COVID-19 and 10,776 have tested negative for COVID-19.

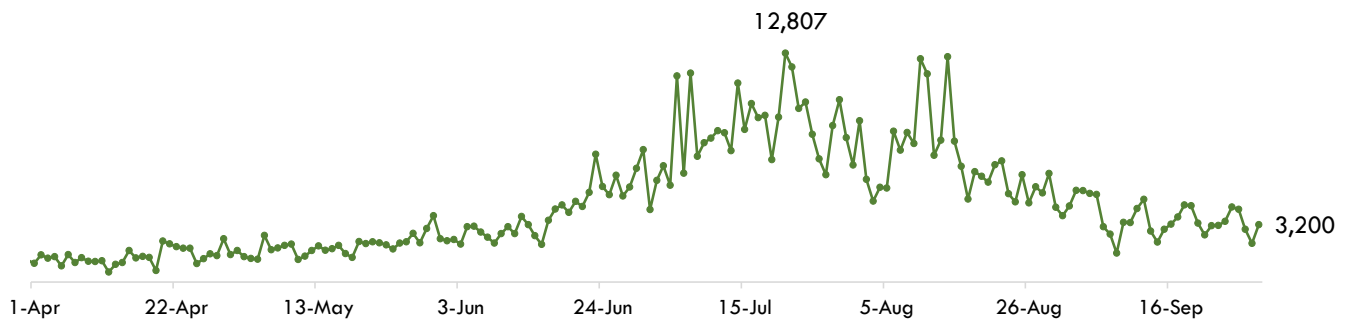

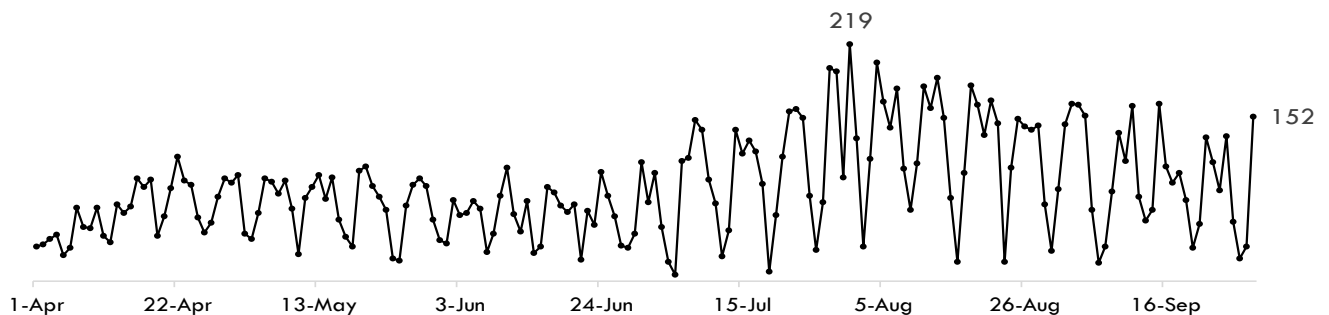

### New Confirmed Cases in California by Date



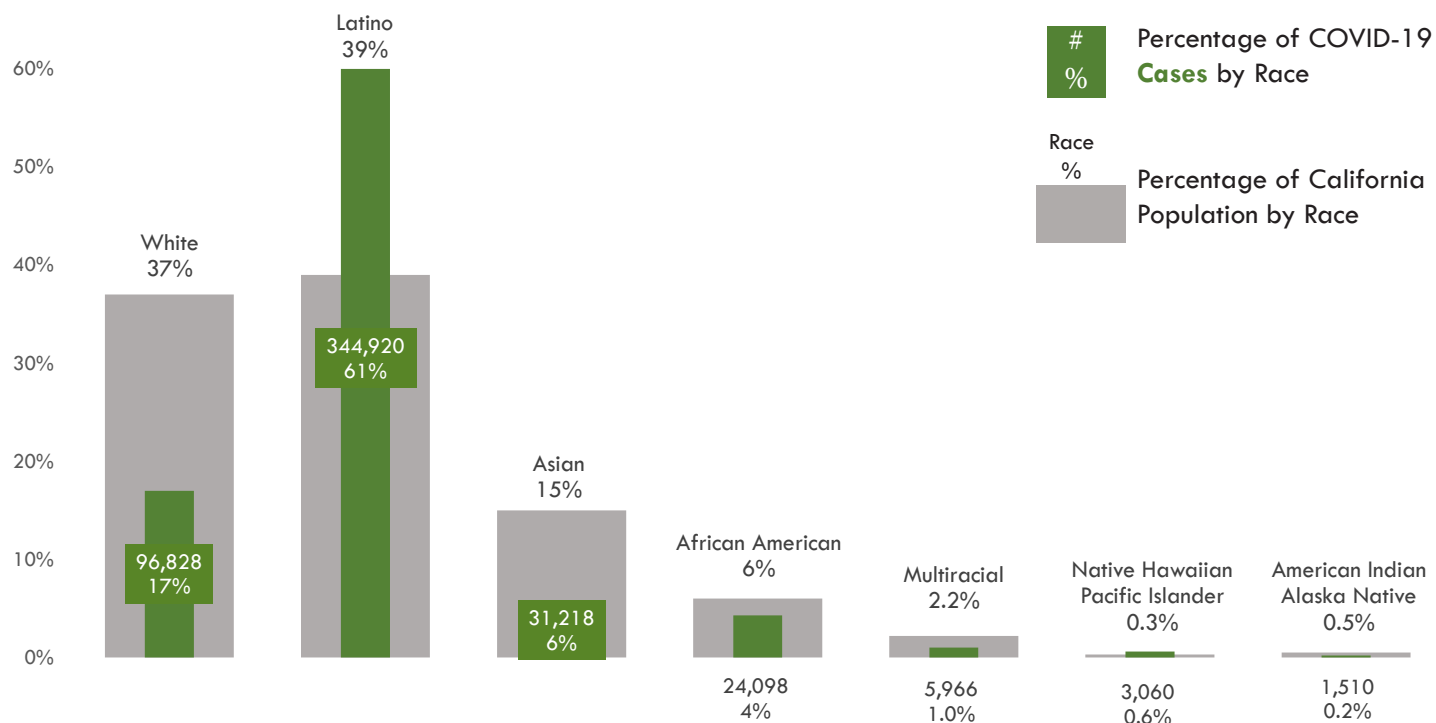
### New Confirmed Deaths in California by Date



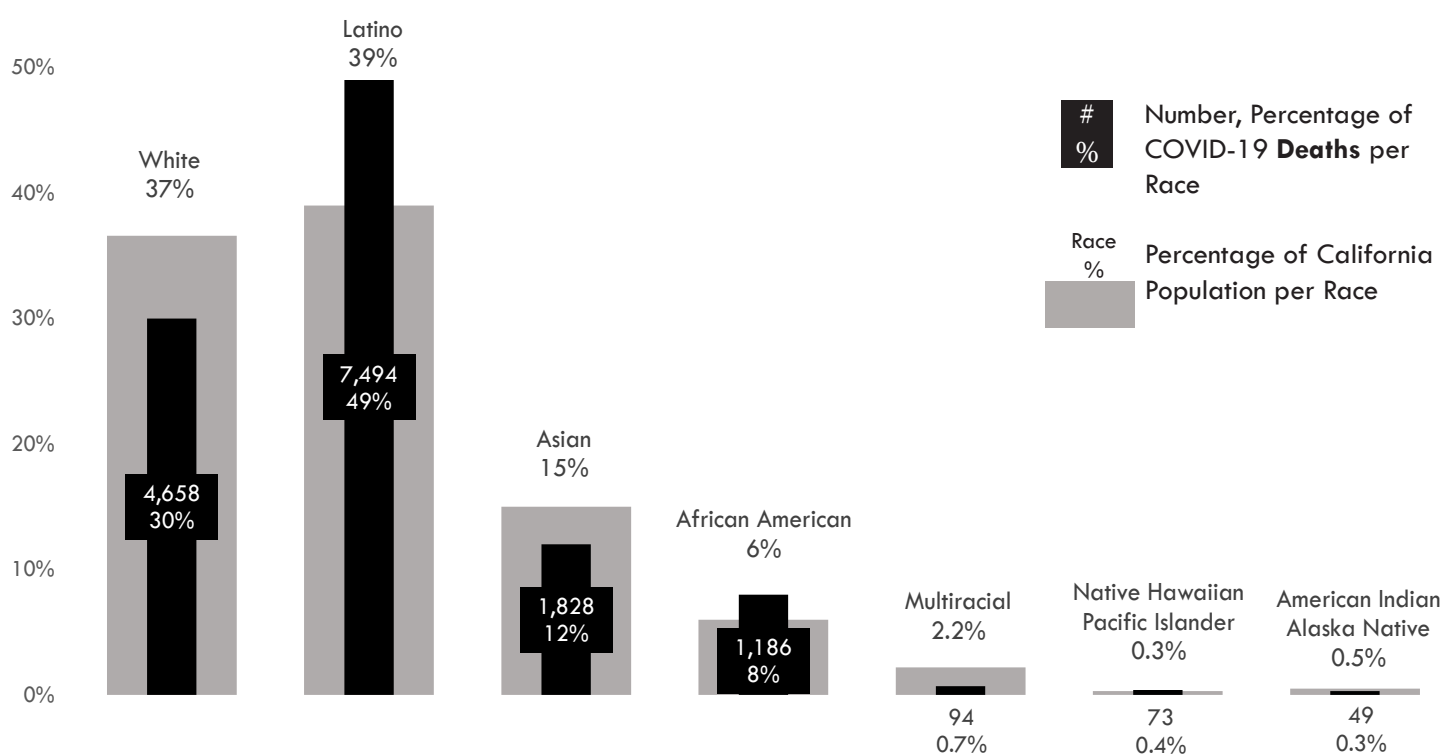

## Racial distribution of confirmed COVID-19 cases and deaths in California

American Indians and Alaska Natives account for 0.5% percent of the population, **0.2% of COVID-19 cases**, and **0.3% of deaths** in California. This includes a total of **1,510 cases** and **49 deaths** among American Indian and Alaska Native people in California.



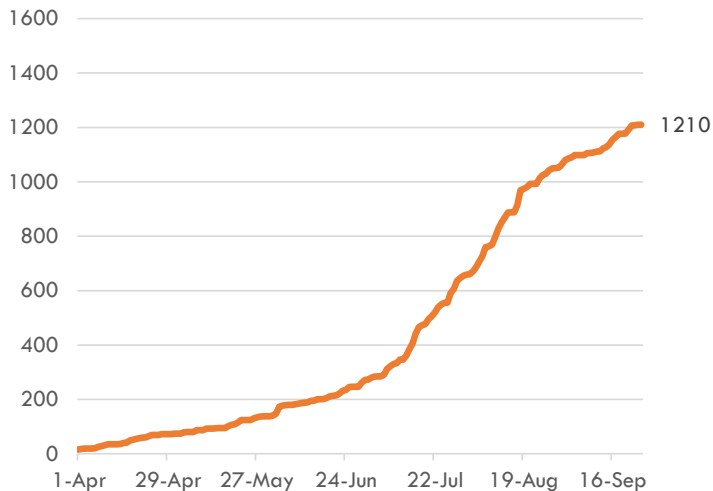
Latinos and African Americans are dying at disproportionately high rates in California. The proportion of COVID-19 deaths in Latinos is 1.3 times their population representation across all adult age categories.



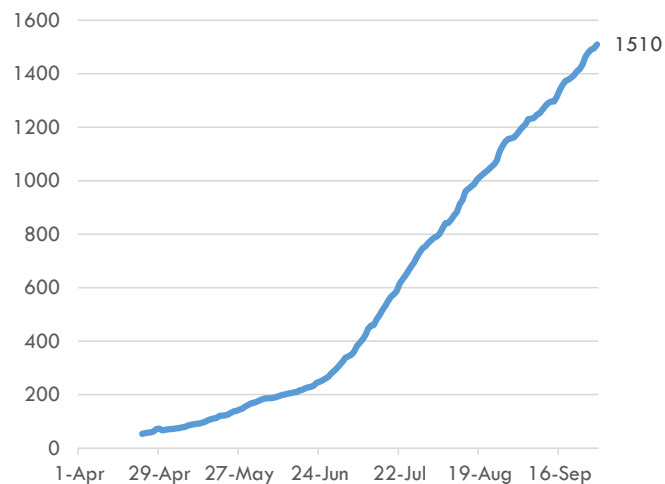

Data from the **Indian Health Service (IHS)** include positive cases reported by Tribal and Urban Indian Health Programs.

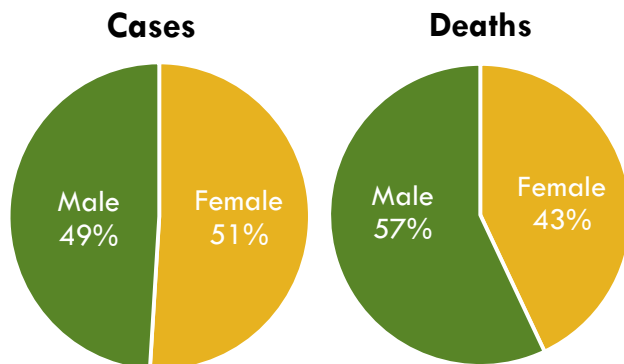
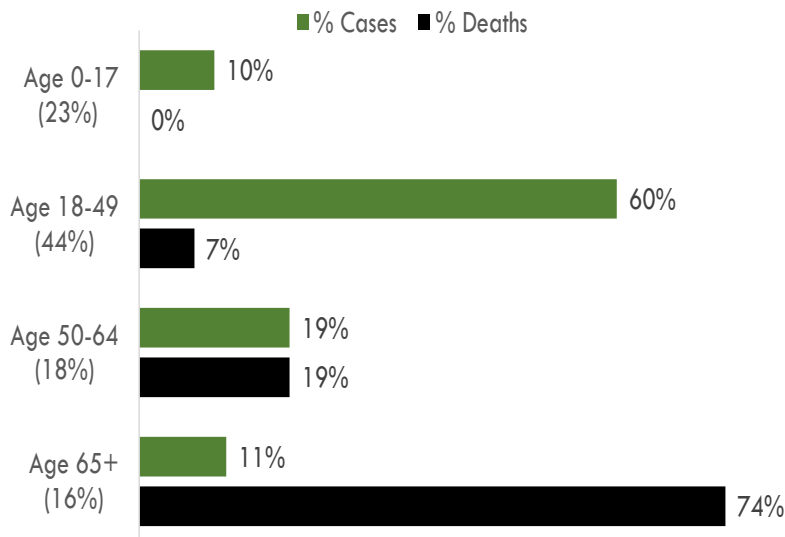

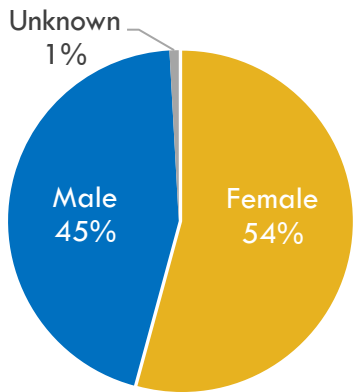
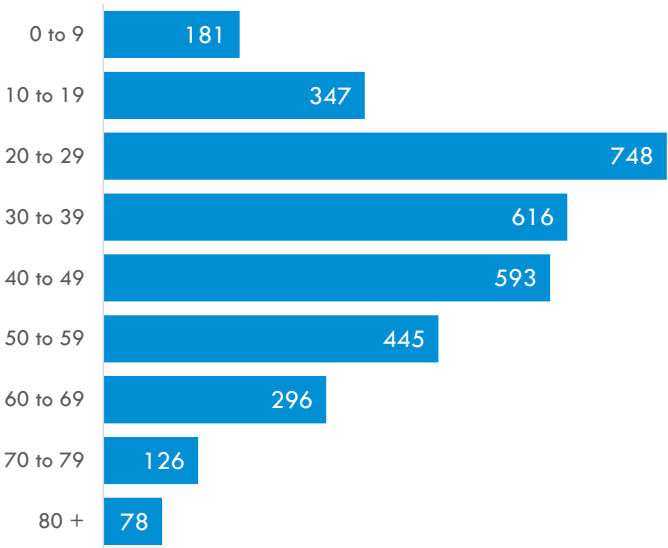

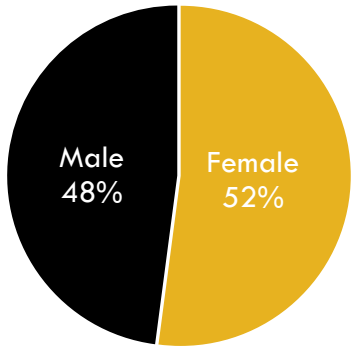
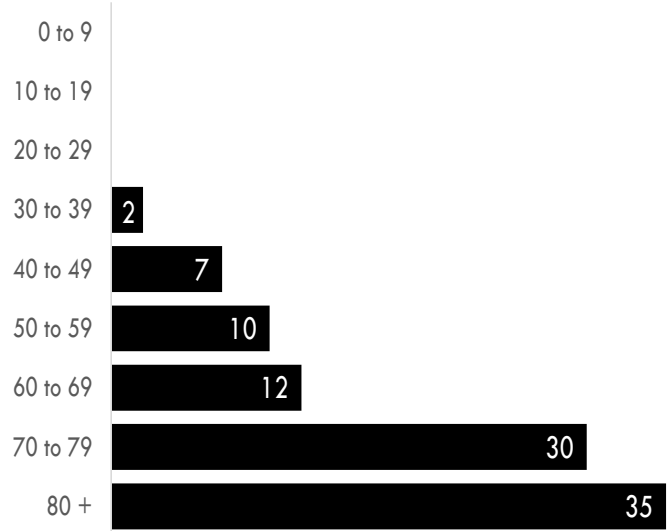

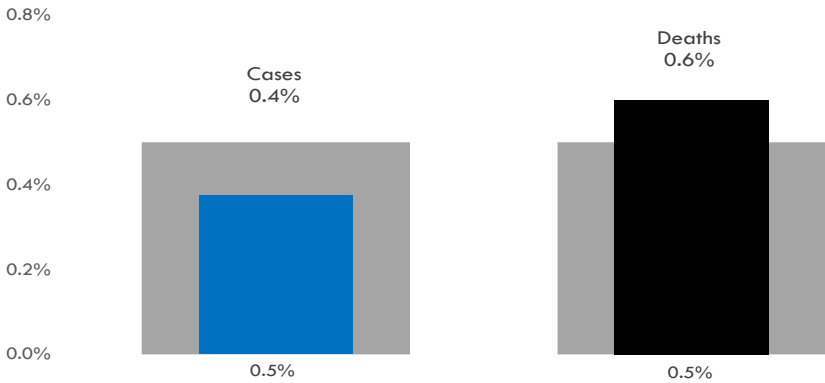
Positive COVID-19 cases among AIAN people in California by Age Group and Gender

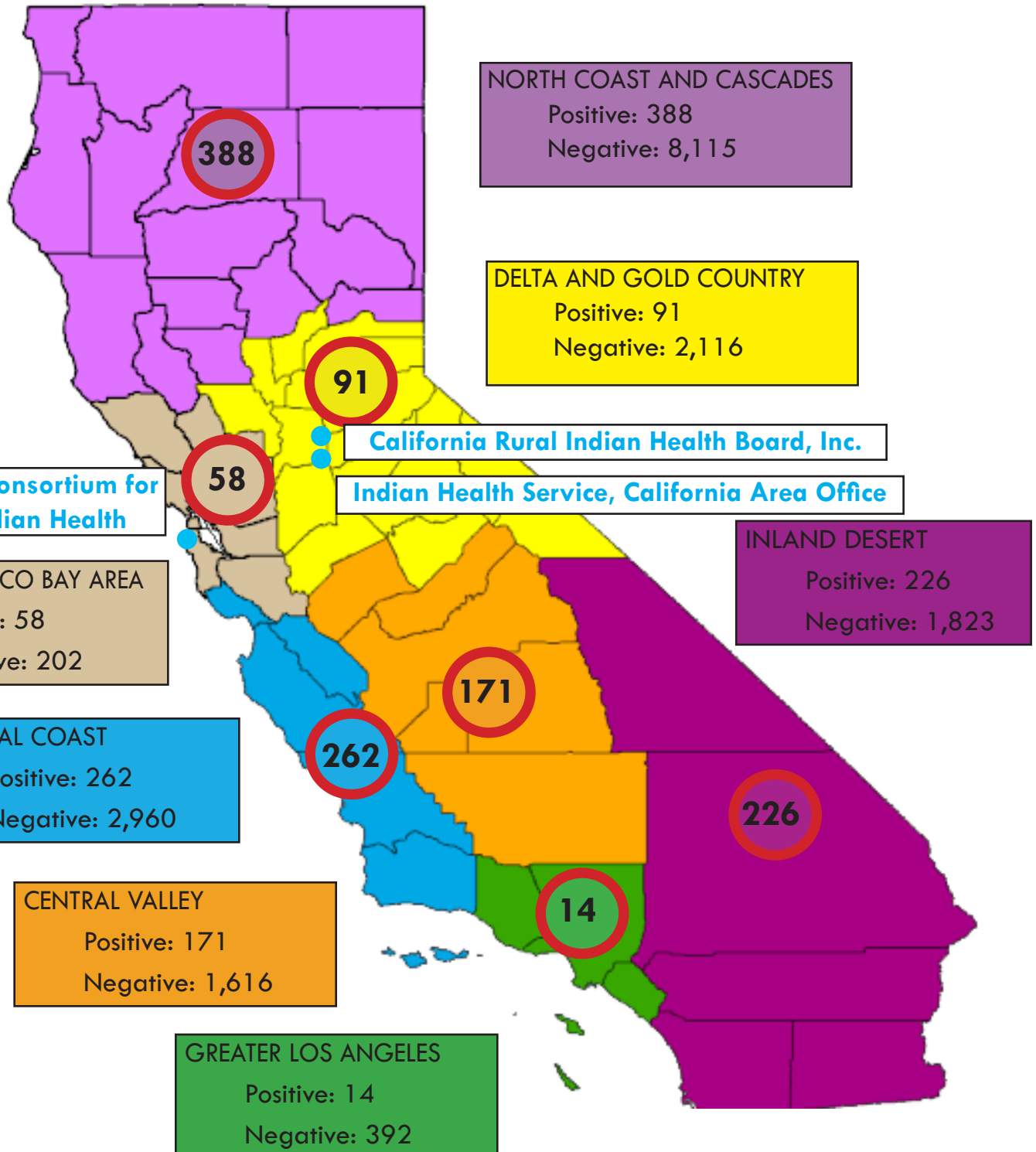

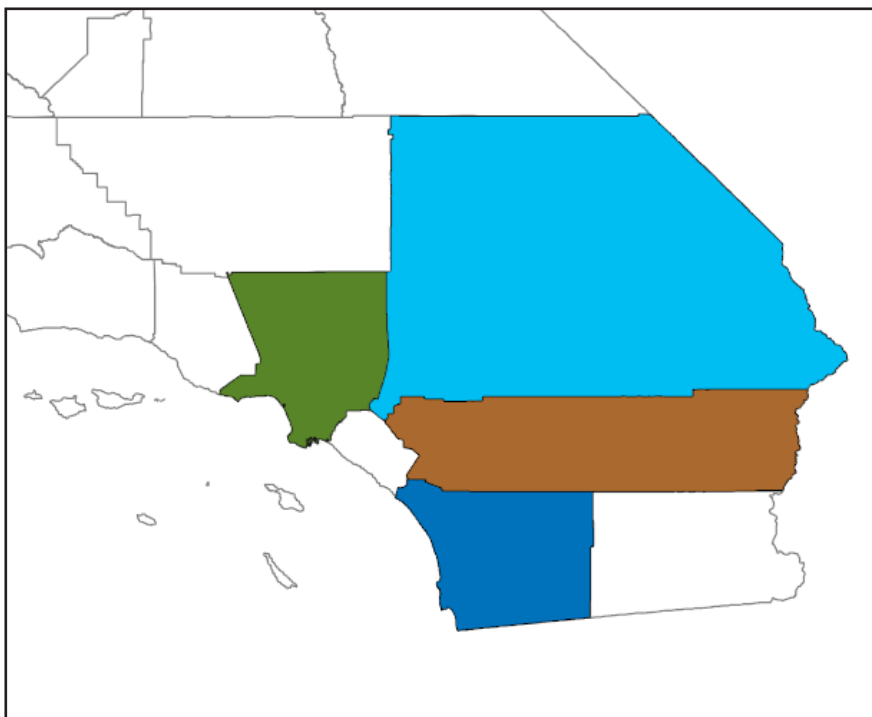

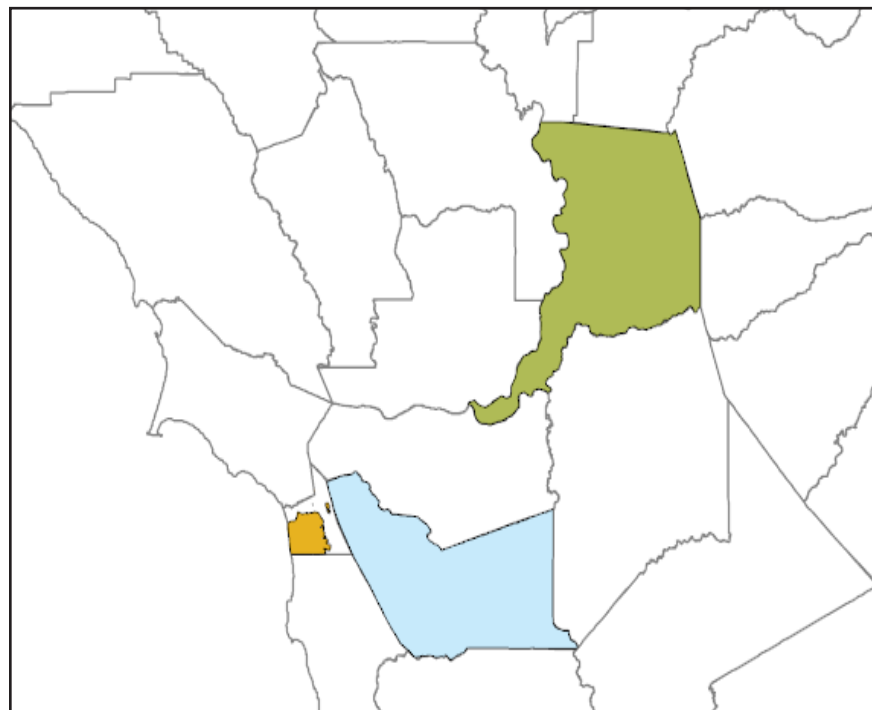
