DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 34.16 million with more than 1.01 million deaths.

The total number of cases in the U.S. increased from 7,213,419 as reported on Thursday 10/1/2020 to 7,260,465 reported today. The number of deaths in the U.S. increased from 206,402 to 207,302.

According to the New York Times, CNN, and other credible news sources, President Trump revealed early Friday morning that he and the first lady, Melania Trump, had tested positive for the coronavirus. To read the full news article, click HERE.

With more than a million deaths worldwide, the COVID-19 death toll has surpassed the 1968 H3N2 flu pandemic's death toll, making it one of the top 10 deadliest pandemics of all time.

*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020. The position statement included a case definition and made COVID-19 a nationally notifiable disease

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID19. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.



CALIFORNIA

As of October 1, 2020, there were a total of 817,277 positive cases and 15,986 deaths in California.

Ages of all confirmed positive cases:

• Age 0-17: 84,871 cases

• Age 18-49: 489,846 cases

• Age 50-64: 154,299 cases

• Age 65 and older: 87,371 cases

• Unknown/Missing: 890 cases

Gender of all confirmed positive cases:

• Female: 412,239 cases

• Male: 398,313 cases

• Unknown: 6,725 cases

Lab tests reported statewide: 14,868,431

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.

INDIAN HEALTH SERVICE CALIFORNIA AREA

Of these, 744 patients have tested positive for COVID-19 and 10,872 have tested negative for COVID-19.





New Confirmed Deaths in California by Date



















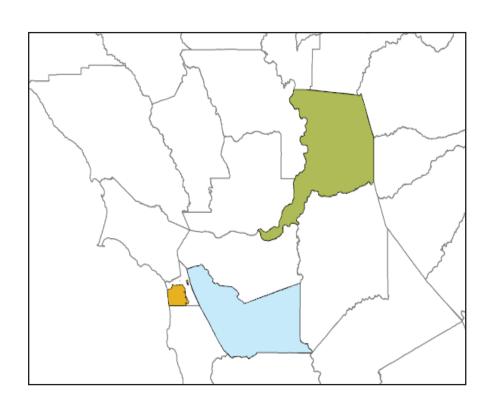


