DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 37.42 million with more than 1.07 million deaths.

The total number of cases in the U.S. increased from 7,583,200 as reported on Friday 10/9/2020 to 7,740,934 reported today. The number of deaths in the U.S. increased from 212,111 to 214,108.

Older adults and adults with chronic conditions, including many people dually eligible for Medicare and Medicaid, face increased risk of adverse outcomes related to the flu. Dually eligible individuals are also at greater risk for severe outcomes due to COVID-19. Flu vaccination uptake may reduce health care system burden during the COVID-19 pandemic. In this panel discussion, health plans will share promising practices for promoting flu vaccinations. Panelists will also discuss how they are adapting these strategies during COVID-19. *As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020. The position statement included a case definition and made COVID-19 a nationally notifiable disease

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID19. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.



As of October 11, 2020, there were a total of 850,028 positive cases and 16,572 deaths in California.

• Unknown/Missing: 882 cases

Gender of all confirmed positive cases:

Lab tests reported statewide: 16,191,341

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.


INDIAN HEALTH SERVICE CALIFORNIA AREA





New Confirmed Cases in California by Date




New Confirmed Deaths in California by Date





American Indians and Alaska Natives account for 0.5% percent of the population, 0.3% of COVID-19 cases, and 0.3% of deaths in California. This includes a total of 1,661 cases and 51 deaths among American Indian and Alaska Native people in California.














