DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 38.78 million with more than 1.09 million deaths.

The total number of cases in the U.S. increased from 7,894,768 as reported on Thursday 10/15/2020 to 7,958,254 reported today. The number of deaths in the U.S. increased from 216,025 to 216,917.

As many people in the United States begin to plan for fall and winter holiday celebrations, CDC offers the following considerations to help protect individuals and their families, friends, and communities from COVID-19. These considerations are meant to supplement—not replace—any state, local, territorial, or tribal health and safety laws, rules, and regulations with which holiday gatherings must comply. When planning to host a holiday celebration, you should assess current COVID-19 levels in your community to determine whether to postpone, cancel, or limit the number of attendees. 

*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020. The position statement included a case definition and made COVID-19 a nationally notifiable disease.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID19. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.





CALIFORNIA

As of October 15, 2020, there were a total of 861,476 positive cases and 16,830 deaths in California.

Ages of all confirmed positive cases:

• Age 65 and older: 91,697 cases

• Unknown/Missing: 891 cases

Gender of all confirmed positive cases:

• Female: 434,912 cases

• Unknown: 6,909 cases

Lab tests reported statewide: 16,621,956

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.







New Confirmed Cases in California by Date




New Confirmed Deaths in California by Date





American Indians and Alaska Natives account for 0.5% percent of the population, 0.3% of COVID-19 cases, and 0.3% of deaths in California. This includes a total of 1,707 cases and 52 deaths among American Indian and Alaska Native people in California.














