

DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 40.2 million with more than 1.1 million deaths.

In the United States, the total number of cases stands at 8,065,615 and deaths at 218,131.

As many people in the United States begin to plan for fall and winter holiday celebrations, CDC offers the following considerations to help protect individuals and their families, friends, and communities from COVID-19. These considerations are meant to supplement—not replace—any state, local, territorial, or tribal health and safety laws, rules, and regulations with which holiday gatherings must comply. When planning to host a holiday celebration, you should assess current COVID-19 levels in your community to determine whether to postpone, cancel, or limit the number of attendees. Various news outlets are reporting that coronavirus cases have risen to their highest level since late July. The U.S. is now climbing steadily toward a new peak in cases that may soon rival the summer surge with new cases having gone up by 30% from two weeks ago. In September, the United States Department of Health and Human Services initiated Tribal consultation to seek input from Tribal leaders on COVID-19 vaccine planning for Indian Country. COVID-19: U.S. at a Glance*

- Total cases: 8,065,615

*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020.

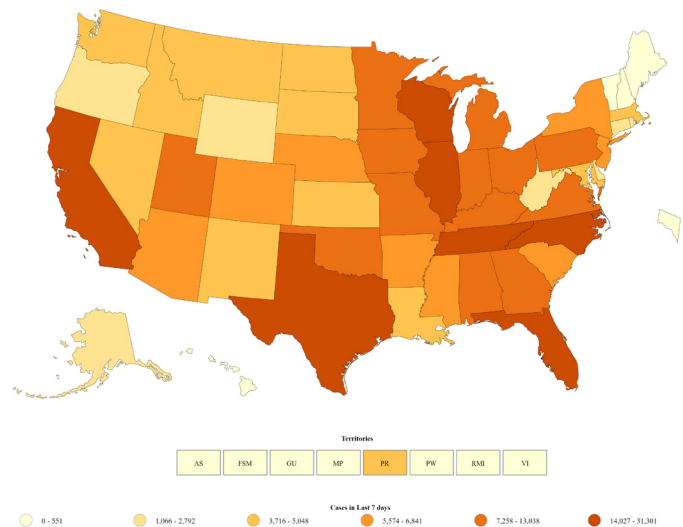
A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

- meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or
 - meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or
 - meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.
- State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

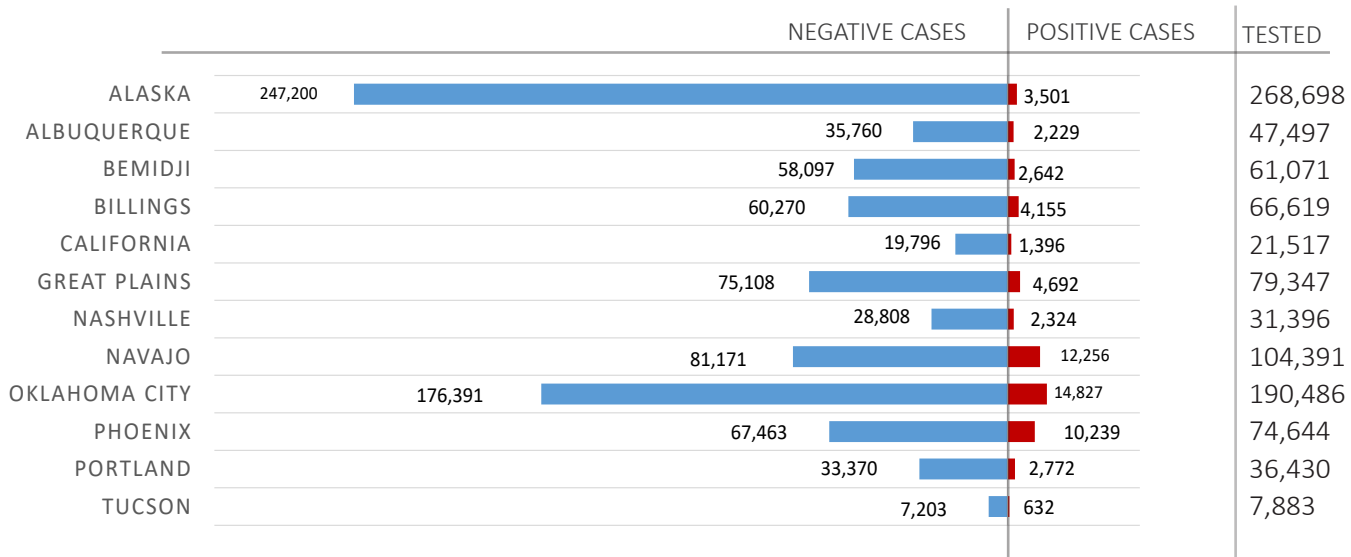

CALIFORNIA

As of October 19, 2020, there were a total of 874,077 positive cases and 16,992 deaths in California.

Ages of all confirmed positive cases:

- Age 0-17: 92,375 cases
- Age 18-49: 523,072 cases
- Age 50-64: 164,817 cases
- Age 65 and older: 92,952 cases
- Unknown/Missing: 861 cases

Gender of all confirmed positive cases:

- Female: 441,502 cases
- Male: 425,648 cases
- Unknown: 6,927 cases

Lab tests reported statewide: 17,189,070

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.

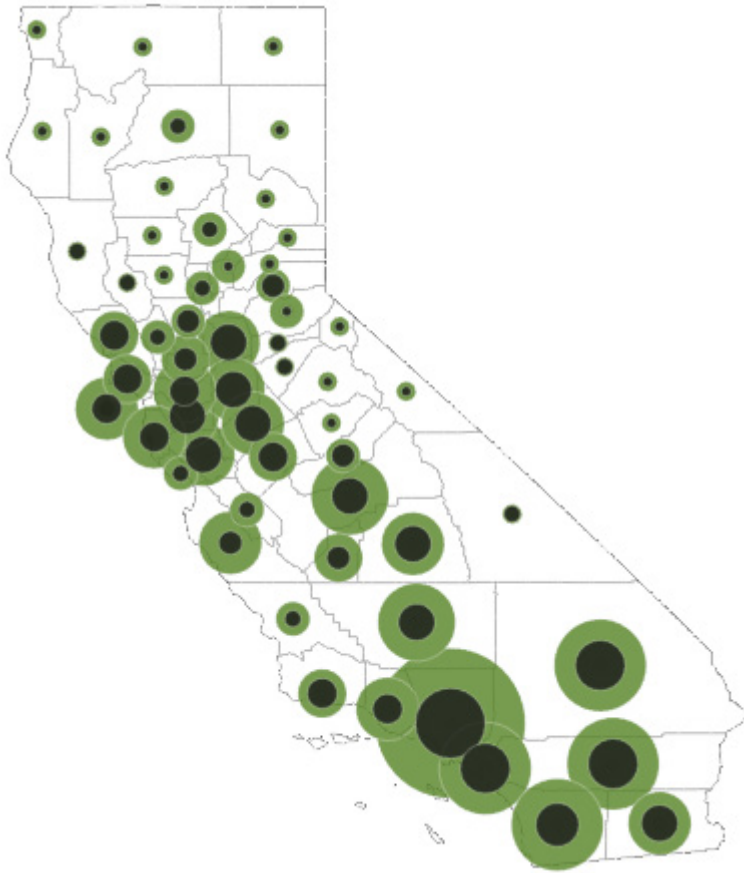

Of these, 1,396 patients have tested positive for COVID-19 and 19,796 have tested negative for COVID-19.

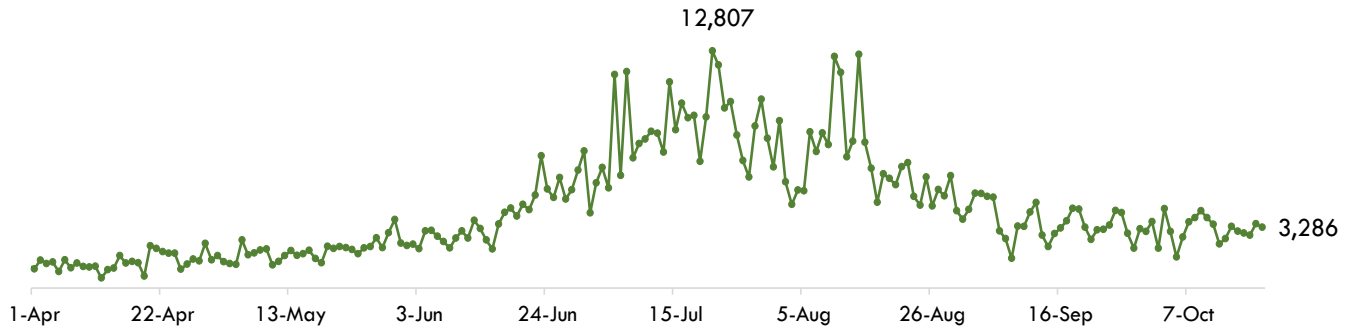

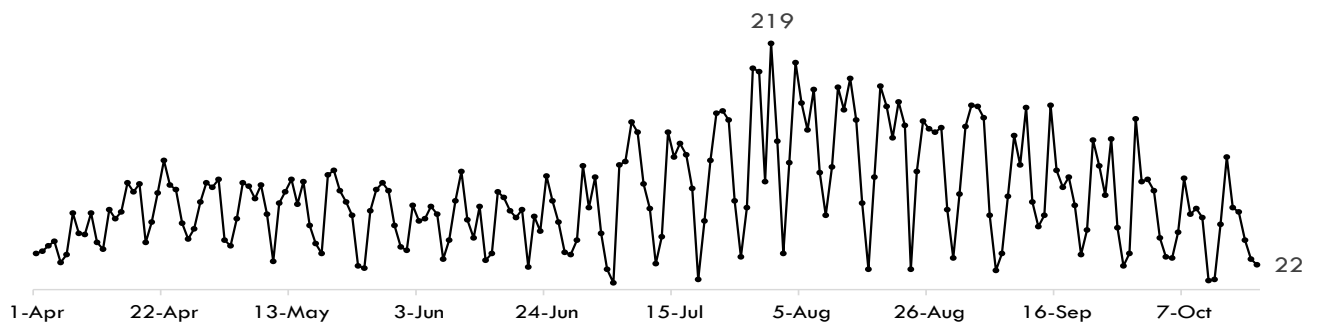

New Confirmed Cases in California by Date



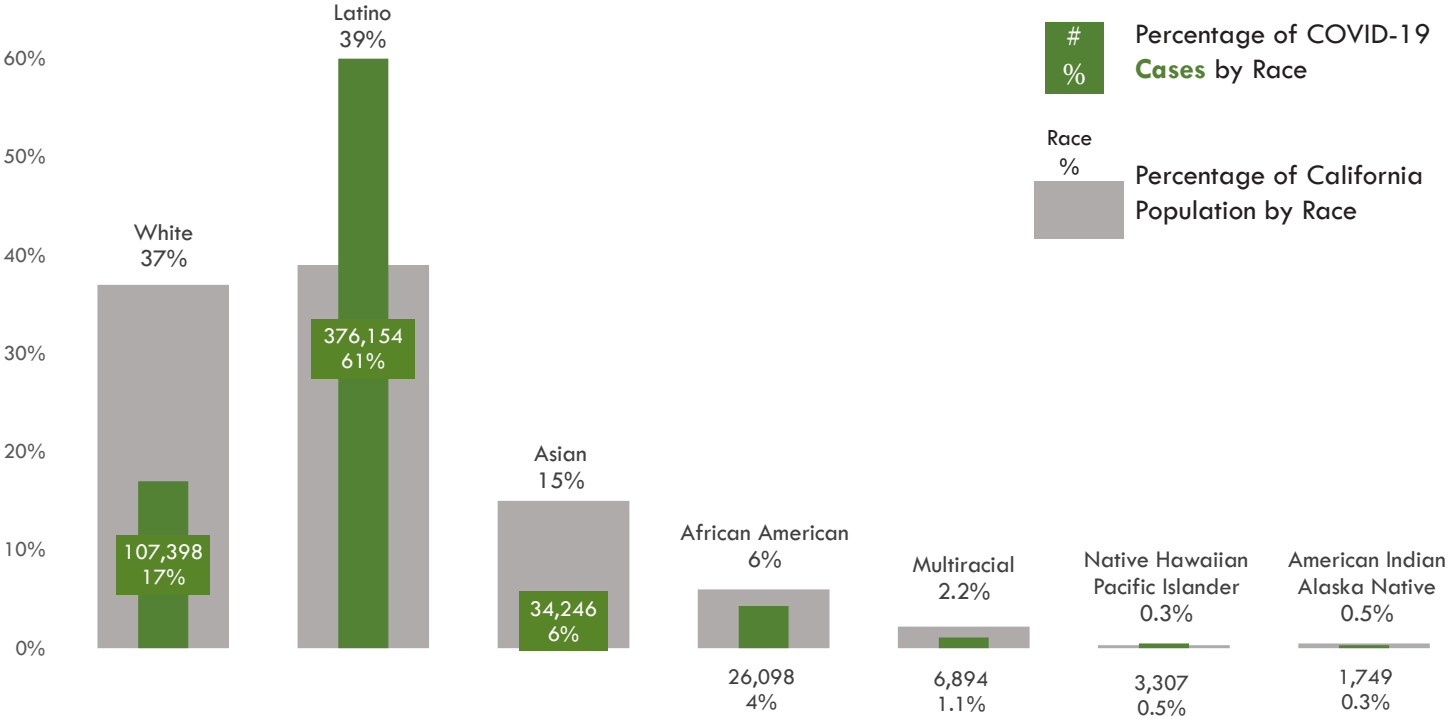
New Confirmed Deaths in California by Date



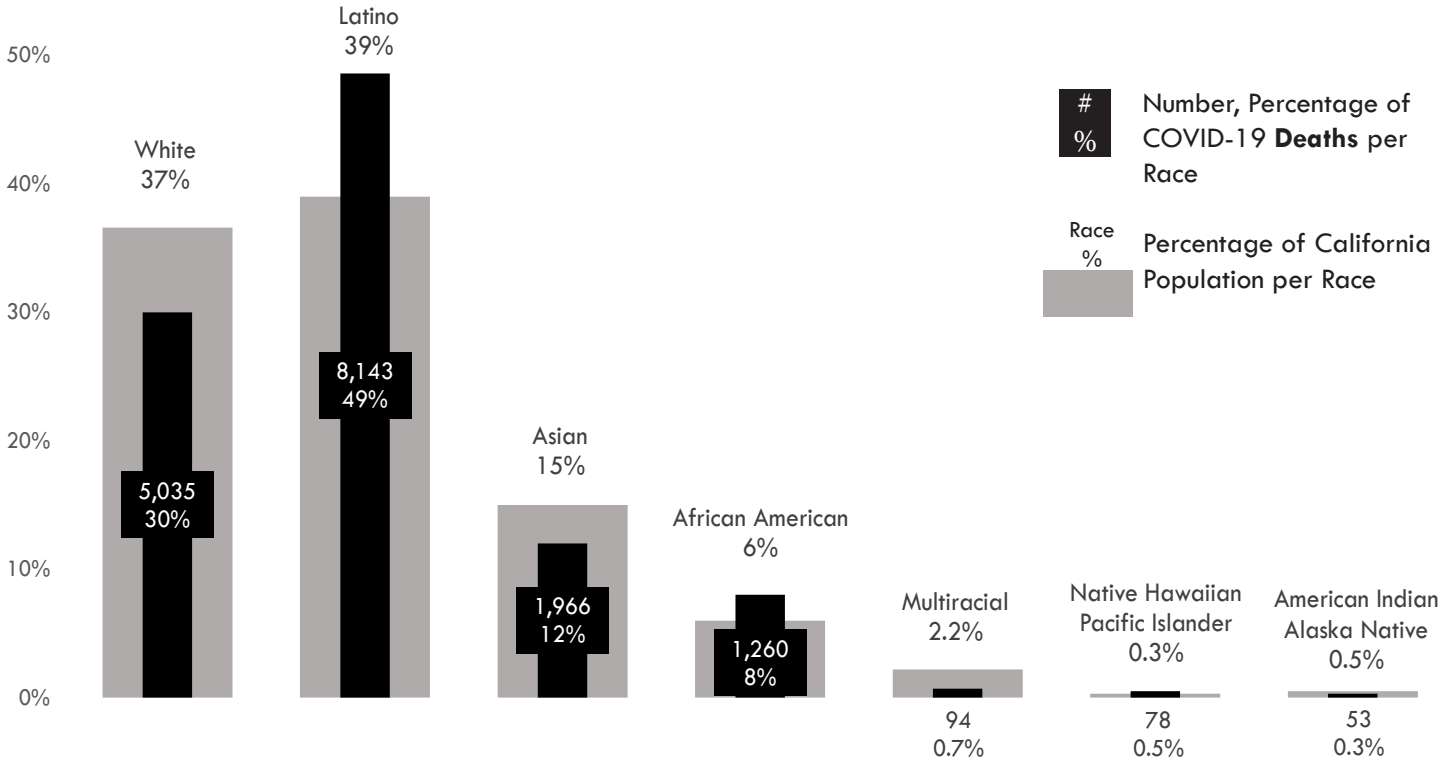

Racial distribution of confirmed COVID-19 cases and deaths in California

American Indians and Alaska Natives account for 0.5% percent of the population, **0.3% of COVID-19 cases**, and **0.3% of deaths** in California. This includes a total of **1,749 cases** and **53 deaths** among American Indian and Alaska Native people in California.



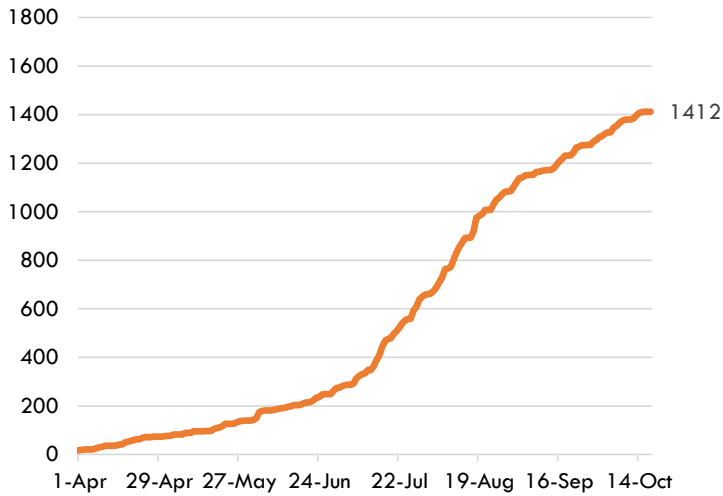
Latinos and African Americans are dying at disproportionately high rates in California. The proportion of COVID-19 deaths in Latinos is 1.3 times their population representation across all adult age categories.

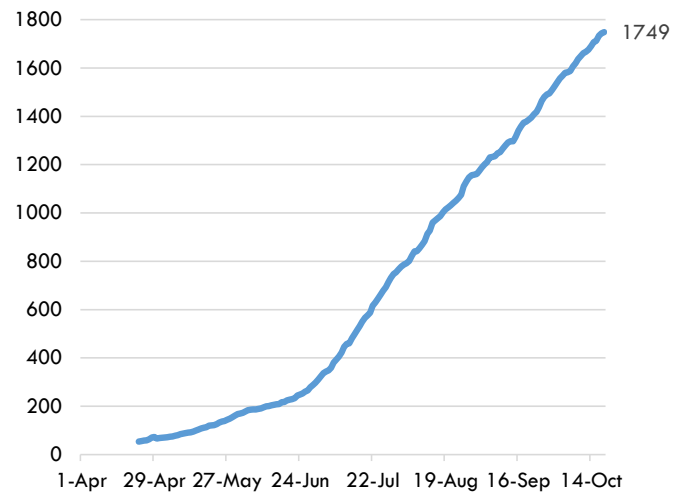

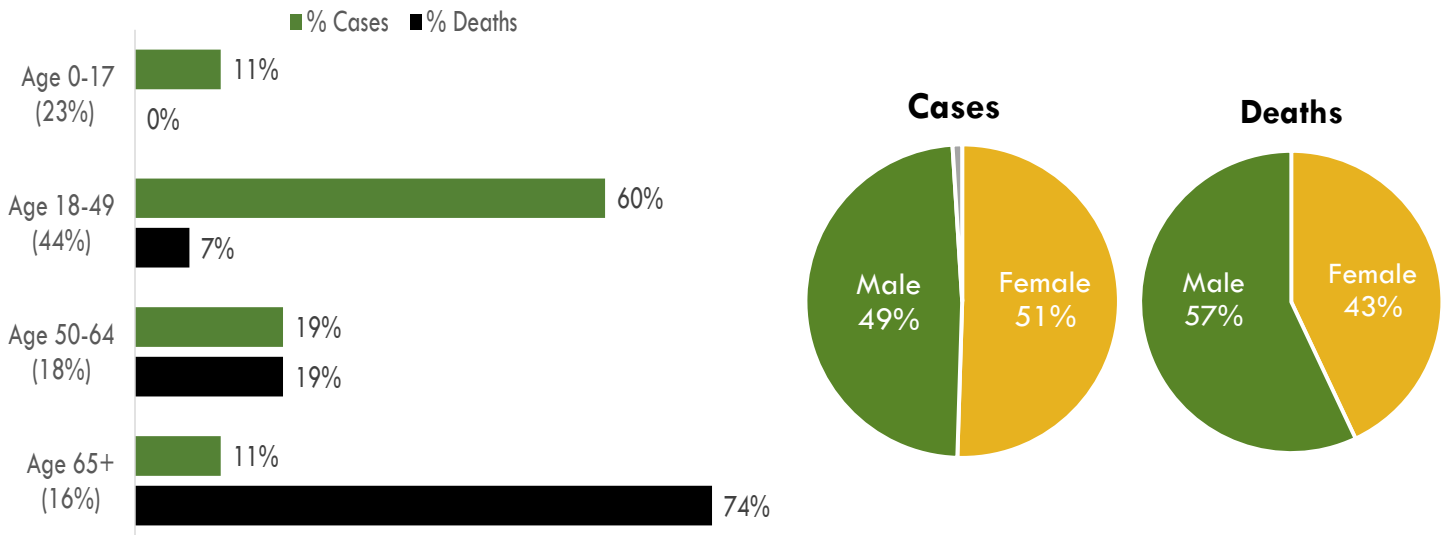

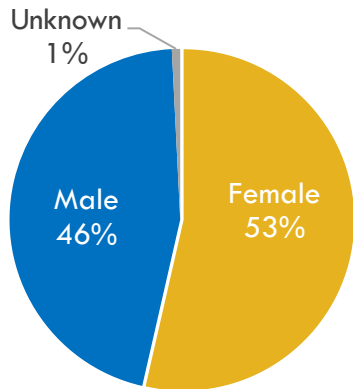
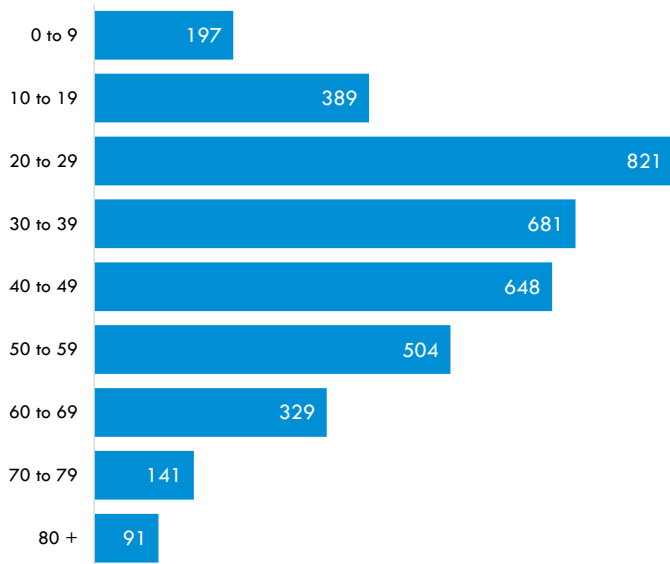

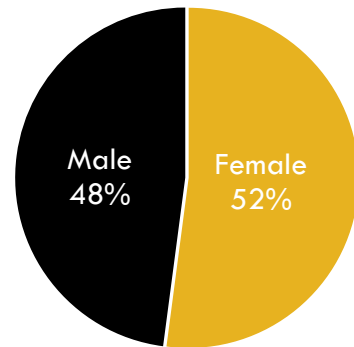
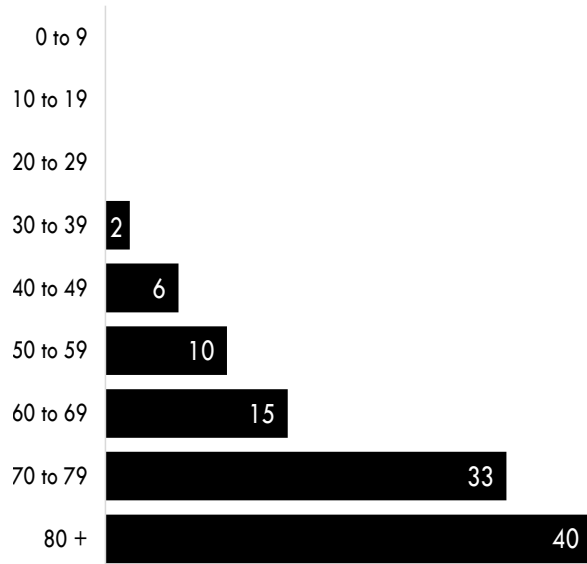

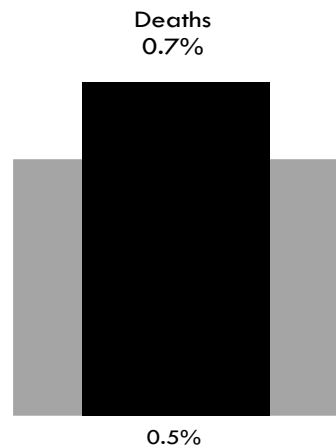
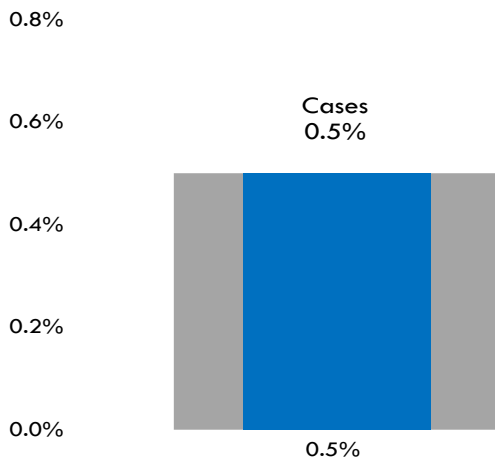
Positive COVID-19 cases among AIAN people in California by Age Group and Gender

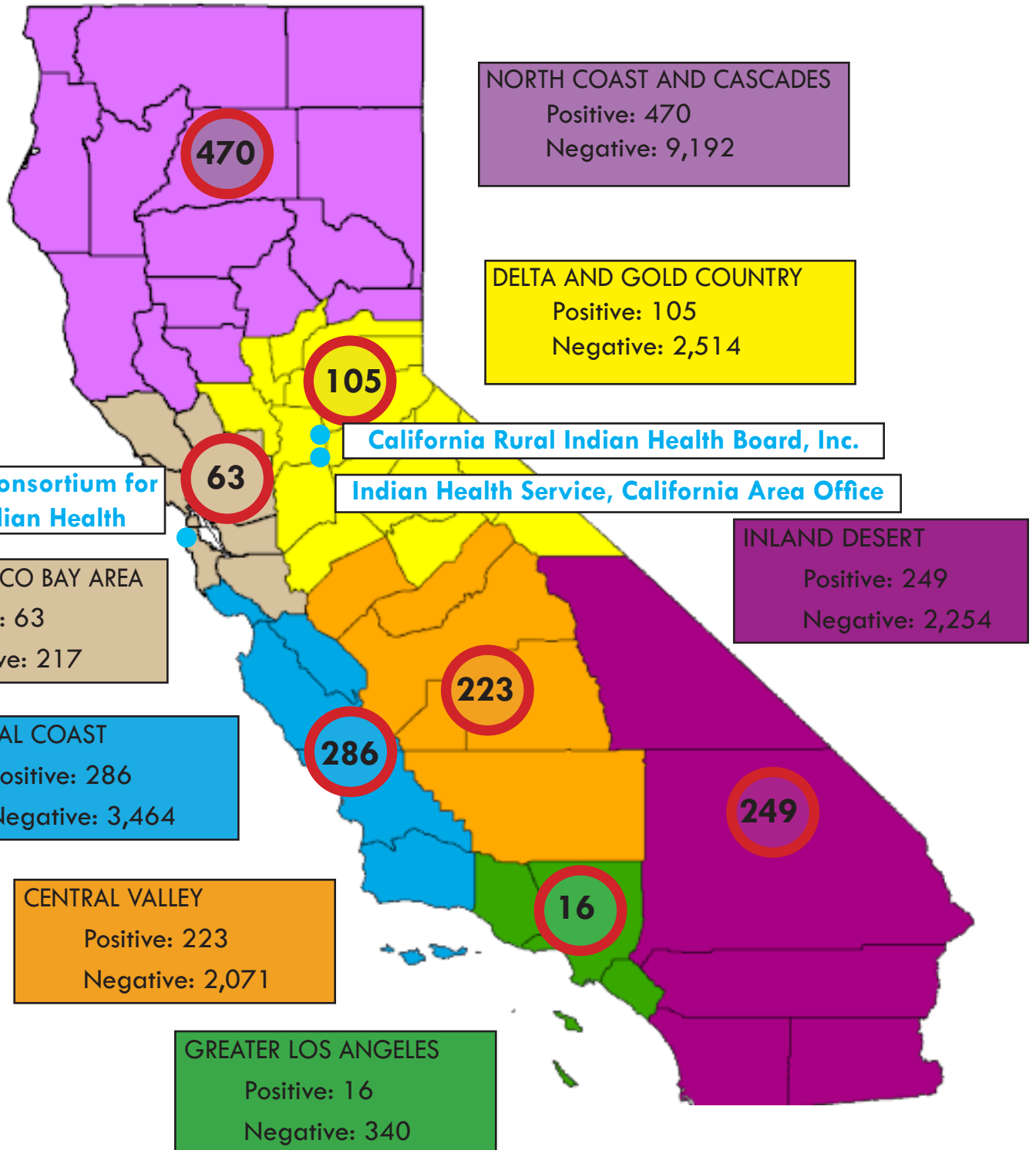

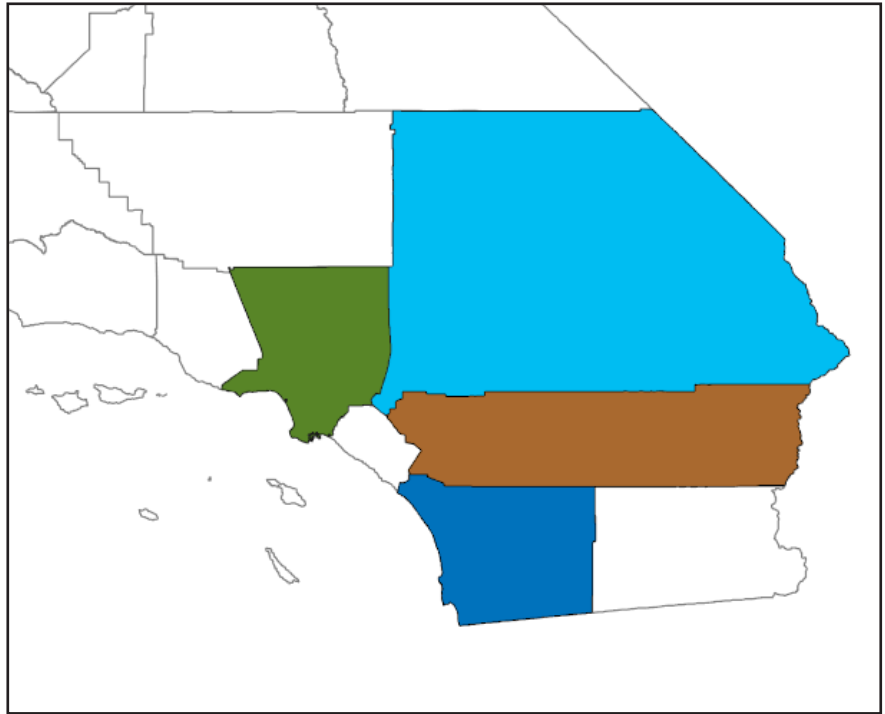

There are 66 tribal casinos in California. As of October 13, 2020, all of these casinos are open and operating.

TRIBAL HEAD START

Beginning in early September 2020, some Tribal early childhood education programs, such as Head Start, will begin reopening either in person, virtually, or in combination of both (i.e. hybrid program). Please check with local school districts, Tribes, or Lead Agencies for start dates.
