## DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 71 million with more than 1.6 million deaths.

In the United States, the total number of cases stands at 16,113,148 and deaths at 298,266.

On December 16 from 3:00-4:00 PM EST, CDC Foundation President and CEO Dr. Judy Monroe and CDC Principal Deputy Director Dr. Anne Schuchat will cover the agency’s current COVID-19 response, including the latest information about vaccines and vaccine distribution plans. California Health Officials announced a Regional Stay at Home Order triggered by ICU capacity. The public health order took effect at 12:59 p.m. on December 5. Under the new order, if a region falls below the 15 percent ICU threshold it will have 24 hours to implement the Stay at Home Order. 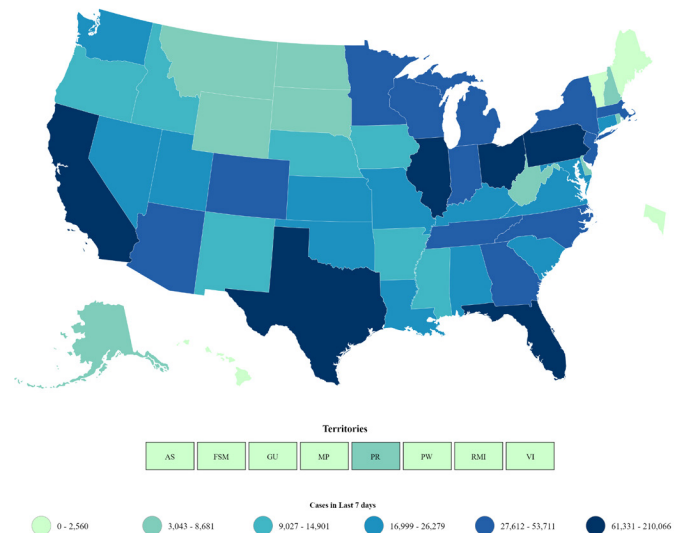
\*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:  
i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

## CALIFORNIA

As of December 13, 2020, there were more than 1.58 million positive cases and a total of 21,046 deaths in California.

Ages of all confirmed positive cases:

- Age 0-17: 184,347 cases
- Age 18-49: 940,264 cases
- Age 50-64: 297,006 cases
- Age 65 and older: 162,211 cases
- Unknown/Missing: 1,149 cases

Gender of all confirmed positive cases:

- Female: 801,788 cases
- Male: 764,445 cases
- Unknown: 18,811 cases

Lab tests reported statewide: 27,552,039

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.

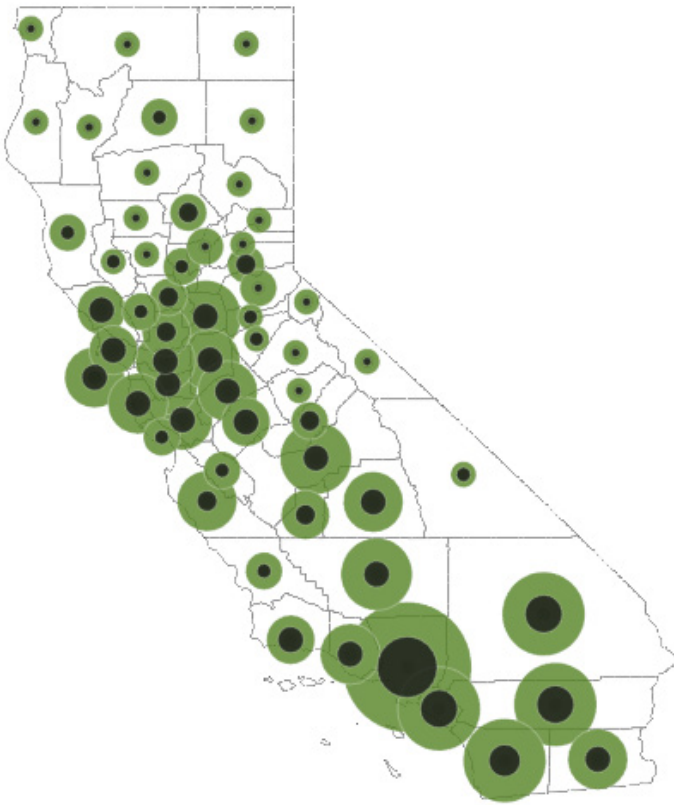

## INDIAN HEALTH SERVICE CALIFORNIA AREA

43,039 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 12/12/2020.

Of these, 3,091 patients have tested positive for COVID-19 and 37,445 have tested negative for COVID-19.

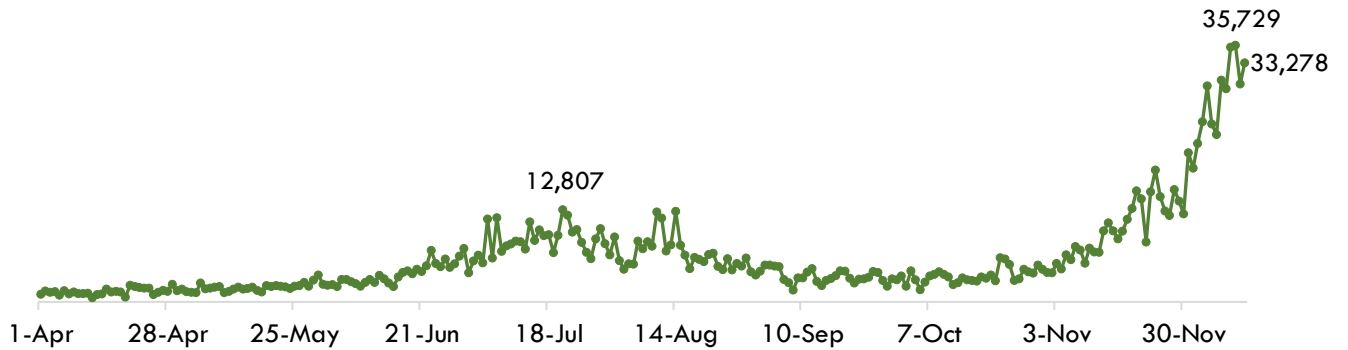

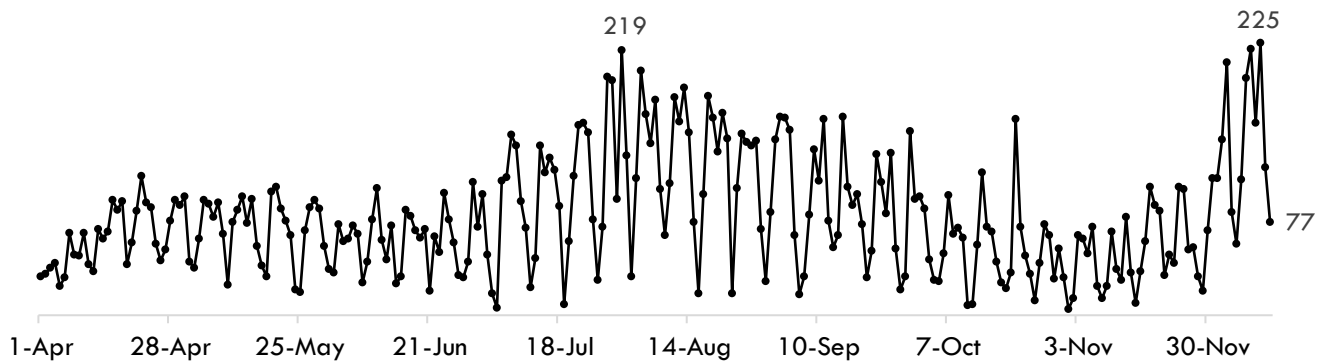

New Confirmed Cases in California by Date



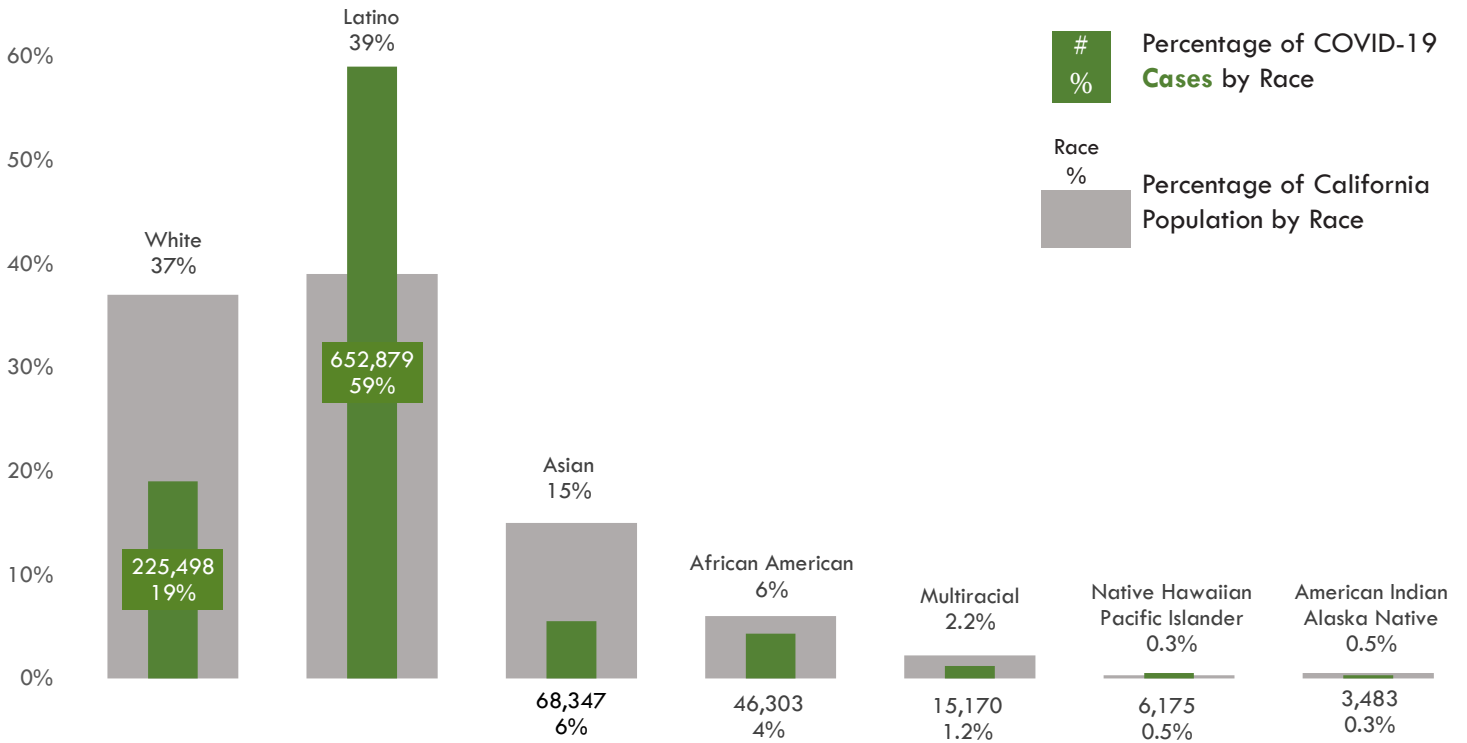
New Confirmed Deaths in California by Date



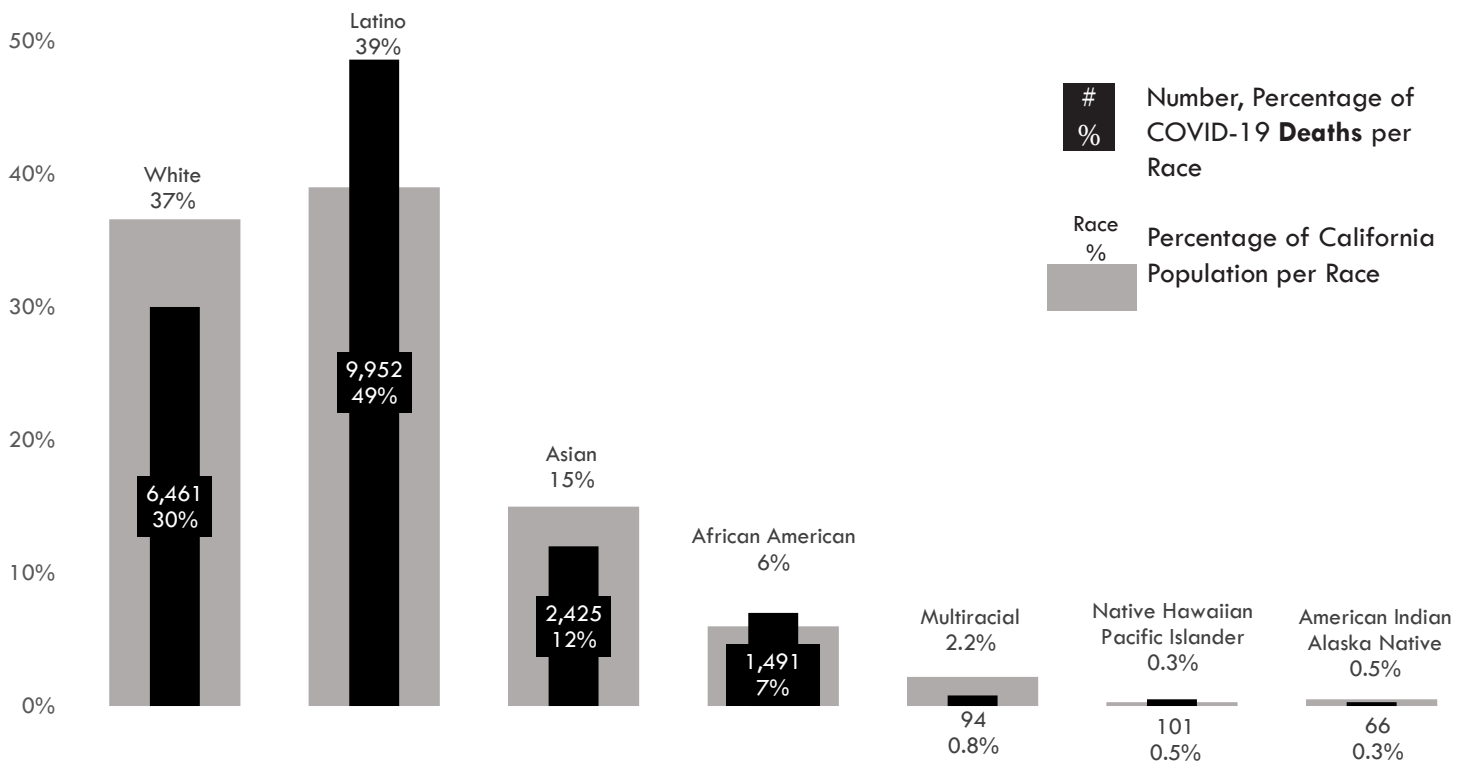

# Racial distribution of confirmed COVID-19 cases and deaths in California

American Indians and Alaska Natives account for 0.5% percent of the population, **0.3% of COVID-19 cases**, and **0.3% of deaths** in California. This includes a total of **3,483 cases** and **66 deaths** among American Indian and Alaska Native people in California.



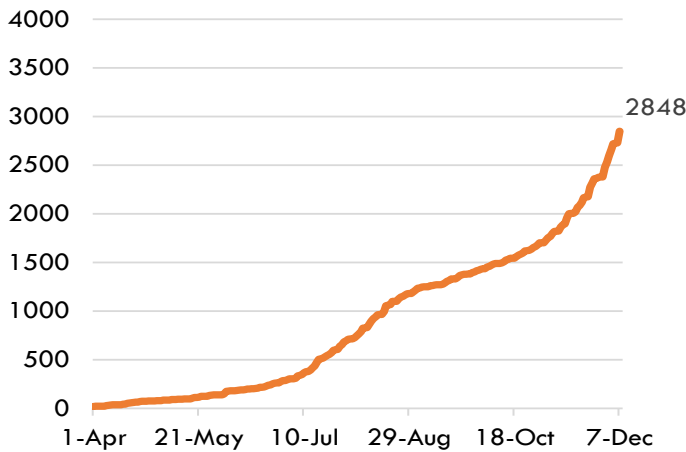
Latinos and African Americans are dying at disproportionately high rates in California. The proportion of COVID-19 deaths in Latinos is 1.3 times their population representation across all adult age categories.

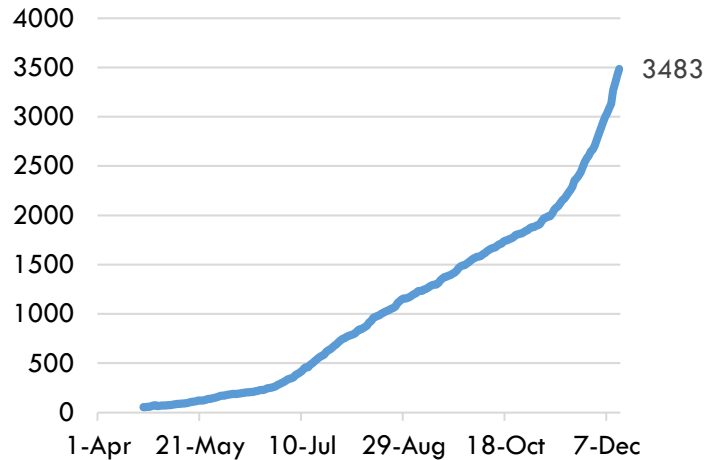

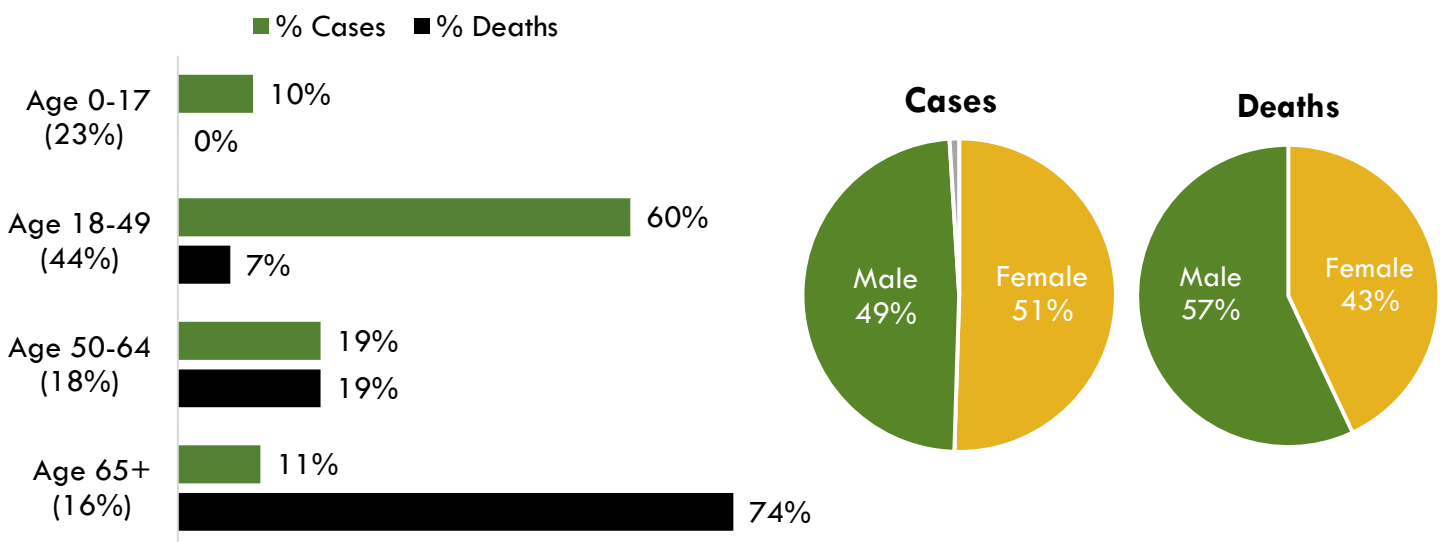

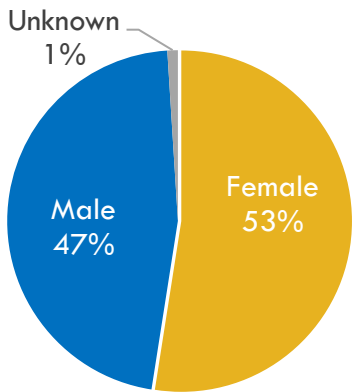
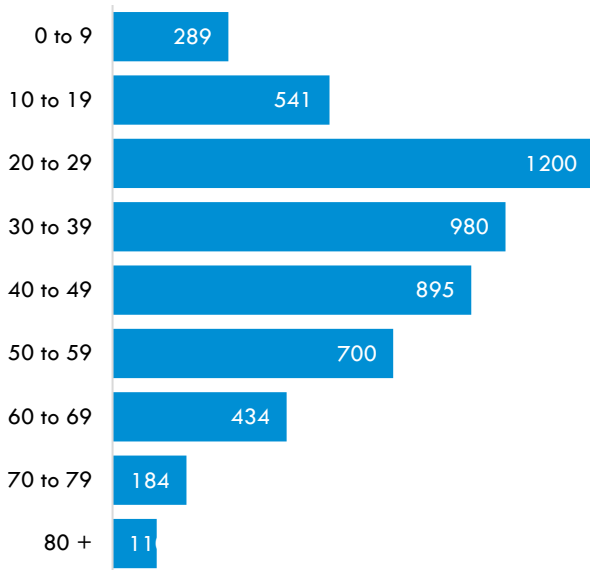

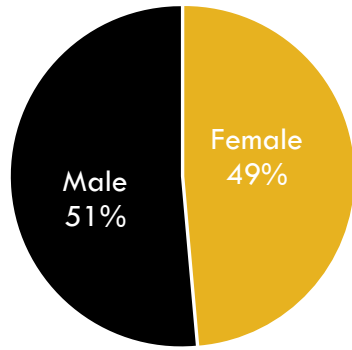
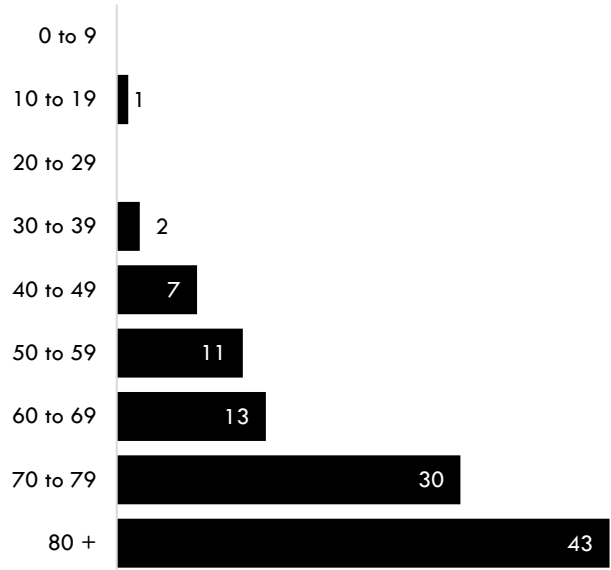

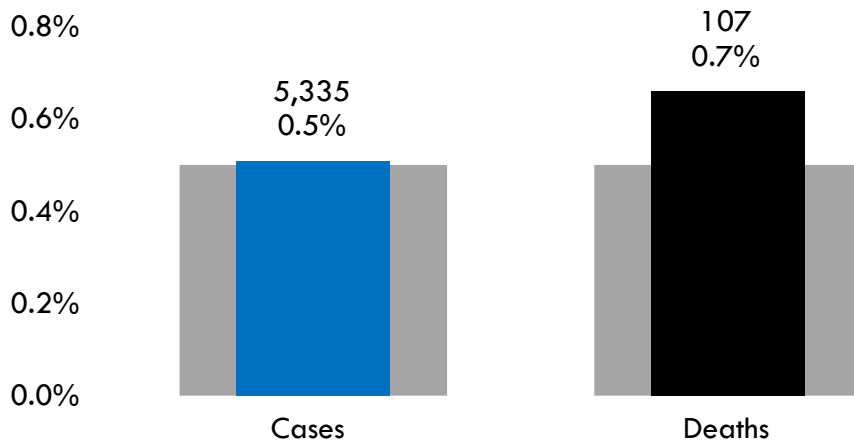
Positive COVID-19 cases among AIAN people in California by Age Group and Gender

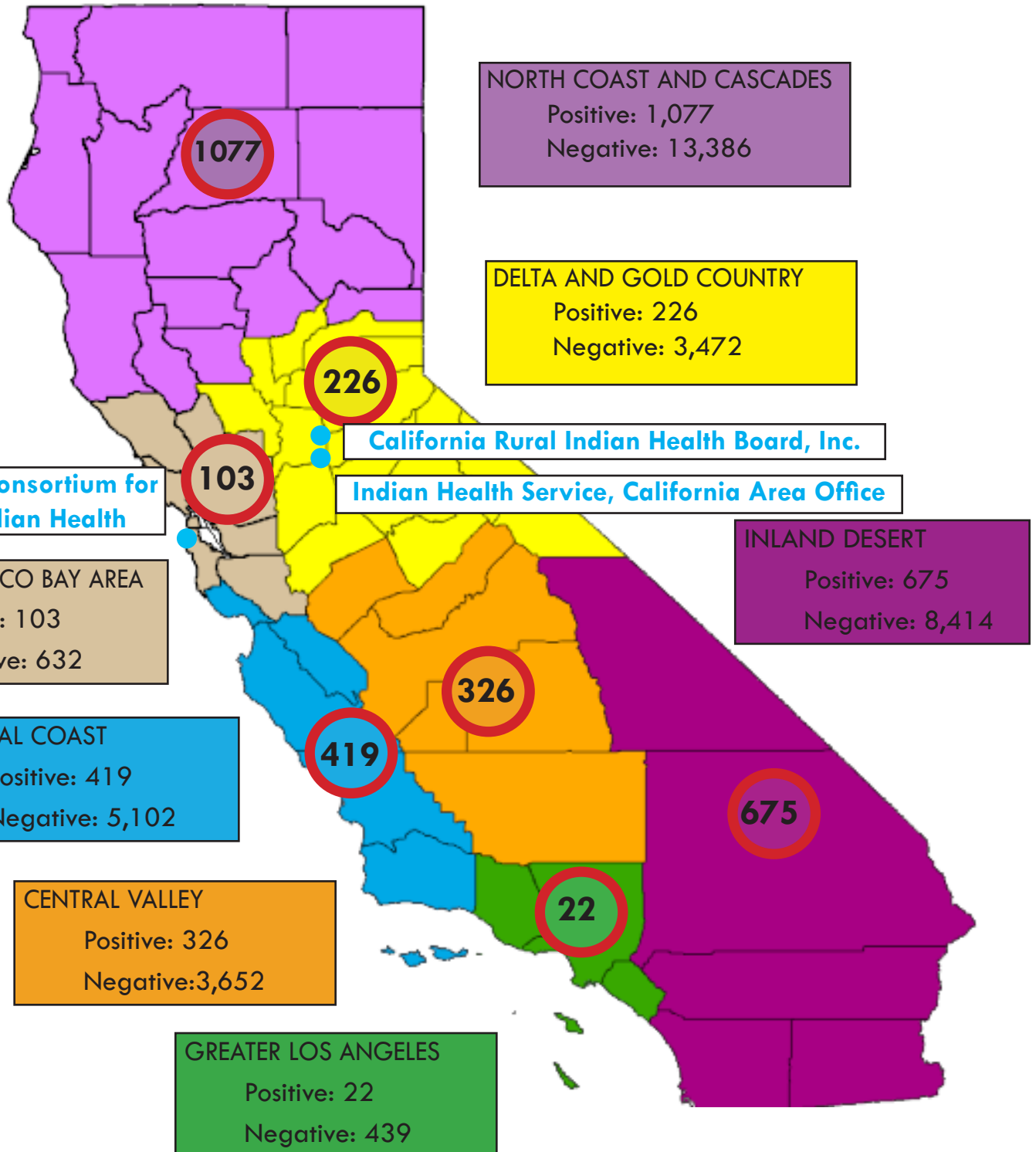

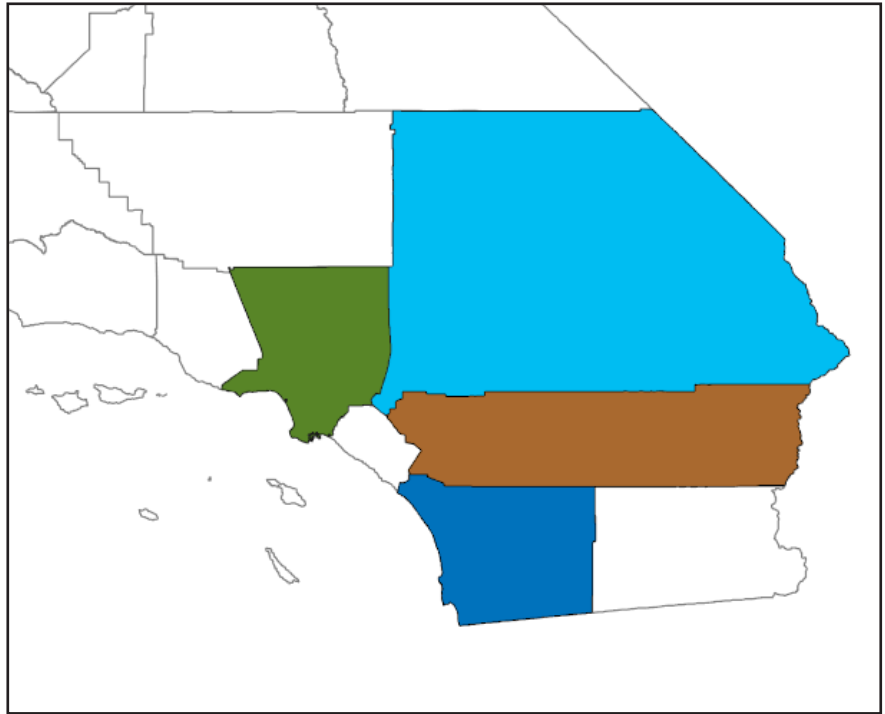
