DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 94.1 million with more than 2 million deaths.

In the United States as of January 17, 2021, the total number of cases stands at 23,653,919 and deaths at 394,495.

National surveys and polls have shown that many people intend to decline a COVID-19 vaccine when it is offered to them. These attitudes have fluctuated over time and vary from person to person. However, factors such as race, ethnicity, gender, age, education, and political affiliation are associated with COVID vaccine hesitancy or acceptance, with communities of color more likely to have hesitancy. A more highly transmissible variant of SARS-CoV-2, B.1.1.7, has been detected in 10 U.S. states as of January 15, 2021. Modeling data indicate that B.1.1.7 has the potential to increase the U.S. pandemic trajectory in the coming months. The increased transmissibility of the B.1.1.7 variant warrants universal and increased compliance with mitigation strategies, including distancing and masking. As California continues its health first approach to fight the COVID-19 pandemic amid an unprecedented surge, CDPH issued a new public health order to reduce pressure on strained hospital systems and redistribute the responsibility of medical care across the state so patients can continue to receive lifesaving care. 

*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID19. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to














American Indians and Alaska Natives account for 0.5% percent of the population, 0.3% of COVID-19 cases, and 0.3% of deaths in California. This includes a total of 7,106 cases and 102 deaths among American Indian and Alaska Native people in California.








Two sources for tracking American Indian and Alaska Native (AIAN) cases reported in California








American Indian and Alaska Native (AIAN) data reported by California to the Centers for Disease Control and Prevention (CDC)








CDC data show that AIAN in California are testing positive for COVID-19 at rates that are proportionate to their population in California but dying at rates that are higher. This includes a total of 9,263 cases and 165 deaths.



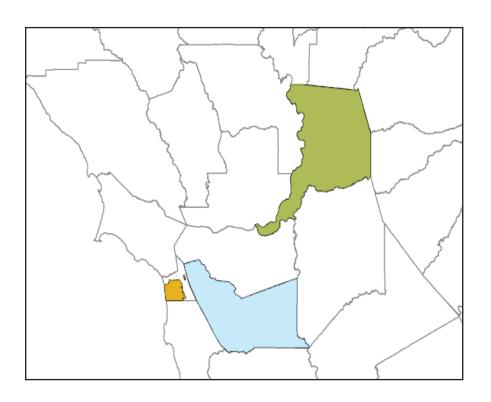


