

DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 100.8 million with more than 2.1 million deaths.

In the United States, the total number of cases stands at 25,615,268 and deaths at 431,619.

Urban Indian Health Institute (UIHI) administered an online survey to better understand COVID-19 vaccine attitudes, knowledge, and perceptions among American Indians and Alaska Natives nationwide. Some key findings include that the primary motivation for participants who indicated willingness to get vaccinated was a strong sense of responsibility to protect the Native community and preserve cultural ways, 75% of participants were willing to receive a COVID-19 vaccine, and 72% of participants wanted evidence that the vaccine is safe right now and in the long term. 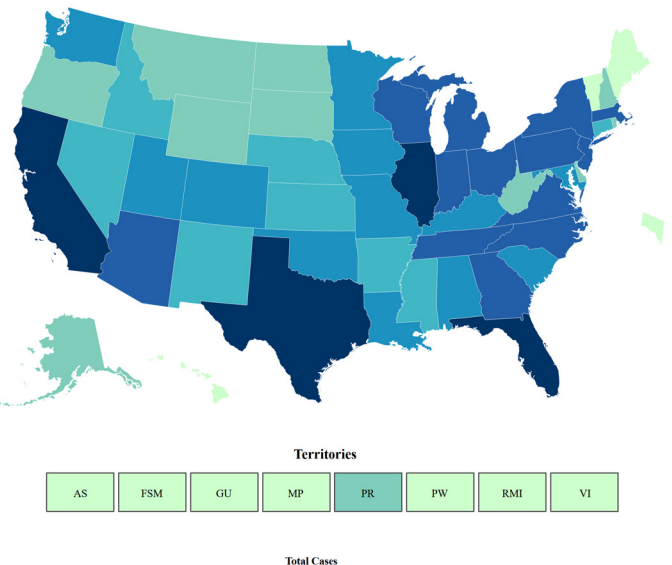
A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

- meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or
 - meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or
 - meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.
- State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

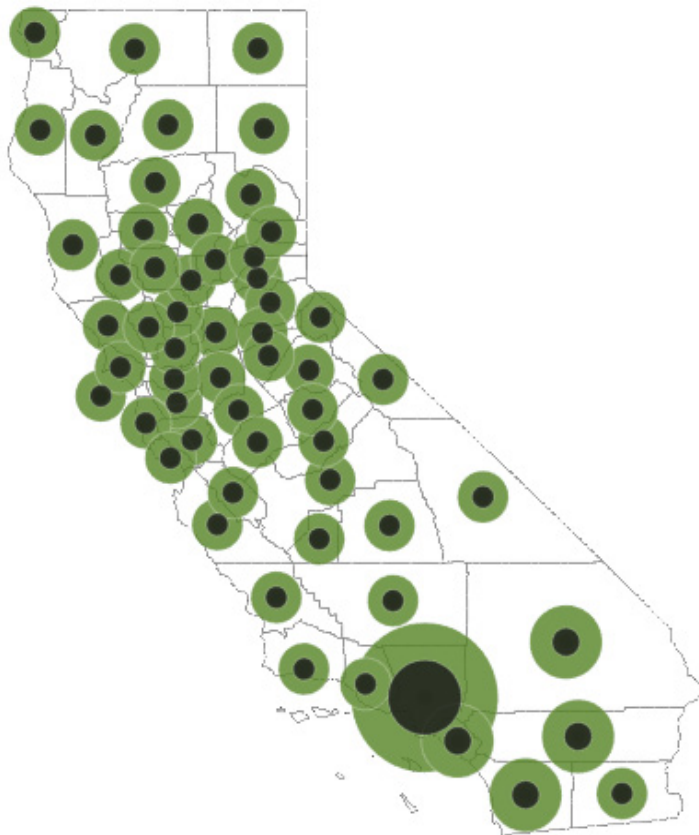

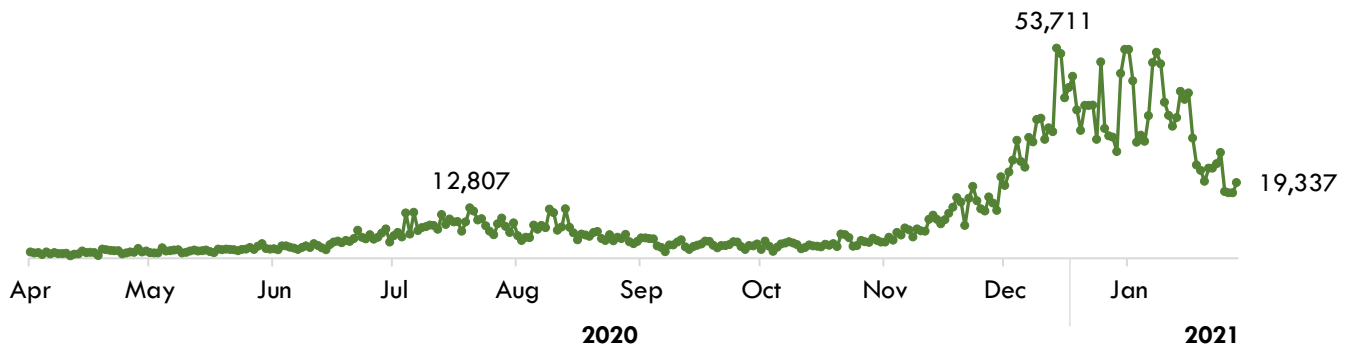

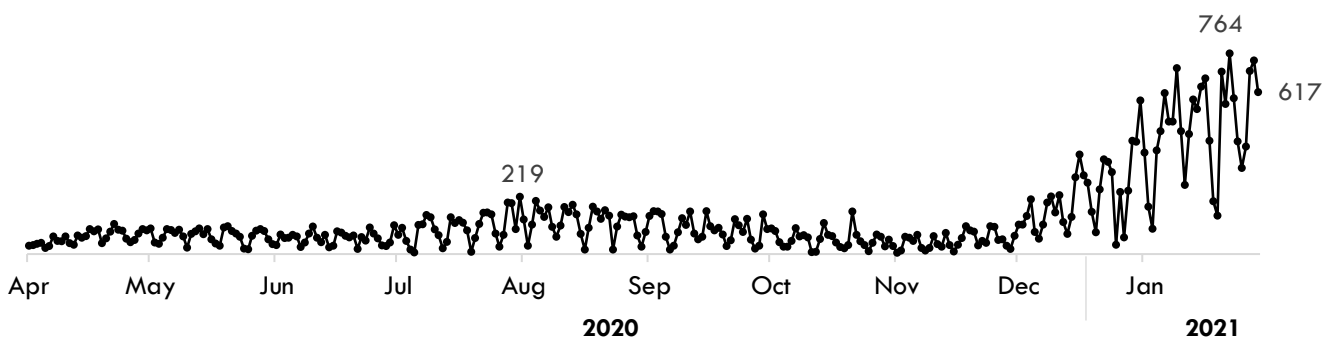

New Confirmed Cases in California by Date



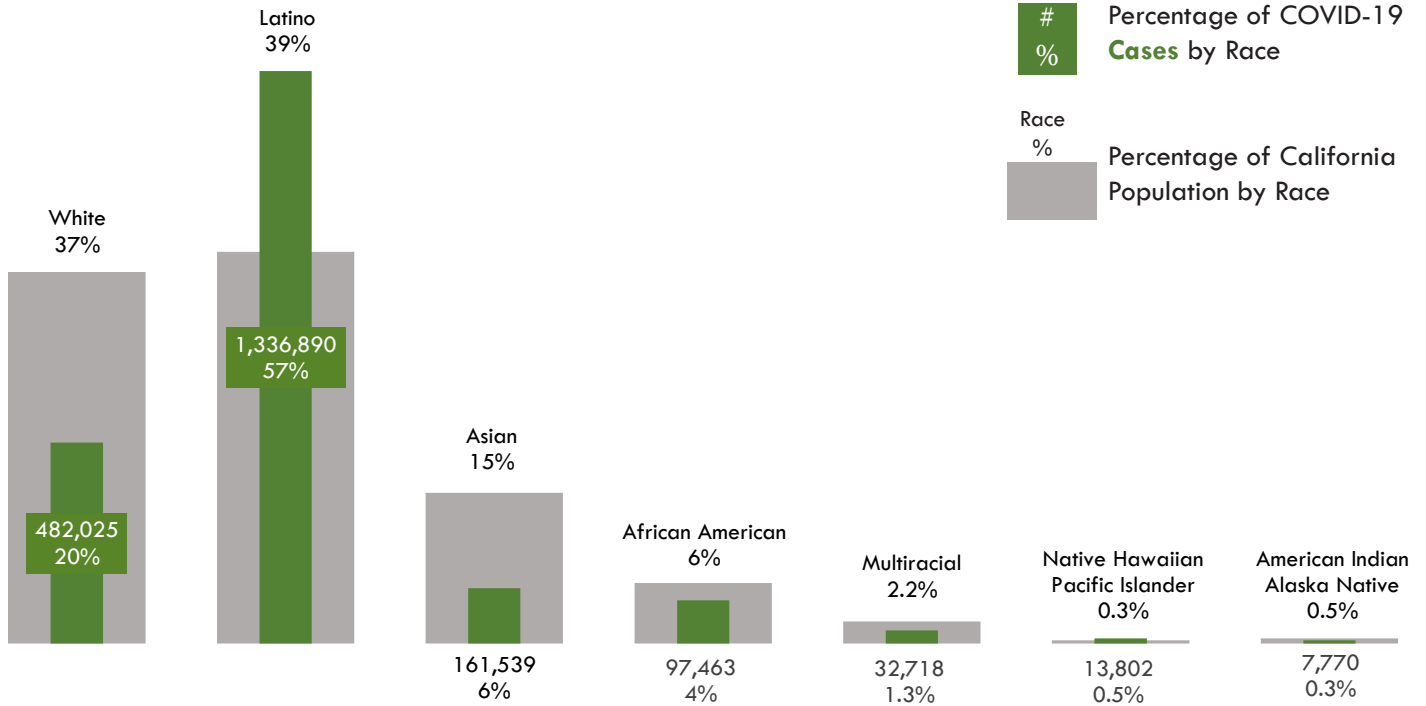
New Confirmed Deaths in California by Date



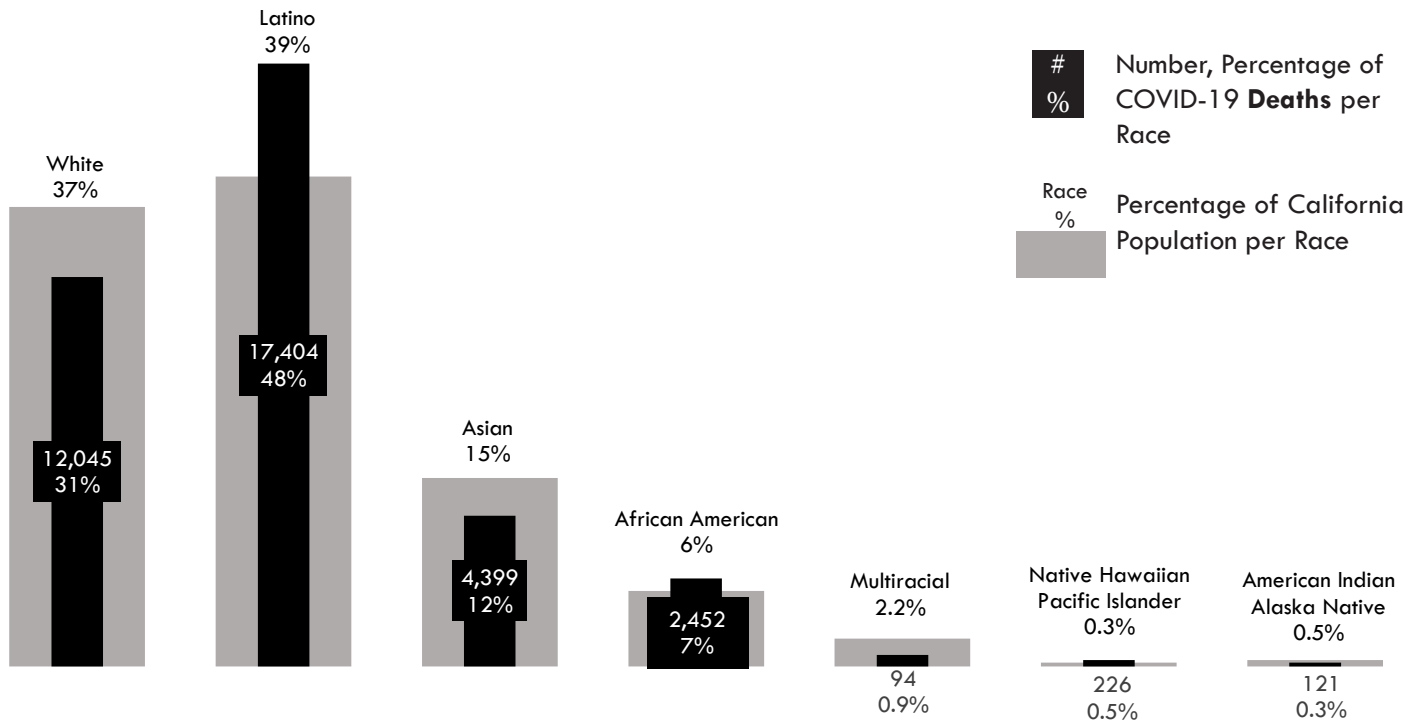

American Indians and Alaska Natives account for 0.5% percent of the population, **0.3% of COVID-19 cases**, and **0.3% of deaths** in California. This includes a total of **7,770 cases** and **121 deaths** among American Indian and Alaska Native people in California.



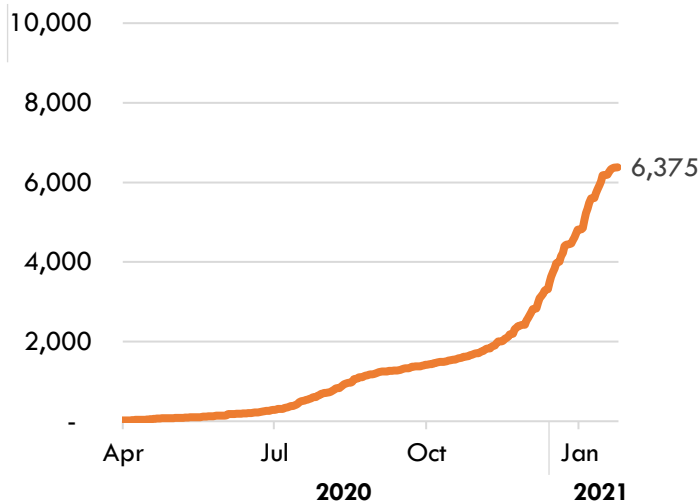

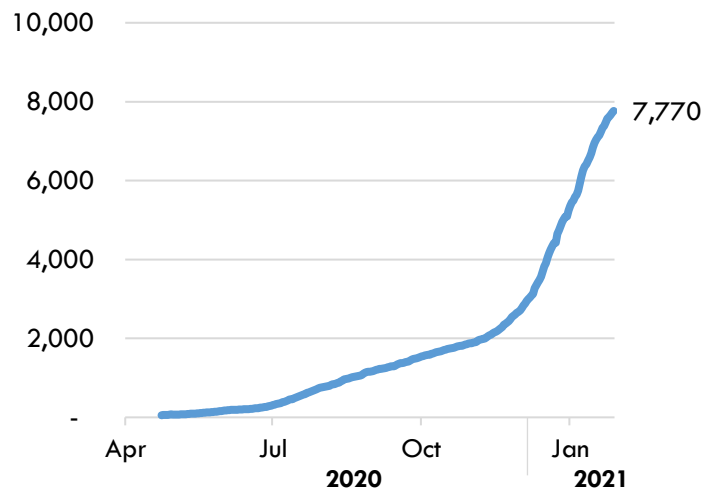

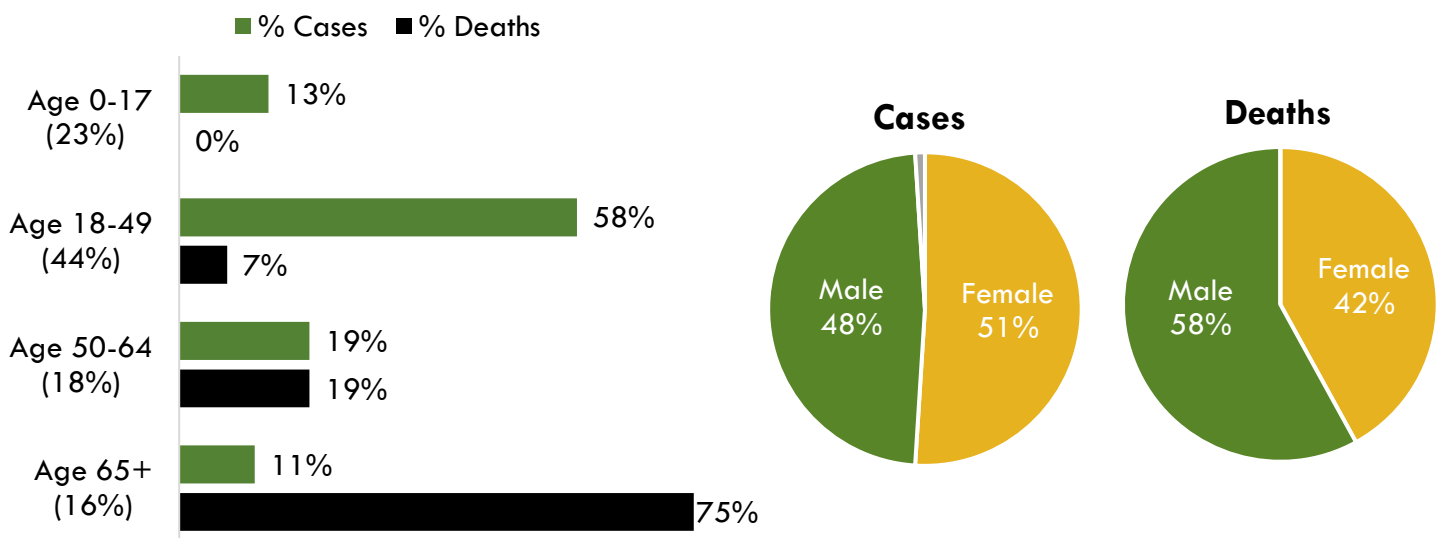

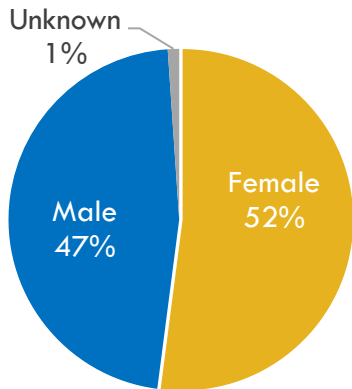
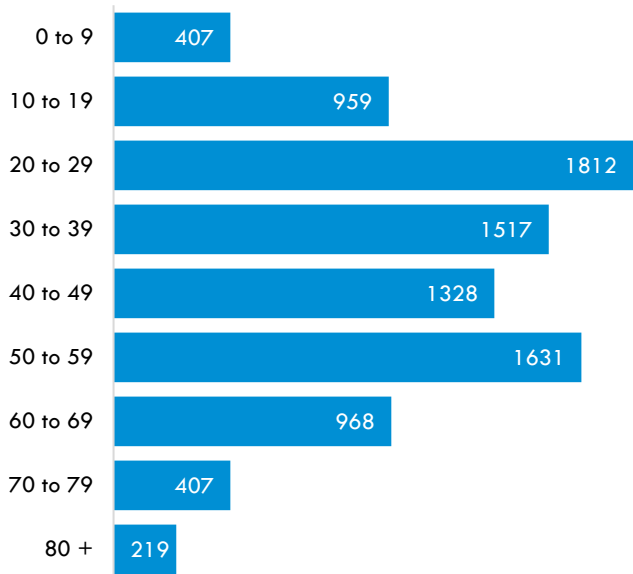

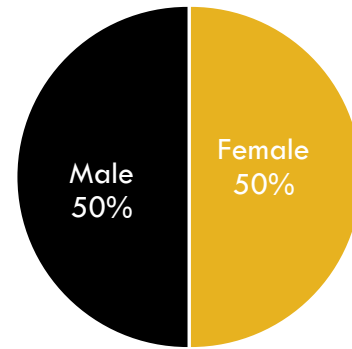
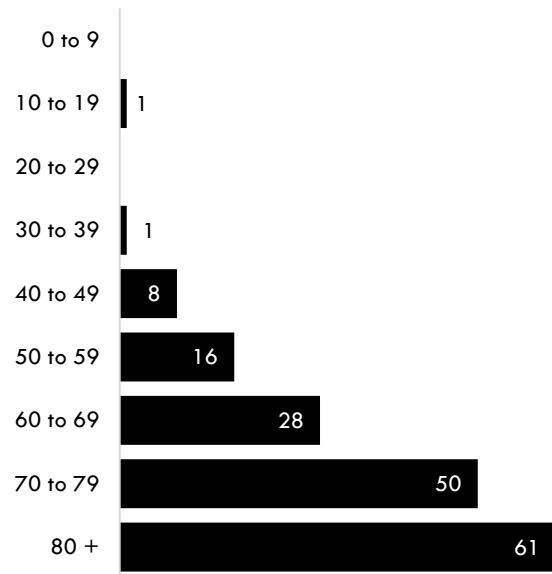

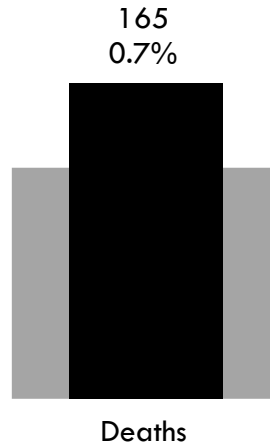
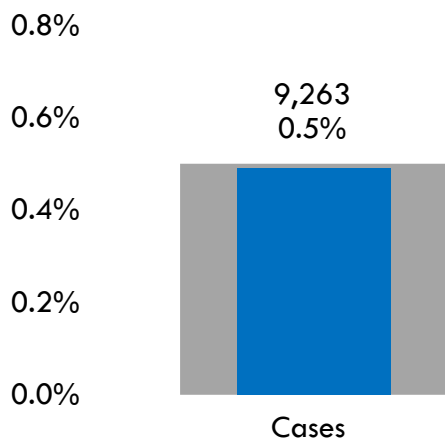
Positive COVID-19 cases among AIAN people in California by Age Group and Gender

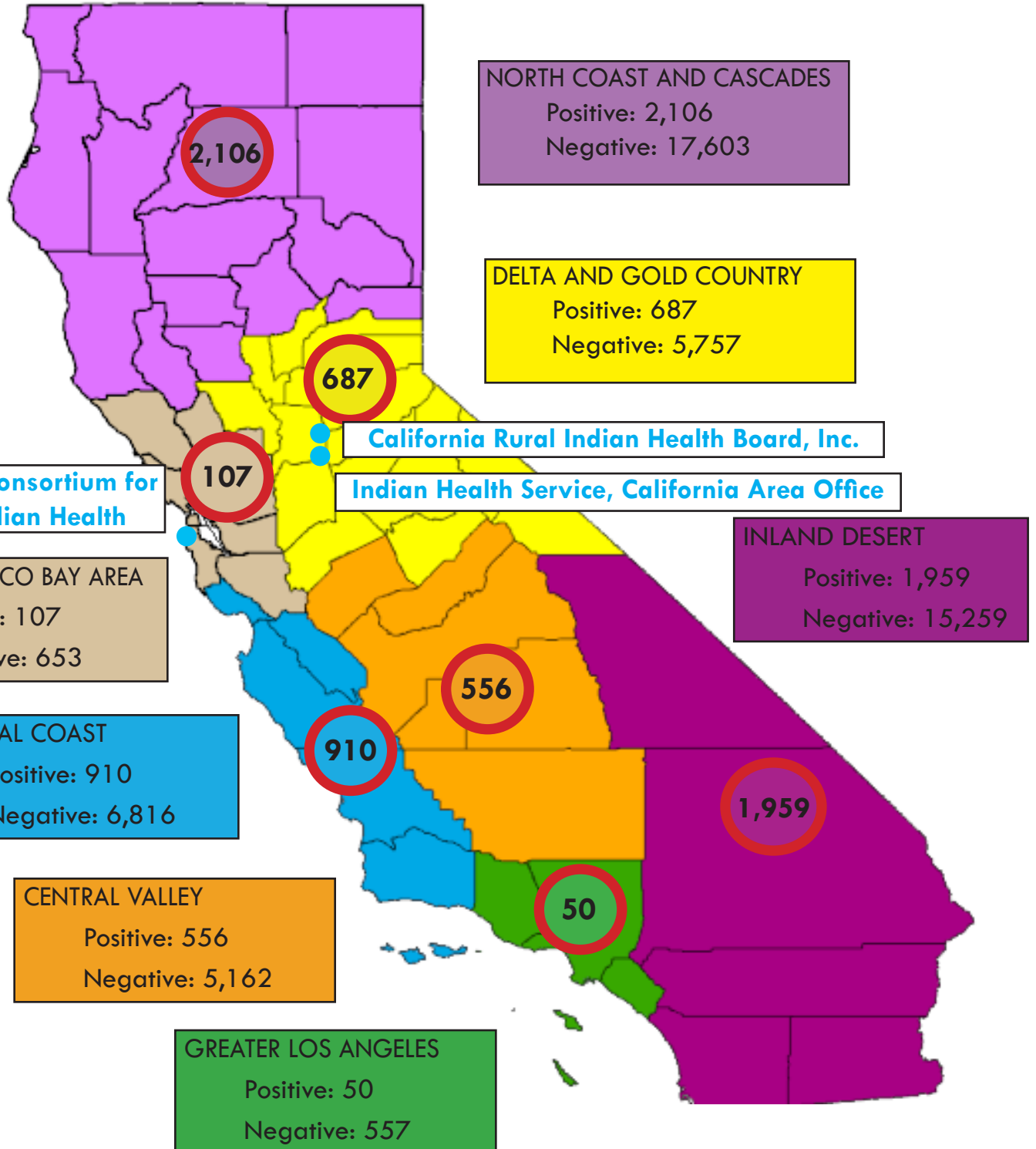

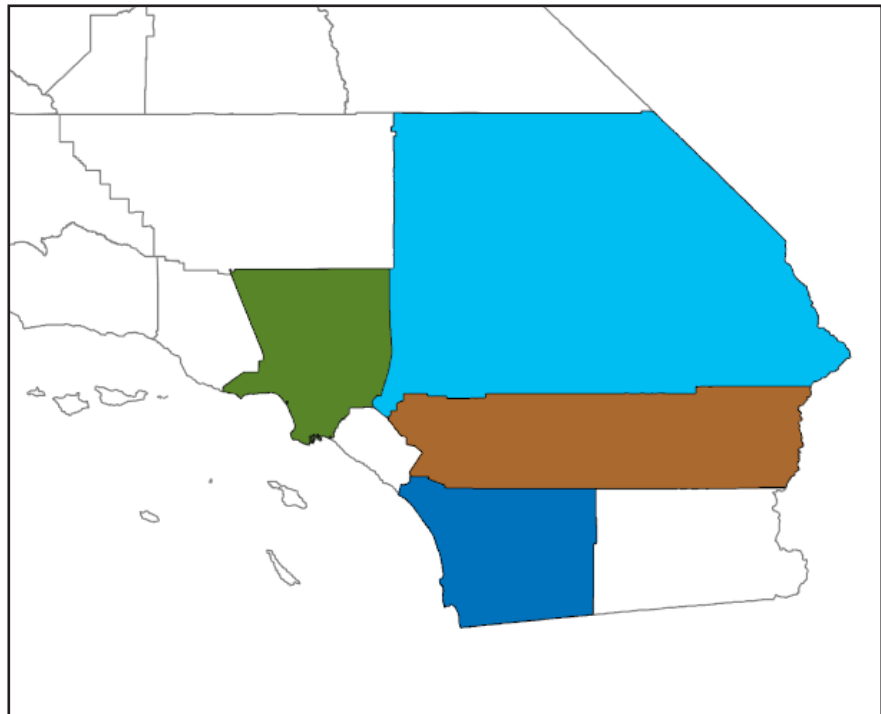

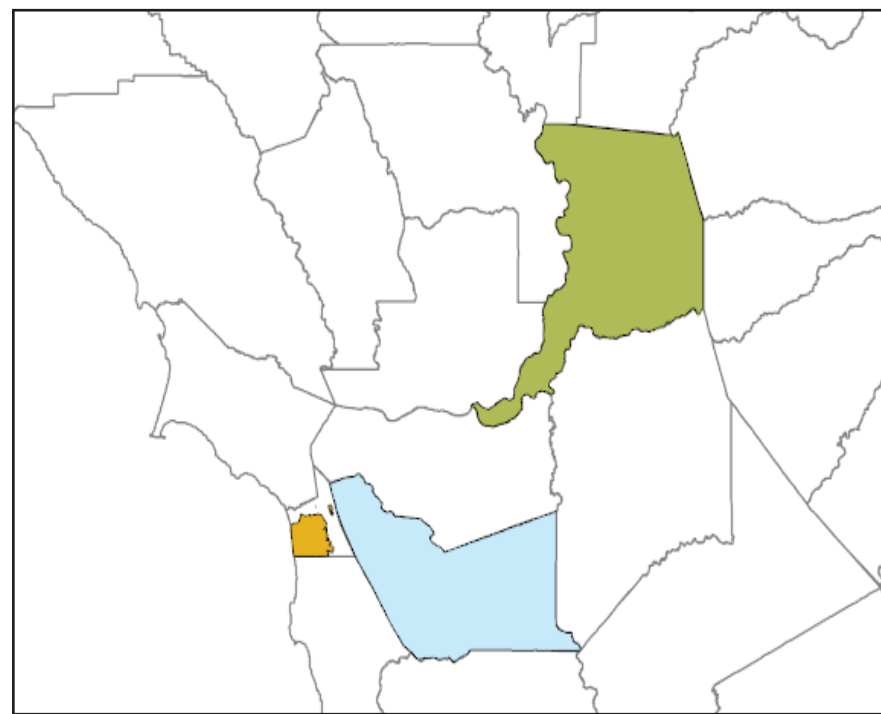
