DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 102.9 million with more than 2.2 million deaths.

In the United States, the total number of cases stands at 26,160,210 and deaths at 441,831.

The Centers for Disease Control and Prevention (CDC) has released their February 1, 2021 Morbidity and Mortality Weekly Report (MMWR) that shows demographic characteristics of persons vaccinated during the first month of the COVID-19 vaccination program. The report shows that 134,127 American Indian/Alaskan Natives (AIAN) initiated COVID-19 vaccination from December 14, 2020-January 14, 2021. To view the full report, click [HERE](#).

In his first days in office, President Joe Biden signed several Executive Orders (EOs) and released a National Strategy for the COVID-19 Response and Pandemic Awareness. In some areas, the EOs bring opportunities for advocacy ensuring American Indian and Alaskan Native (AI/AN) voices are heard. The EOs also bring opportunities for consultation with the federal government to improve testing, vaccination, and treatment for patients using the Indian health care system. Urban Indian Health Institute (UIHI) administered an online survey to better understand COVID-19 vaccine attitudes, knowledge, and perceptions among American Indians and Alaska Natives nationwide. Some key findings include that the primary motivation for participants who indicated willingness to get vaccinated was a strong sense of responsibility to protect the Native community and preserve cultural ways, 75% of participants were willing to receive a COVID-19 vaccine, and 72% of participants wanted evidence that the vaccine is safe right now and in the long term. COVID-19: U.S. at a Glance*

- Total cases: 26,160,210

*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020.

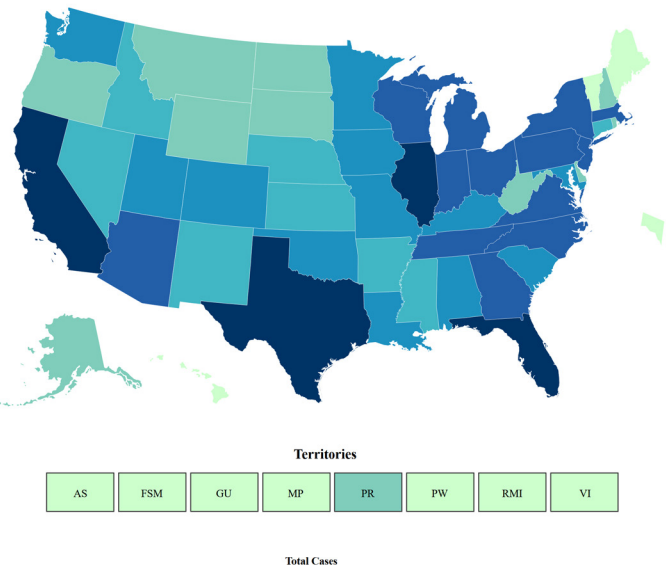
A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

- i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.
- State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

- Percent of positive tests: 9.2%

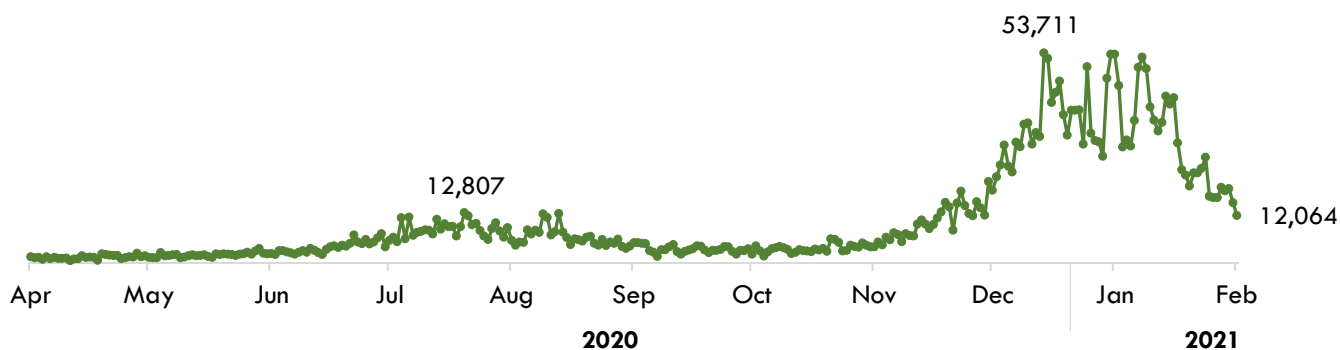

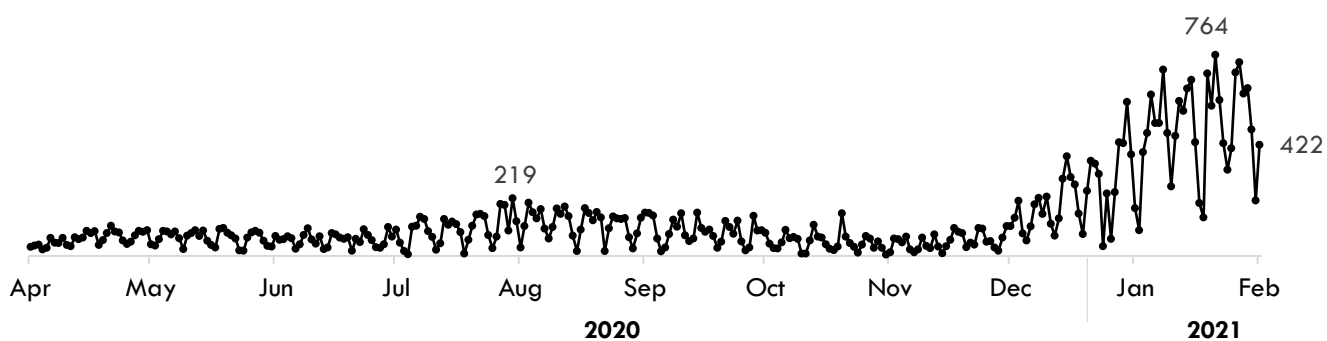

New Confirmed Cases in California by Date



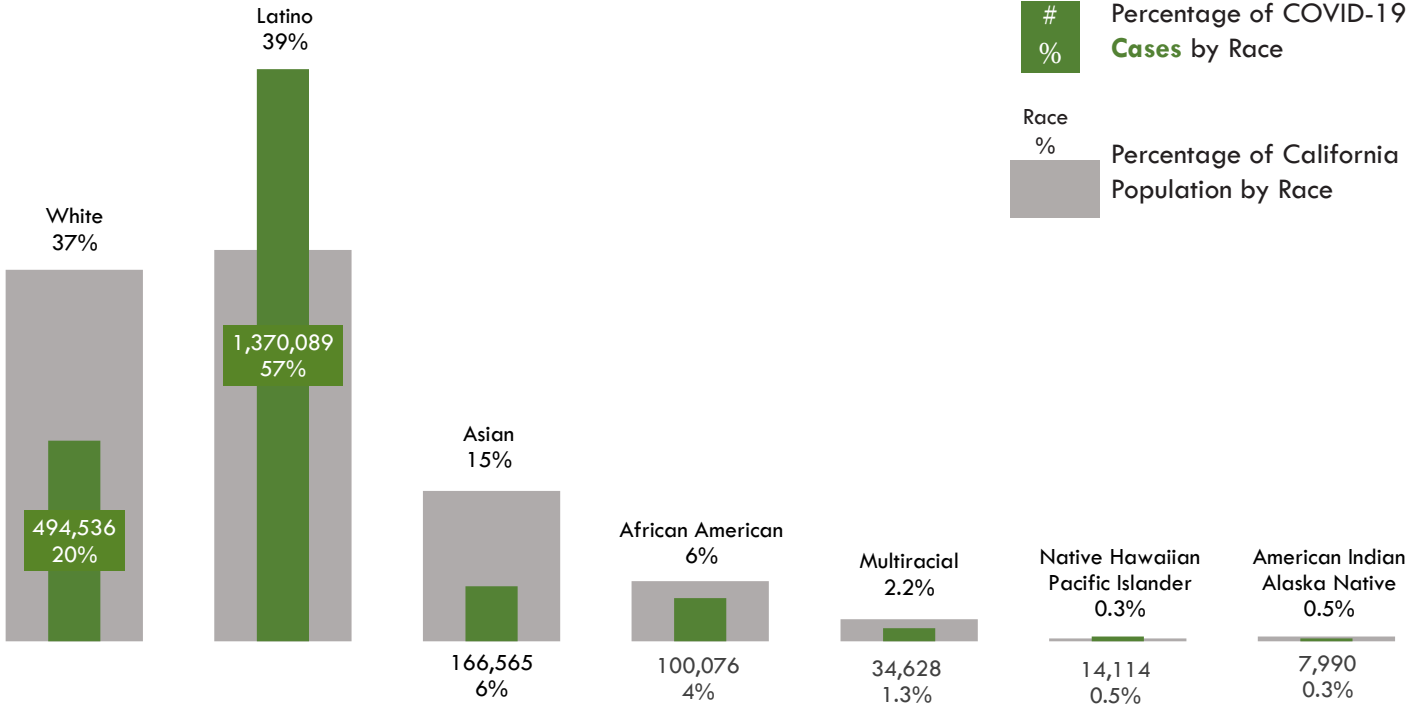
New Confirmed Deaths in California by Date



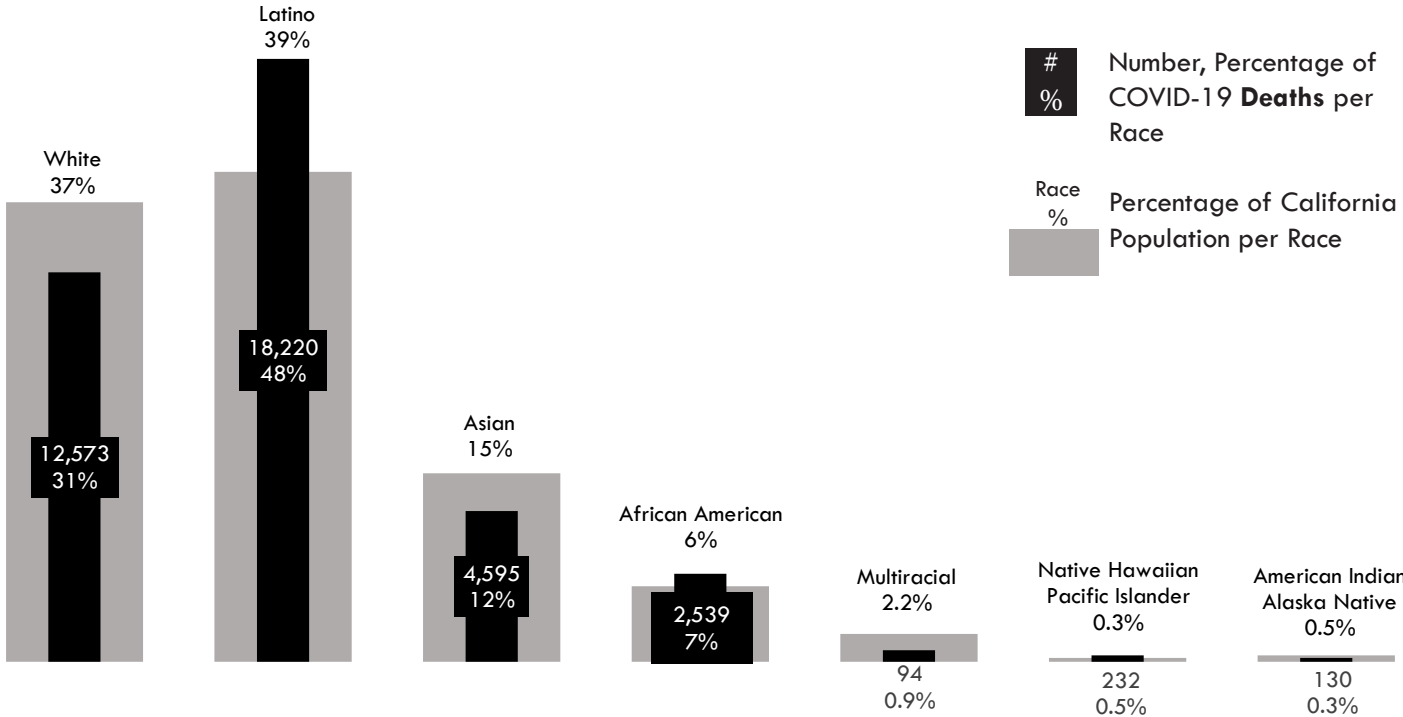

Racial distribution of confirmed COVID-19 cases and deaths in California

American Indians and Alaska Natives account for 0.5% percent of the population, **0.3% of COVID-19 cases**, and **0.3% of deaths** in California. This includes a total of **7,990 cases** and **130 deaths** among American Indian and Alaska Native people in California.



California Department of Public Health has nearly complete data on race and ethnicity for COVID-19 deaths, and are reporting the following trends: Latinos, African Americans and Native Hawaiians and Pacific Islanders are dying at disproportionately higher levels.

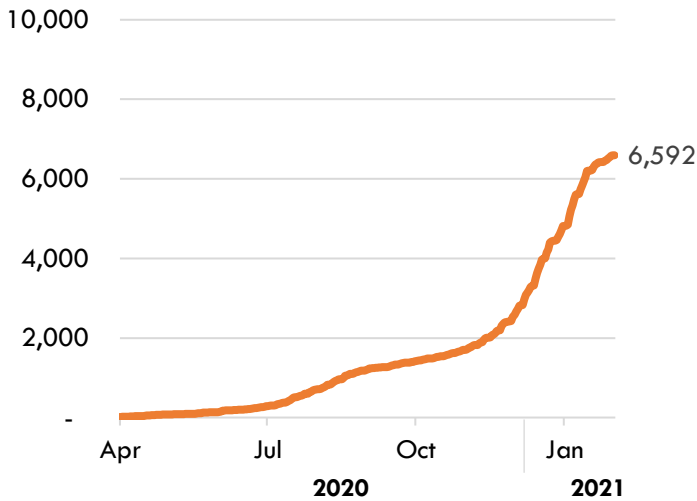

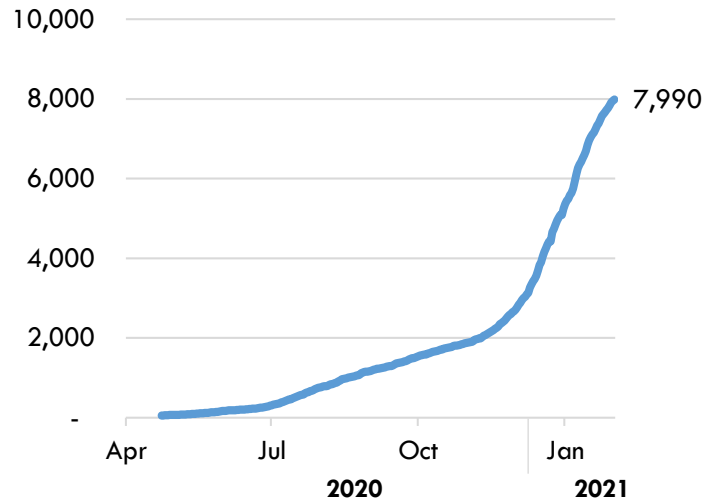

Data from **California Department of Public Health (CDPH)** include all positive cases of AIAN diagnosed in California.

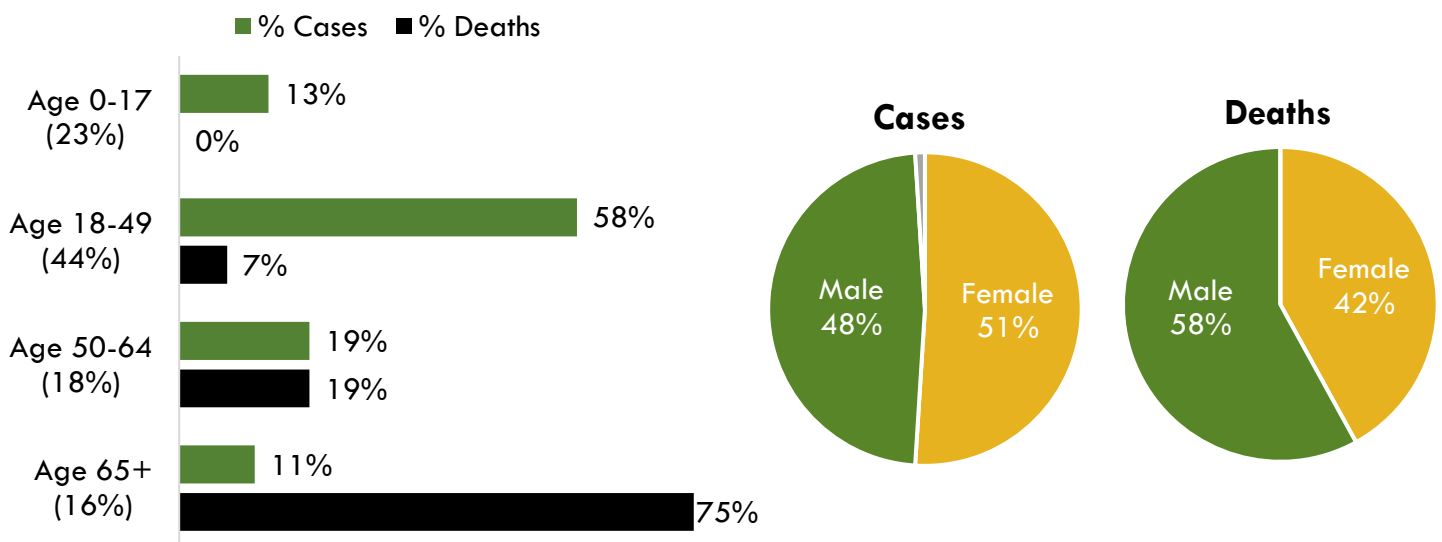

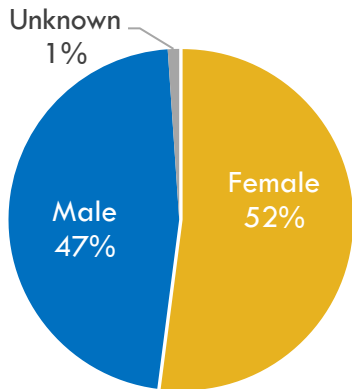
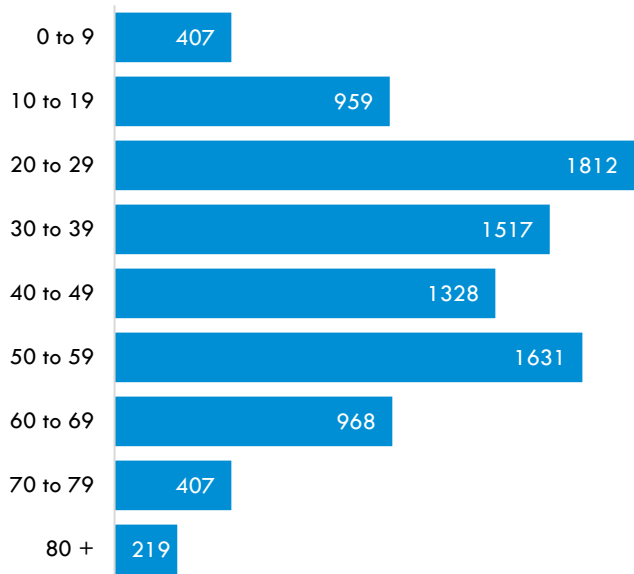

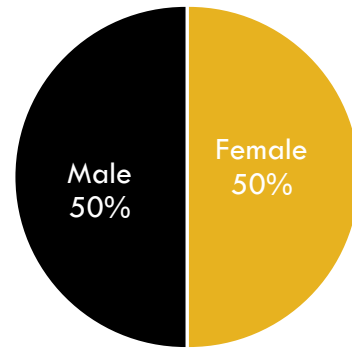
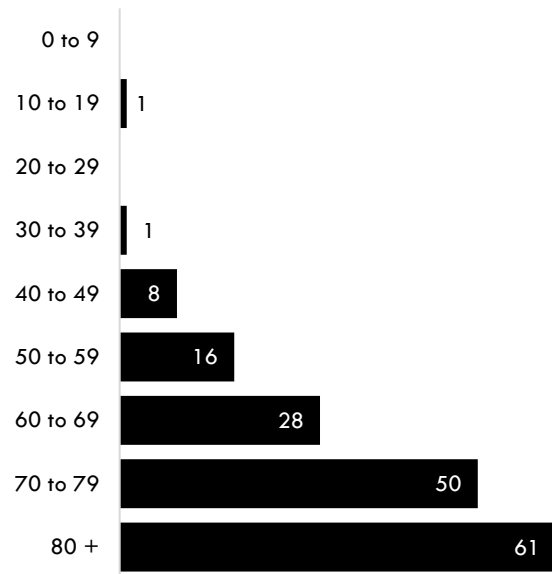

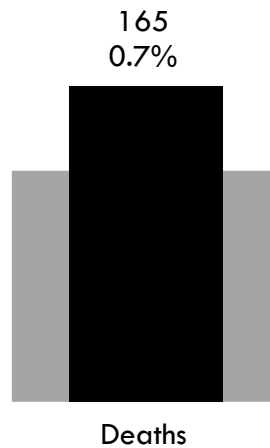
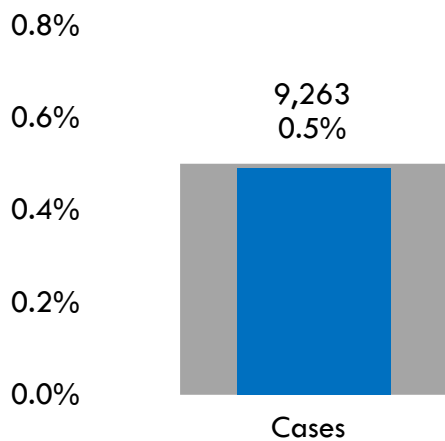
Positive COVID-19 cases among AIAN people in California by Age Group and Gender

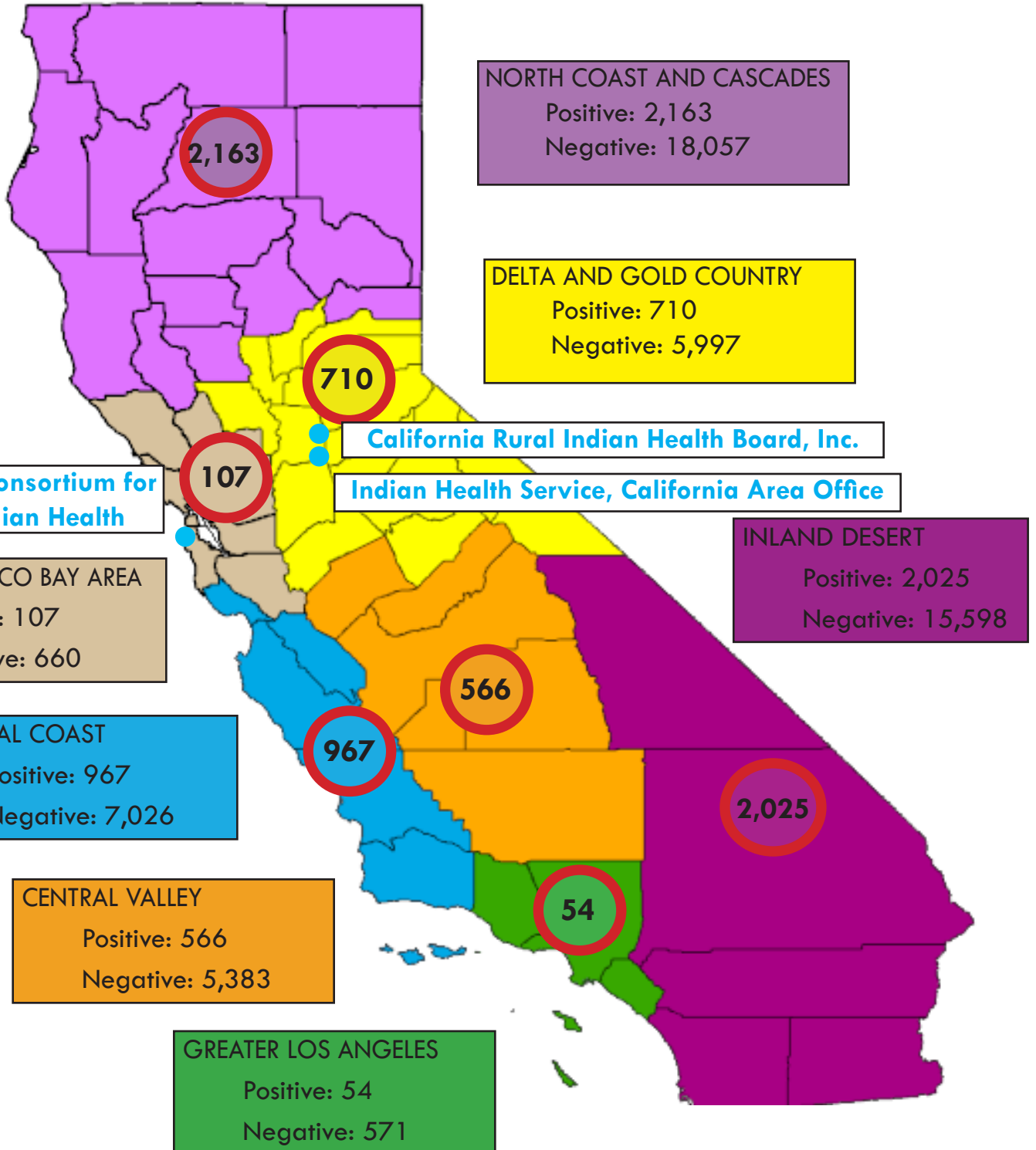


COVID-19 testing information from patients seen at a Tribal or Urban Indian Health Program in California

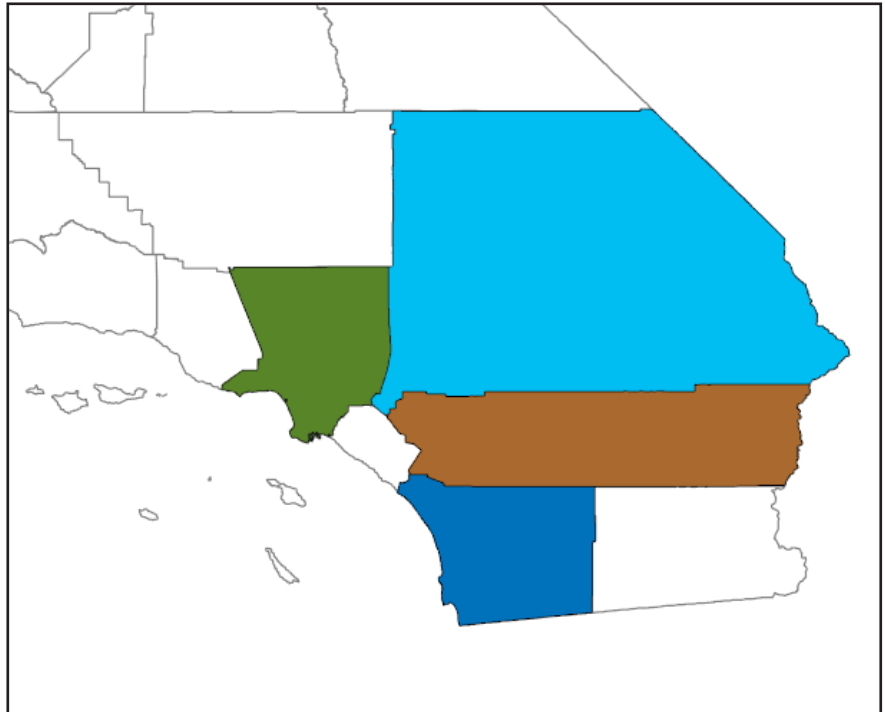

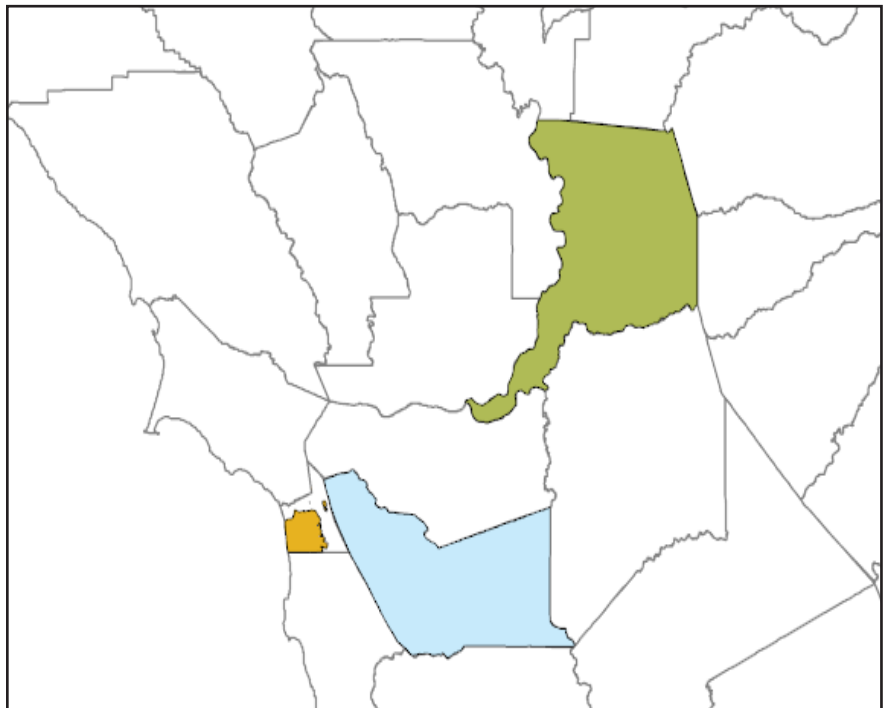
