

DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 107.4 million with more than 2.3 million deaths.

In the United States, the total number of cases stands at 27,229,862 and deaths at 473,699.

The Centers for Disease Control and Prevention (CDC) released their February 10 Morbidity and Mortality Weekly Report (MMWR) on maximizing the fit for cloth and medical procedure masks to improve performance and reduce SARS-CoV-2 transmission and exposure. CDC conducted experiments to assess two ways of improving the fit of medical procedure masks: fitting a cloth mask over a medical procedure mask, and knotting the ear loops of a medical procedure mask and then tucking in and flattening the extra material close to the face. 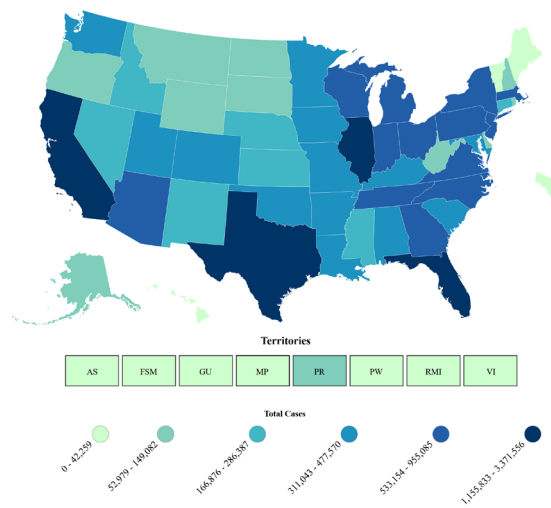
A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

- meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or
 - meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or
 - meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.
- State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

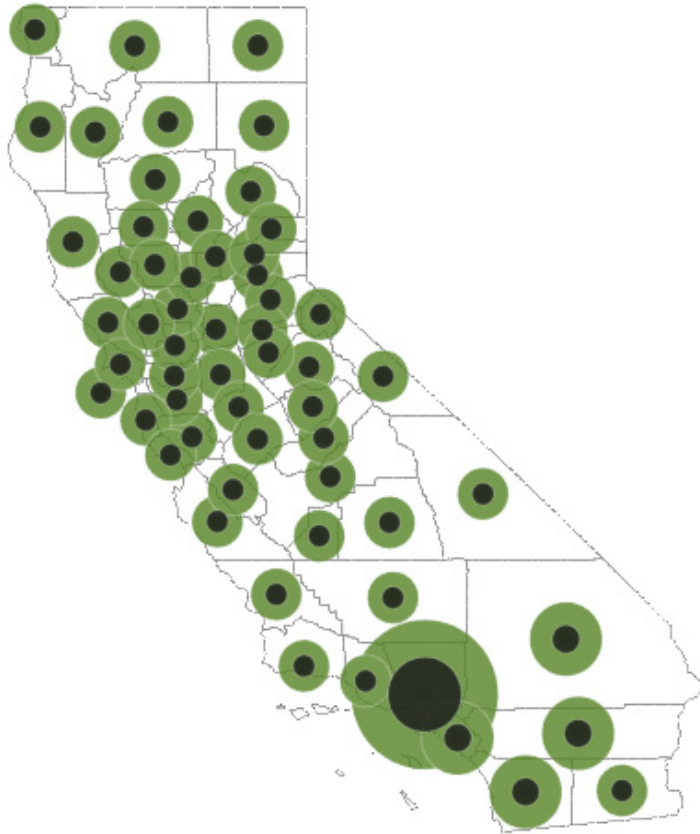

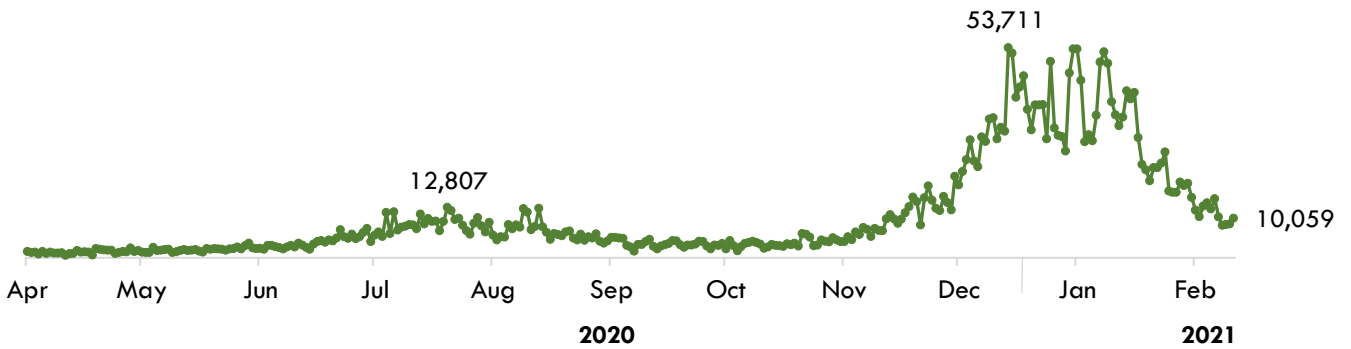

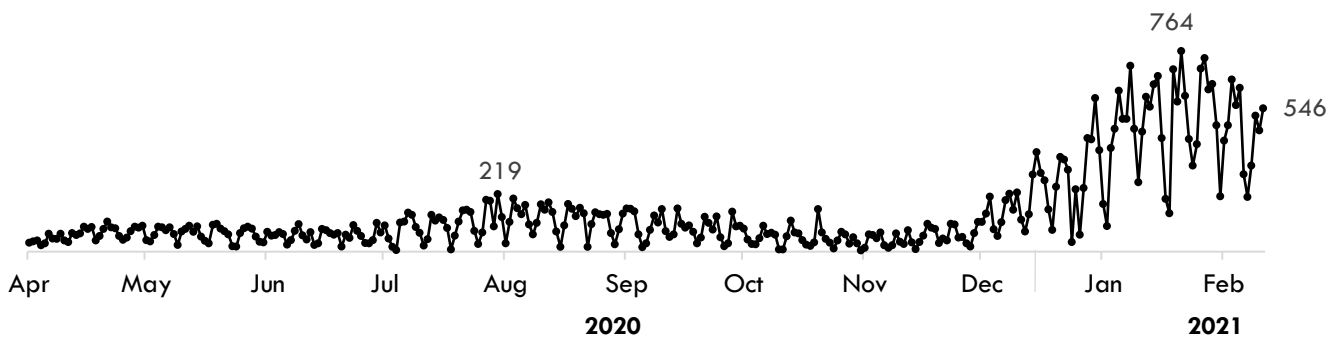

New Confirmed Cases in California by Date



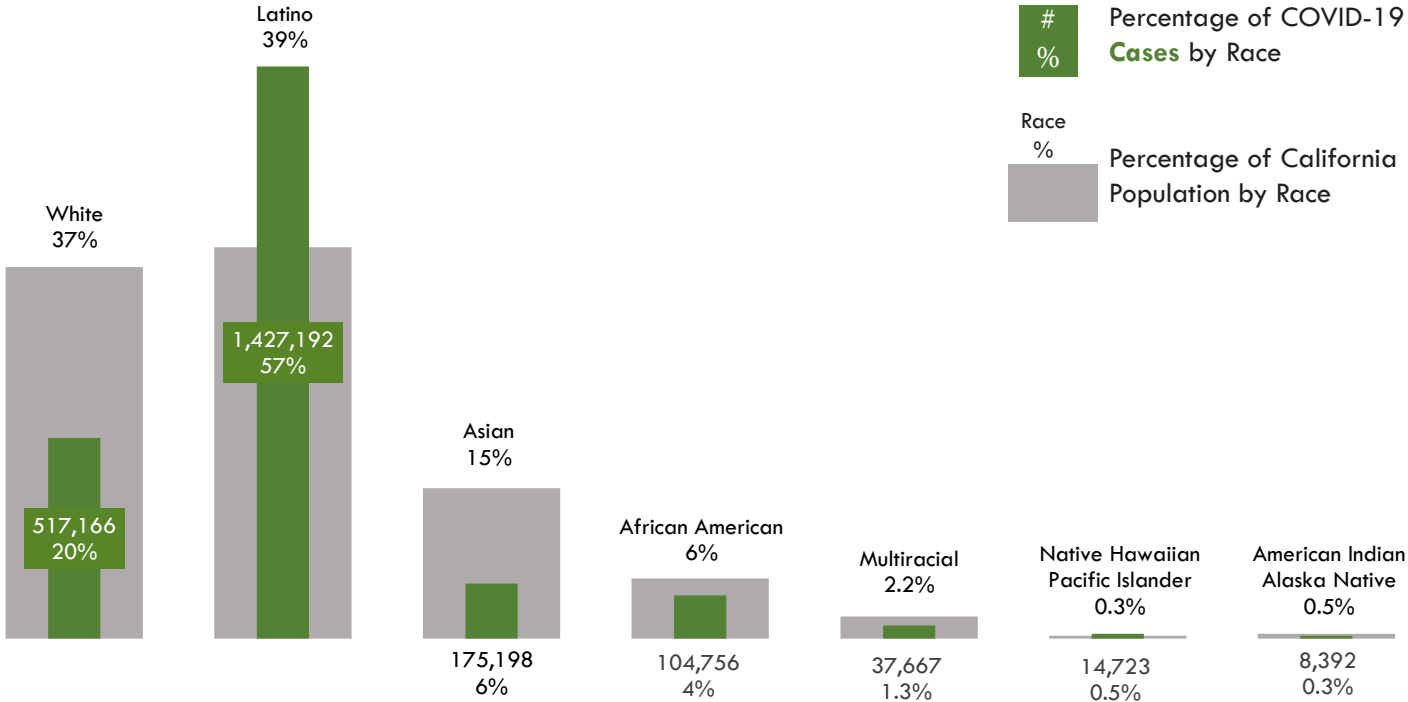
New Confirmed Deaths in California by Date



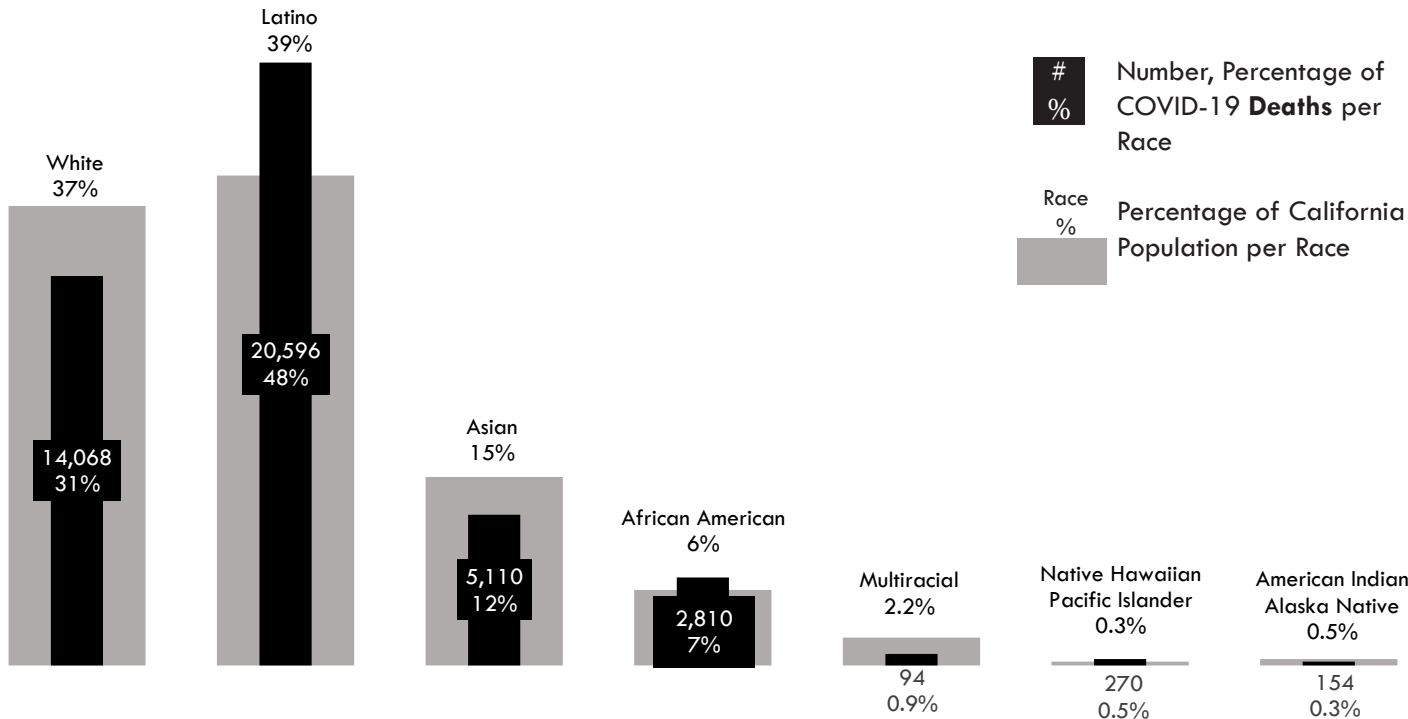

American Indians and Alaska Natives account for 0.5% percent of the population, **0.3% of COVID-19 cases**, and **0.3% of deaths** in California. This includes a total of **8,392 cases** and **154 deaths** among American Indian and Alaska Native people in California.



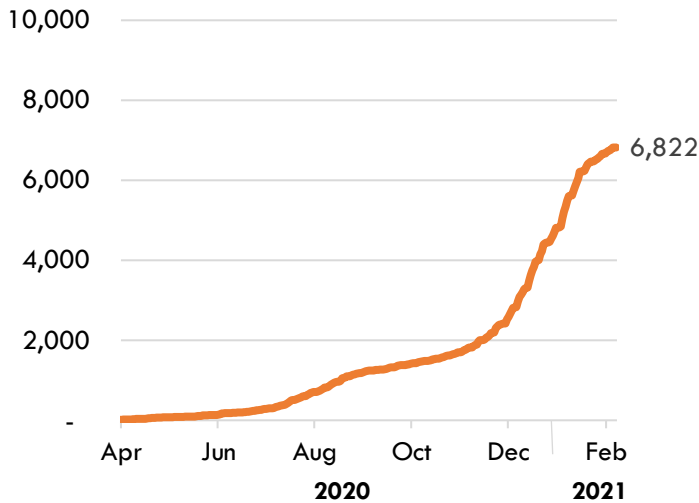

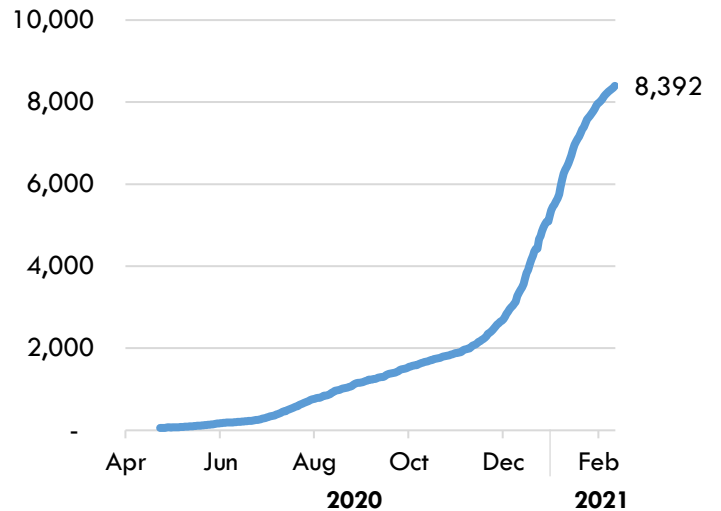

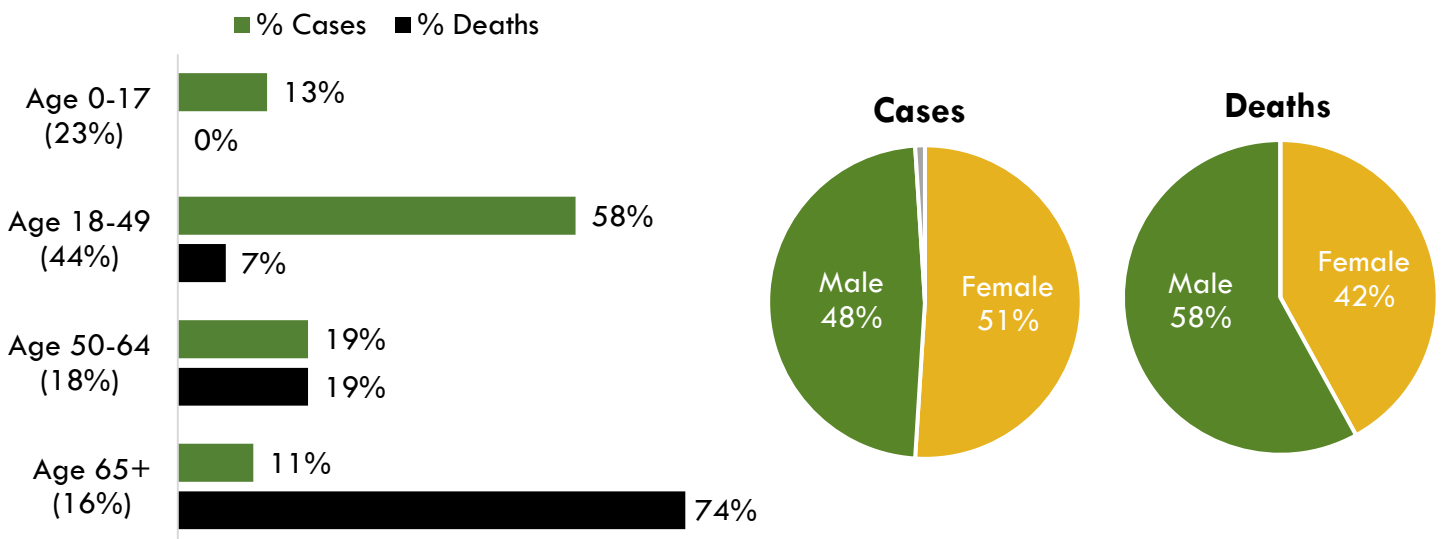

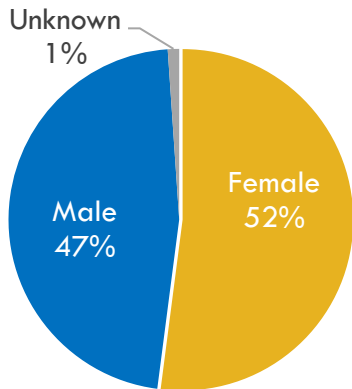

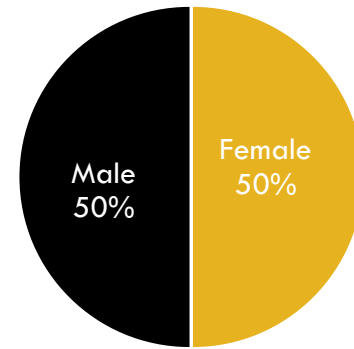
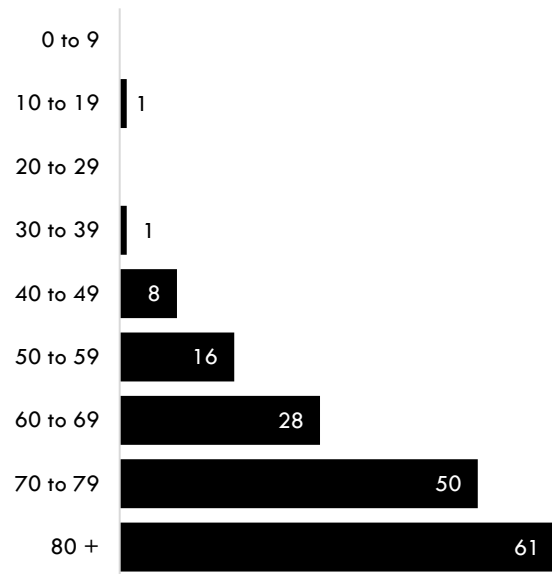

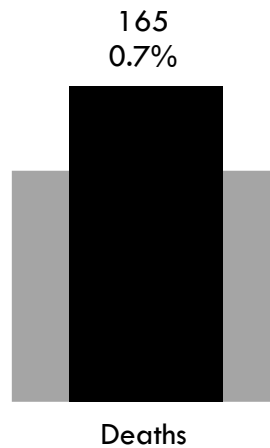
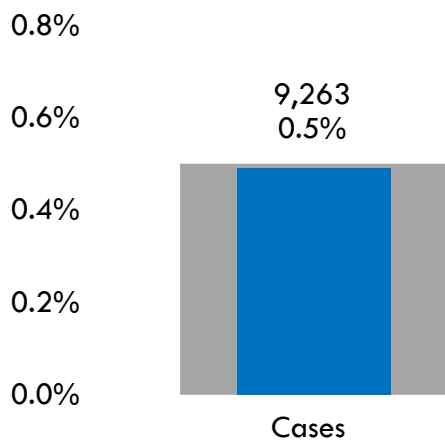
Positive COVID-19 cases among AIAN people in California by Age Group and Gender

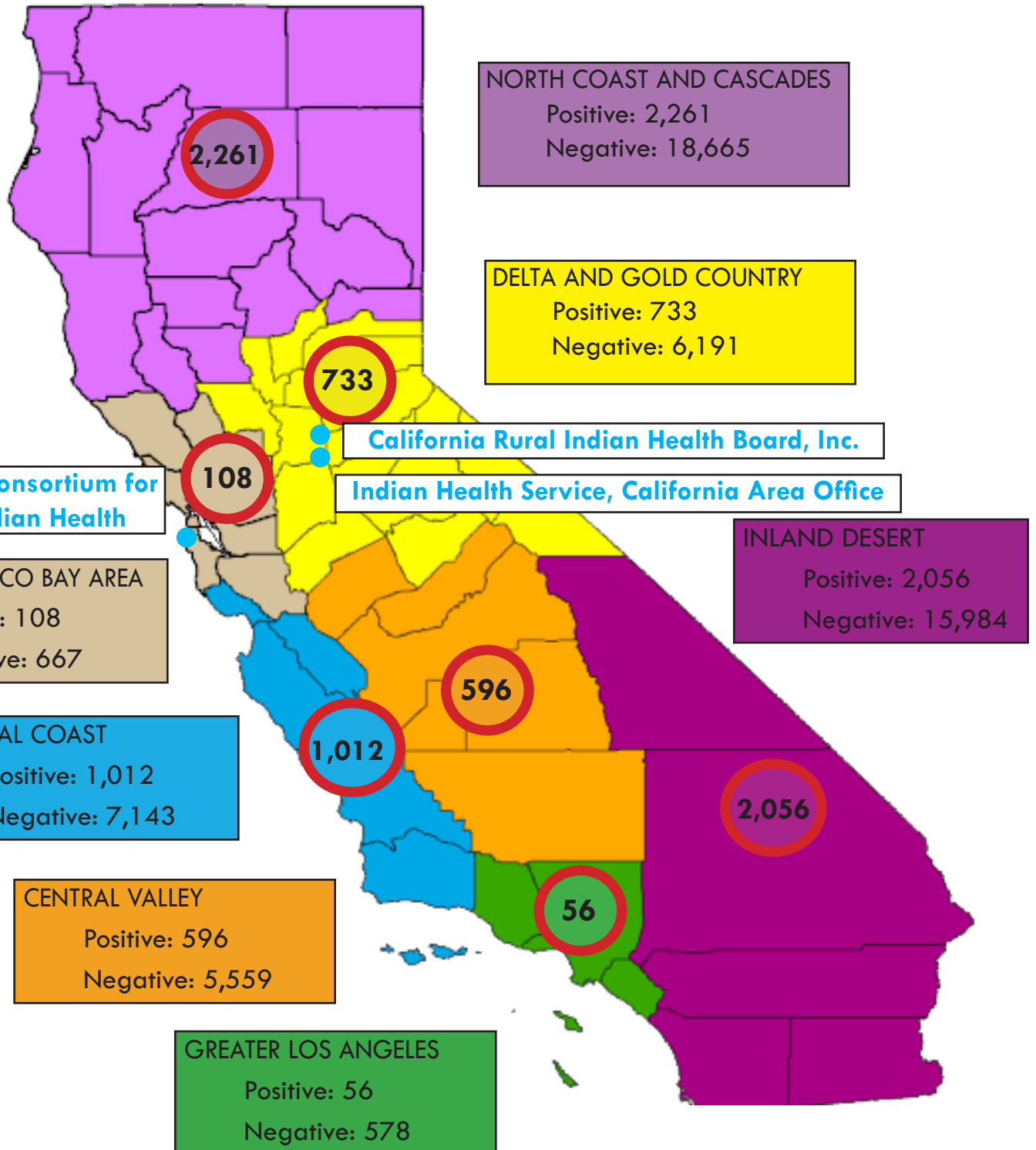


COVID-19 testing information from patients seen at a Tribal or Urban Indian Health Program in California

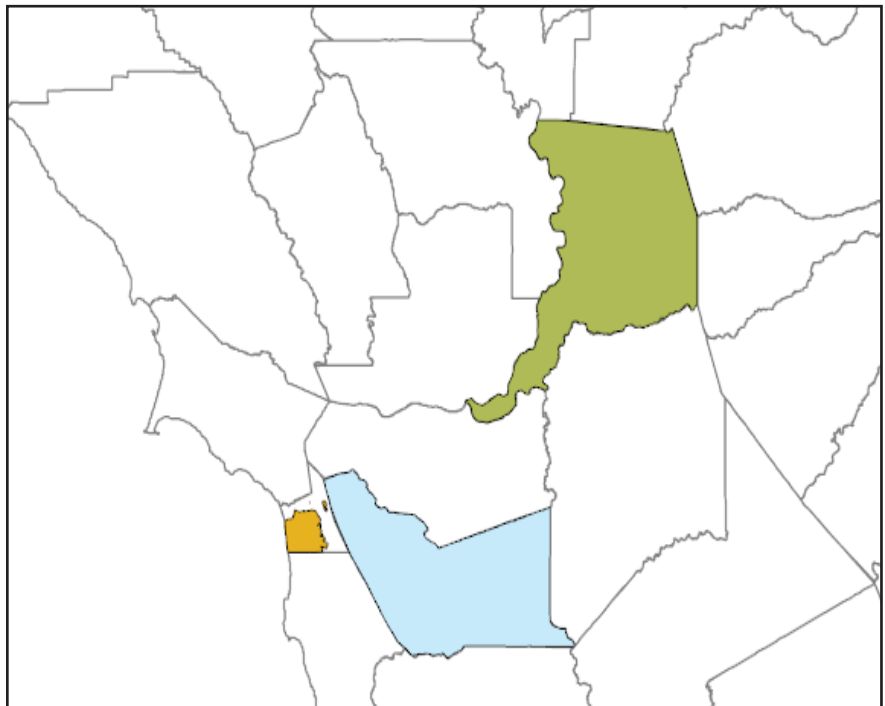
