## DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 111.7 million with more than 2.4 million deaths.

In the United States as of February 23, the total number of cases stands at 27,993,504 and deaths at 498,993.

The California Department of Public Health has released new guidance for youth and adult recreational sports which will go into effect February 26. ## UNITED STATES

### COVID-19: U.S. at a Glance\* (as of 2/23/21)

- Total cases: 27,993,504
- Total deaths: 498,993
- Jurisdictions reporting cases: 55 (50 states, District of Columbia, Guam, Puerto Rico, the Northern Mariana Islands, and the U.S. Virgin Islands)

\*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020.

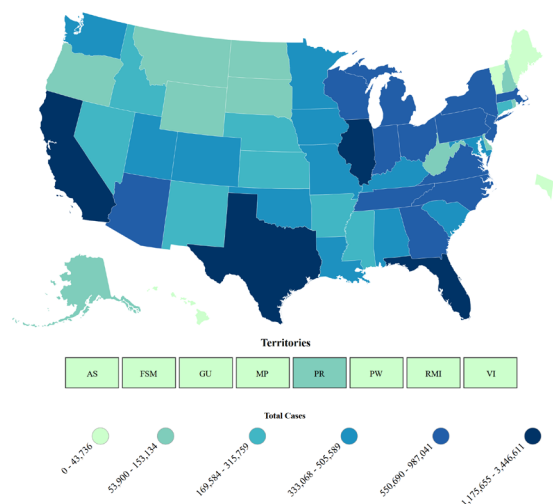
A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

- i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.
- State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

- Total tests reported: 324,226,934
- Positive tests reported: 29,287,282
- Percent of positive tests: 9%

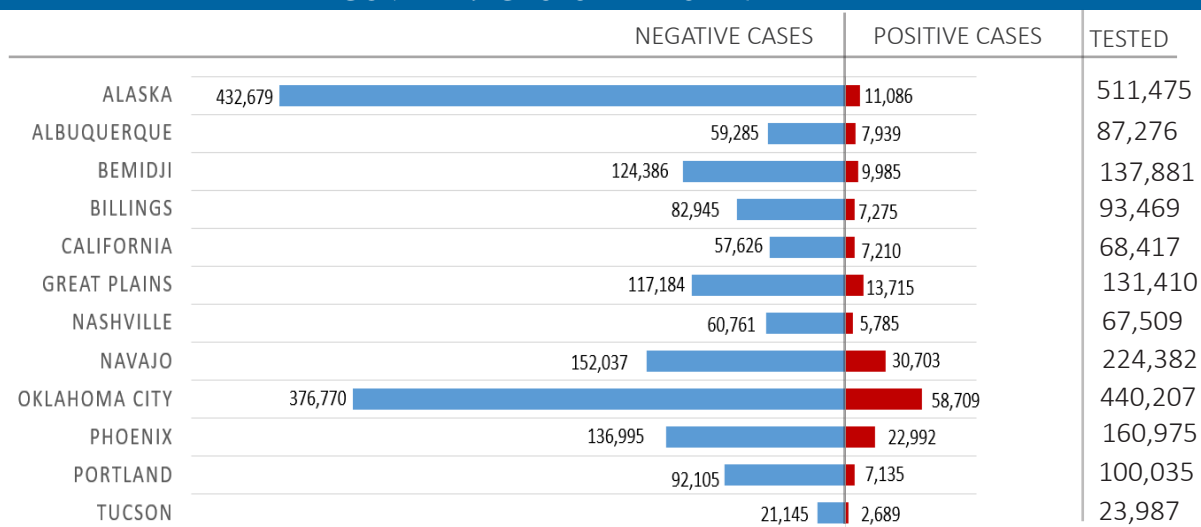

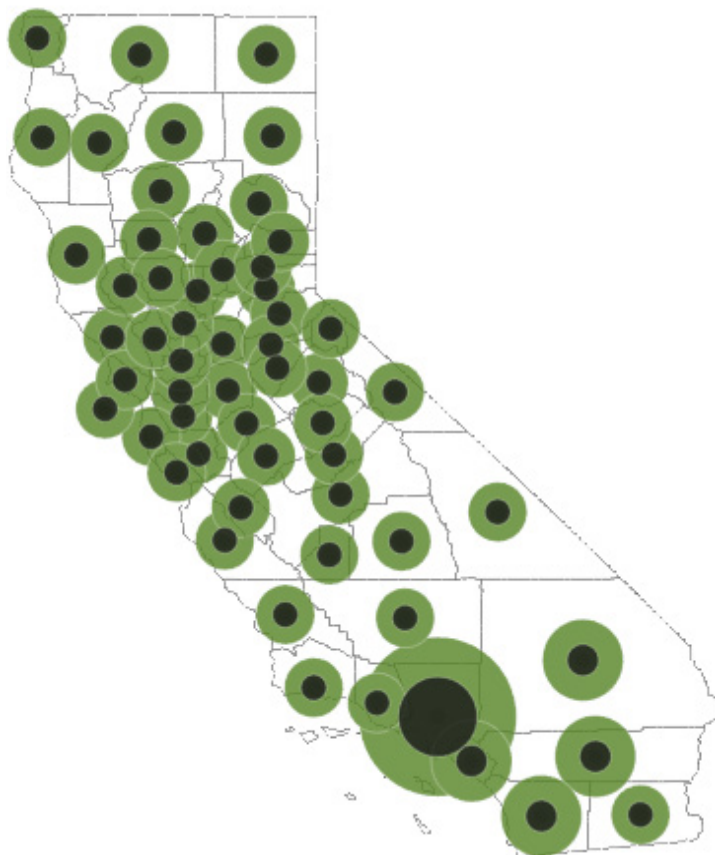

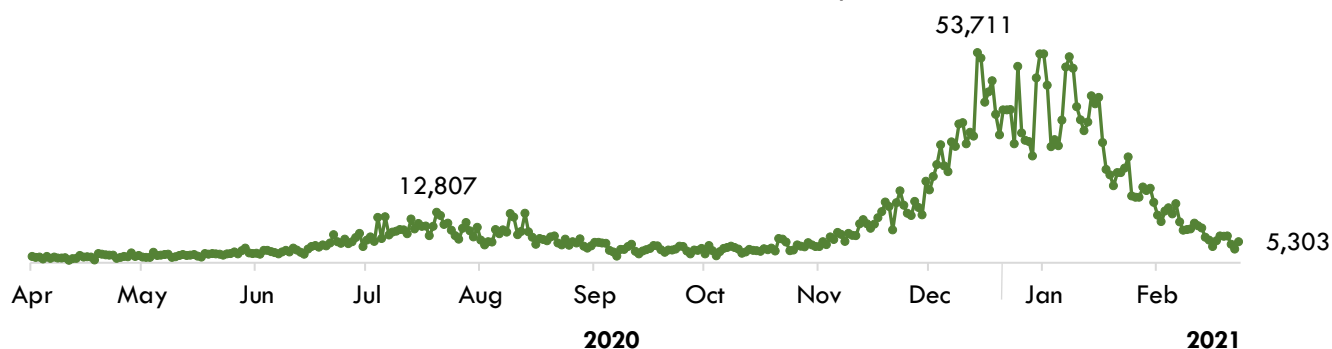

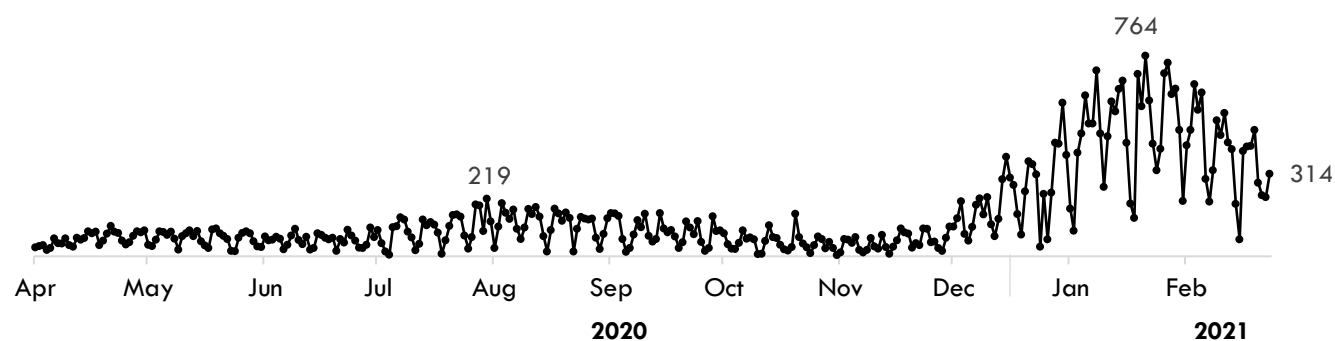

### New Confirmed Cases in California by Date



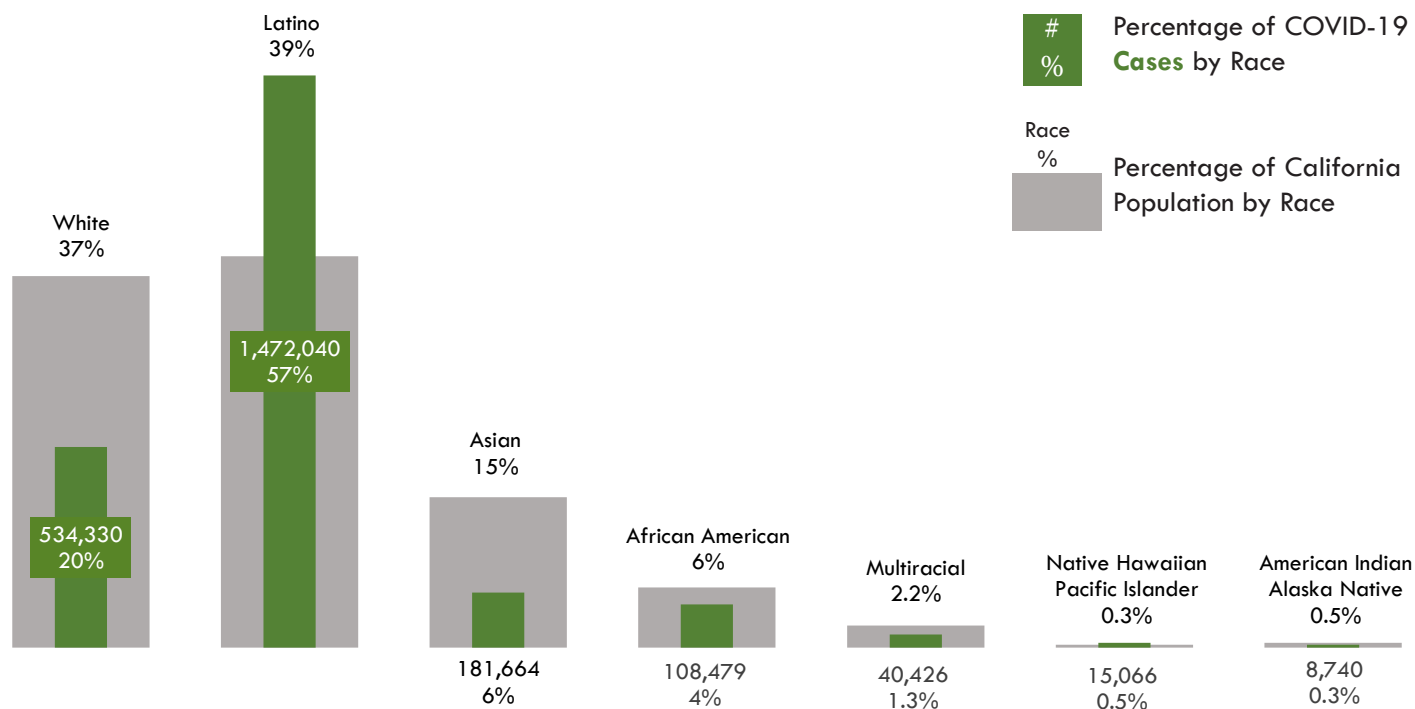
### New Confirmed Deaths in California by Date



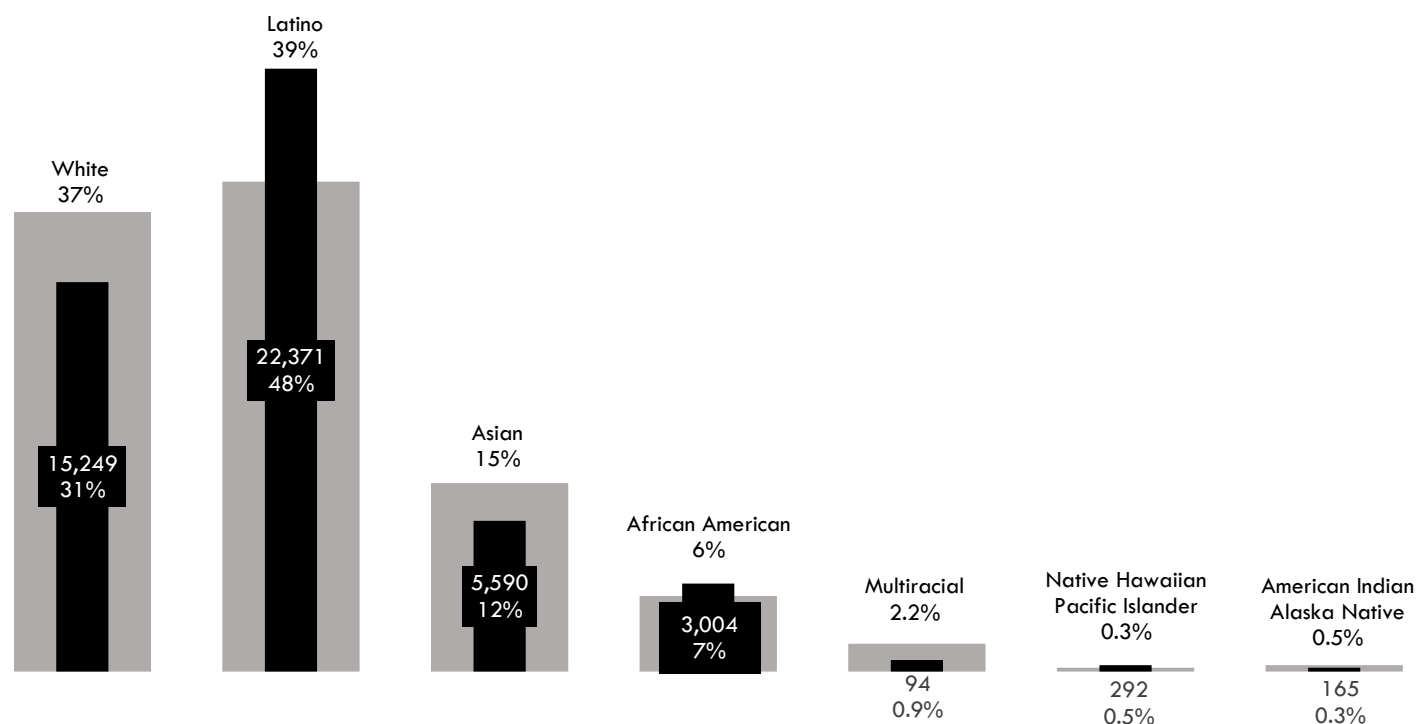

## Racial distribution of confirmed COVID-19 cases and deaths in California

American Indians and Alaska Natives account for 0.5% percent of the population, **0.3% of COVID-19 cases**, and **0.3% of deaths** in California. This includes a total of **8,740 cases** and **165 deaths** among American Indian and Alaska Native people in California.



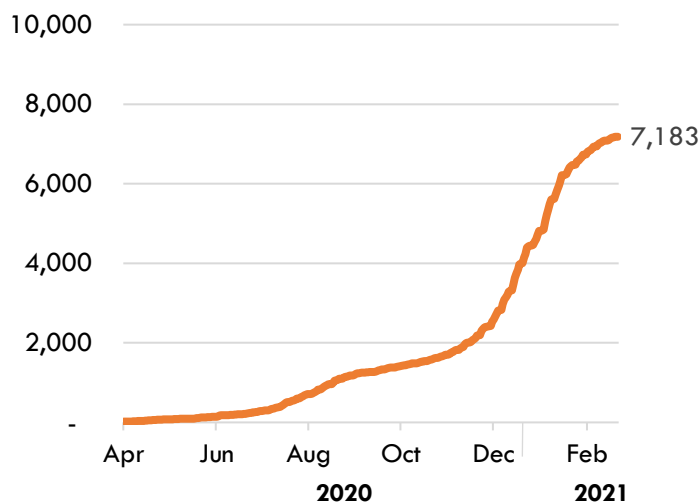

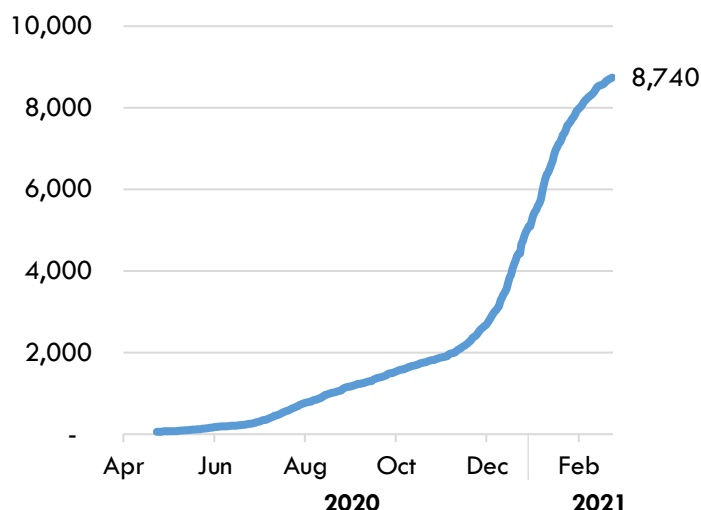

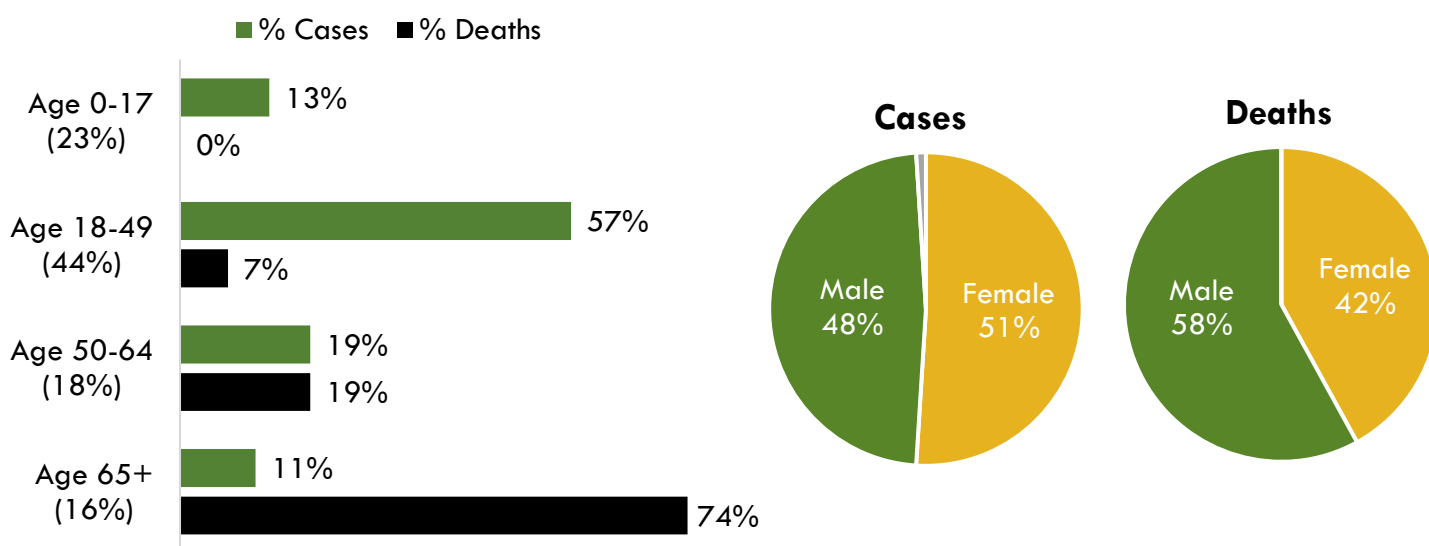

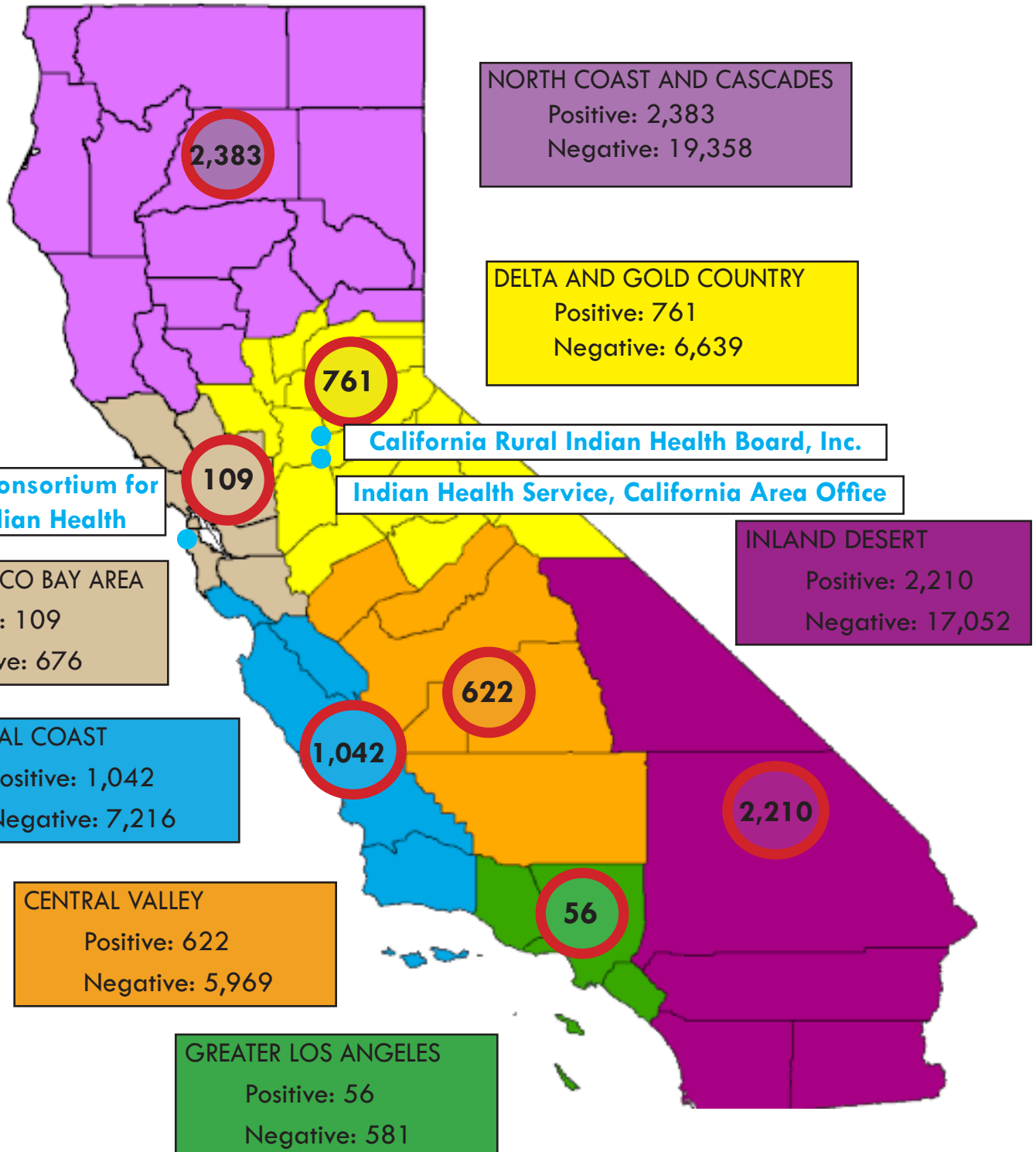

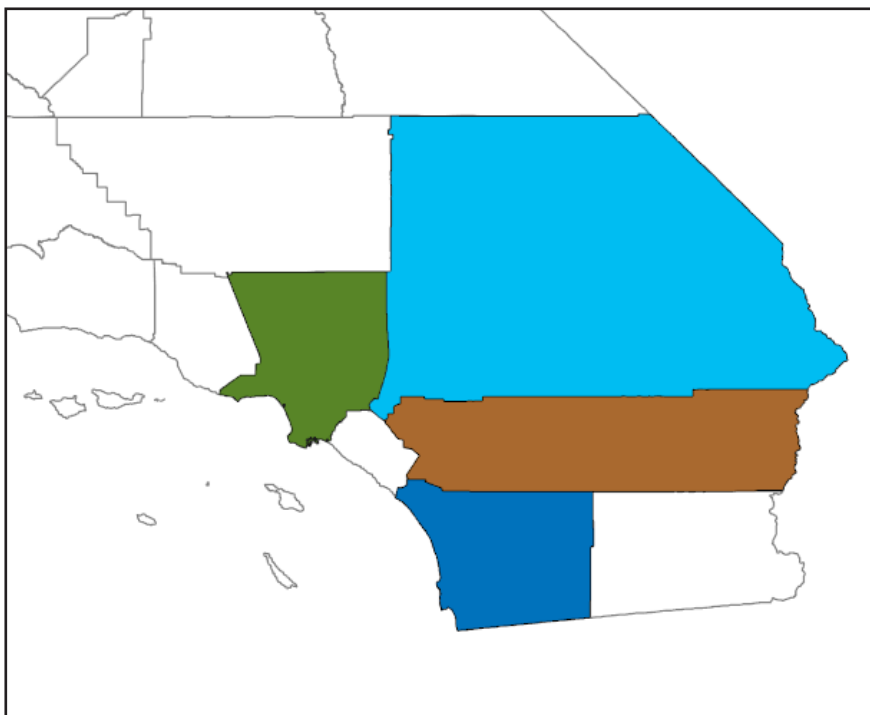

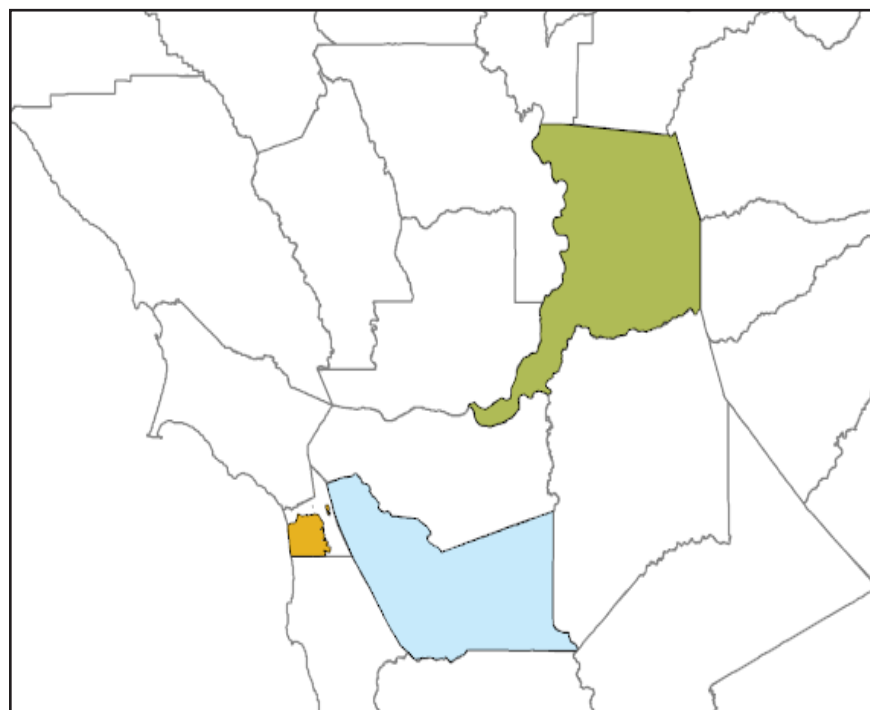

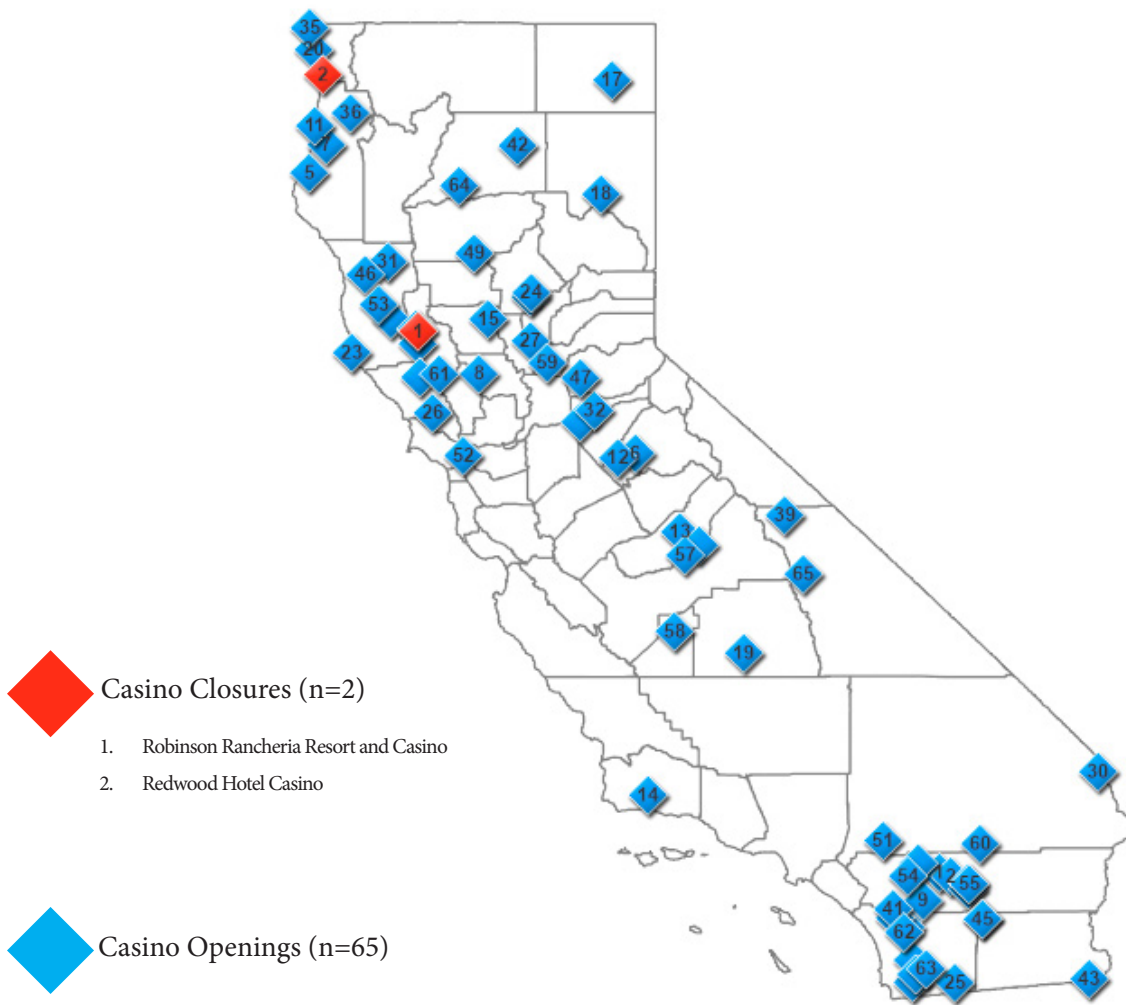
