DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 114.1 million with more than 2.5 million deaths.

In the United States, the total number of cases stands at 28,456,860 and deaths at 513,122.

On February 27, Food and Drug Administration (FDA) approved an Emergency Use Authorization (EUA) for the Janssen (Johnson & Johnson) COVID-19 Vaccine and on February 28, Janssen's single-dose COVID-19 vaccine was unanimously recommended by the Center for Disease Control and Prevention's (CDC) Advisory Committee on Immunization Practices. COVID-19: U.S. at a Glance*

- Total cases: 28,456,860
- Total deaths: 513,122
- Jurisdictions reporting cases: 55 (50 states, District of Columbia, Guam, Puerto Rico, the Northern Mariana Islands, and the U.S. Virgin Islands)

*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020.

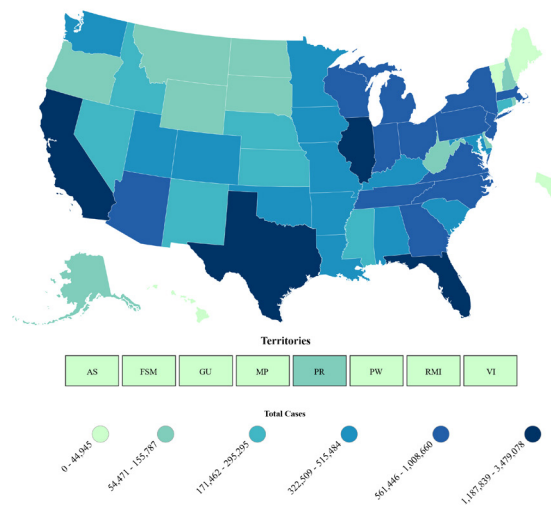
A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

- i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.
- State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

- Percent of positive tests: 8.9%

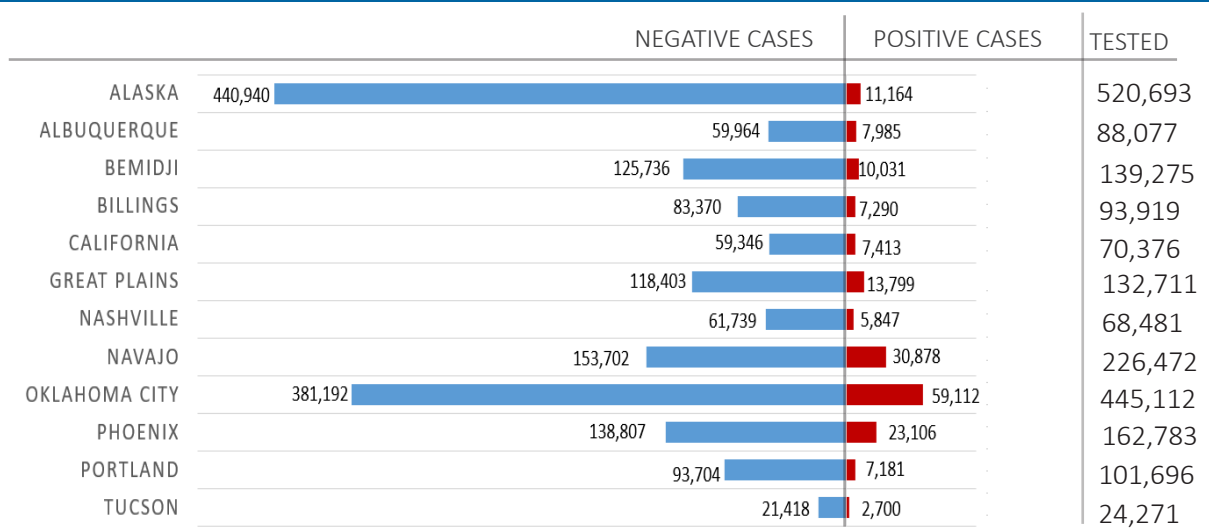

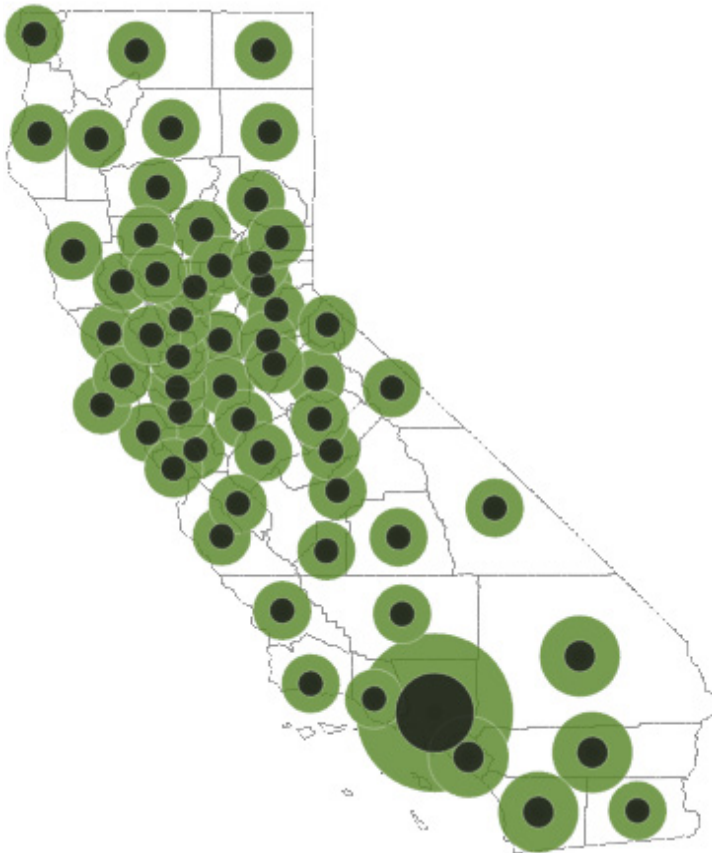

Of these, 7,413 patients have tested positive for COVID-19 and 59,346 have tested negative for COVID-19.

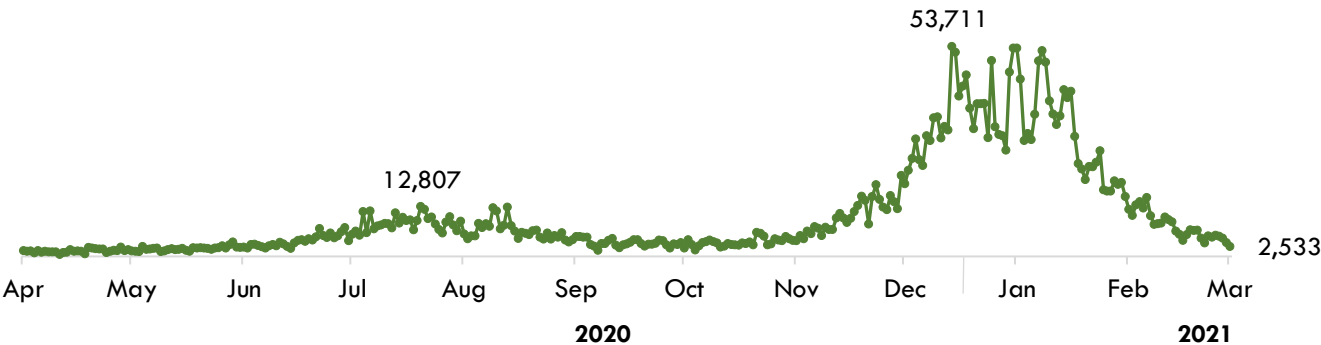

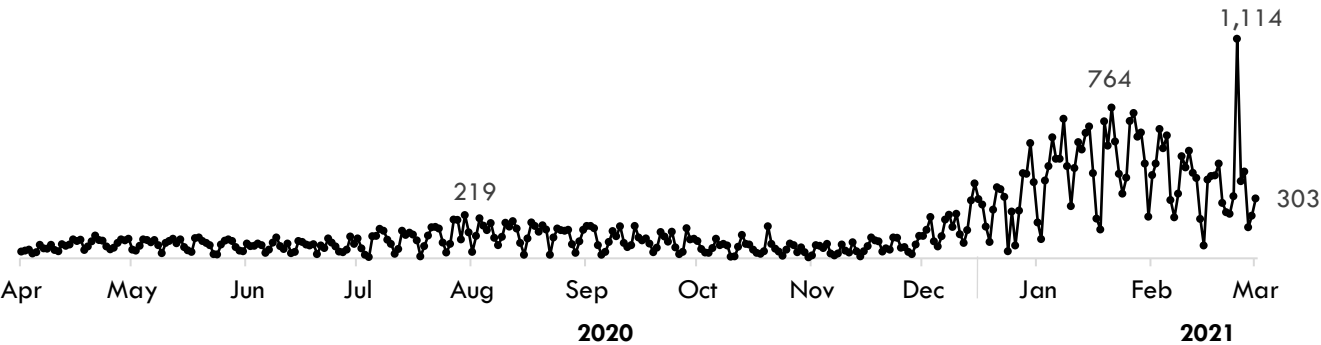

New Confirmed Cases in California by Date



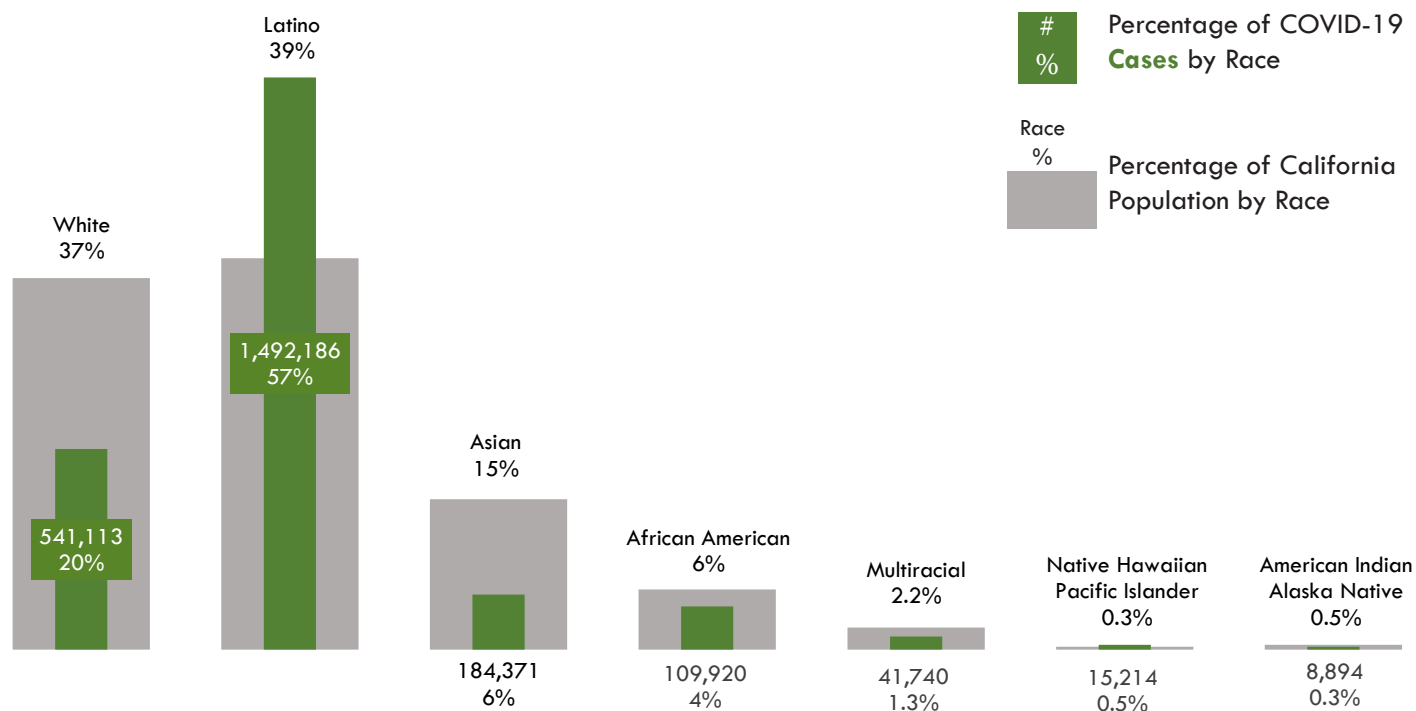
New Confirmed Deaths in California by Date



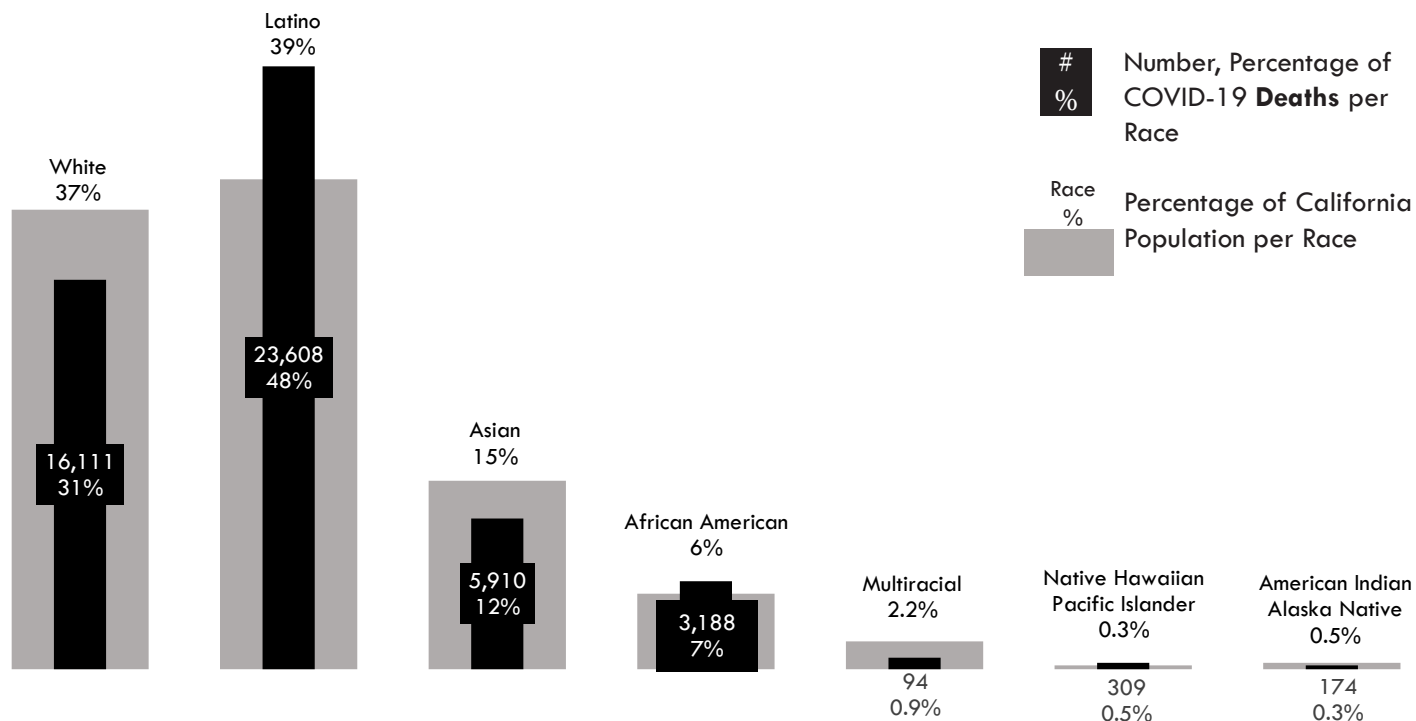

Racial distribution of confirmed COVID-19 cases and deaths in California

American Indians and Alaska Natives account for 0.5% percent of the population, **0.3% of COVID-19 cases**, and **0.3% of deaths** in California. This includes a total of **8,894 cases** and **174 deaths** among American Indian and Alaska Native people in California.



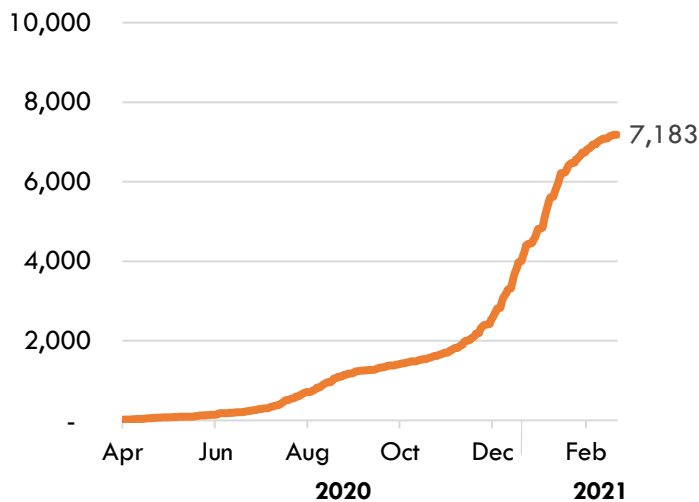

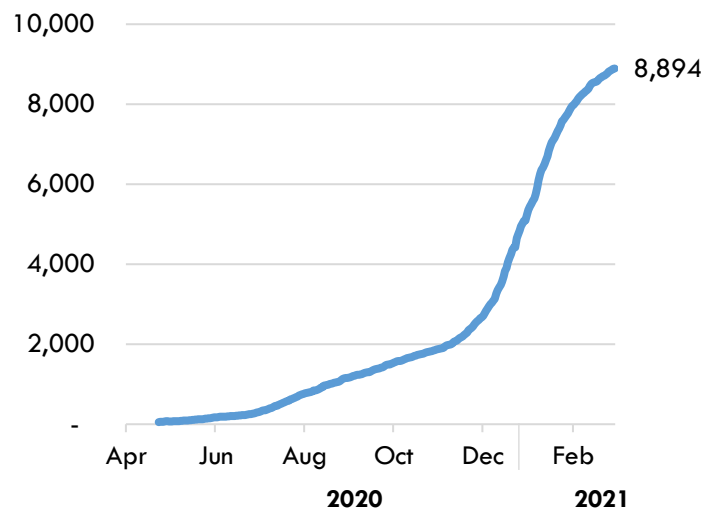

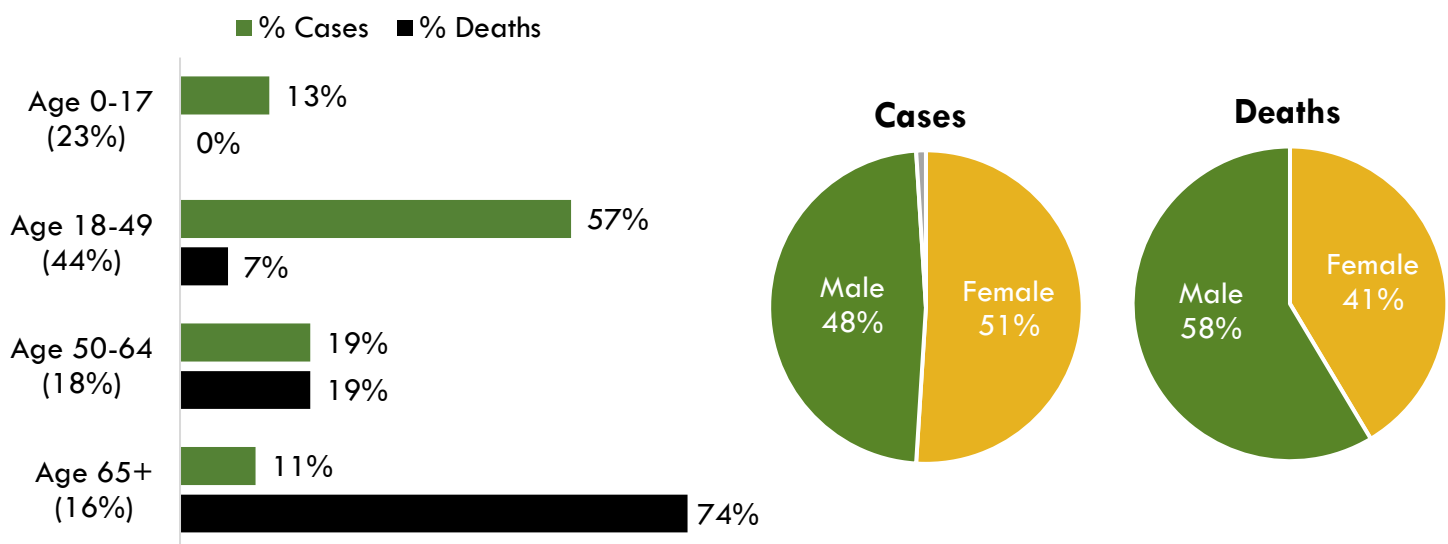

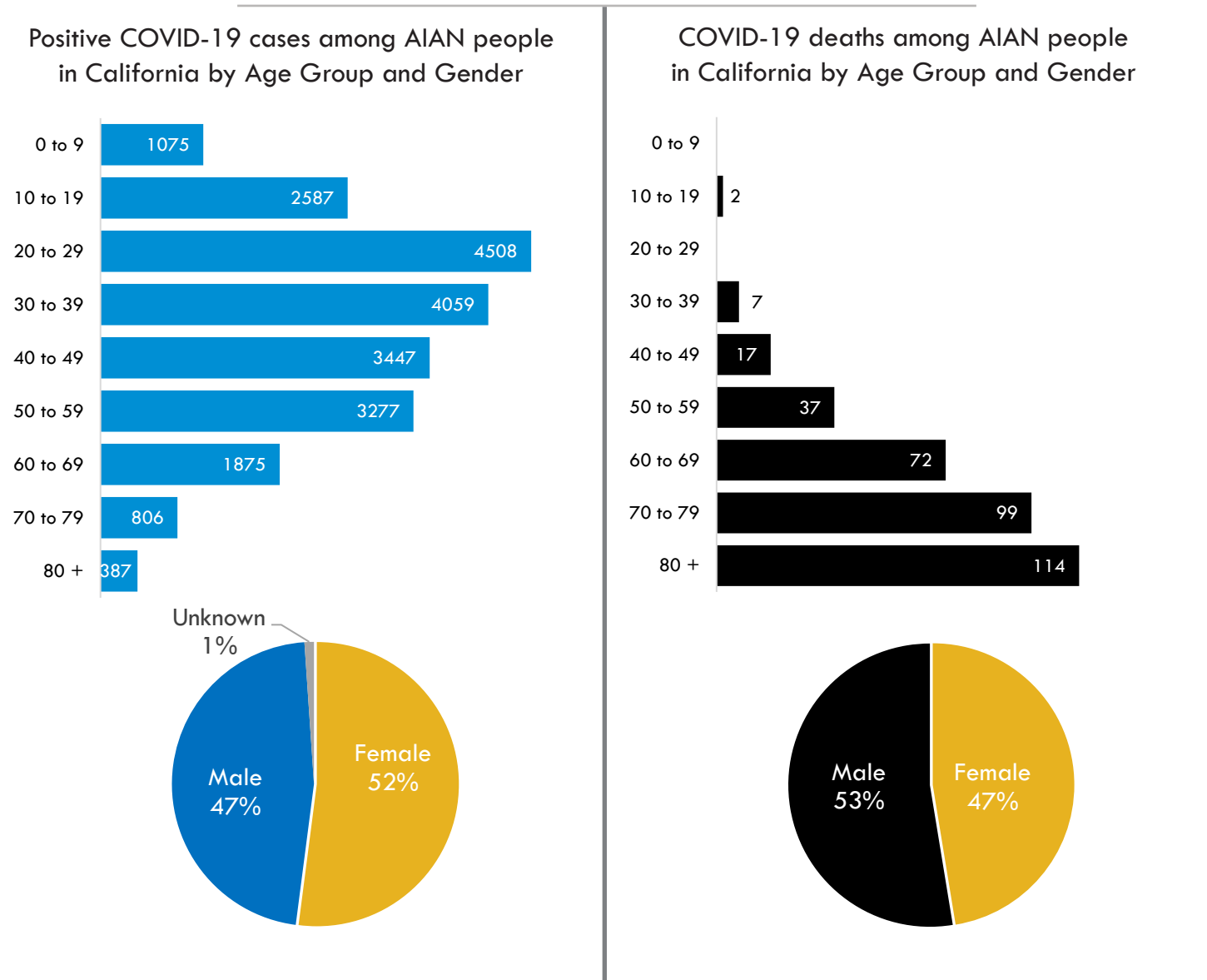

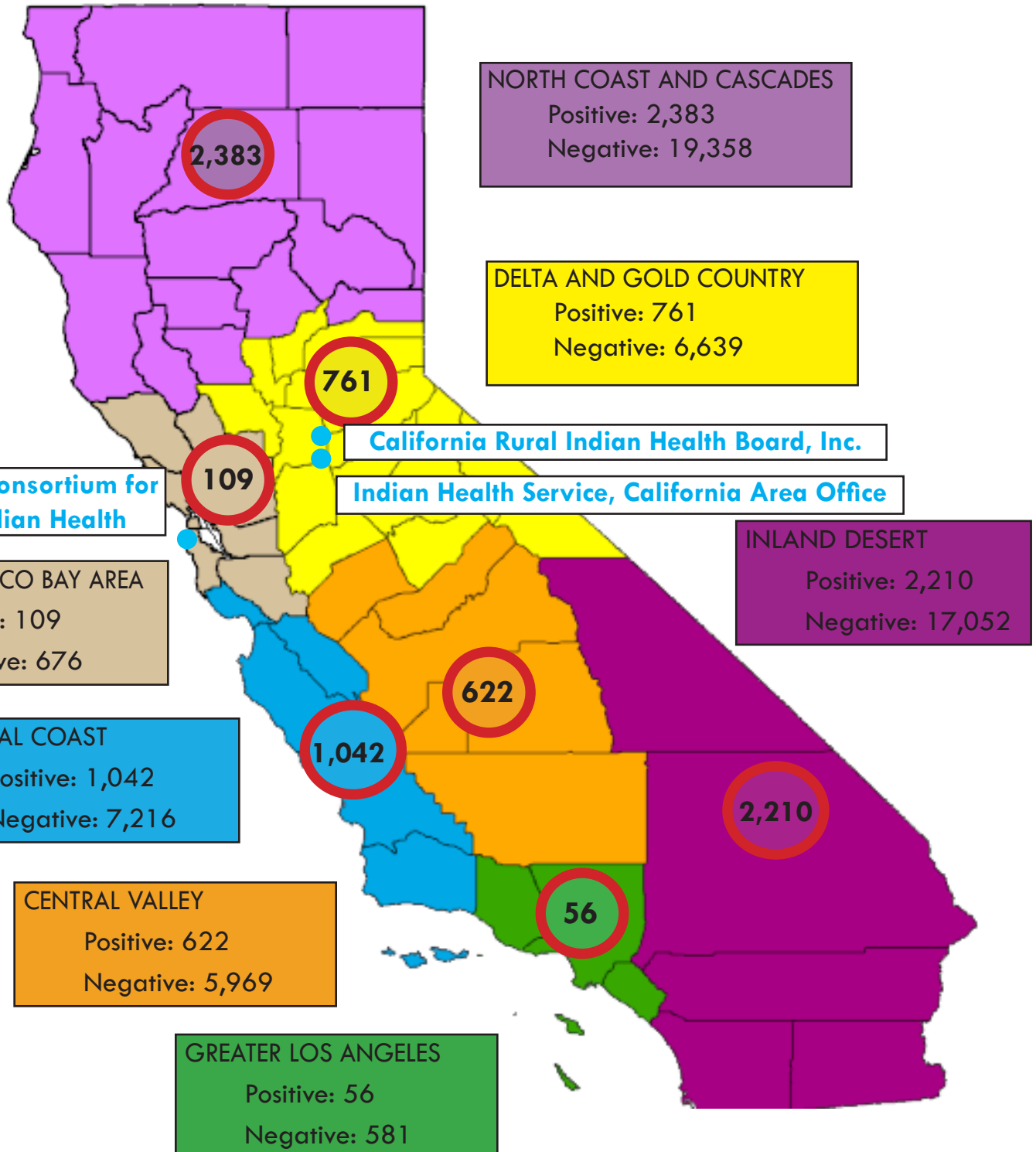

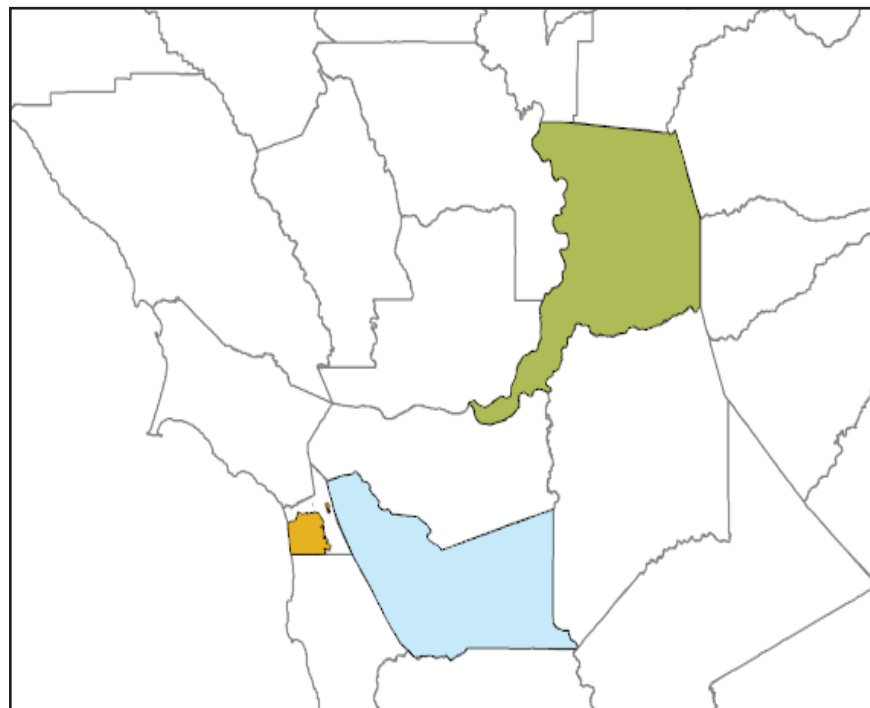

Tribes Issuing Shelter in Place Order

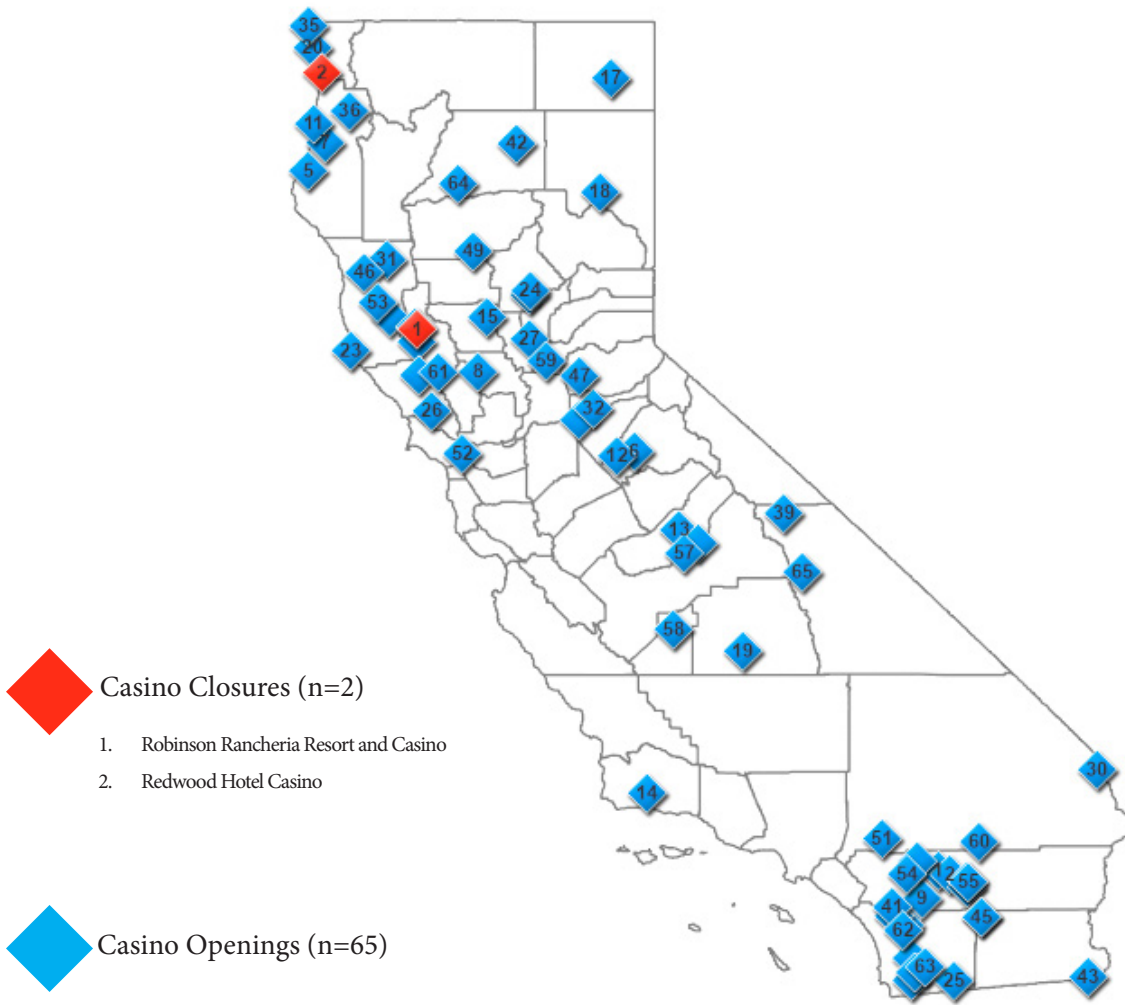
