DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 116.8 million with more than 2.5 million deaths.

In the United States, the total number of cases stands at 28,937,762 and deaths at 524,695.

The Centers for Disease Control and Prevention (CDC), in partnership with Boston Children's Hospital and Castlight Health, is launching a new tool that allows Americans to search for COVID-19 vaccine providers with stock of vaccine where they live. COVID-19: U.S. at a Glance*

- Total cases: 28,937,762
- Total deaths: 524,695
- Jurisdictions reporting cases: 55 (50 states, District of Columbia, Guam, Puerto Rico, the Northern Mariana Islands, and the U.S. Virgin Islands)

*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

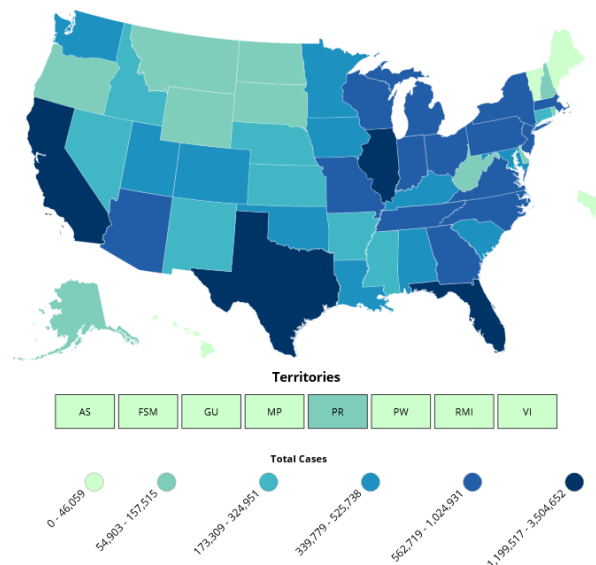
A probable case or death is defined by:

- i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.
- State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

Total Number of COVID-19 Cases in the US Reported to the CDC, by State/Territory

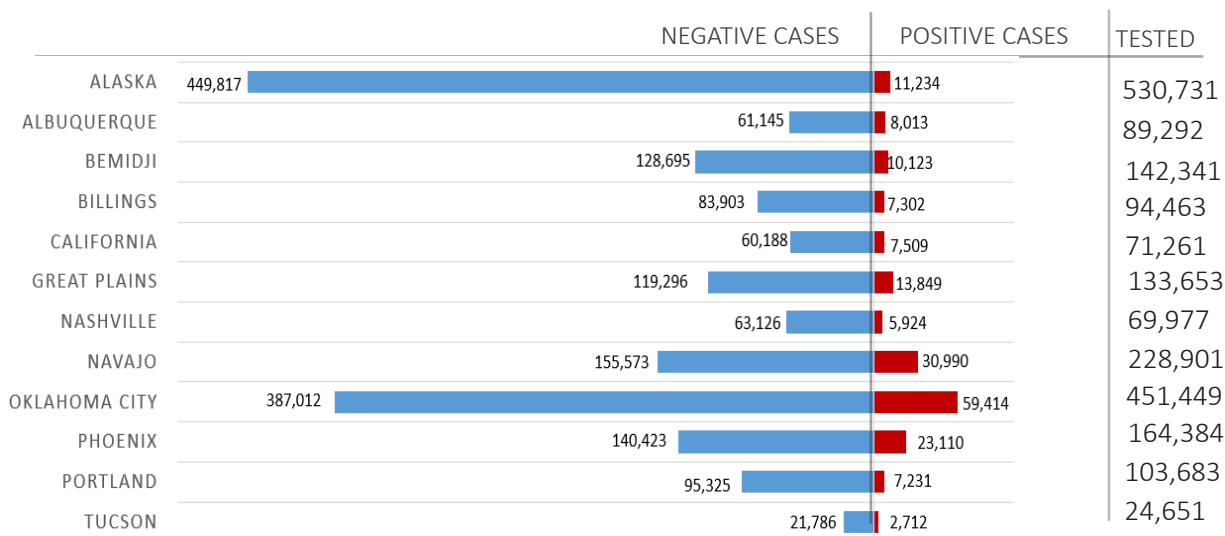

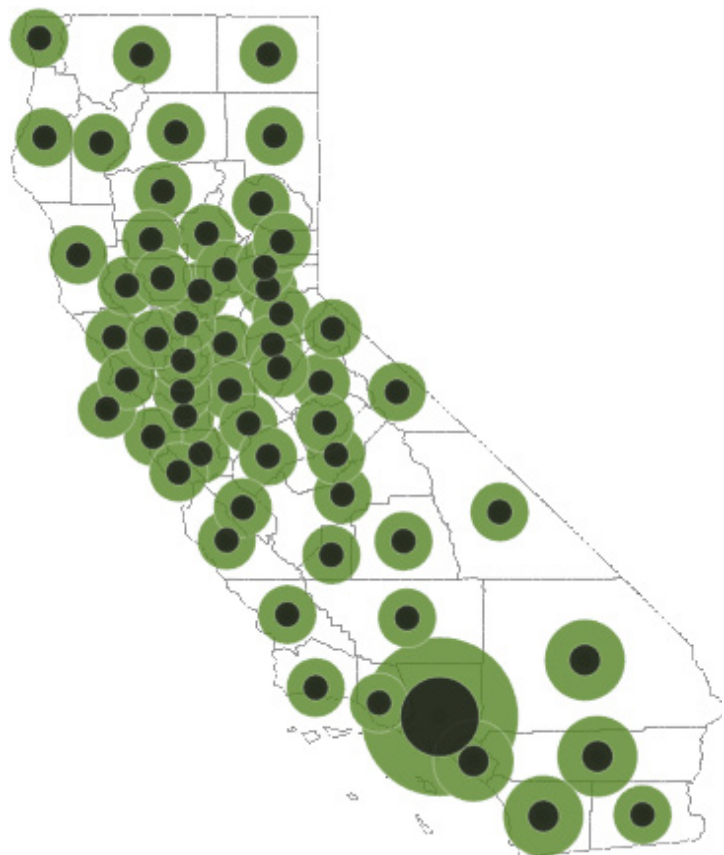

71,261 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 3/7/2021.

Of these, 7,509 patients have tested positive for COVID-19 and 60,188 have tested negative for COVID-19.

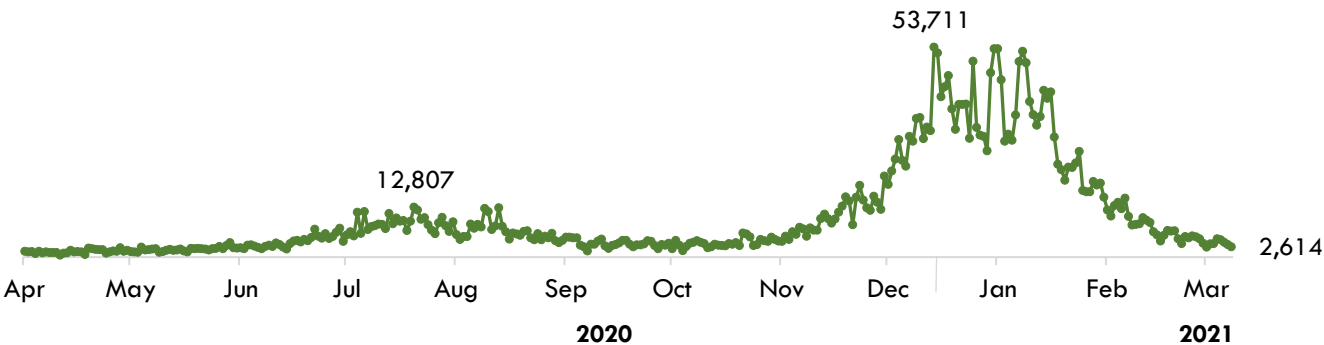

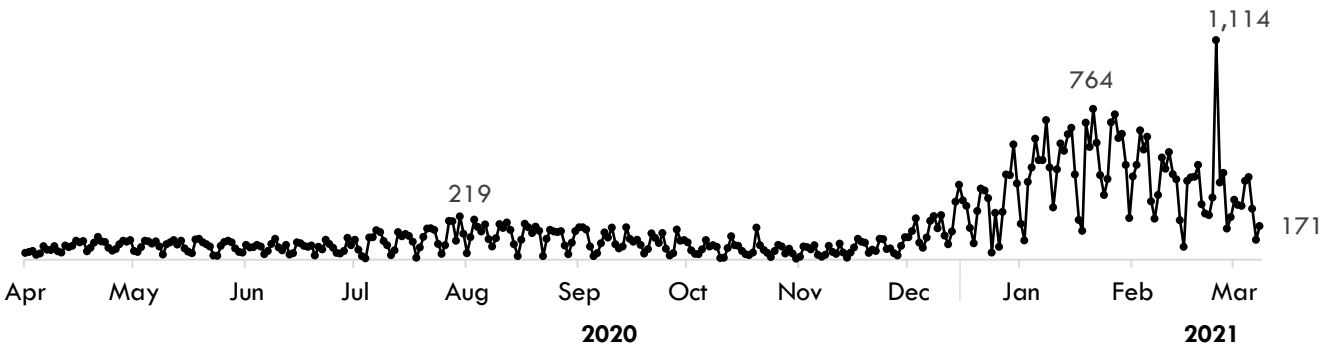

New Confirmed Cases in California by Date



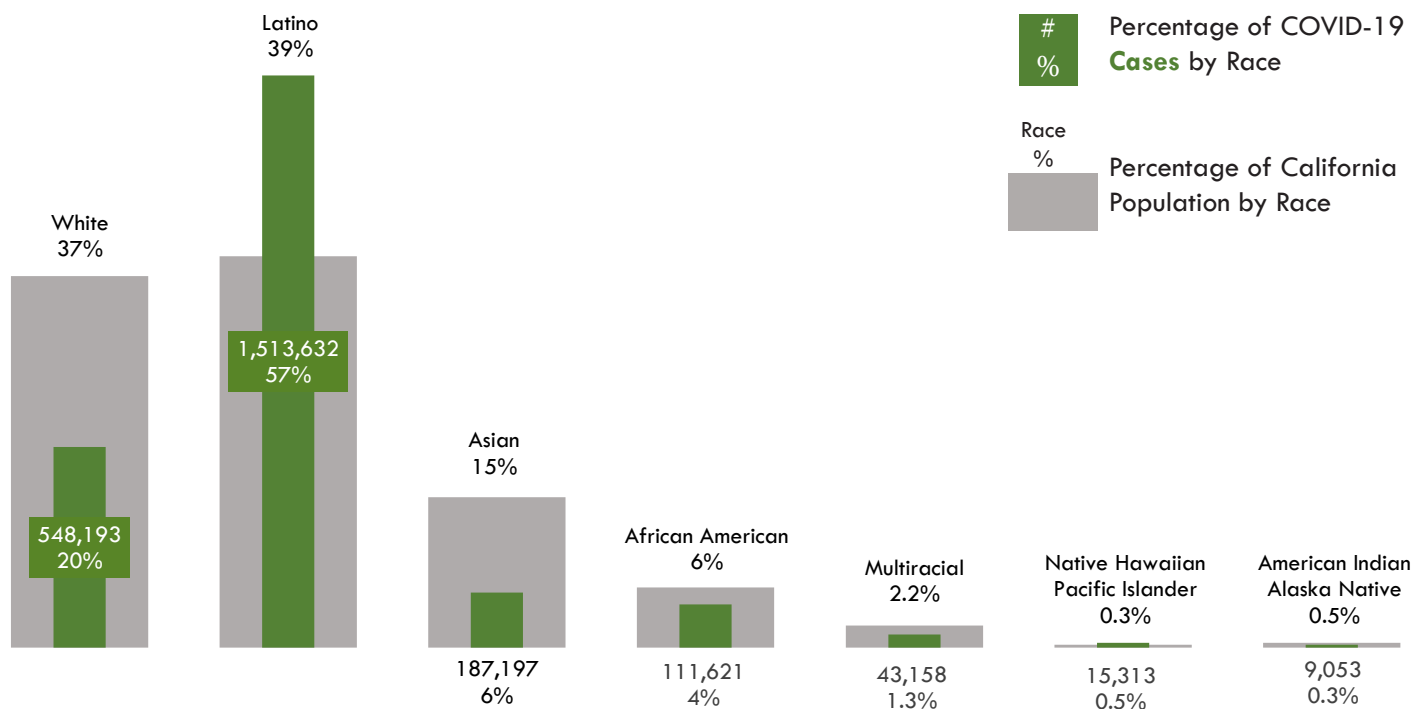
New Confirmed Deaths in California by Date



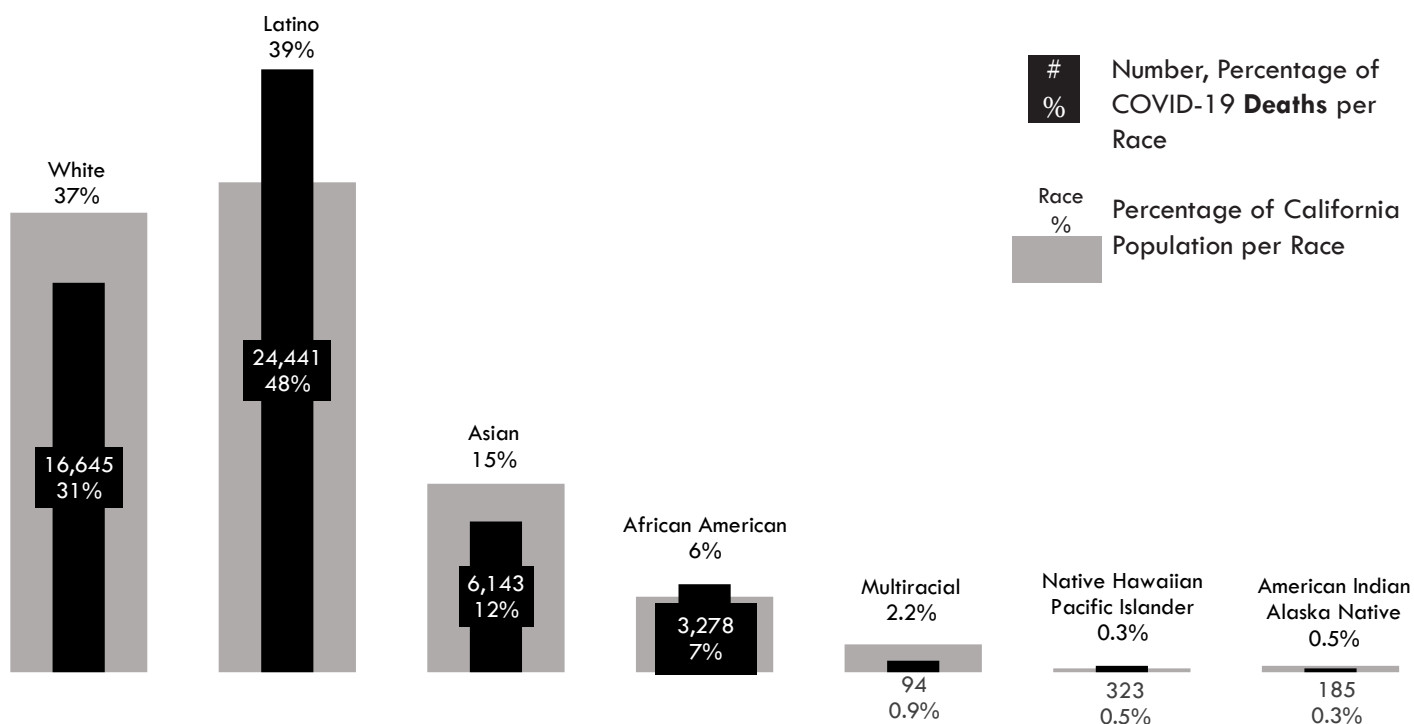

Racial distribution of confirmed COVID-19 cases and deaths in California

American Indians and Alaska Natives account for 0.5% percent of the population, **0.3% of COVID-19 cases**, and **0.3% of deaths** in California. This includes a total of **9,053 cases** and **185 deaths** among American Indian and Alaska Native people in California.



California Department of Public Health has nearly complete data on race and ethnicity for COVID-19 deaths, and are reporting the following trends: Latinos, African Americans and Native Hawaiians and Pacific Islanders are dying at disproportionately higher levels.

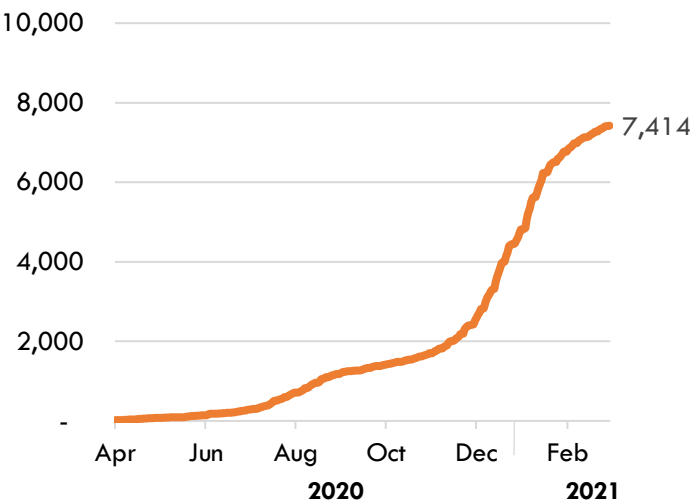

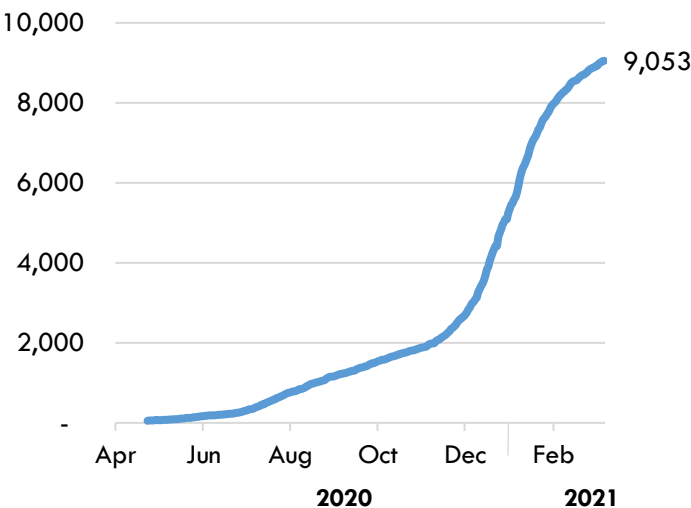

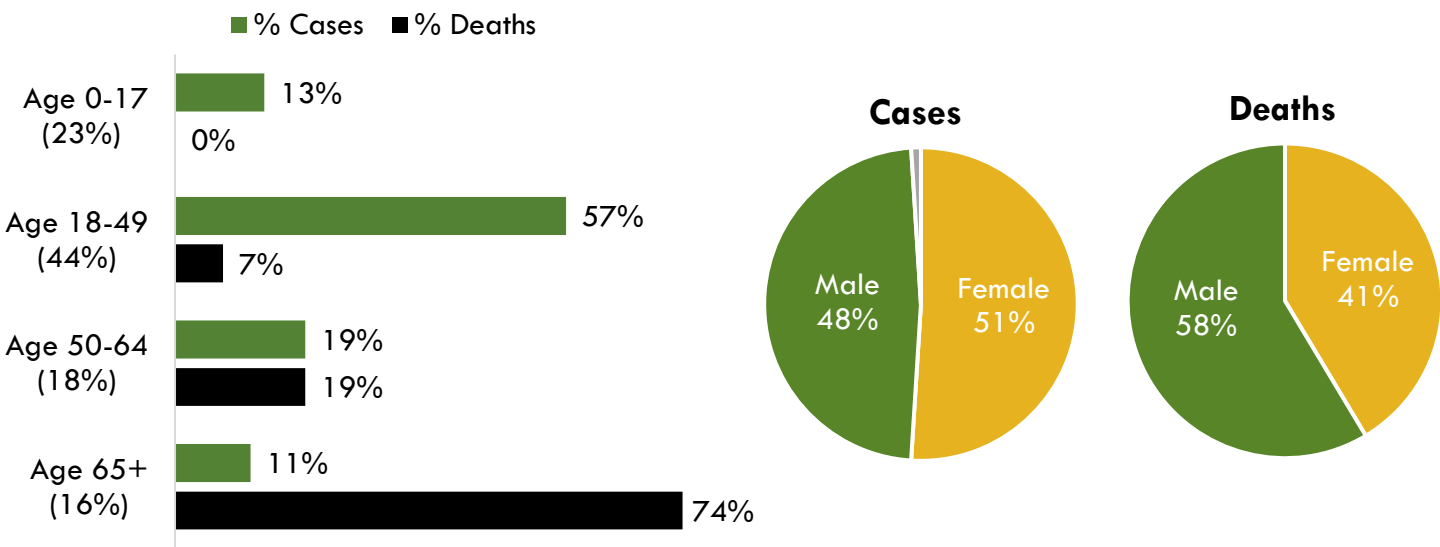

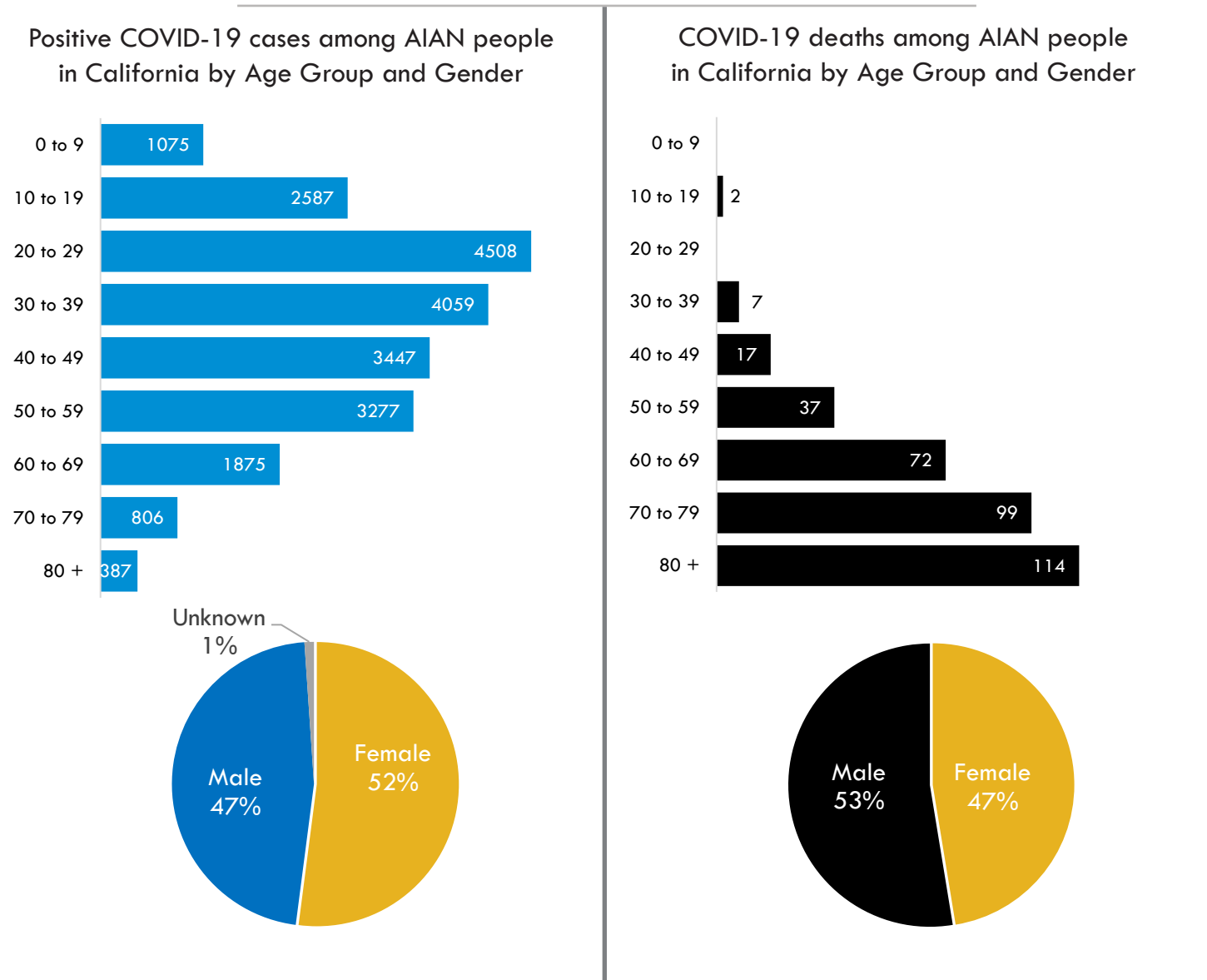

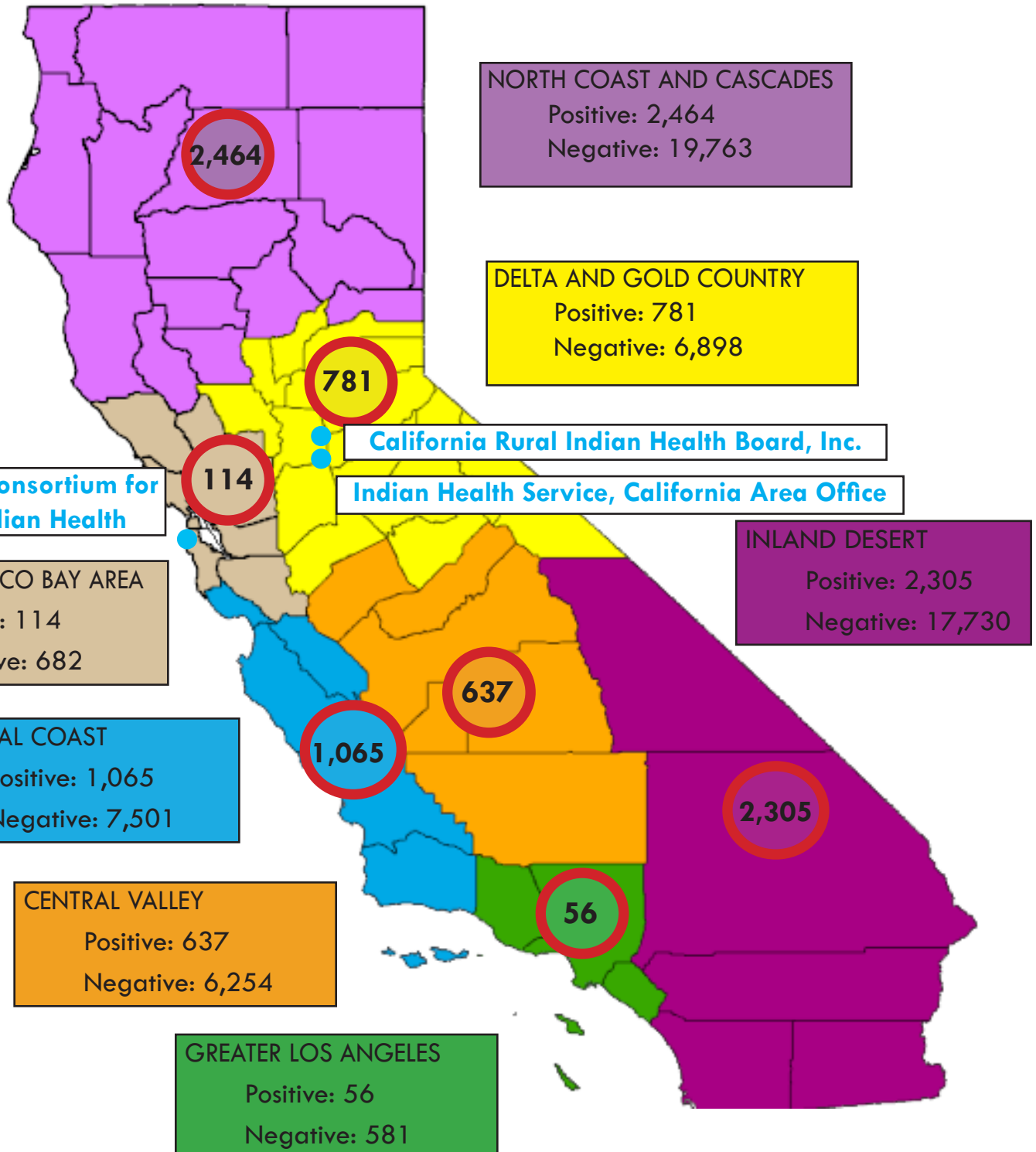

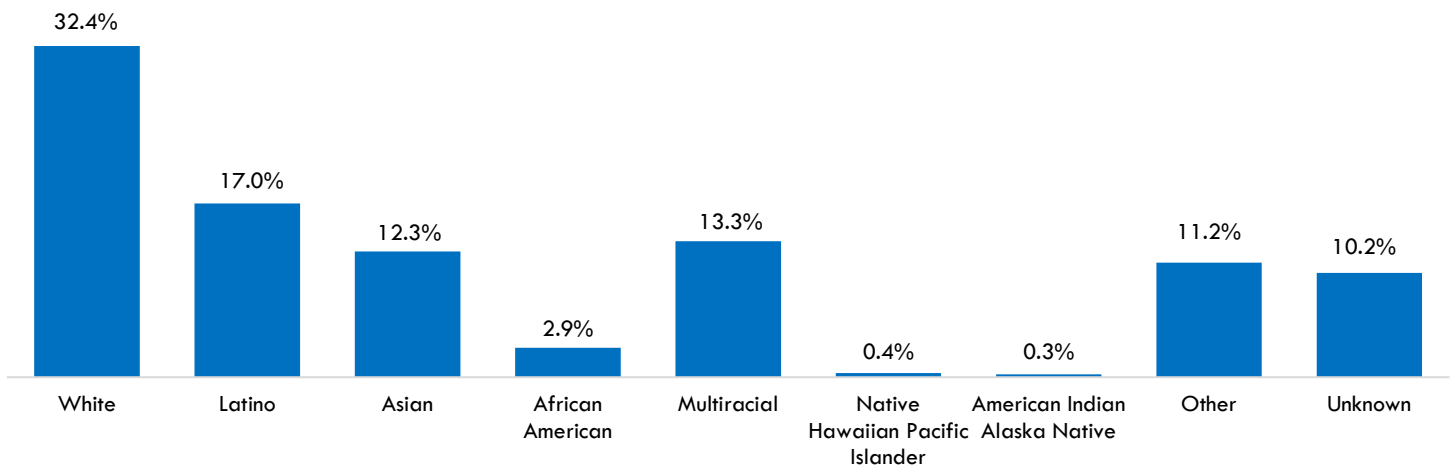

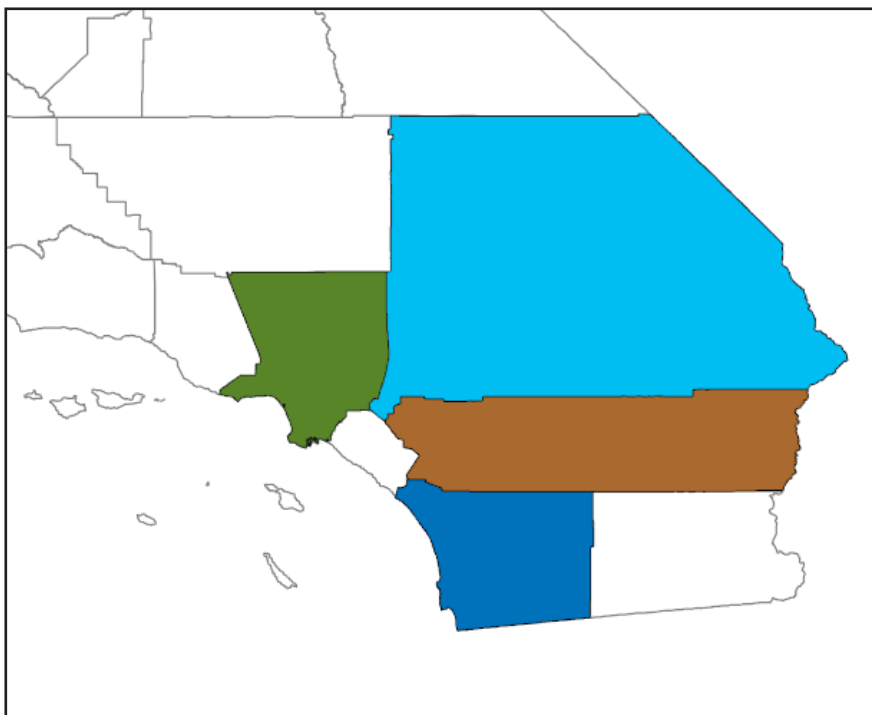

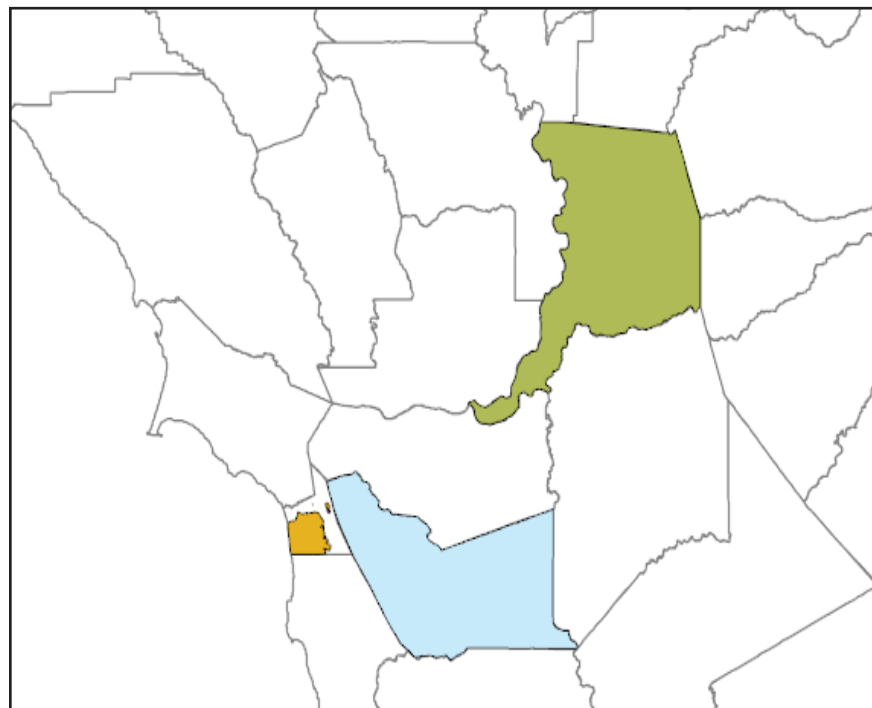

Tribes Issuing Shelter in Place Order

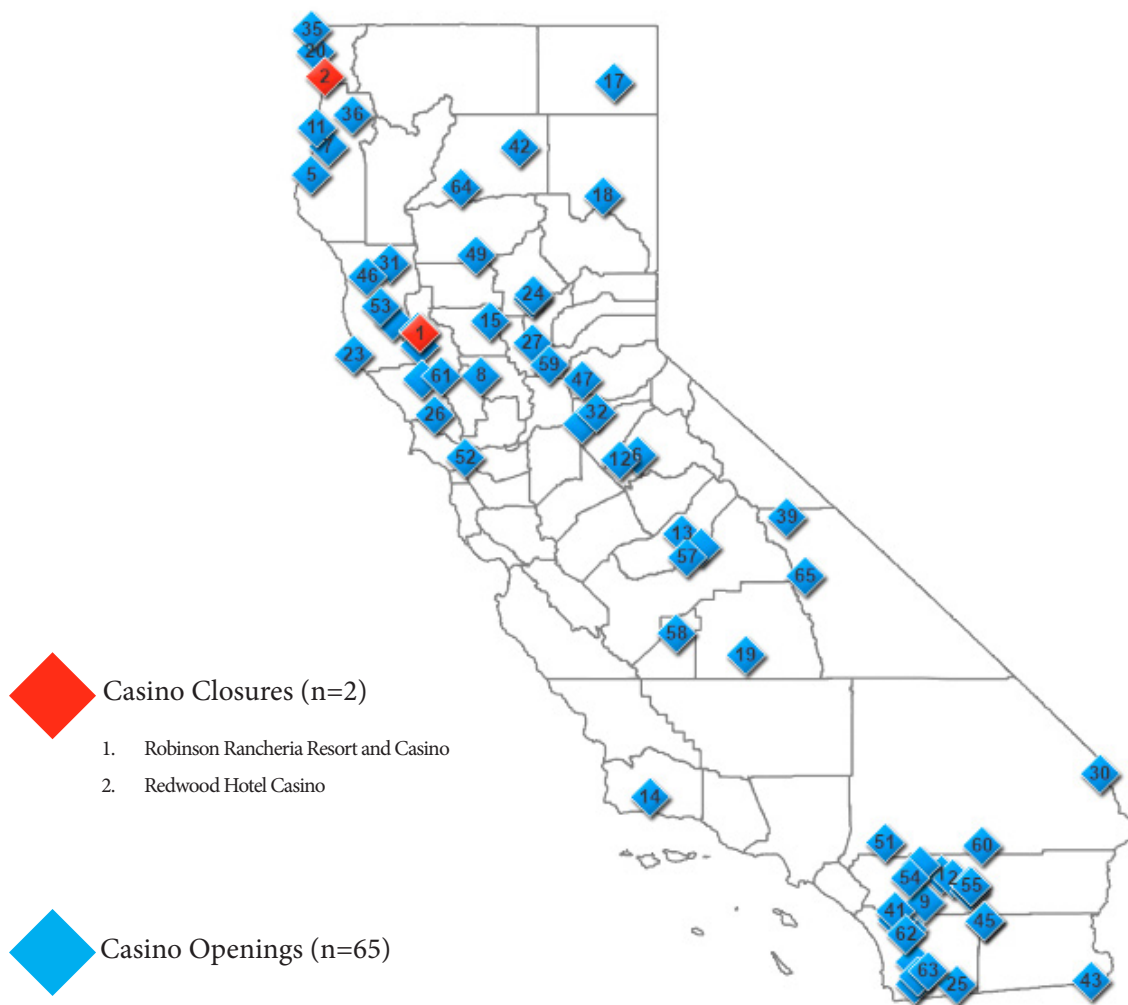
