

CORONAVIRUS DISEASE 2019 (COVID-19) SITUATIONAL REPORT #249 MARCH 11, 2021



DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 117.7 million with more than 2.6 million deaths.

In the United States, the total number of cases stands at 29,052,862 and deaths at 527,726.

The Centers for Disease Control and Prevention (CDC) has released their Morbidity and Mortality Weekly Report (MMWR) for March 10. It was found that disparities in COVID-19 incidence were substantial during January-April and generally decreased during May-December, largely because of a greater increase in incidence among White persons. The largest persistent disparities involved Native Hawaiian and Pacific Islander, American Indian or Alaska Native (AIAN), and Hispanic persons. From January 1-April 30, 2020, AIAN were 4.62 times more likely to get COVID-19 than non-Hispanic Whites. The full report is available HERE.

The CDC, in partnership with Boston Children's Hospital and Castlight Health, is launching a new tool that allows Americans to search for COVID-19 vaccine providers with stock of vaccine where they live. COVID-19: U.S. at a Glance*

- Total cases: 29,052,862
- Total deaths: 527,726
- Jurisdictions reporting cases: 55 (50 states, District of Columbia, Guam, Puerto Rico, the Northern Mariana Islands, and the U.S. Virgin Islands)

*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.


A probable case or death is defined by:

i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID19. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

Total Number of COVID-19 Cases in the US Reported to the CDC, by State/Territory



As of March 10, 2021, there were a total of 3,516,862 positive cases and 54,891 deaths in California.

INDIAN HEALTH SERVICE CALIFORNIA AREA

71,770 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 3/9/2021.

Of these, 7,537 patients have tested positive for COVID-19 and 60,557 have tested negative for COVID-19.












Racial distribution of confirmed COVID-19 cases and deaths in California

American Indians and Alaska Natives account for 0.5% percent of the population, 0.3% of COVID-19 cases, and 0.3% of deaths in California. This includes a total of 9,183 cases and 188 deaths among American Indian and Alaska Native people in California.



California Department of Public Health has nearly complete data on race and ethnicity for COVID-19 deaths, and are reporting the following trends: Latinos, African Americans and Native Hawaiians and Pacific Islanders are dying at disproportionately higher levels.




Two sources for tracking American Indian and Alaska Native (AIAN) cases reported in California






COVID-19 testing information from patients seen at a Tribal or Urban Indian Health Program in California

Note: This map shows patients by the regional location of the clinic where they were tested and NOT by the residence of the patients.








