DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 119.6 million with more than 2.6 million deaths.

In the United States, the total number of cases stands at 29,319,457 and deaths at 533,057.

If you have a medical condition or disability that increases your risk of getting sick with COVID-19, or live or work in high-risk settings, you will be eligible for vaccination starting March 15th. Find out how to check your eligibility [HERE](#).

The Centers for Disease Control and Prevention (CDC) has released their Morbidity and Mortality Weekly Report (MMWR) for March 10. It was found that disparities in COVID-19 incidence were substantial during January-April and generally decreased during May-December, largely because of a greater increase in incidence among White persons. The largest persistent disparities involved Native Hawaiian and Pacific Islander, American Indian or Alaska Native (AIAN), and Hispanic persons. From January 1-April 30, 2020, AIAN were 4.62 times more likely to get COVID-19 than non-Hispanic Whites. The full report is available [HERE](#).

COVID-19: U.S. at a Glance*

- Total cases: 29,319,457
- Total deaths: 533,057
- Jurisdictions reporting cases: 55 (50 states, District of Columbia, Guam, Puerto Rico, the Northern Mariana Islands, and the U.S. Virgin Islands)

*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

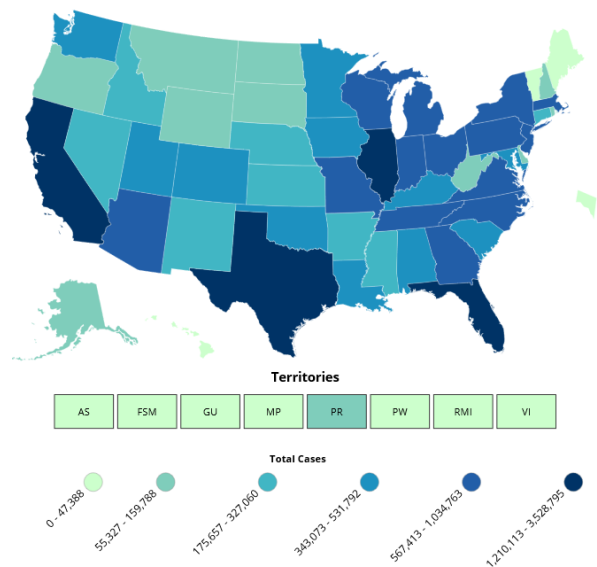
A probable case or death is defined by:

- i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.
- State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

Total Number of COVID-19 Cases in the US Reported to the CDC, by State/Territory

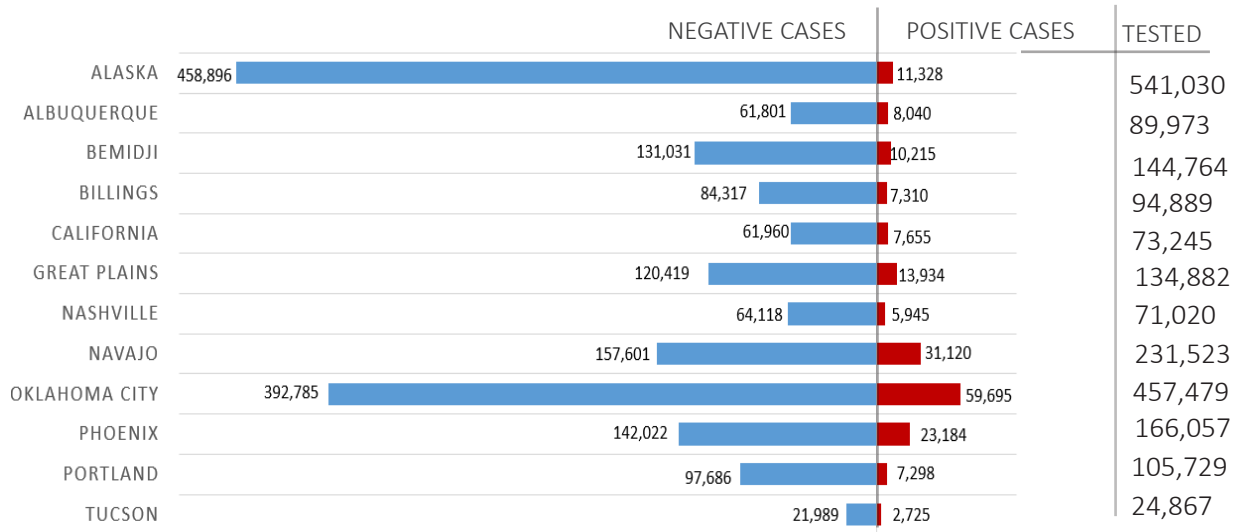

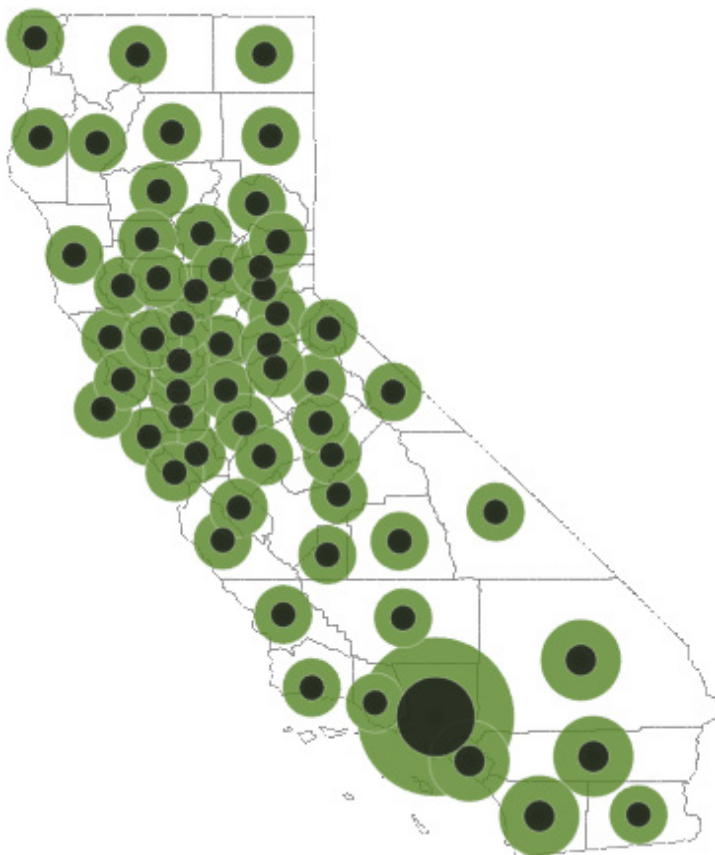

73,245 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 3/14/2021.

Of these, 7,655 patients have tested positive for COVID-19 and 61,960 have tested negative for COVID-19.

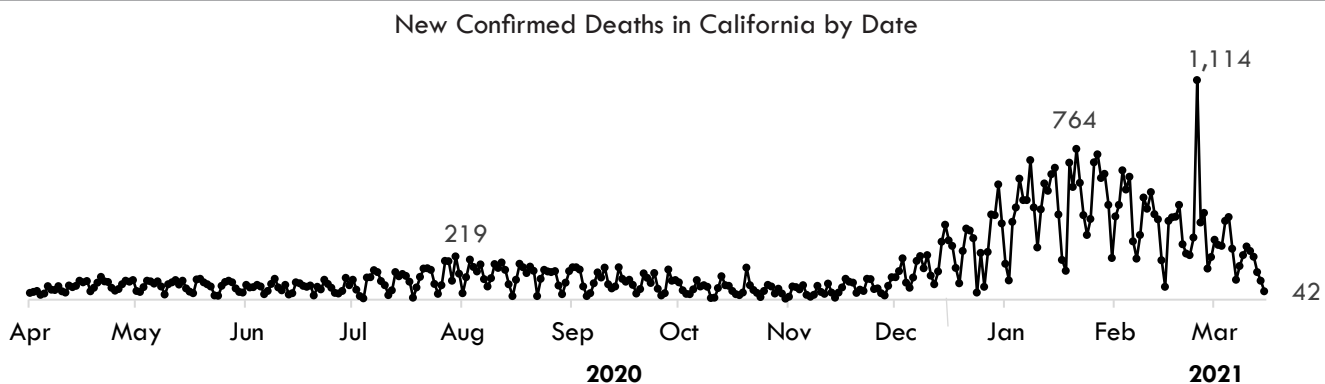
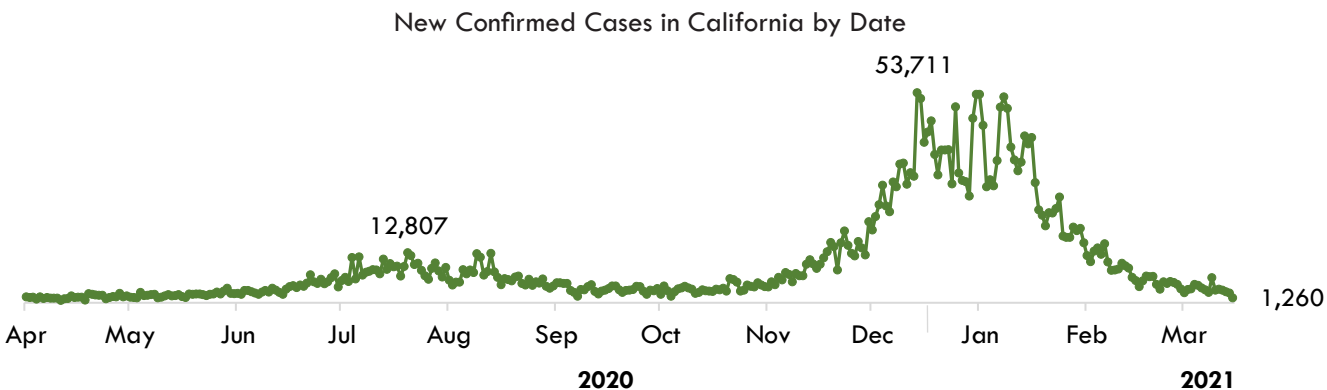

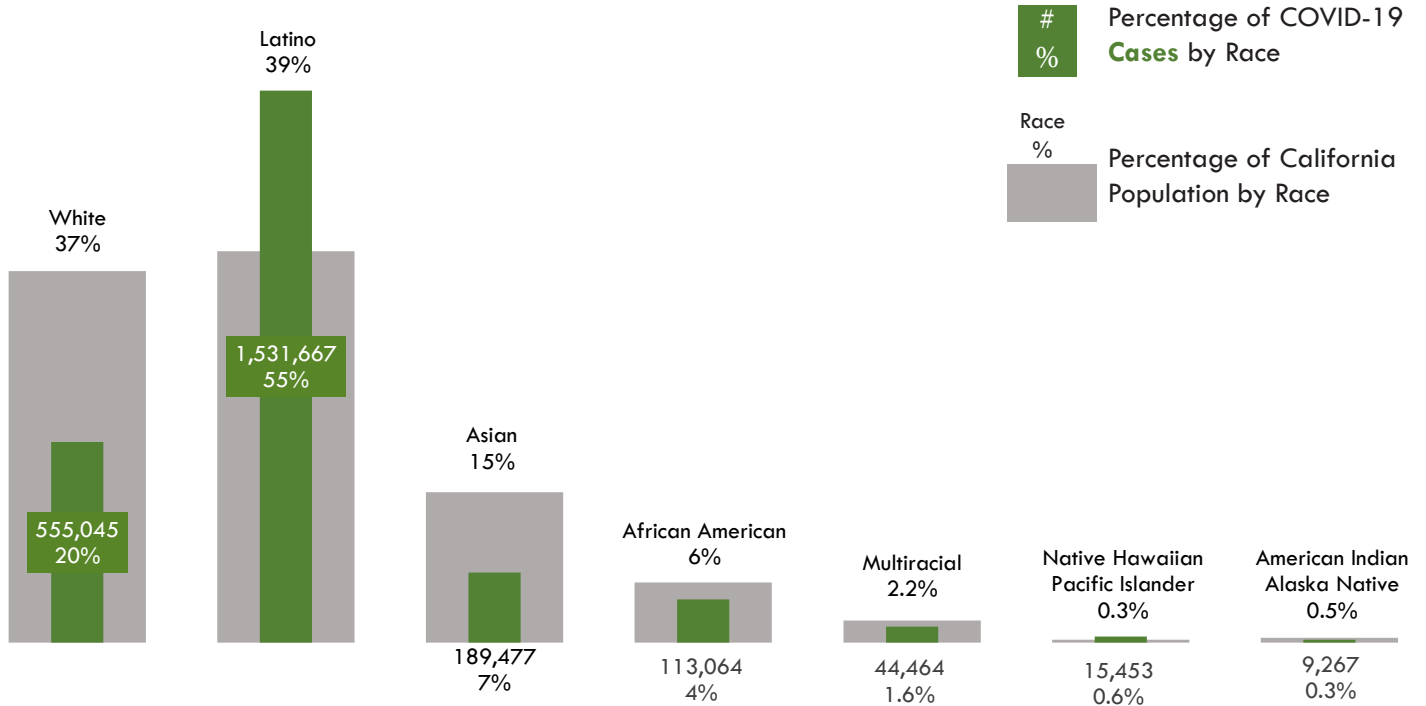

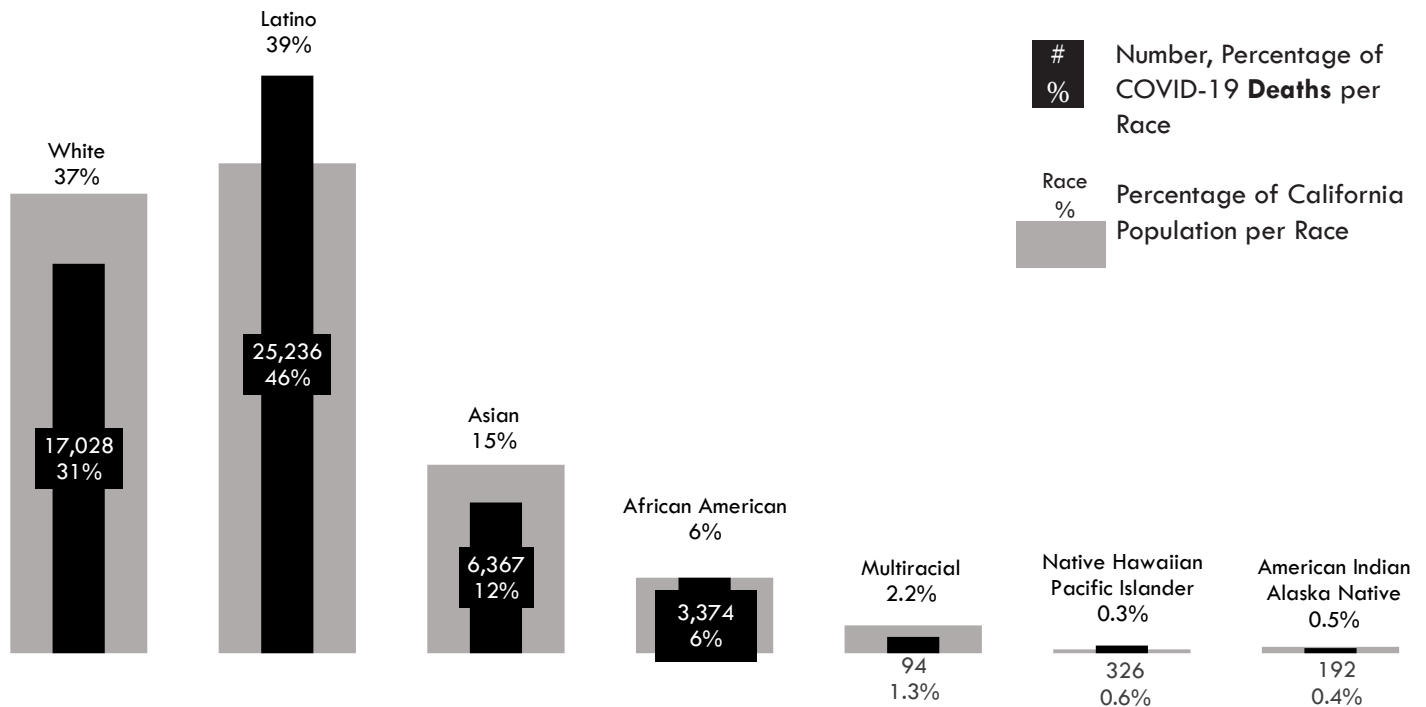

Racial distribution of confirmed COVID-19 cases and deaths in California

American Indians and Alaska Natives account for 0.5% percent of the population, **0.3% of COVID-19 cases**, and **0.4% of deaths** in California. This includes a total of **9,267 cases** and **192 deaths** among American Indian and Alaska Native people in California.



California Department of Public Health has nearly complete data on race and ethnicity for COVID-19 deaths, and are reporting the following trends: Latinos, African Americans and Native Hawaiians and Pacific Islanders are dying at disproportionately higher levels.

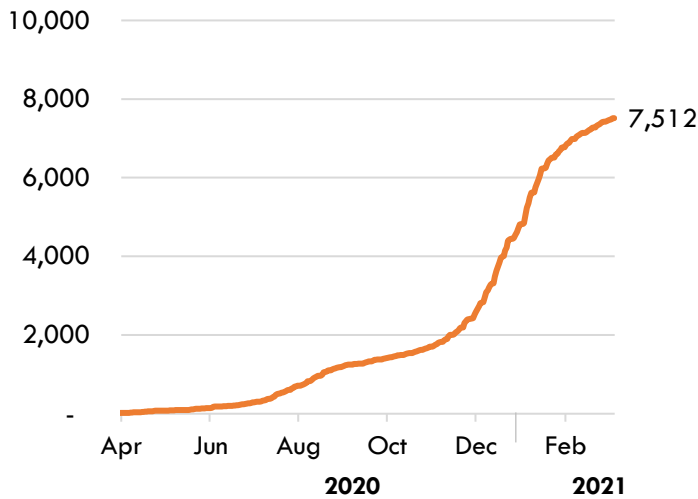

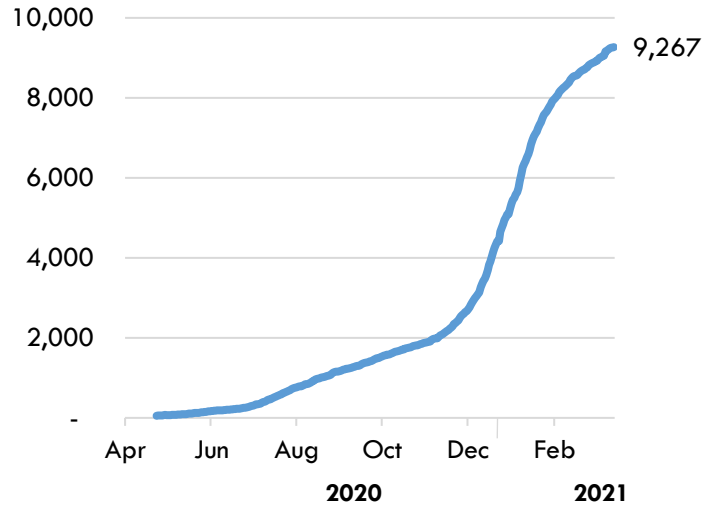

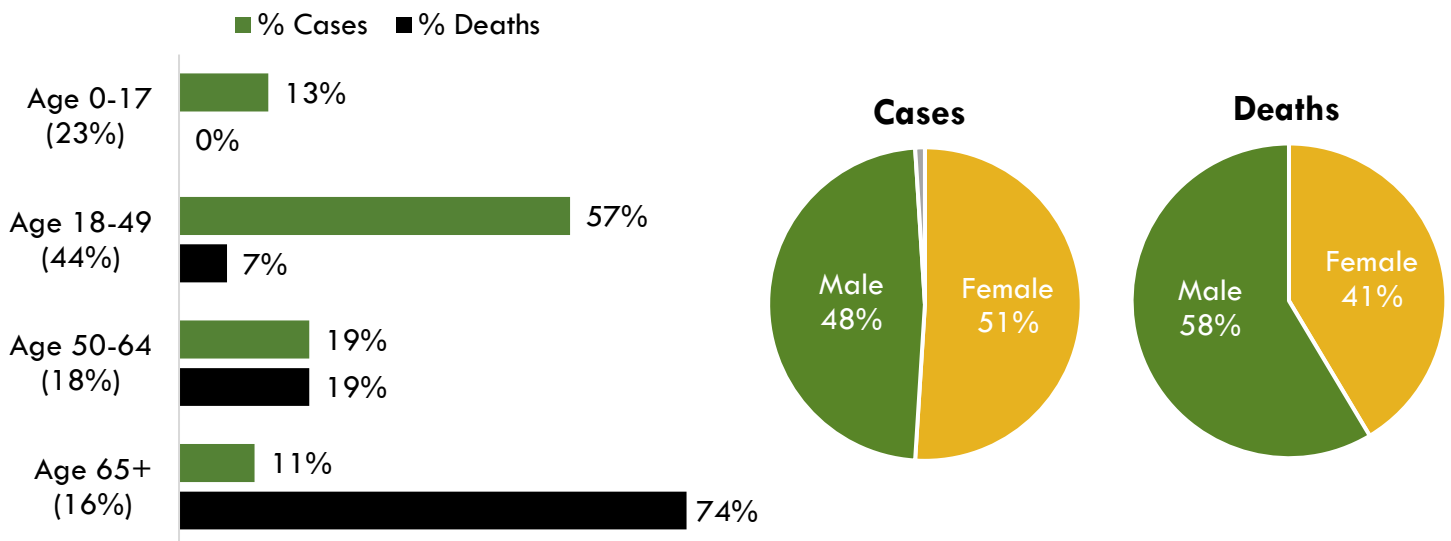

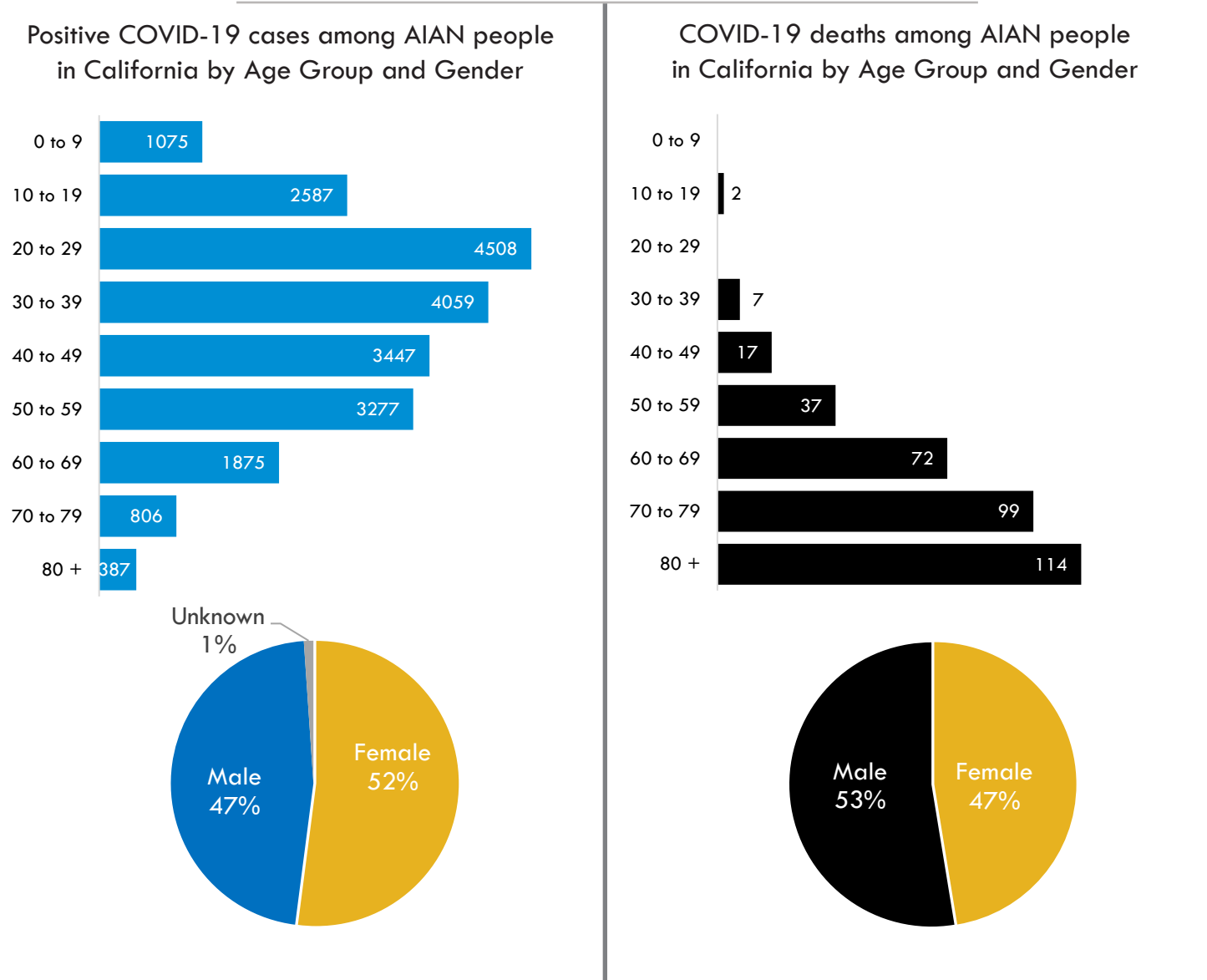

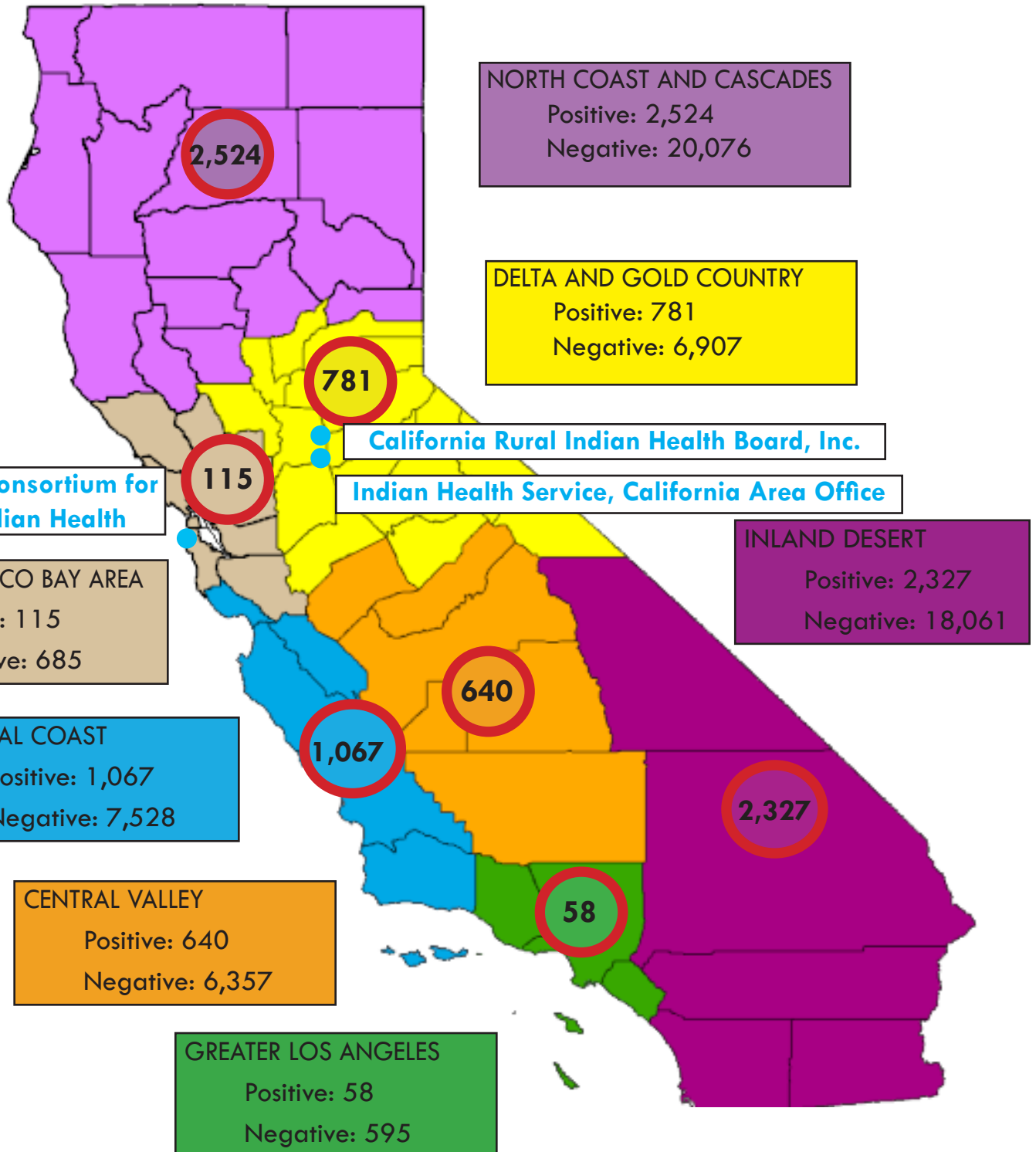

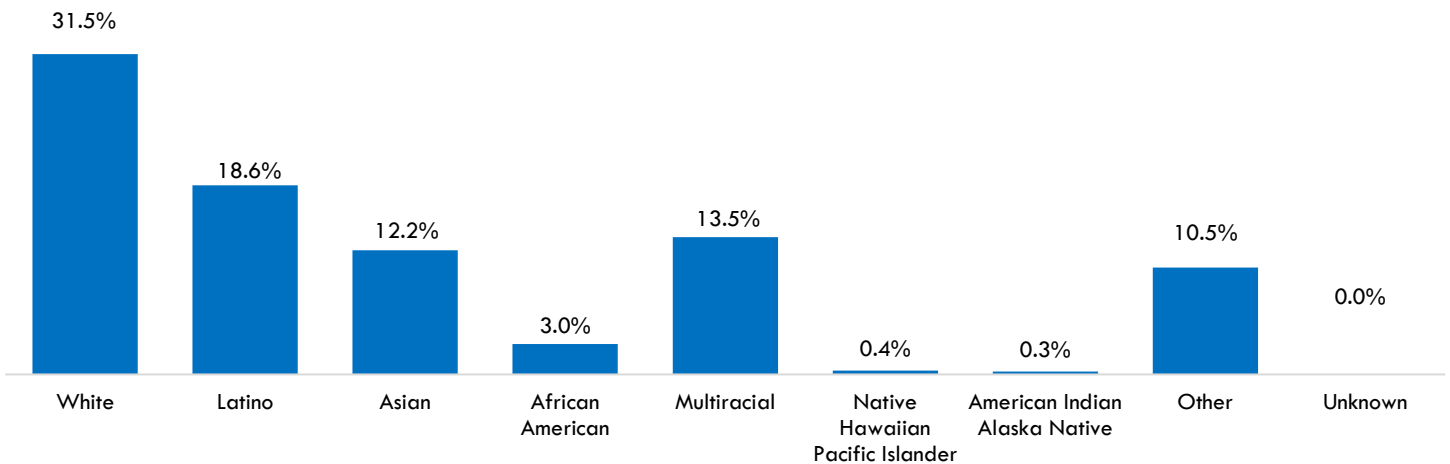

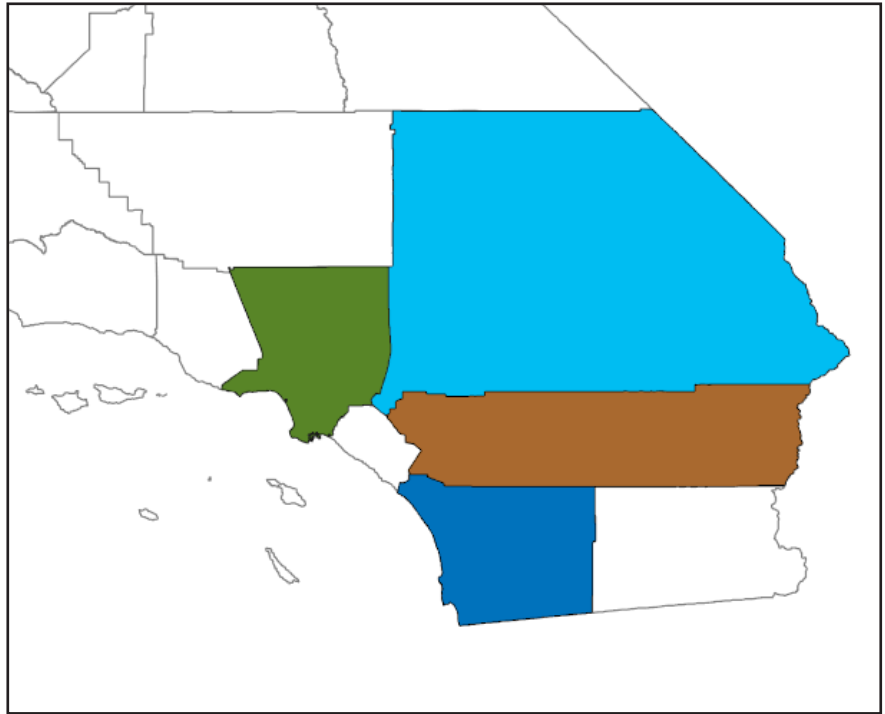

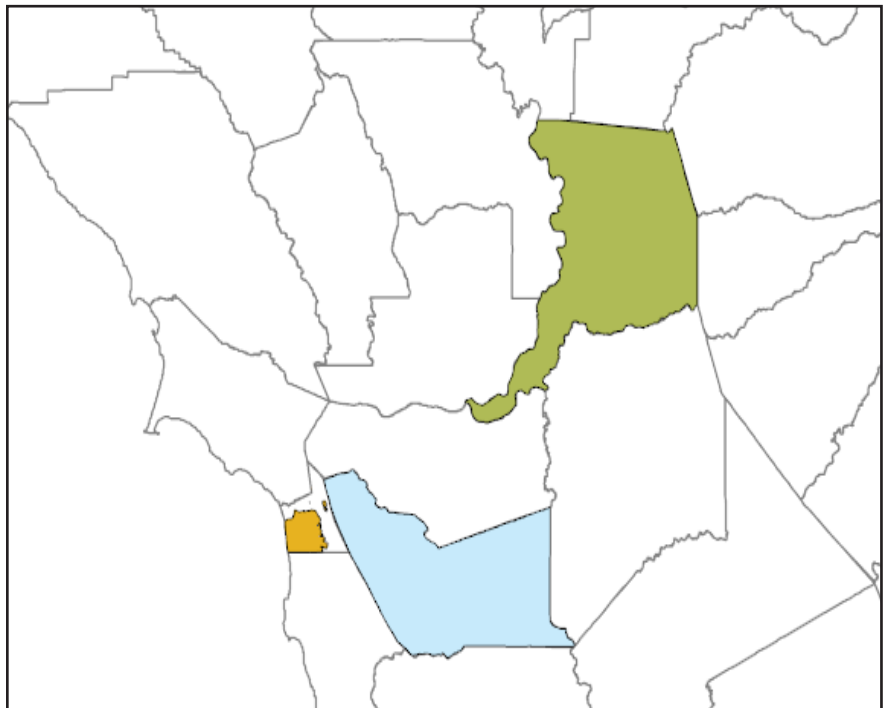

TRIBAL STATE OF EMERGENCY AND SHELTER IN PLACE DECLARATIONS



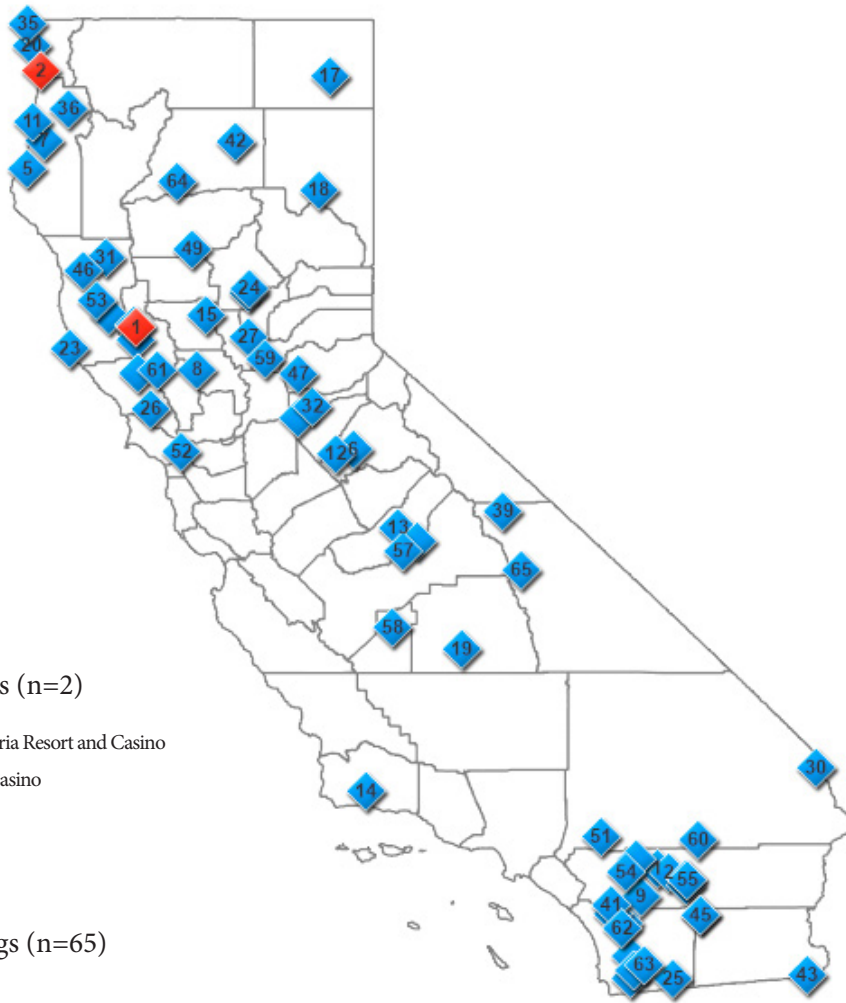
