

DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 127.3 million with more than 2.7 million deaths.

In the United States, the total number of cases stands at 30,147,895 and deaths at 547,296.

A new CDC study provides strong evidence that mRNA COVID-19 vaccines are highly effective in preventing SARS-CoV-2 infections in real-world conditions among health care personnel, first responders, and other essential workers. Results showed that following the second dose of vaccine (the recommended number of doses), risk of infection was reduced by 90 percent two or more weeks after vaccination. Following a single dose of either vaccine, the participants' risk of infection with SARS-CoV-2 was reduced by 80 percent two or more weeks after vaccination. The state is expanding who is eligible to get the vaccine based on expected supply increases. Californians 50+ will be eligible for vaccination starting April 1. Every Californian 16 and up will be eligible for vaccination on April 15, 2021. Learn how to get vaccinated [HERE](#).

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

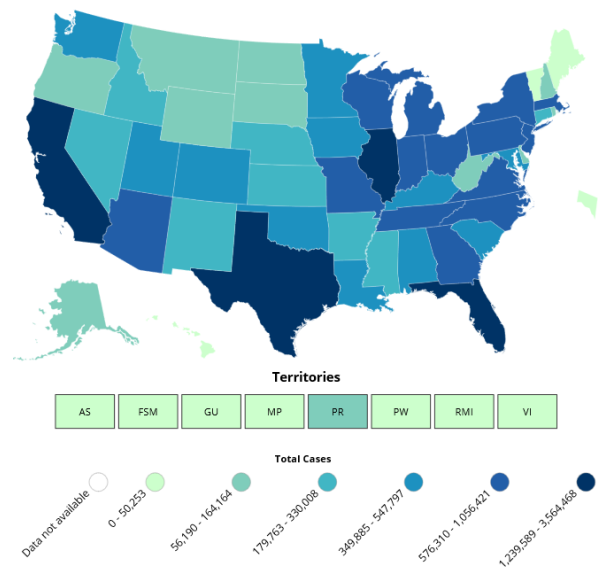
A probable case or death is defined by:

- meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or
 - meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or
 - meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.
- State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

Total Number of COVID-19 Cases in the US Reported to the CDC, by State/Territory

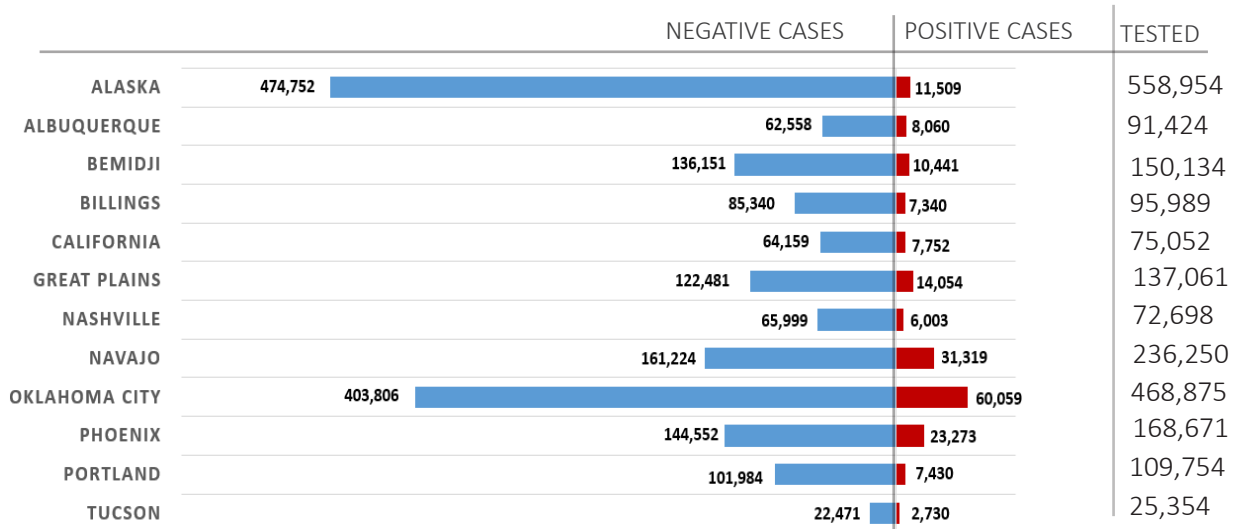

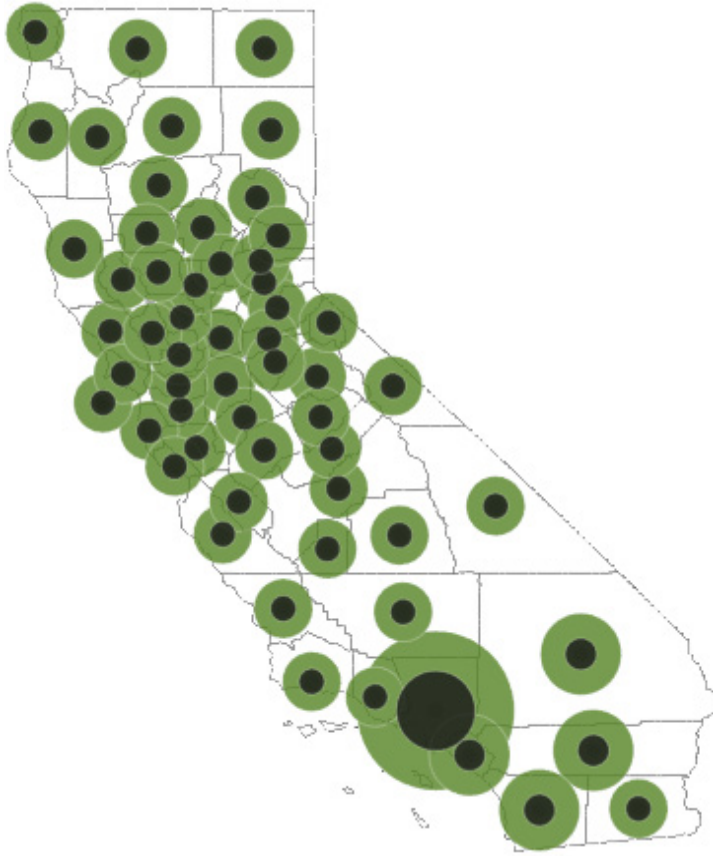

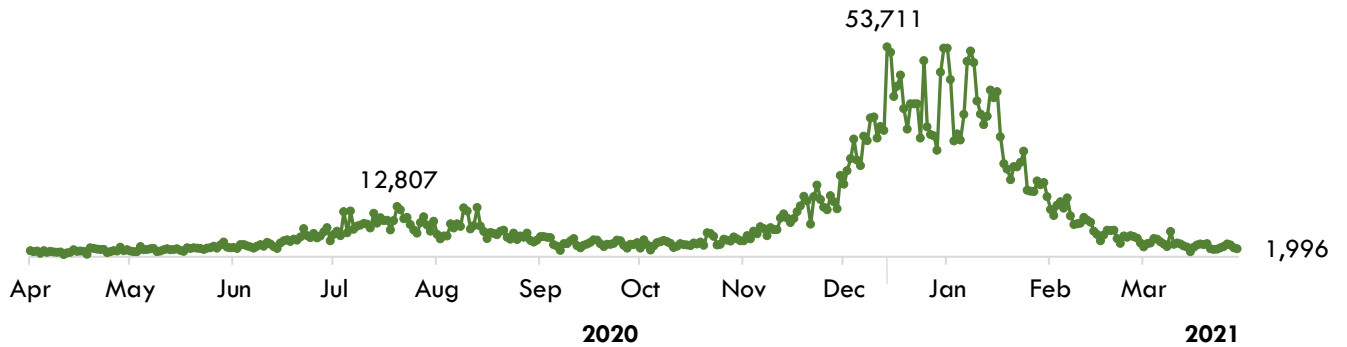

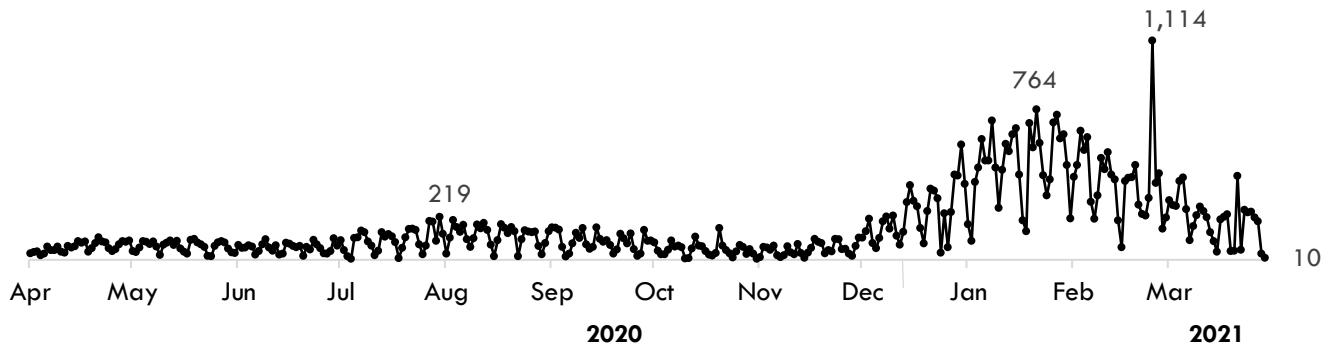

New Confirmed Cases in California by Date



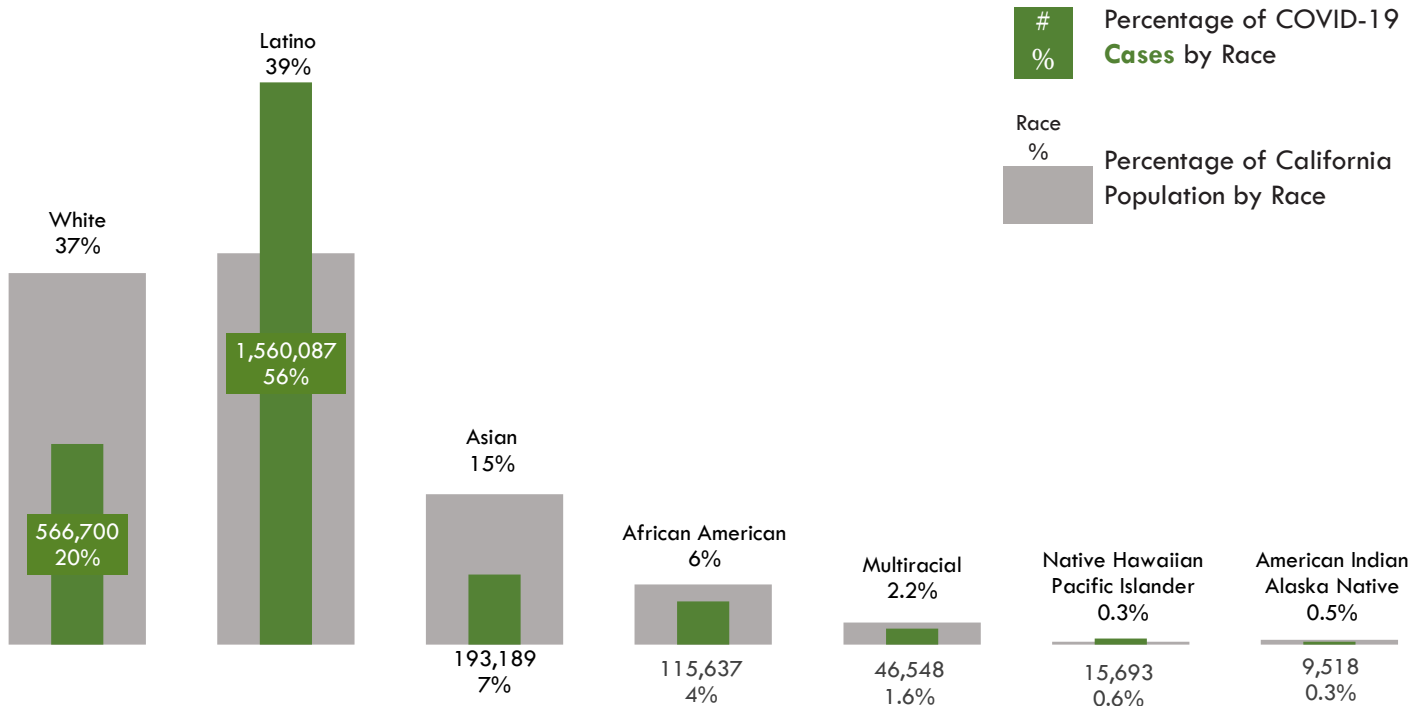
New Confirmed Deaths in California by Date



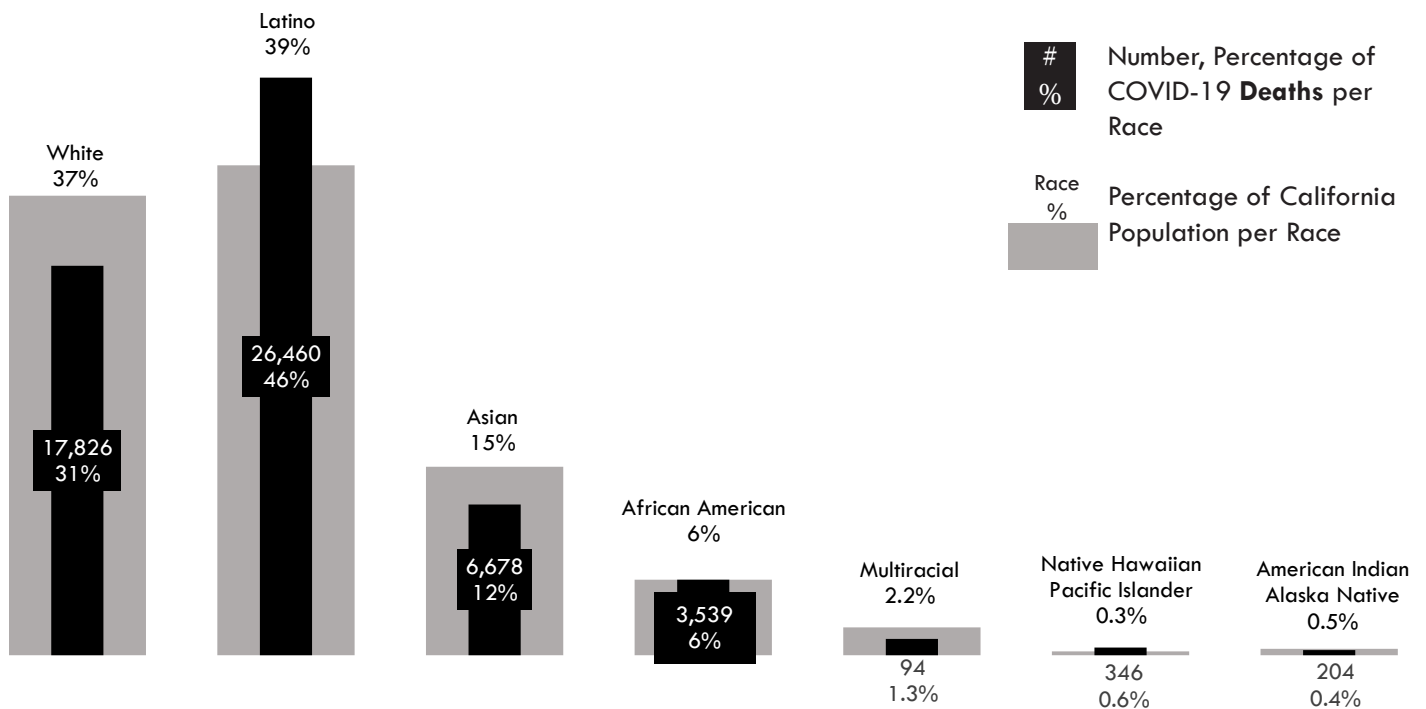

Racial distribution of confirmed COVID-19 cases and deaths in California

American Indians and Alaska Natives account for 0.5% percent of the population, **0.3% of COVID-19 cases**, and **0.4% of deaths** in California. This includes a total of **9,518 cases** and **204 deaths** among American Indian and Alaska Native people in California.



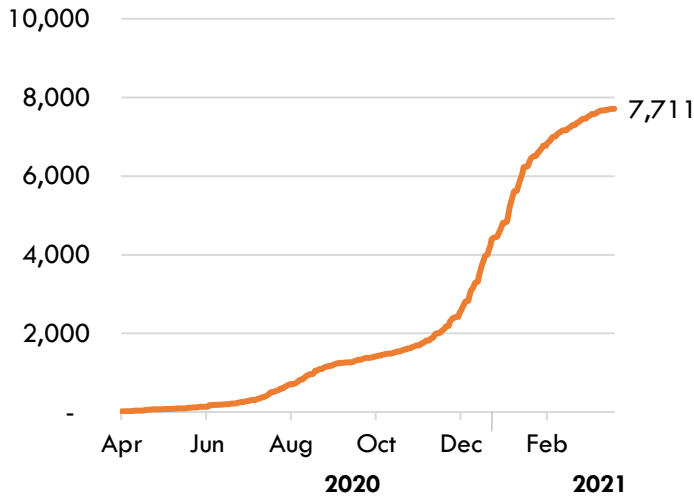

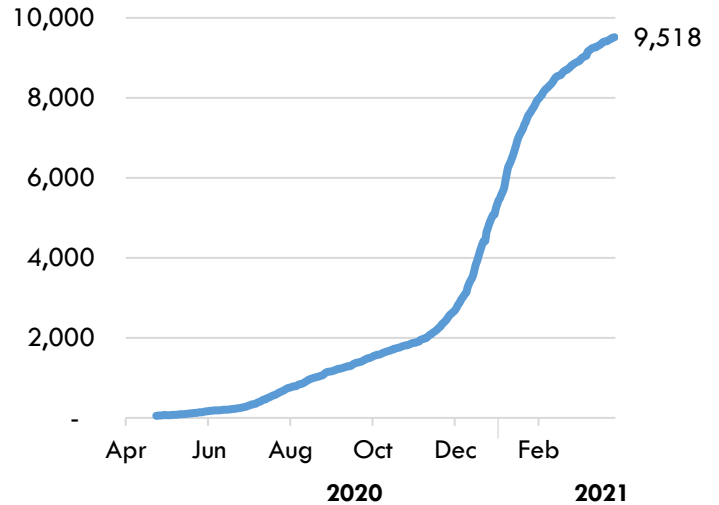

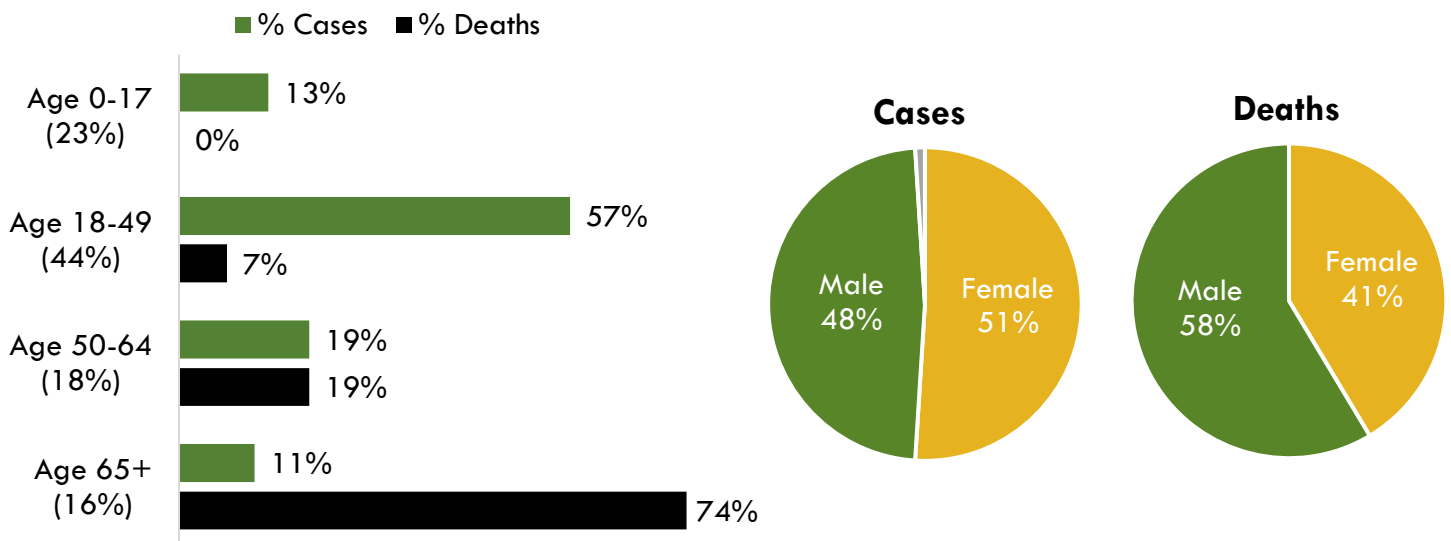

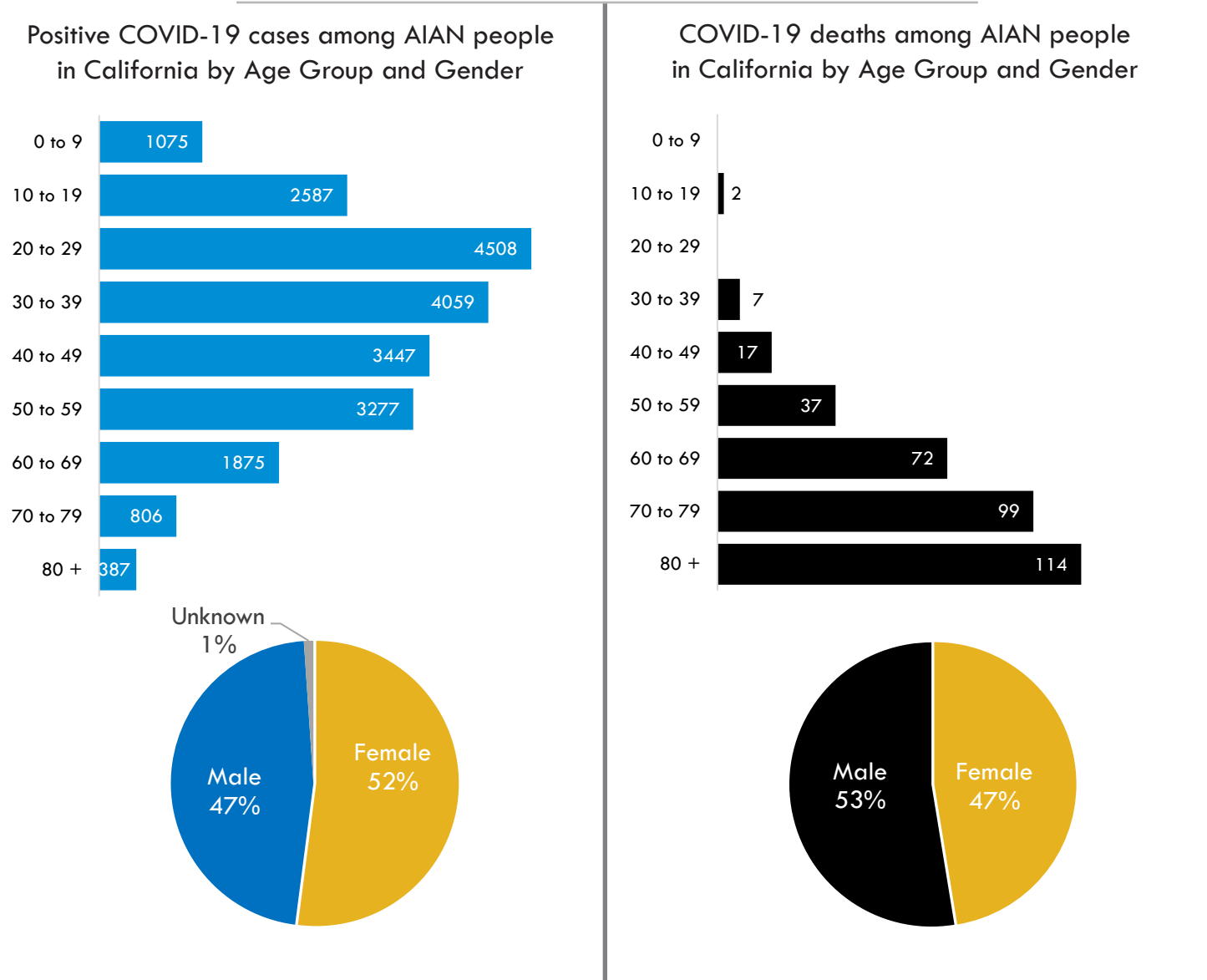

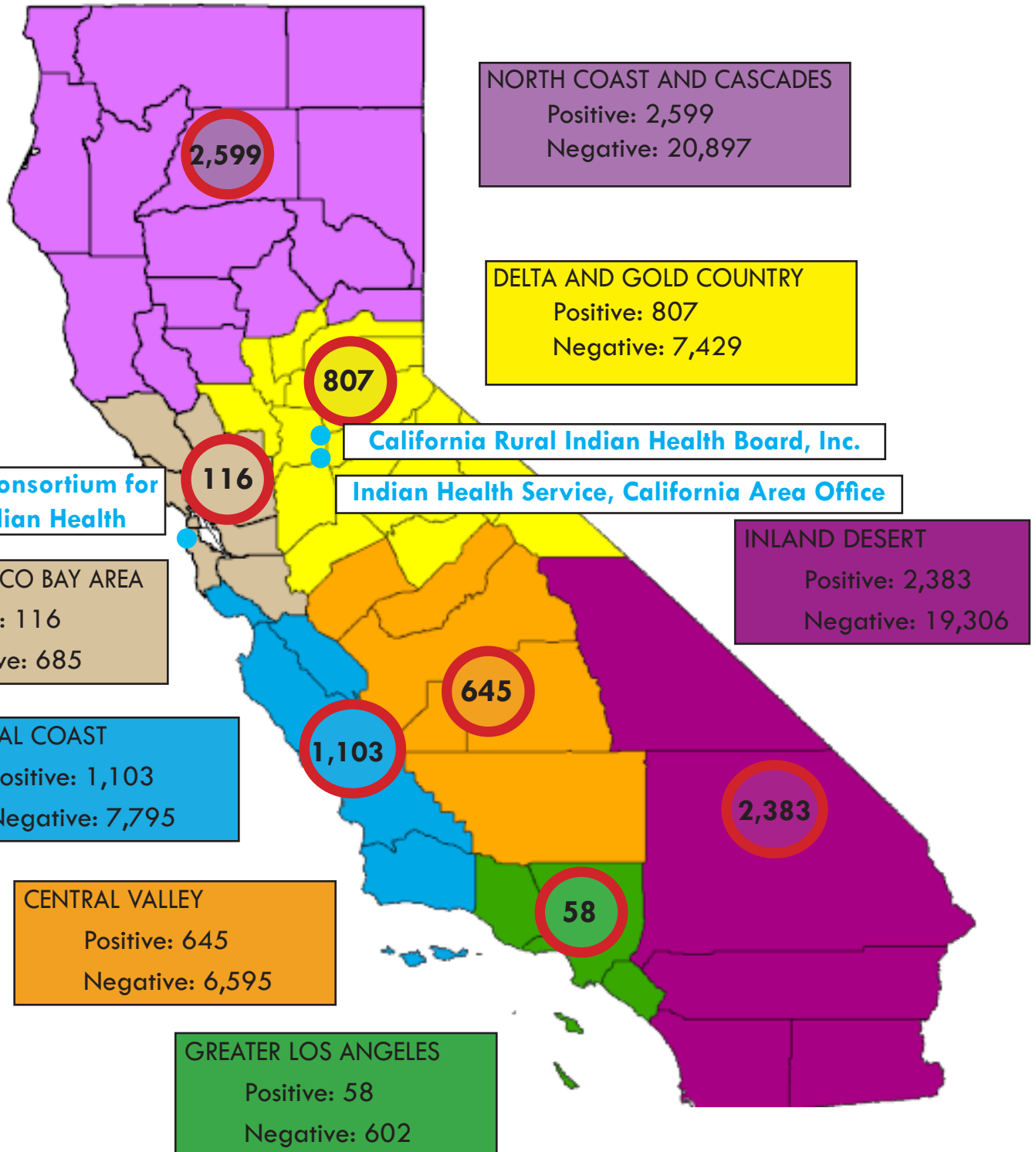

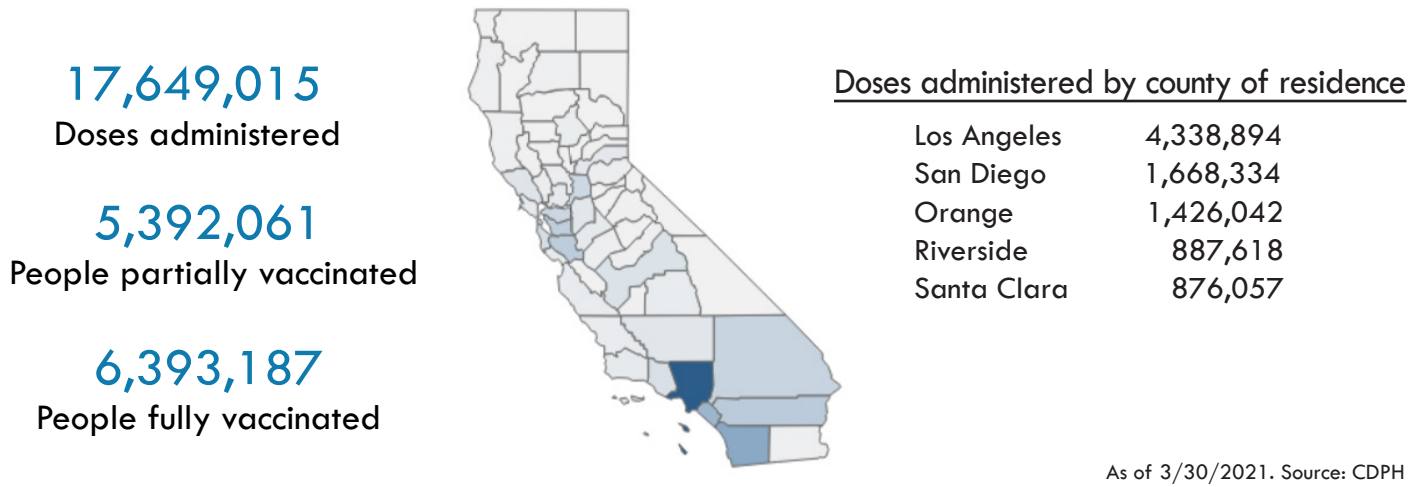


Number of positive cases identified by region

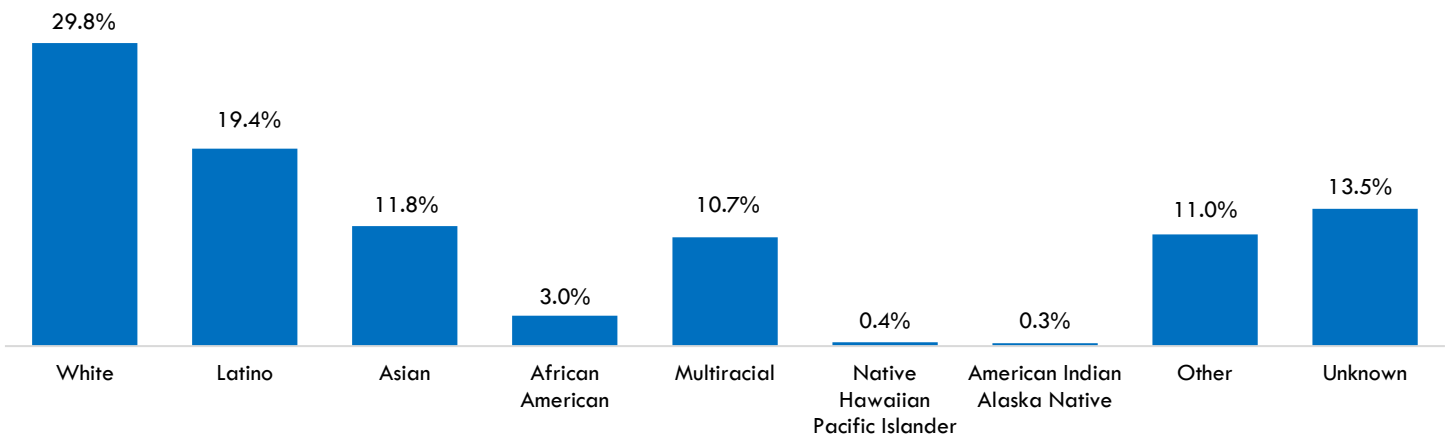

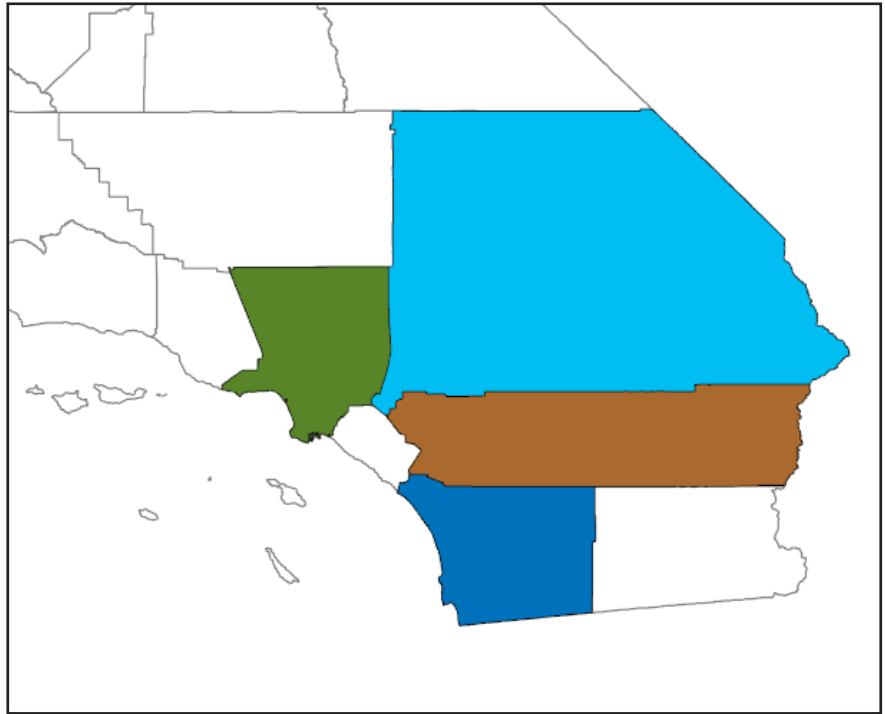

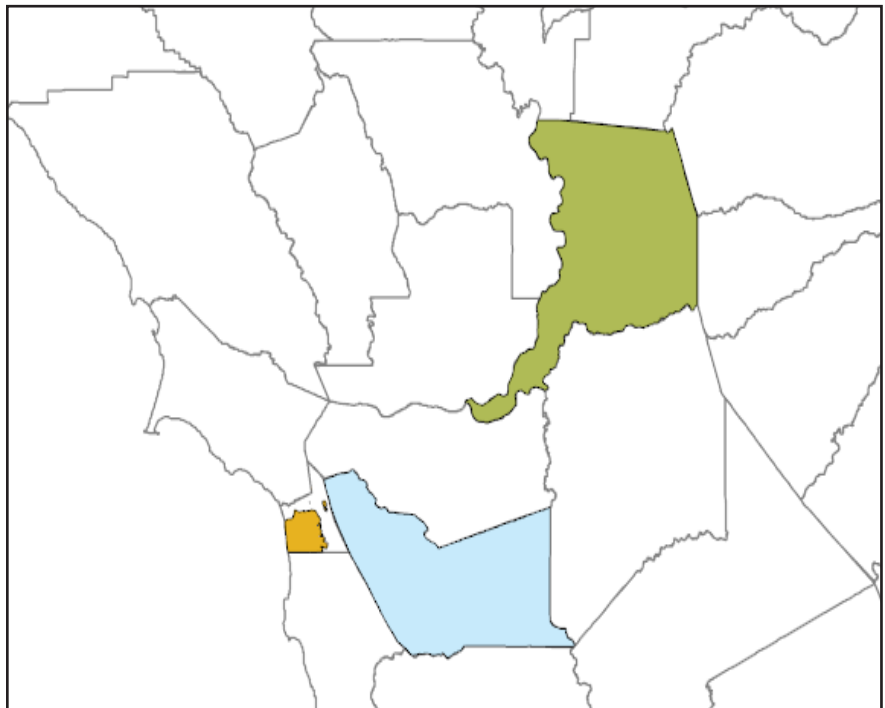
