DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 132 million with more than 2.8 million deaths.

In the United States, the total number of cases stands at 30,662,171 and deaths at 555,231.

California aims to fully reopen June 15. The move forward comes as the state has reached 20 million vaccinations, including 4 million in its hardest-hit communities. Masking and vaccinations will continue. Hospitalization rates must stay low and vaccination availability high for the state to fully reopen. When California fully reopens the economy, the state will move beyond the Blueprint for a Safer Economy. Commonsense health measures such as masking will remain across the state. Testing or vaccination verification requirements will remain in relevant settings Find out more HERE.




A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID19. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.














American Indians and Alaska Natives account for 0.5% percent of the population, 0.3% of COVID-19 cases, and 0.4% of deaths in California. This includes a total of 9,539 cases and 205 deaths among American Indian and Alaska Native people in California.

















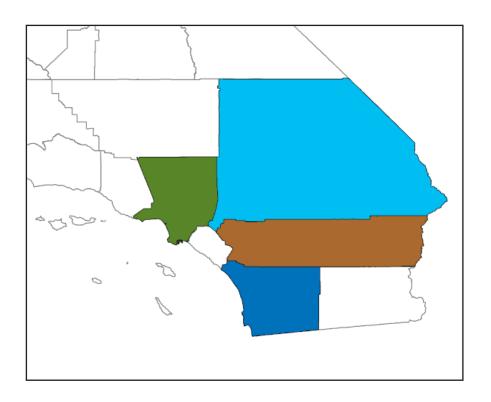


