DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 133.5 million with more than 2.8 million deaths.

In the United States as of April 8, the total number of cases stands at 30,737,477 and deaths at 556,106.

California aims to fully reopen June 15. The move forward comes as the state has reached 20 million vaccinations, including 4 million in its hardest-hit communities. Masking and vaccinations will continue. Hospitalization rates must stay low and vaccination availability high for the state to fully reopen. When California fully reopens the economy, the state will move beyond the Blueprint for a Safer Economy. Common-sense health measures such as masking will remain across the state. COVID-19: U.S. at a Glance* (as of 4/8/21)

- Total cases: 30,737,477
- Total deaths: 556,106
- Jurisdictions reporting cases: 55 (50 states, District of Columbia, Guam, Puerto Rico, the Northern Mariana Islands, and the U.S. Virgin Islands)

*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

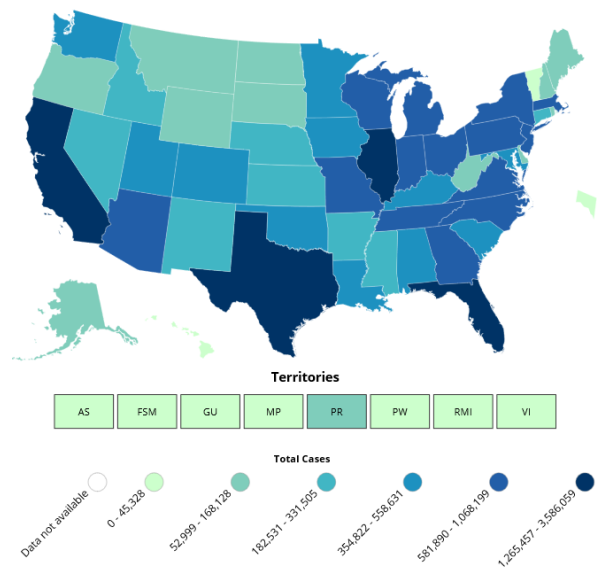
A probable case or death is defined by:

- i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.
- State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

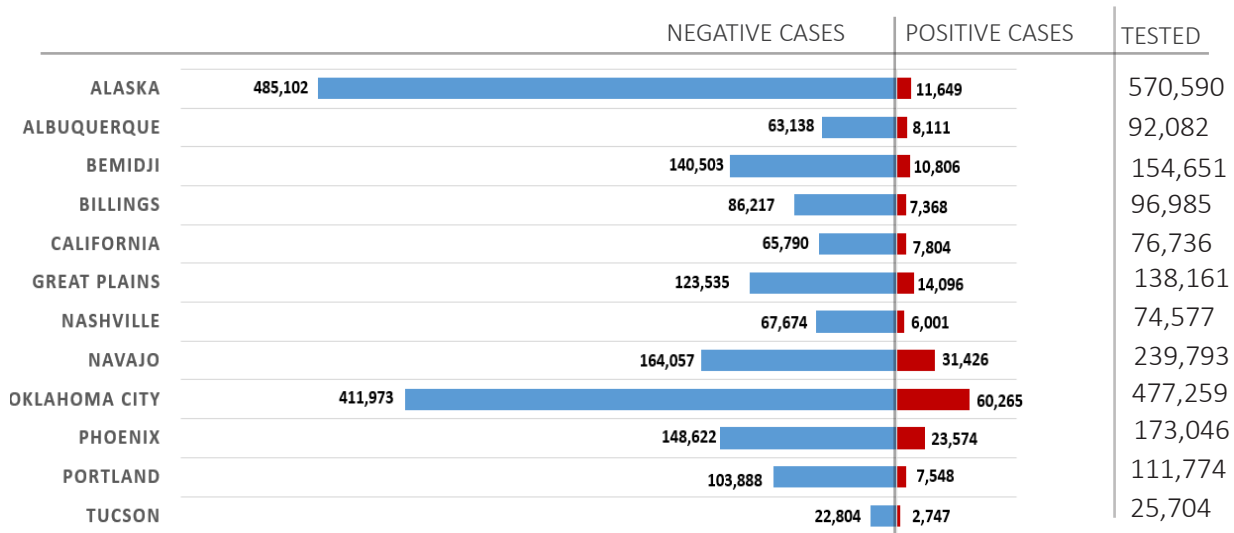


RISK FOR COVID-19 INFECTION, HOSPITALIZATION, & DEATH BY RACE/ETHNICITY, U.S.

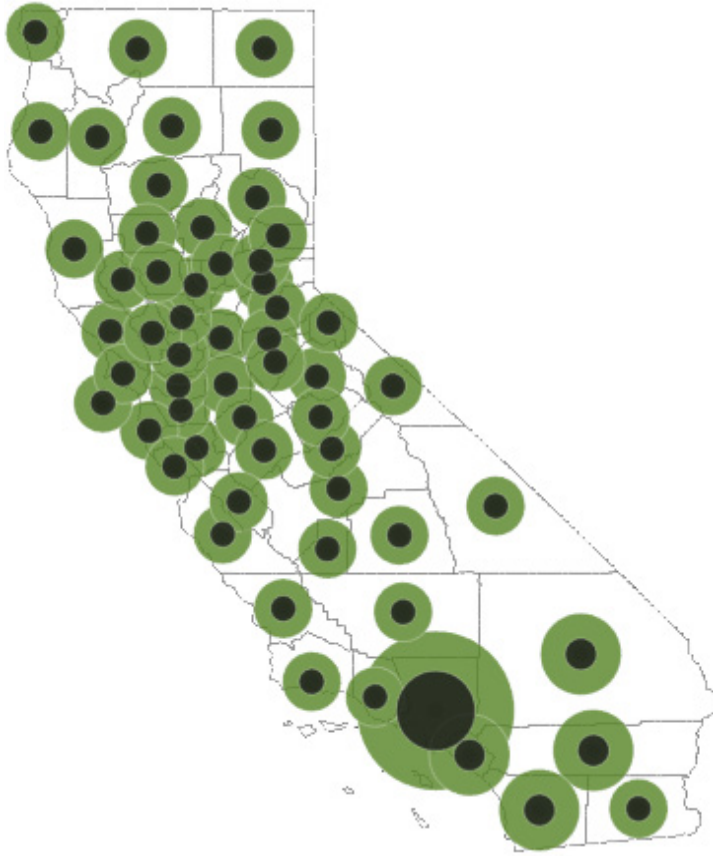

Of these, 7,804 patients have tested positive for COVID-19 and 65,790 have tested negative for COVID-19.

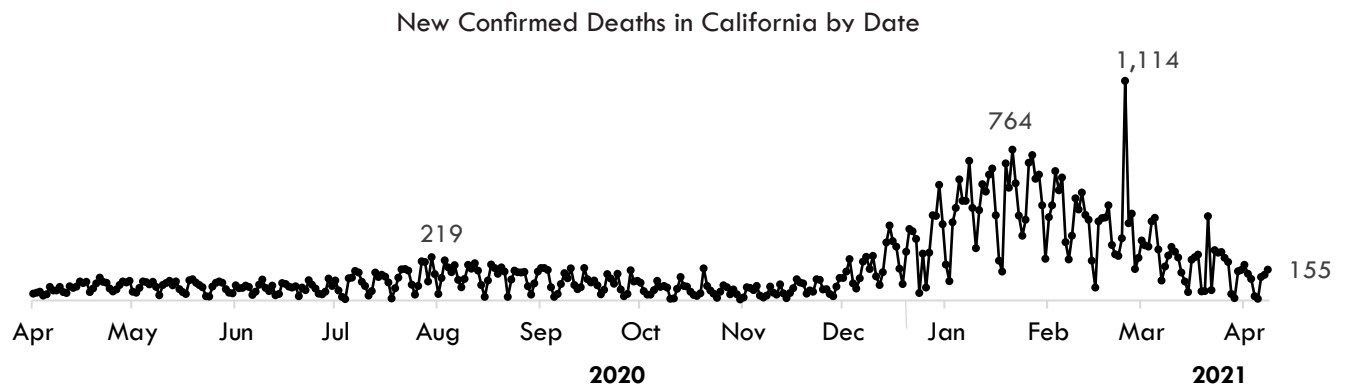
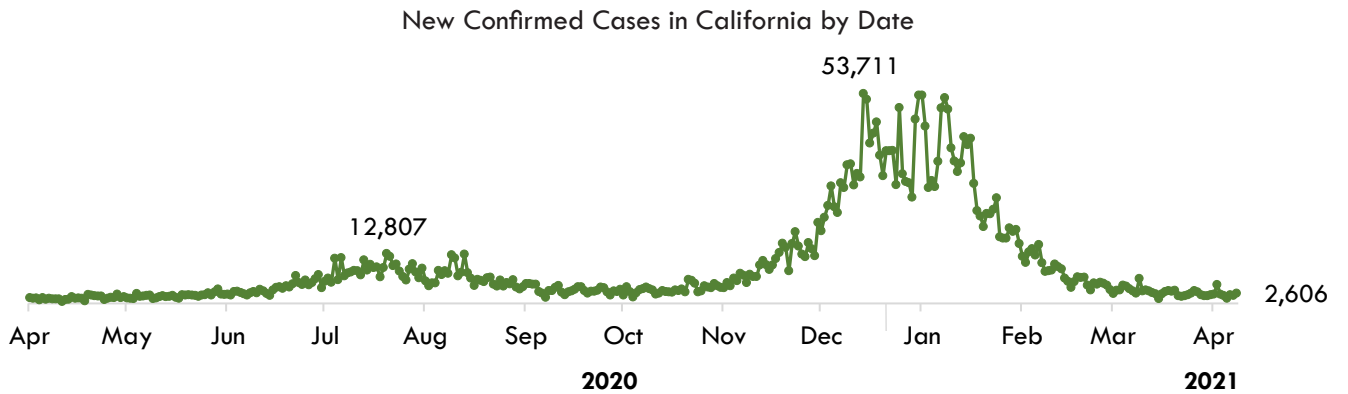

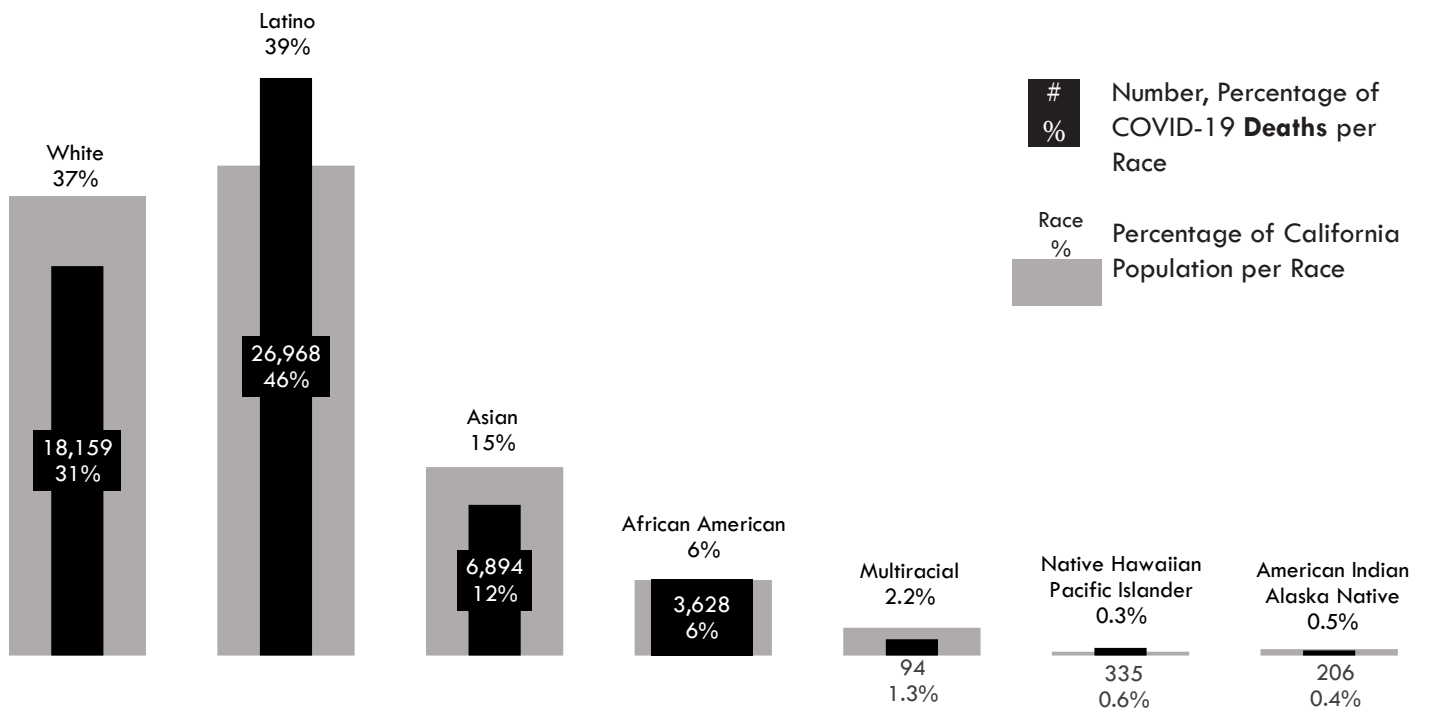
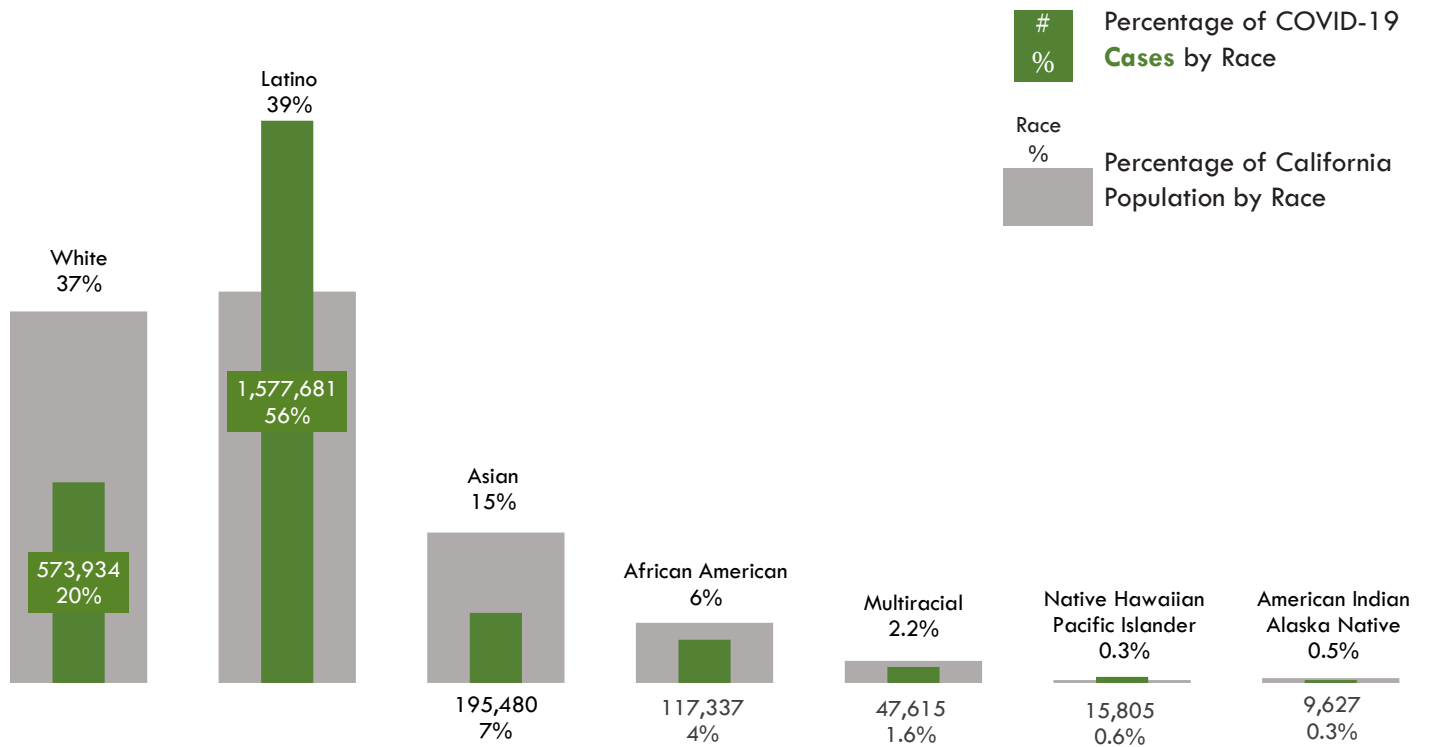

American Indians and Alaska Natives account for 0.5% percent of the population, **0.3% of COVID-19 cases**, and **0.4% of deaths** in California. This includes a total of **9,627 cases** and **206 deaths** among American Indian and Alaska Native people in California.

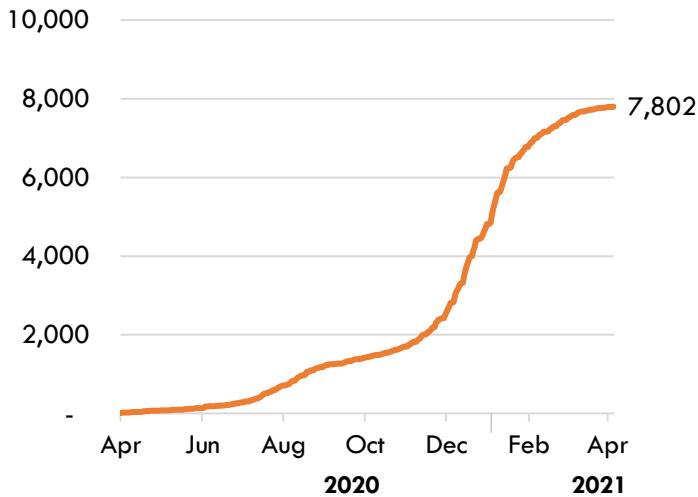

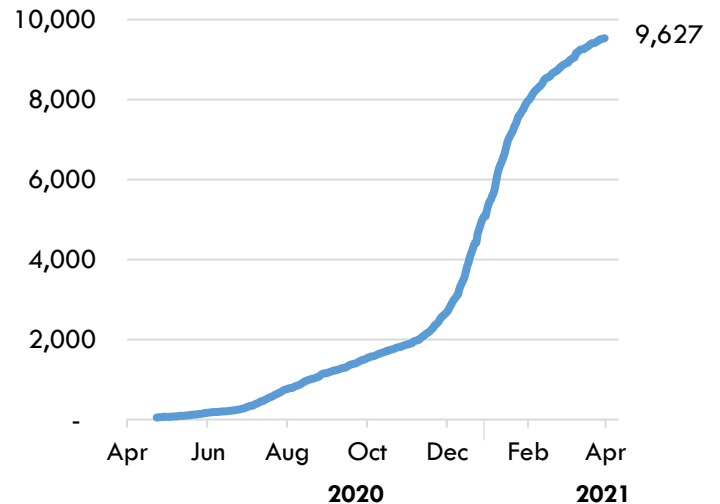

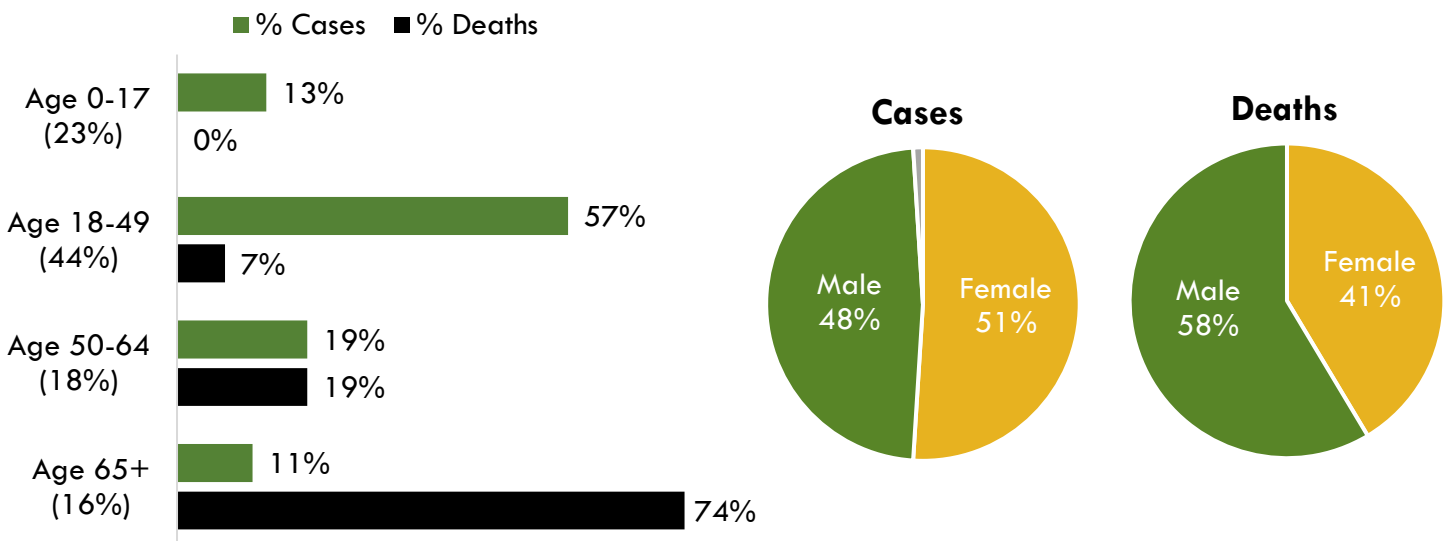

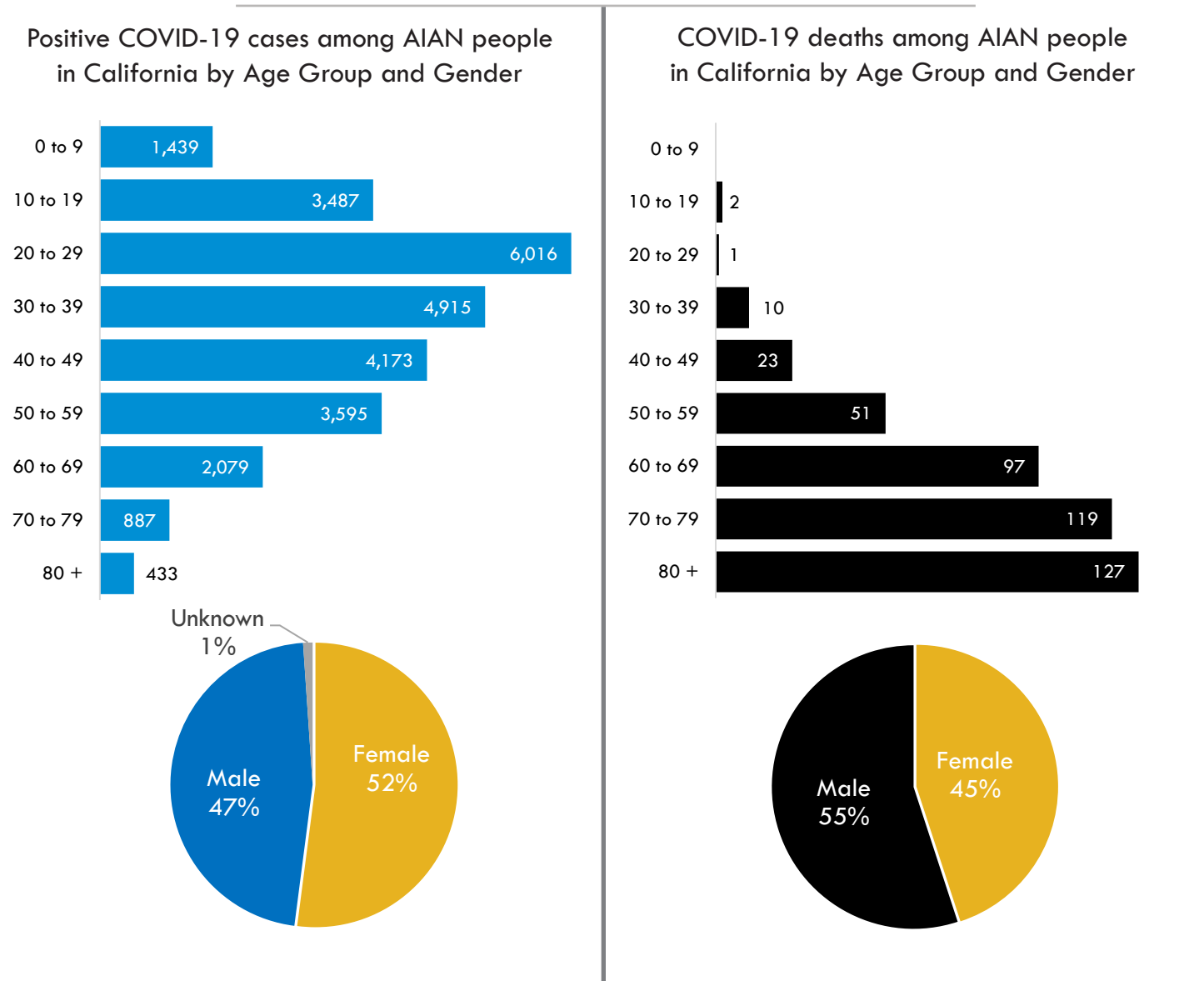

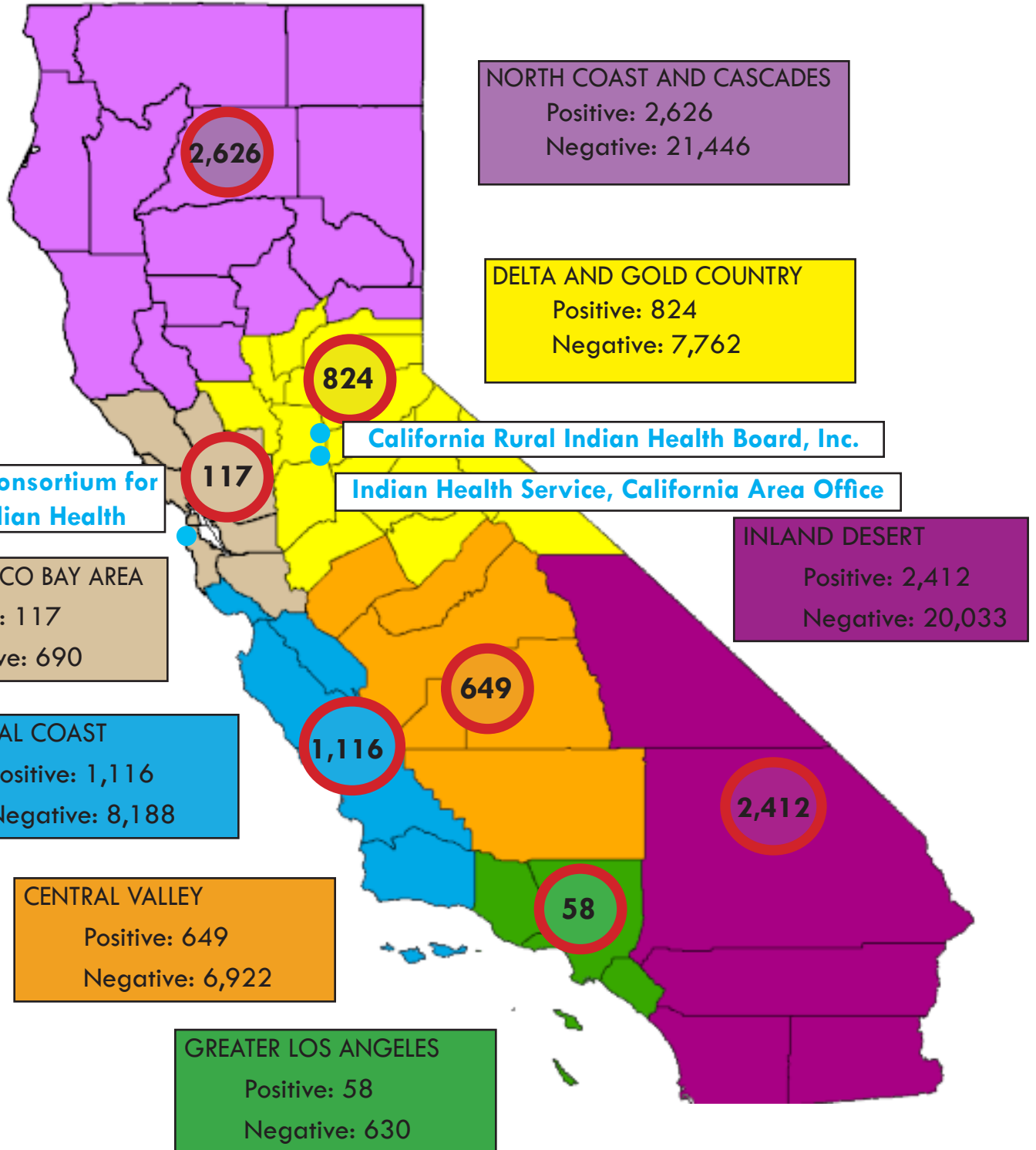

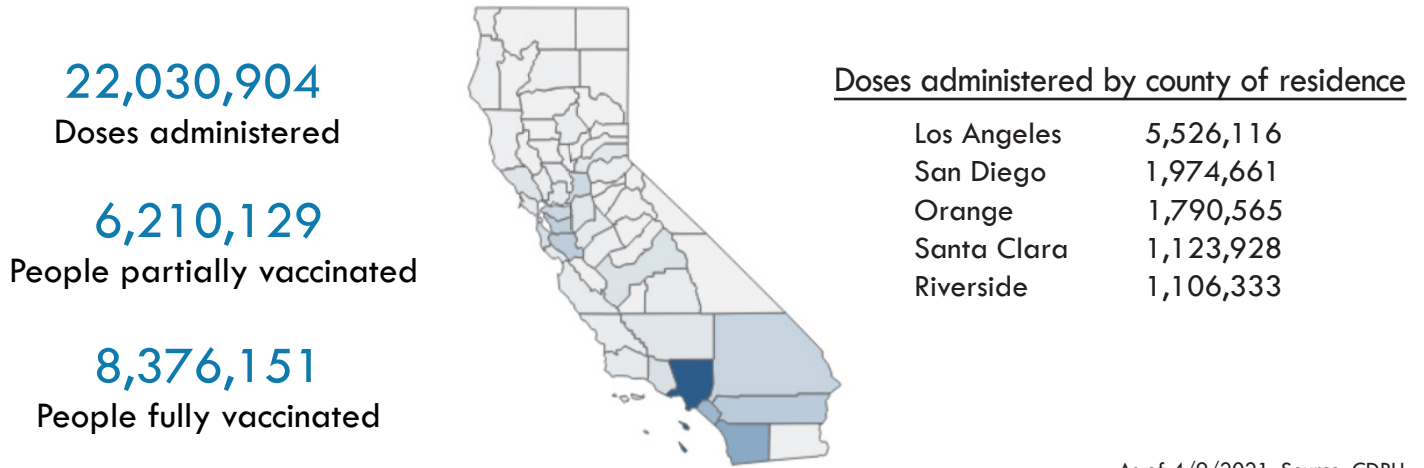


Number of positive cases identified by region



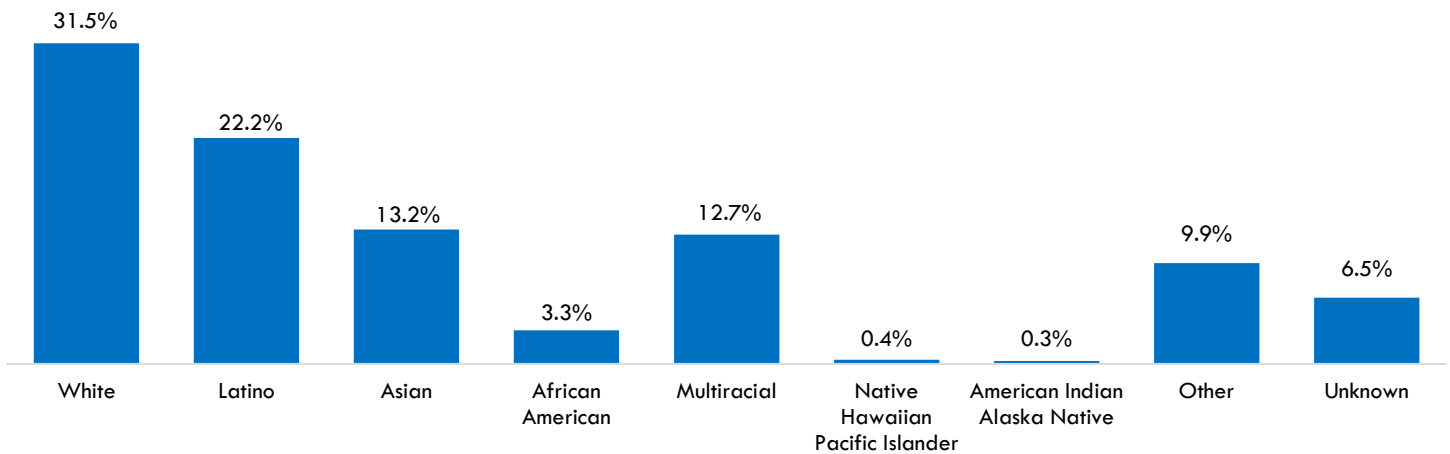

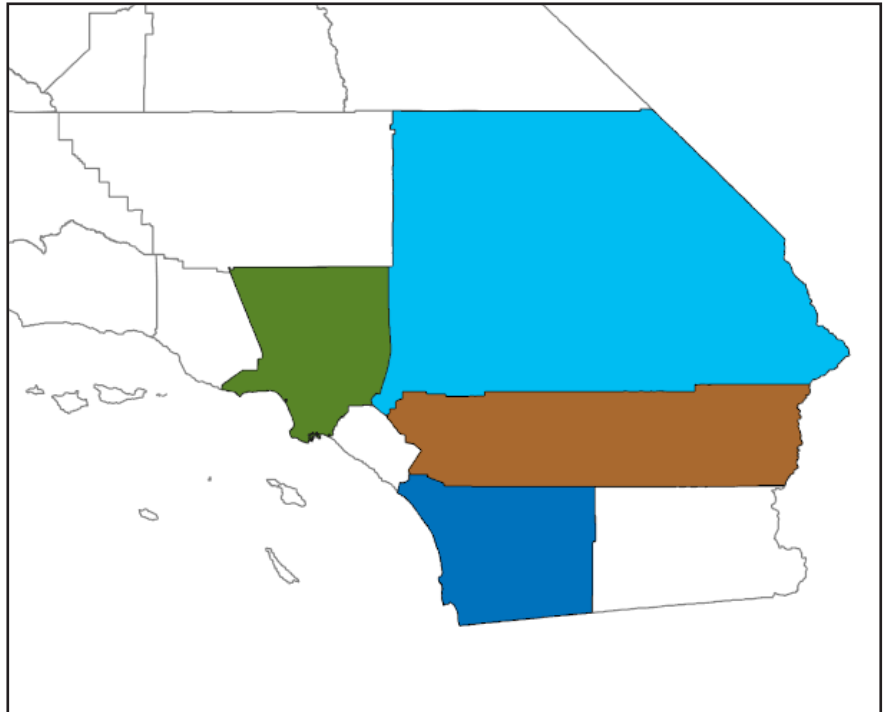

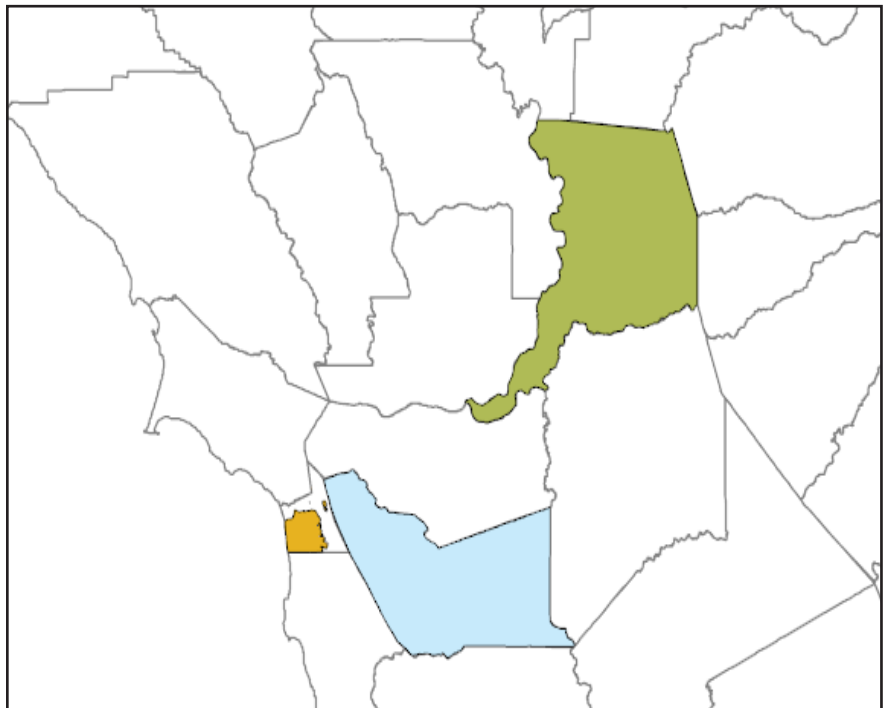

TRIBAL STATE OF EMERGENCY AND SHELTER IN PLACE DECLARATIONS



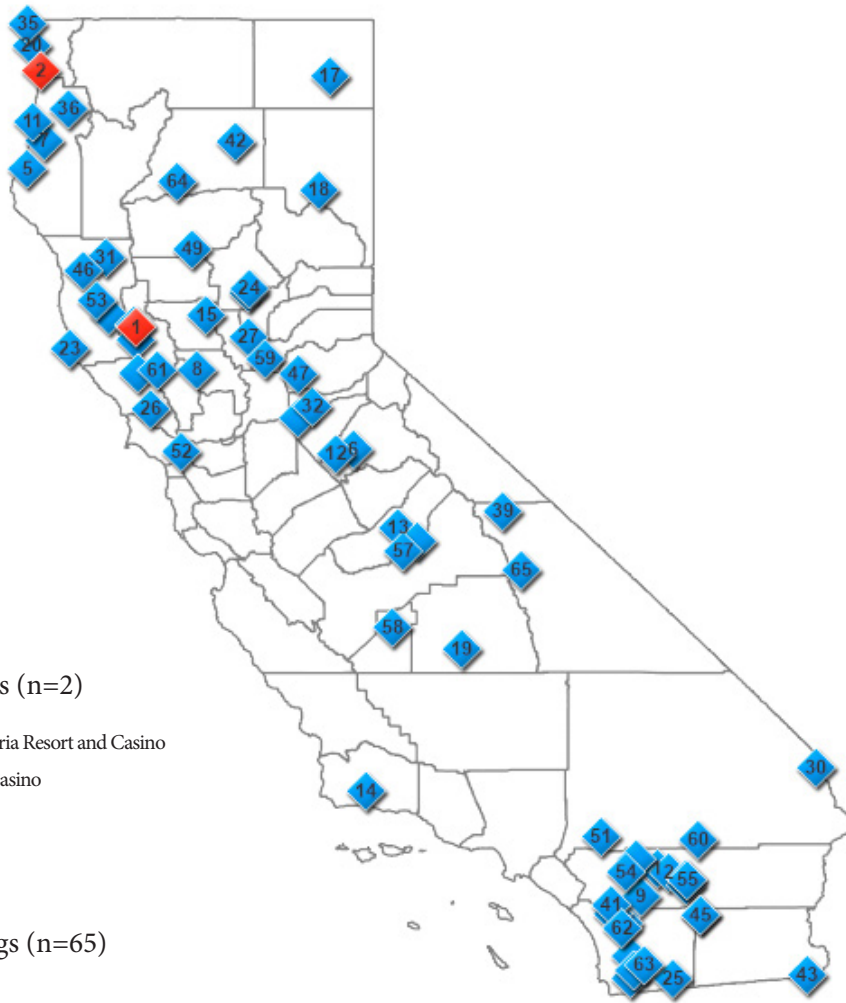
