

## DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 141.7 million with more than 3 million deaths.

In the United States, the total number of cases stands at 31,484,148 and deaths at 564,292.

While the safety of the Johnson & Johnson vaccine is being reviewed by federal authorities, please immediately pause further use of the Johnson & Johnson COVID-19 vaccine. Additional information and recommendations will follow soon. California aims to fully reopen June 15. The move forward comes as the state has reached 20 million vaccinations, including 4 million in its hardest-hit communities. Masking and vaccinations will continue. Hospitalization rates must stay low and vaccination availability high for the state to fully reopen. When California fully reopens the economy, the state will move beyond the Blueprint for a Safer Economy. Common-sense health measures such as masking will remain across the state. A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

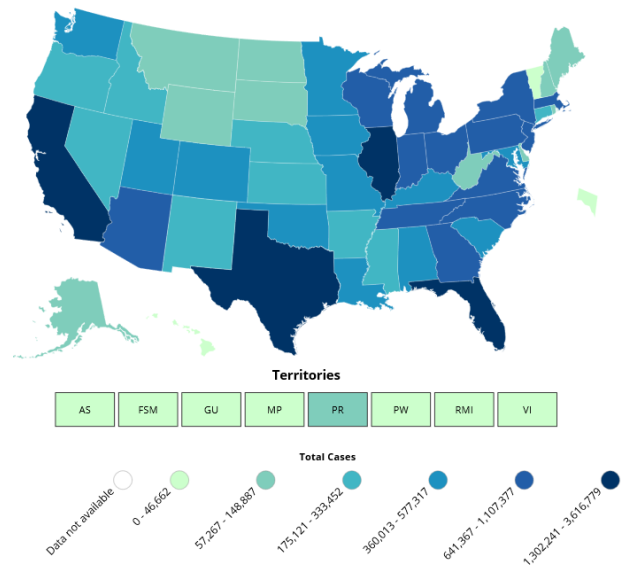
A probable case or death is defined by:

- meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or
  - meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or
  - meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.
- State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

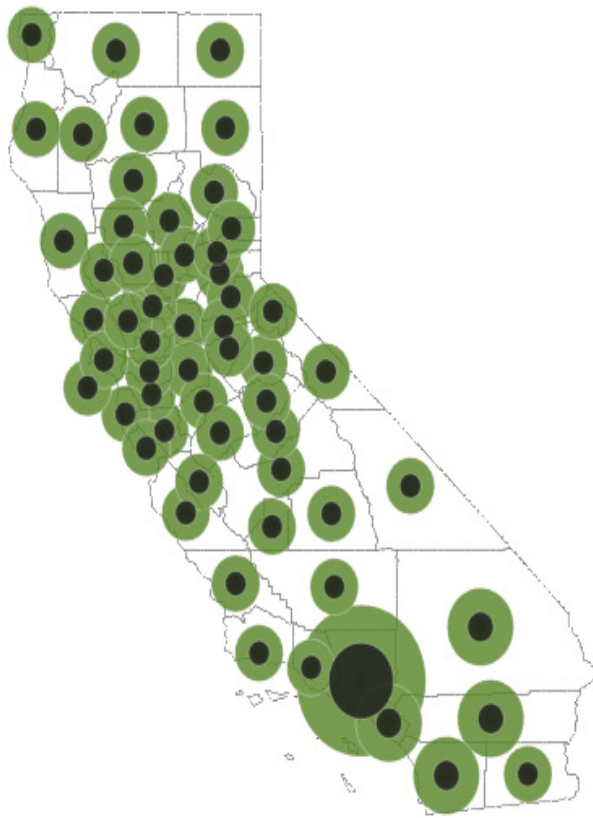

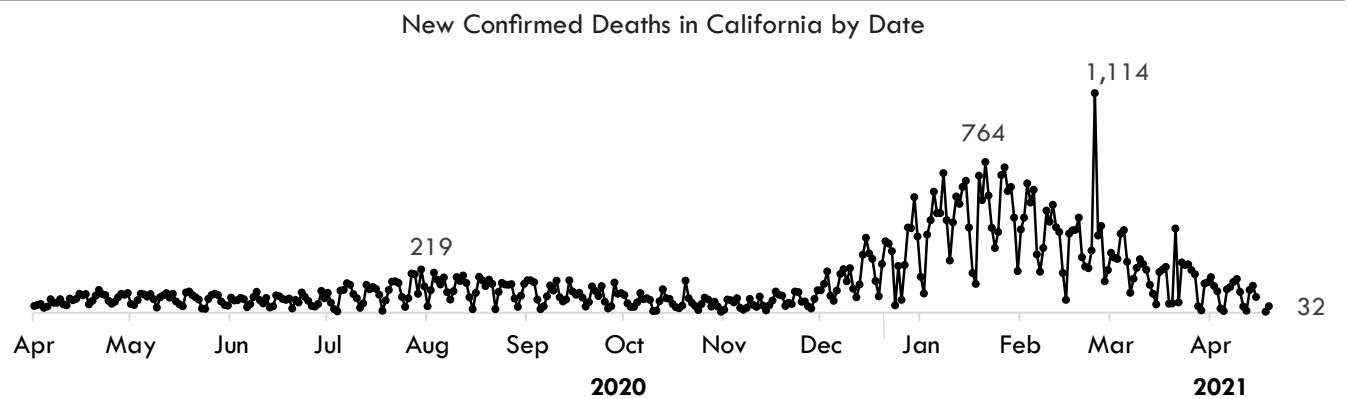
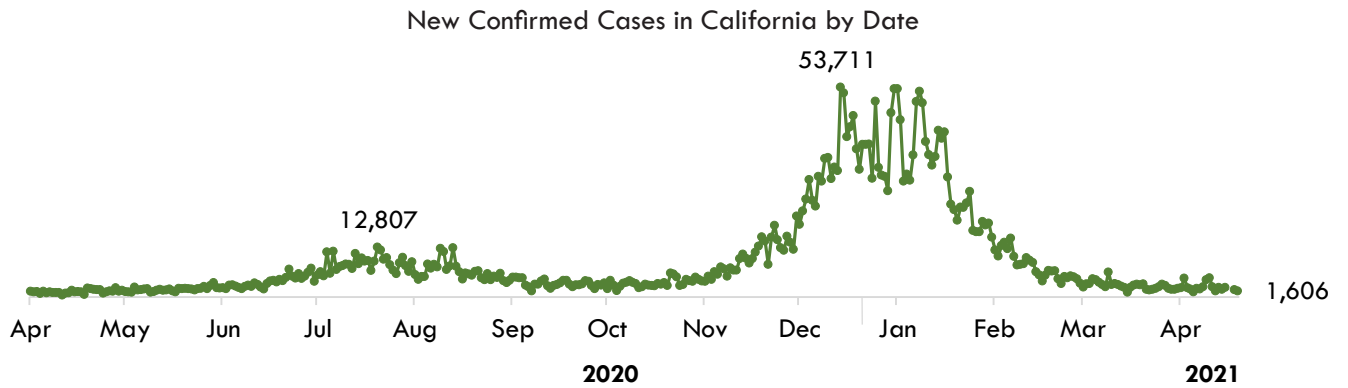

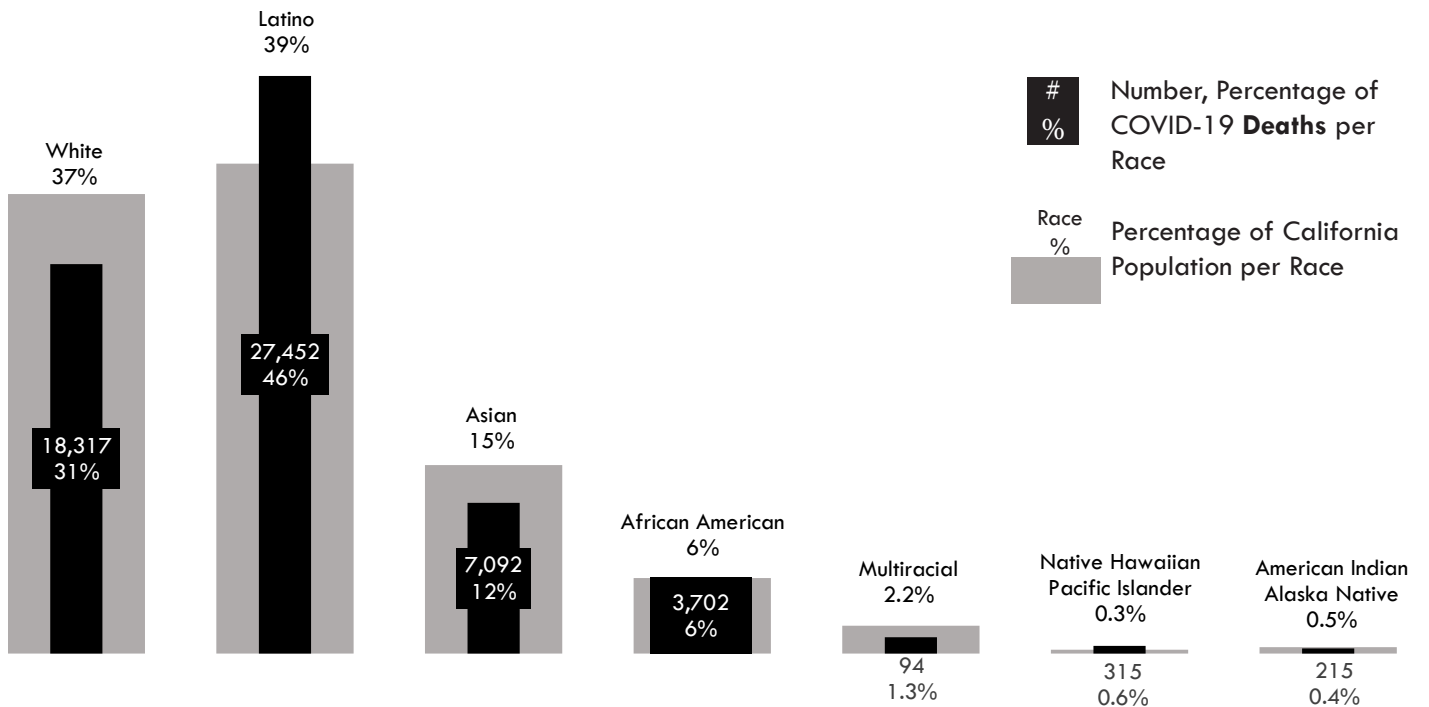
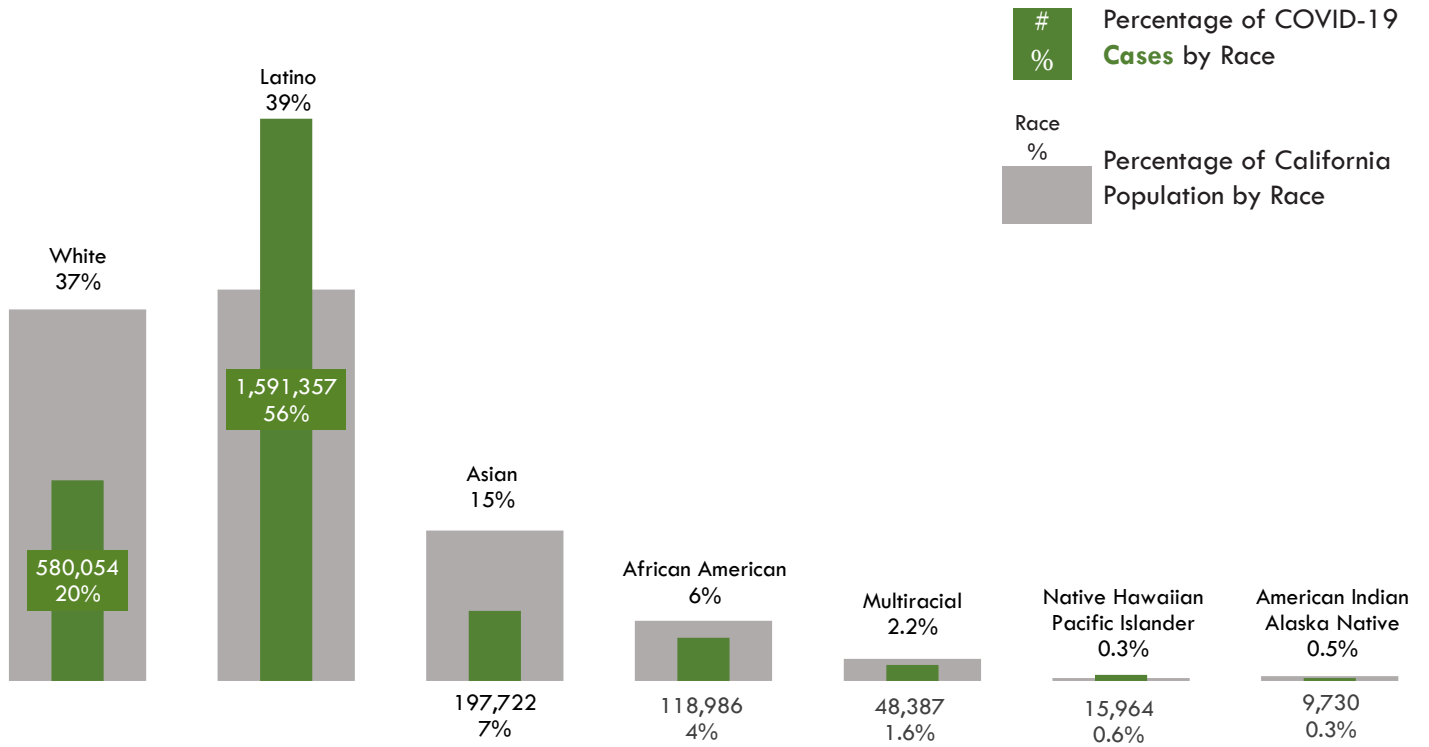

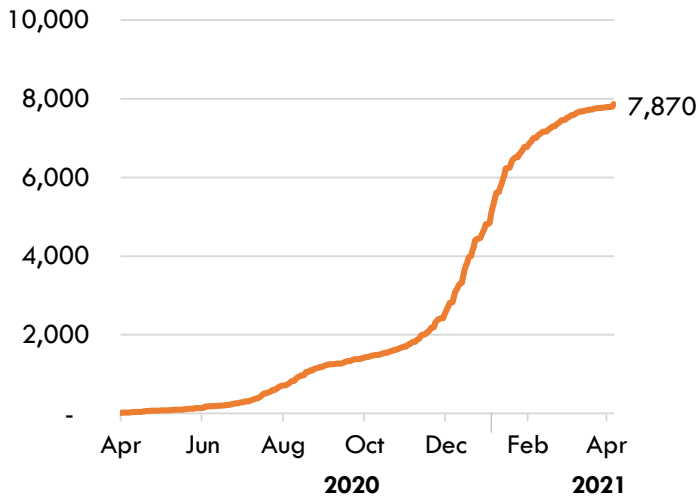

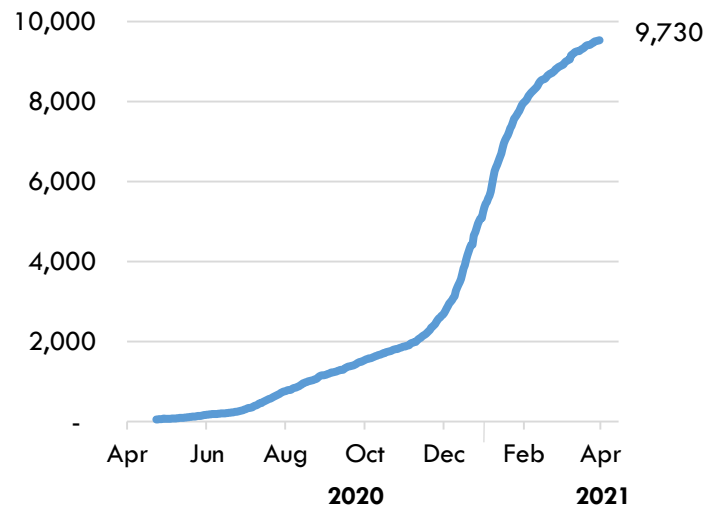

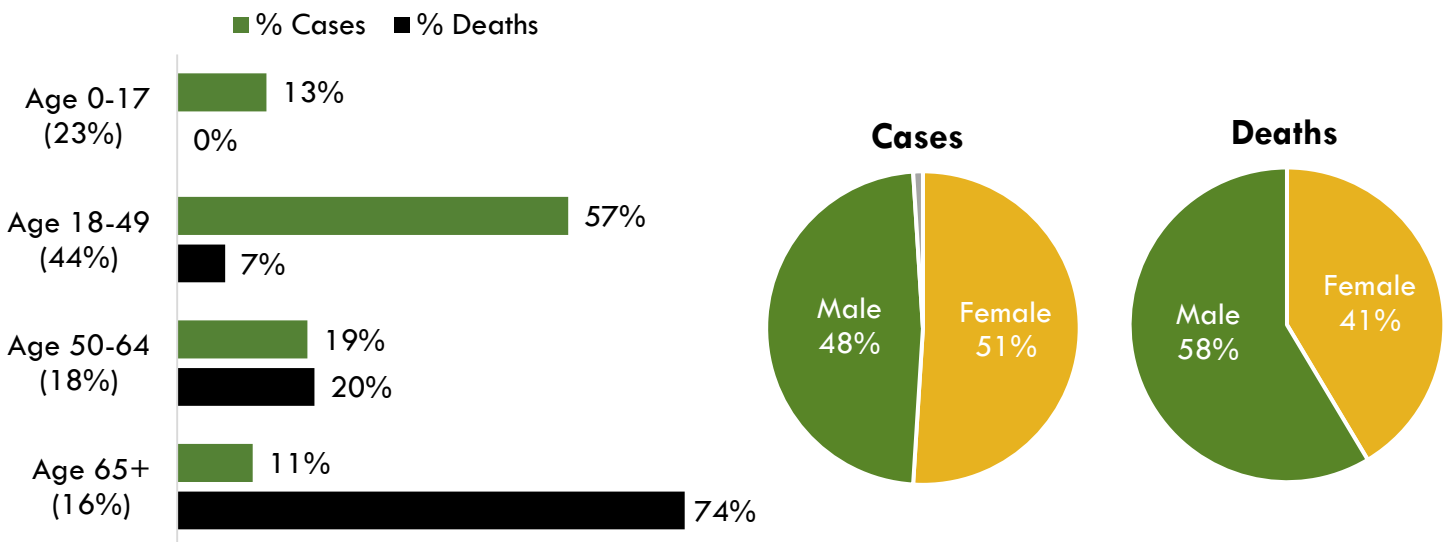

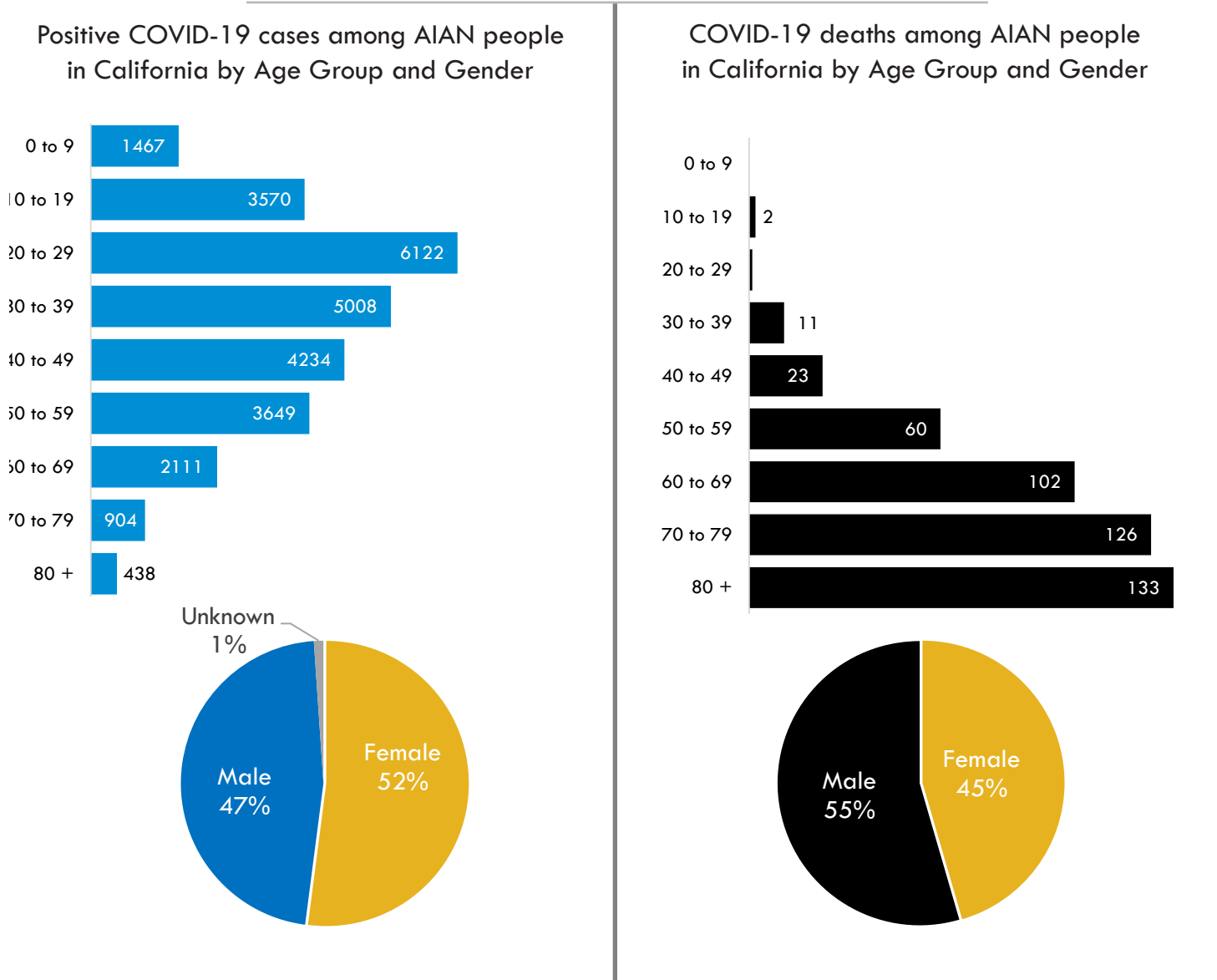

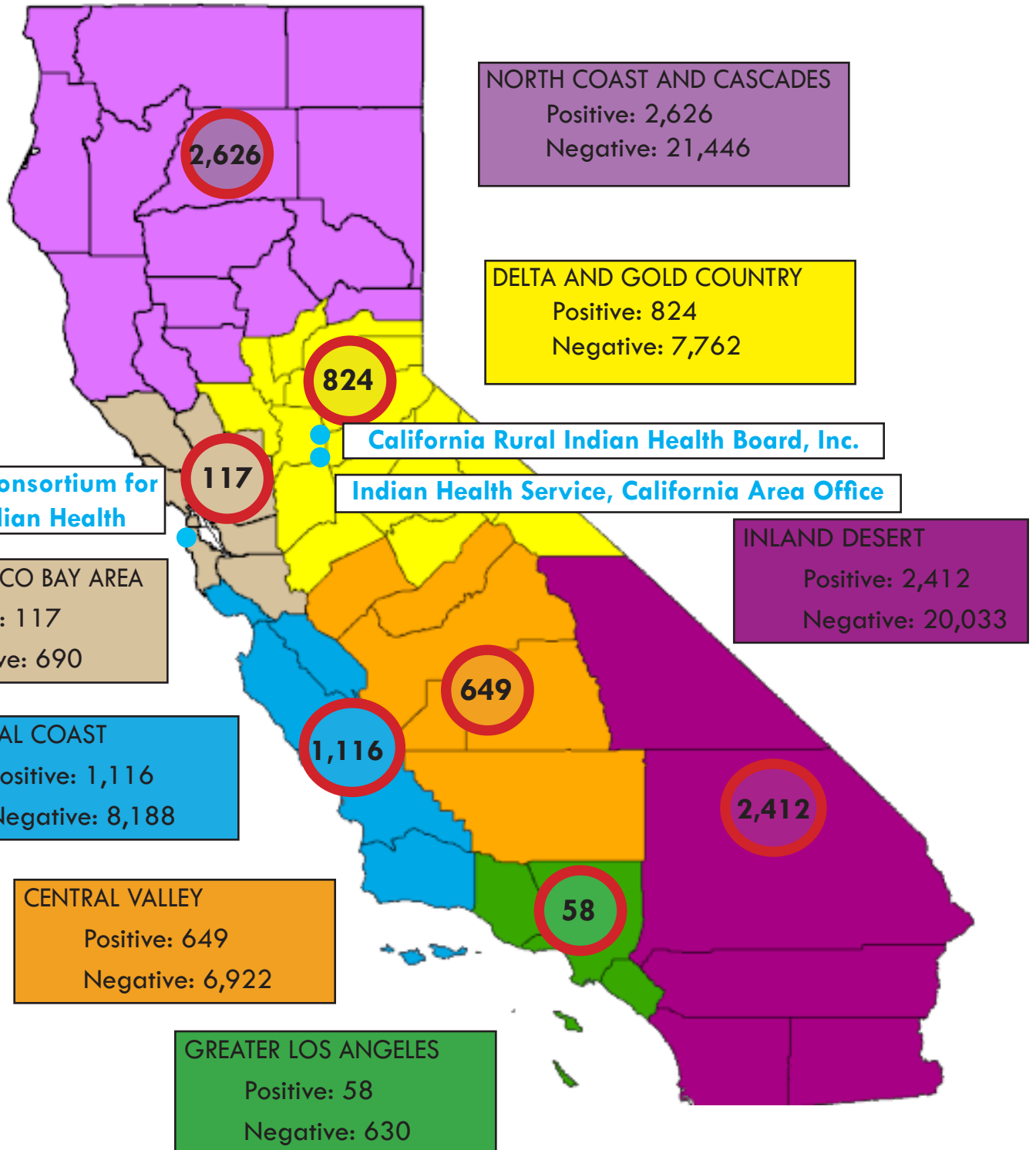

Note: This map shows patients by the regional location of the clinic where they were tested and NOT by the residence of the patients.

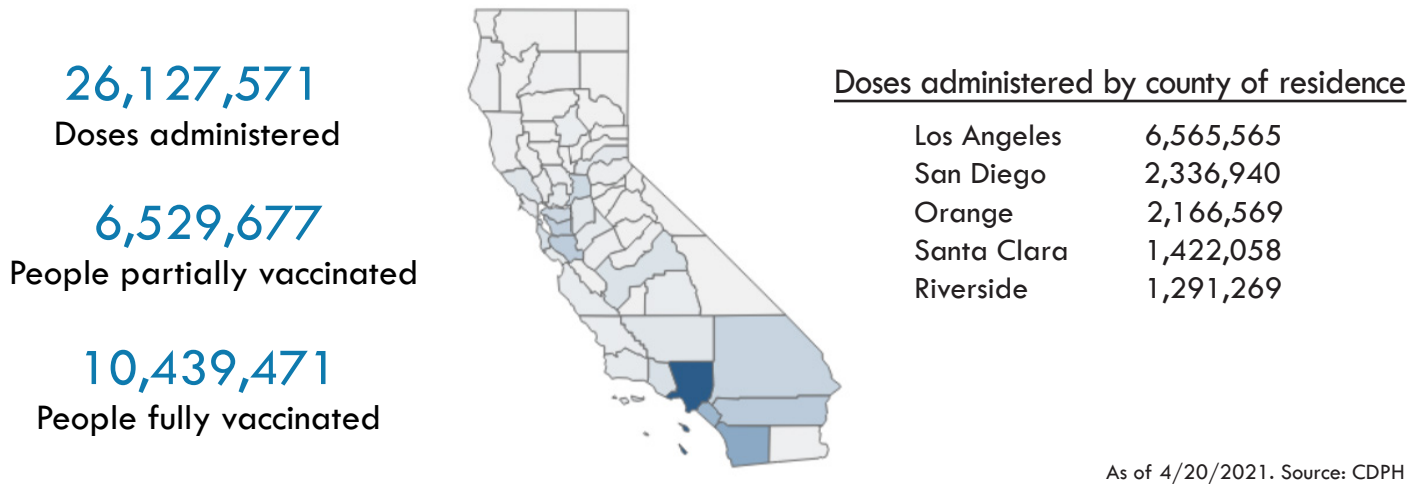


Number of positive cases identified by region

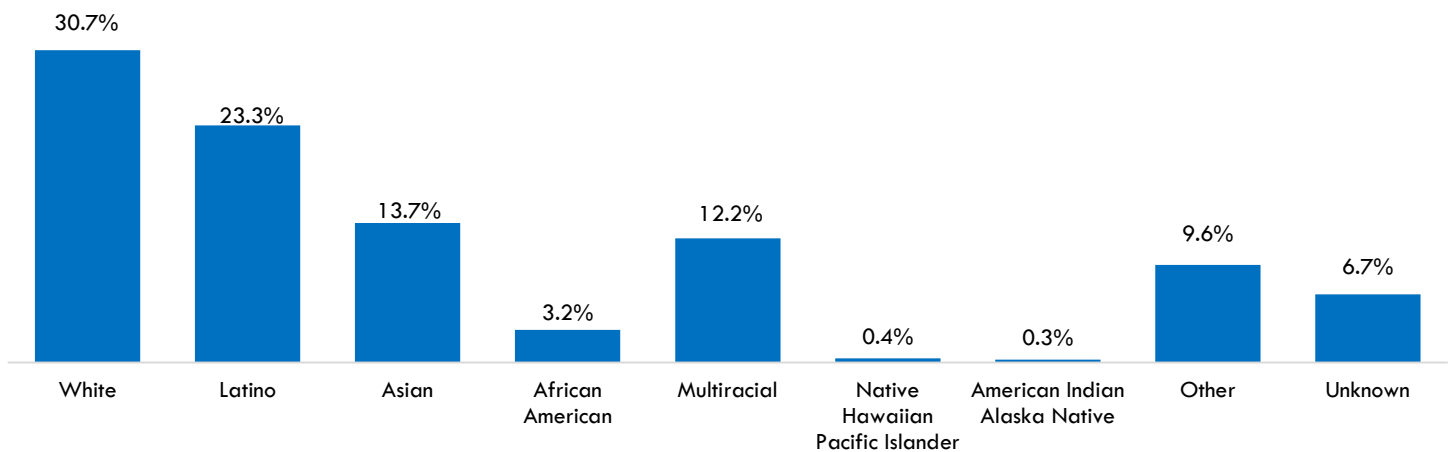

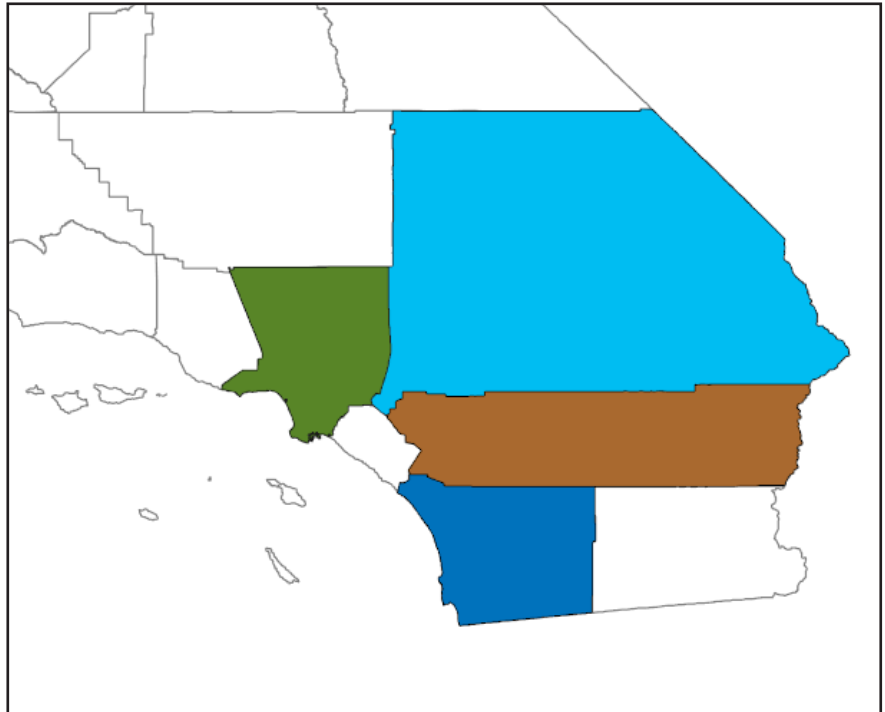

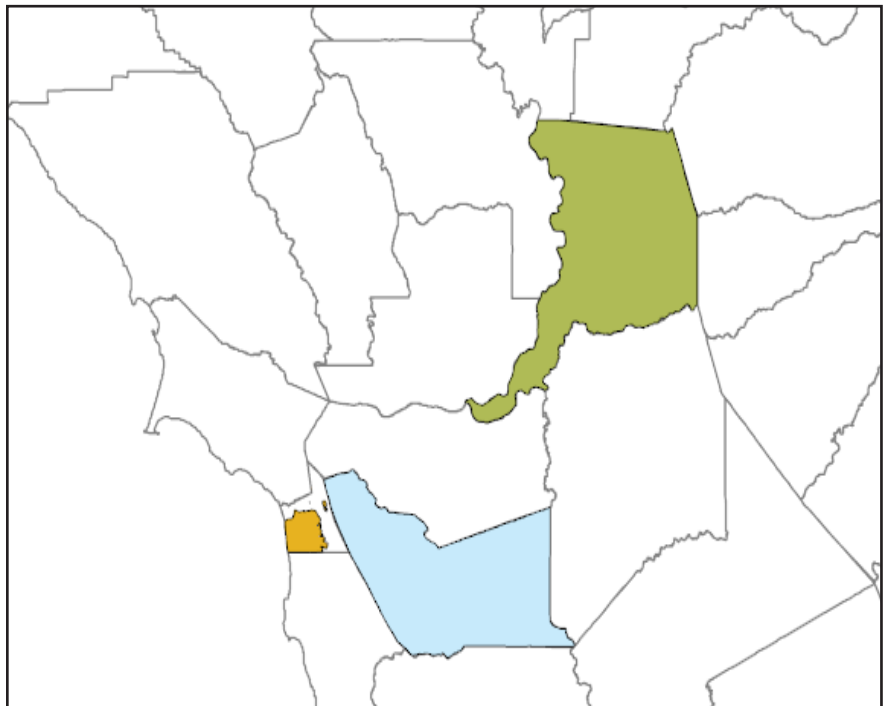
