DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 143.4 million with more than 3 million deaths.

In the United States, the total number of cases stands at 31,666,546 and deaths at 566,494.

While the safety of the Johnson & Johnson vaccine is being reviewed by federal authorities, please immediately pause further use of the Johnson & Johnson COVID-19 vaccine. Additional information and recommendations will follow soon. California aims to fully reopen June 15. The move forward comes as the state has reached 20 million vaccinations, including 4 million in its hardest-hit communities. Masking and vaccinations will continue. Hospitalization rates must stay low and vaccination availability high for the state to fully reopen. When California fully reopens the economy, the state will move beyond the Blueprint for a Safer Economy. Commonsense health measures such as masking will remain across the state. *As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.


A probable case or death is defined by:

i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID19. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.




RISK FOR COVID-19 INFECTION, HOSPITALIZATION, & DEATH BY RACE/ETHNICITY, U.S.








Racial distribution of confirmed COVID-19 cases and deaths in California

















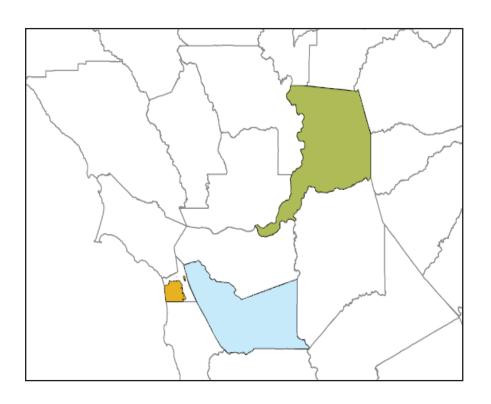


