

DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 148.1 million with more than 3.1 million deaths.

In the United States, the total number of cases stands at 32,031,068 and deaths at 571,297.

The Centers for Disease Control and Prevention has released guidance for fully vaccinated people, outlining what they can safely do — including indoor, mask-free visits with other vaccinated people. View the updated guidance [HERE](#).

The COVID-19 Health Equity Playbook for Communities is intended to support local communities in achieving their Health Equity Measure as part of the California’s Blueprint for a Safer Economy and building an equitable recovery. Following a thorough safety review, including two meetings of the CDC’s Advisory Committee on Immunization Practices, the U.S. Food and Drug Administration and the U.S. Centers for Disease Control and Prevention have determined that the recommended pause regarding the use of the Janssen (Johnson & Johnson) COVID-19 Vaccine in the U.S. should be lifted and use of the vaccine should resume. The pause was recommended after reports of six cases of a rare and severe type of blood clot in individuals following administration of the Janssen COVID-19 Vaccine. The Indian Health Service is also lifting the pause of all Johnson & Johnson/ Janssen COVID-19 vaccine administration. To date, there have been no cases reported through IHS of the rare and severe type of blood clot seen in some individuals who have received the Johnson & Johnson/Janssen vaccine.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

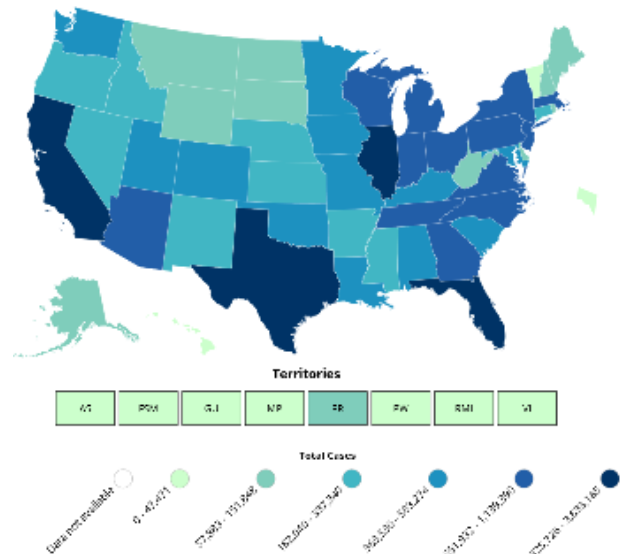
A probable case or death is defined by:

- meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or
 - meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or
 - meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.
- State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

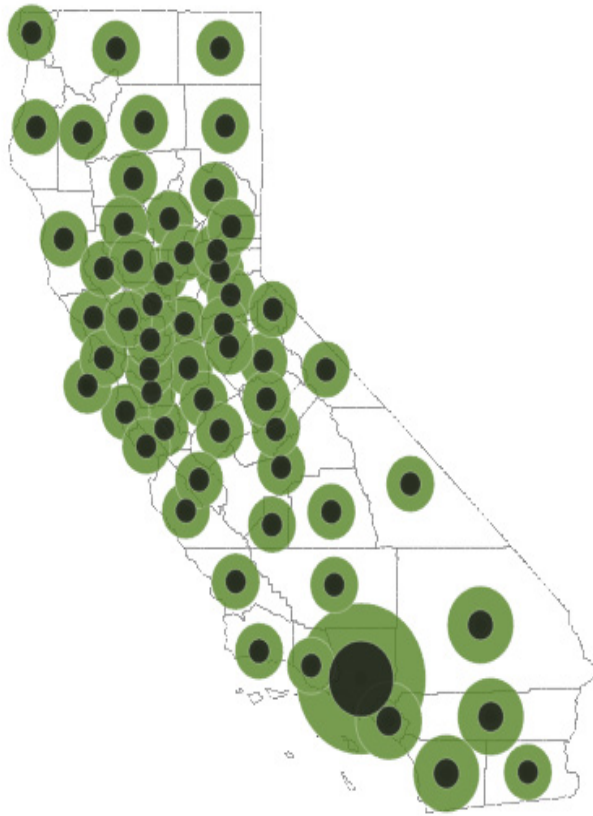

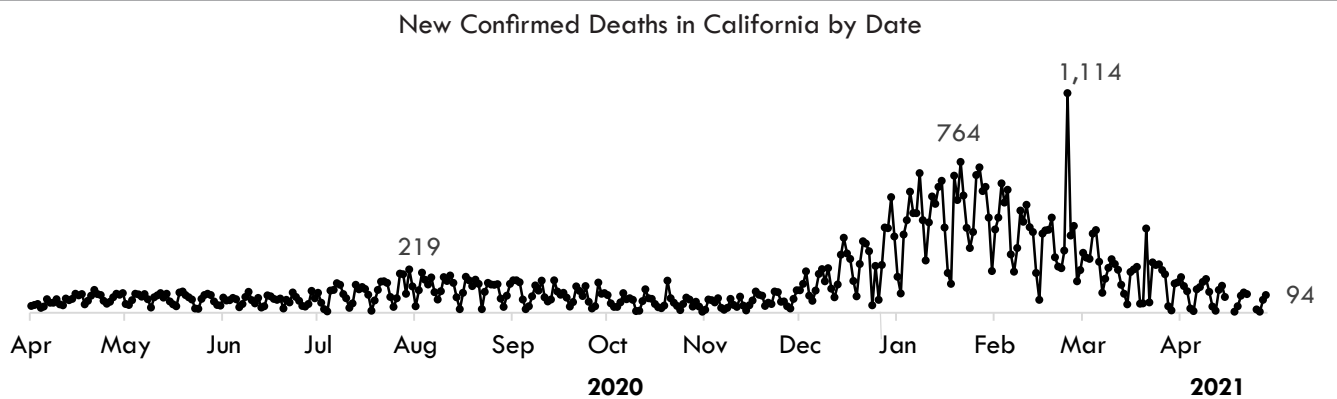
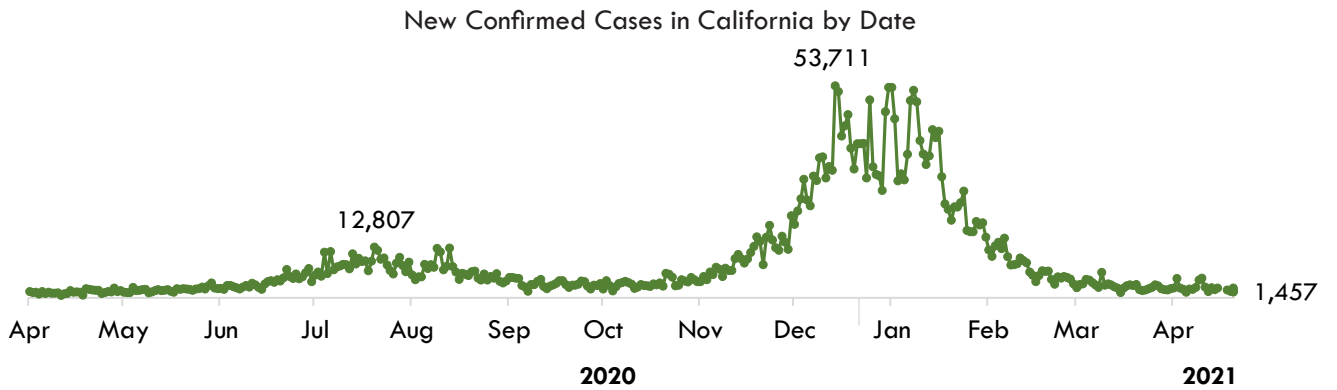

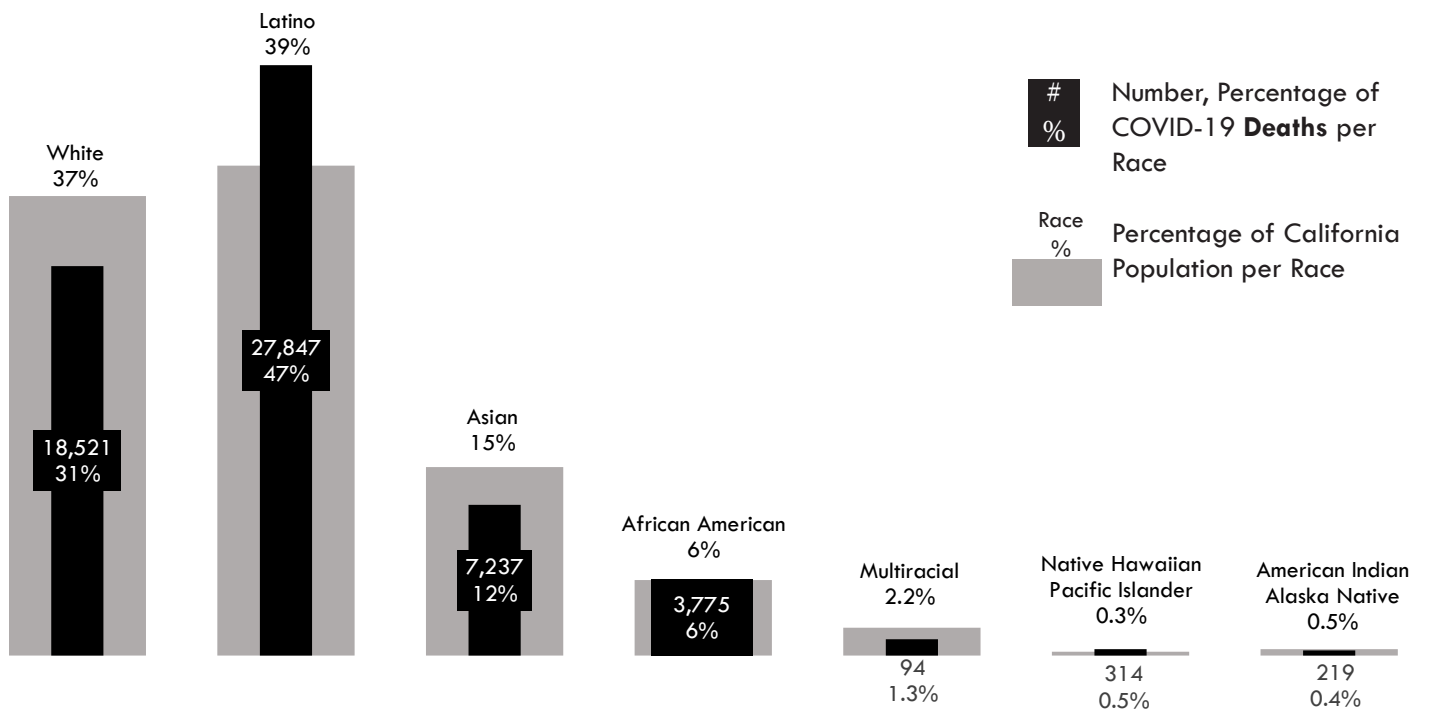
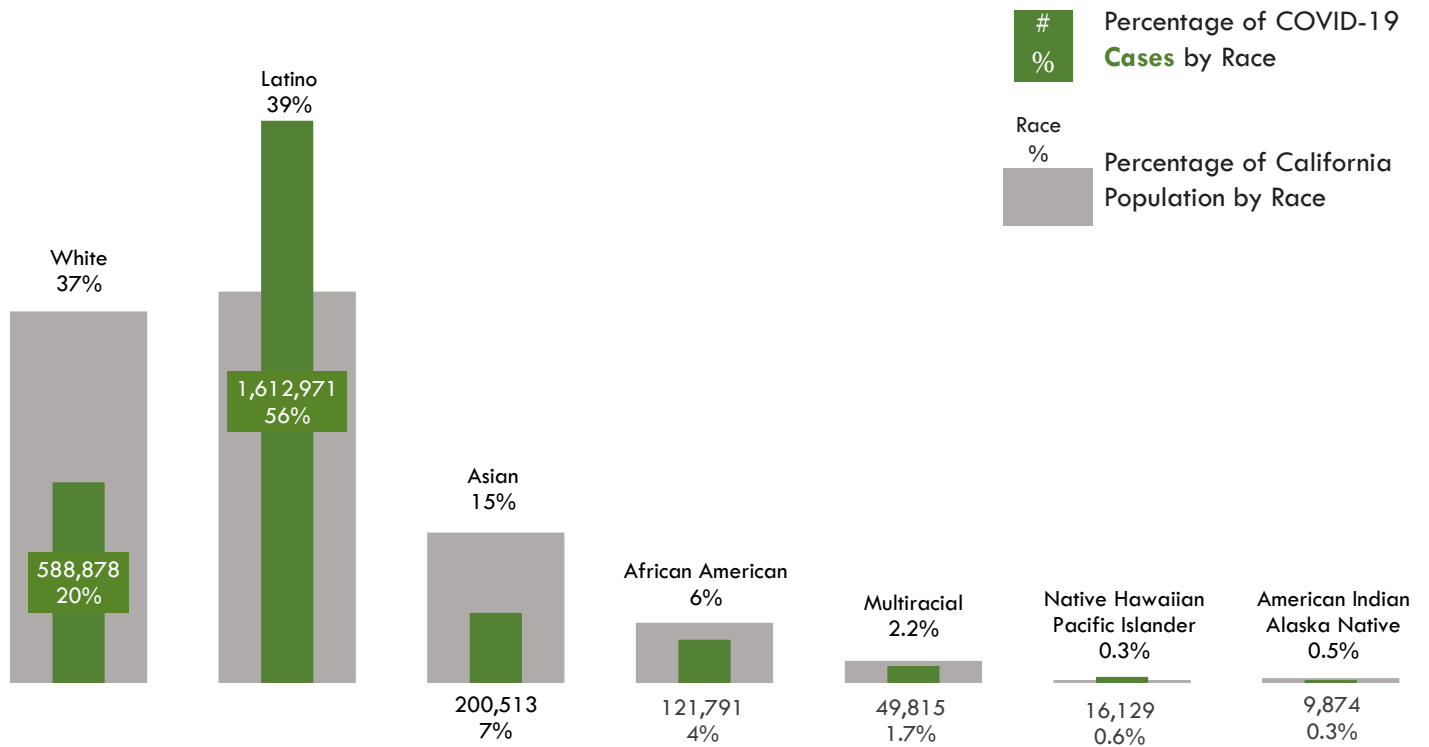

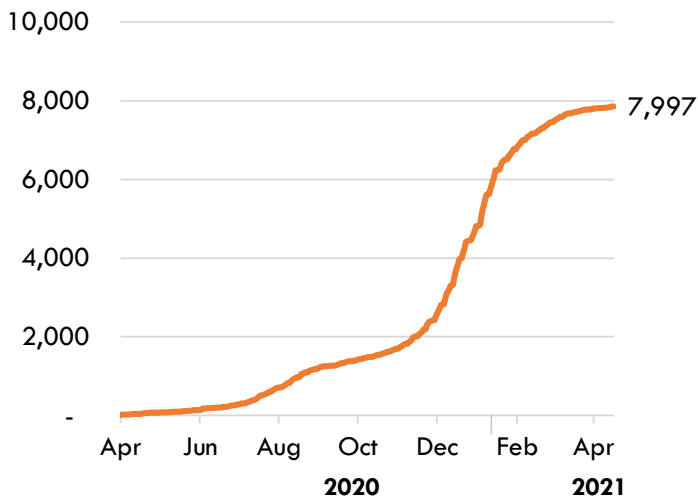

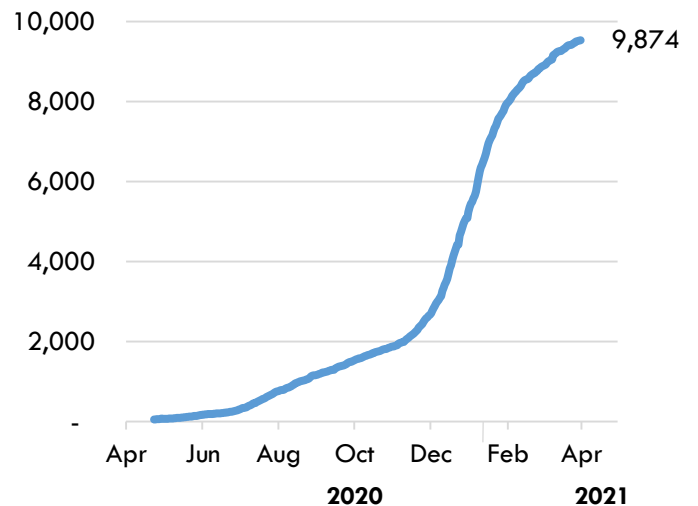

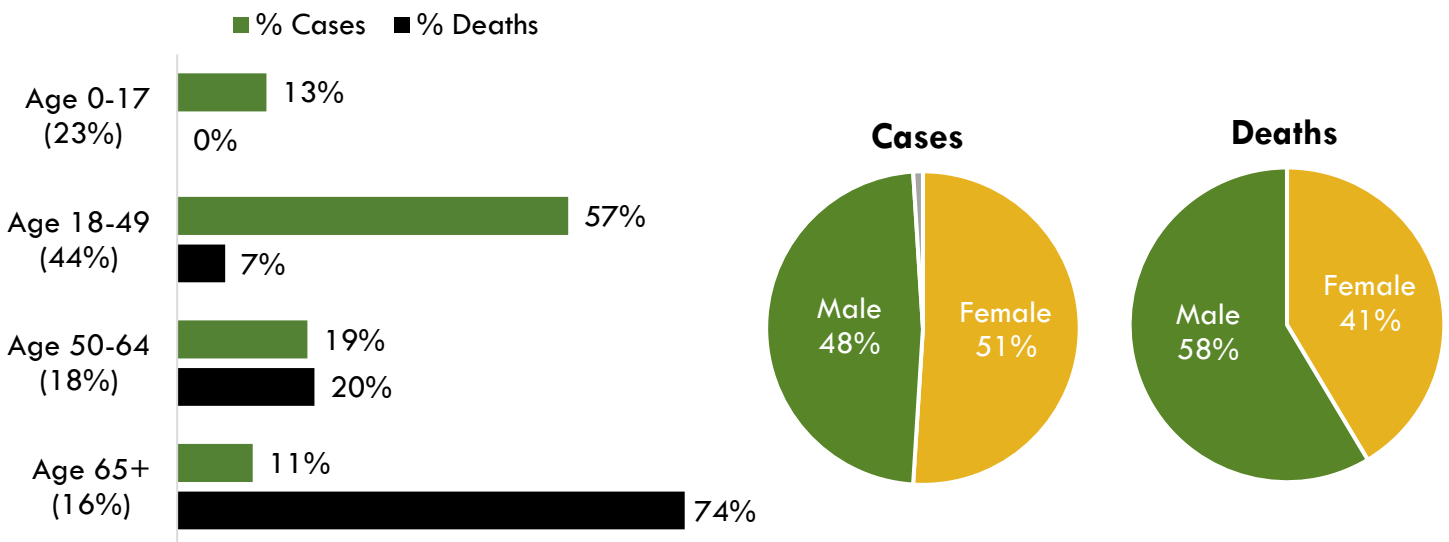

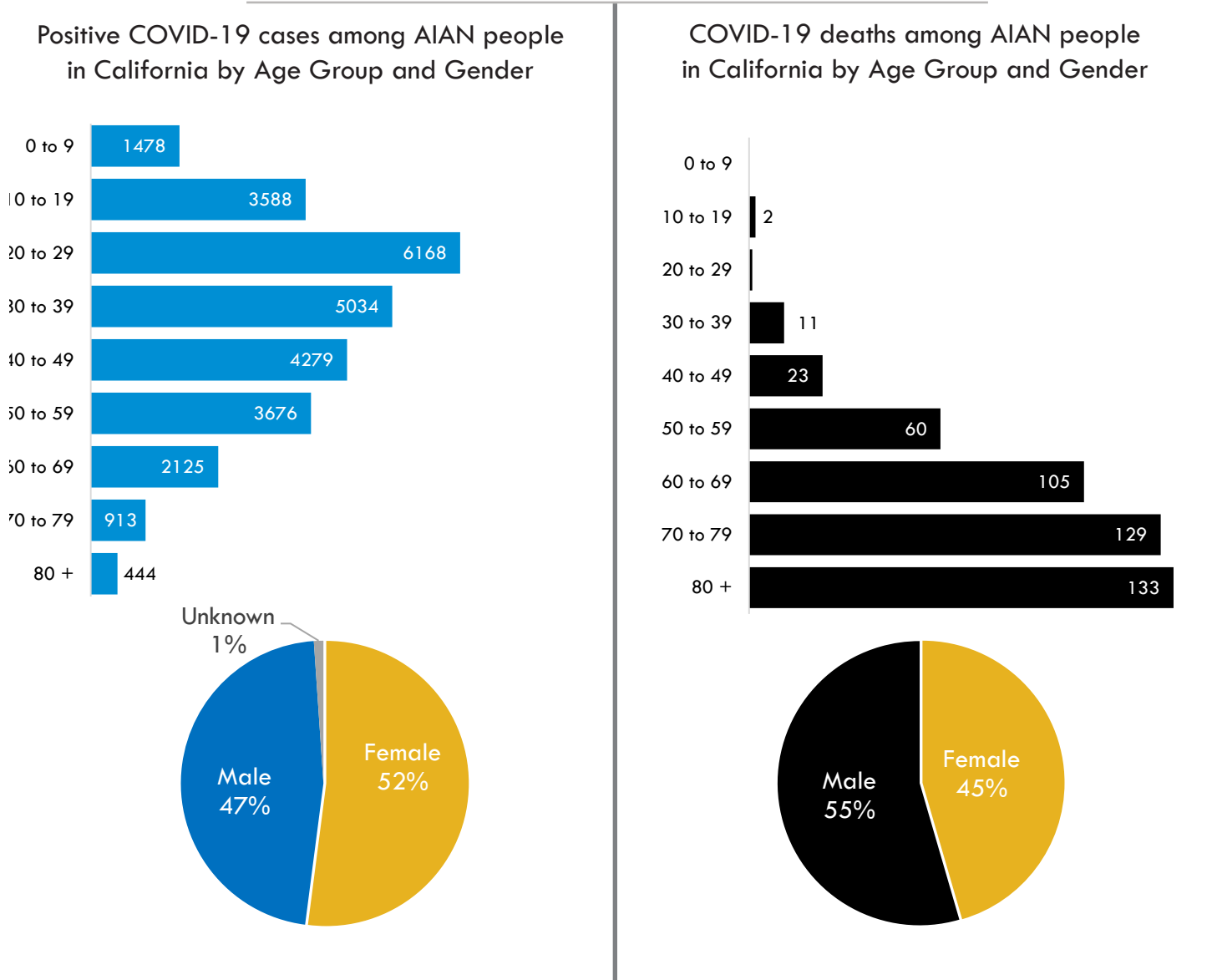

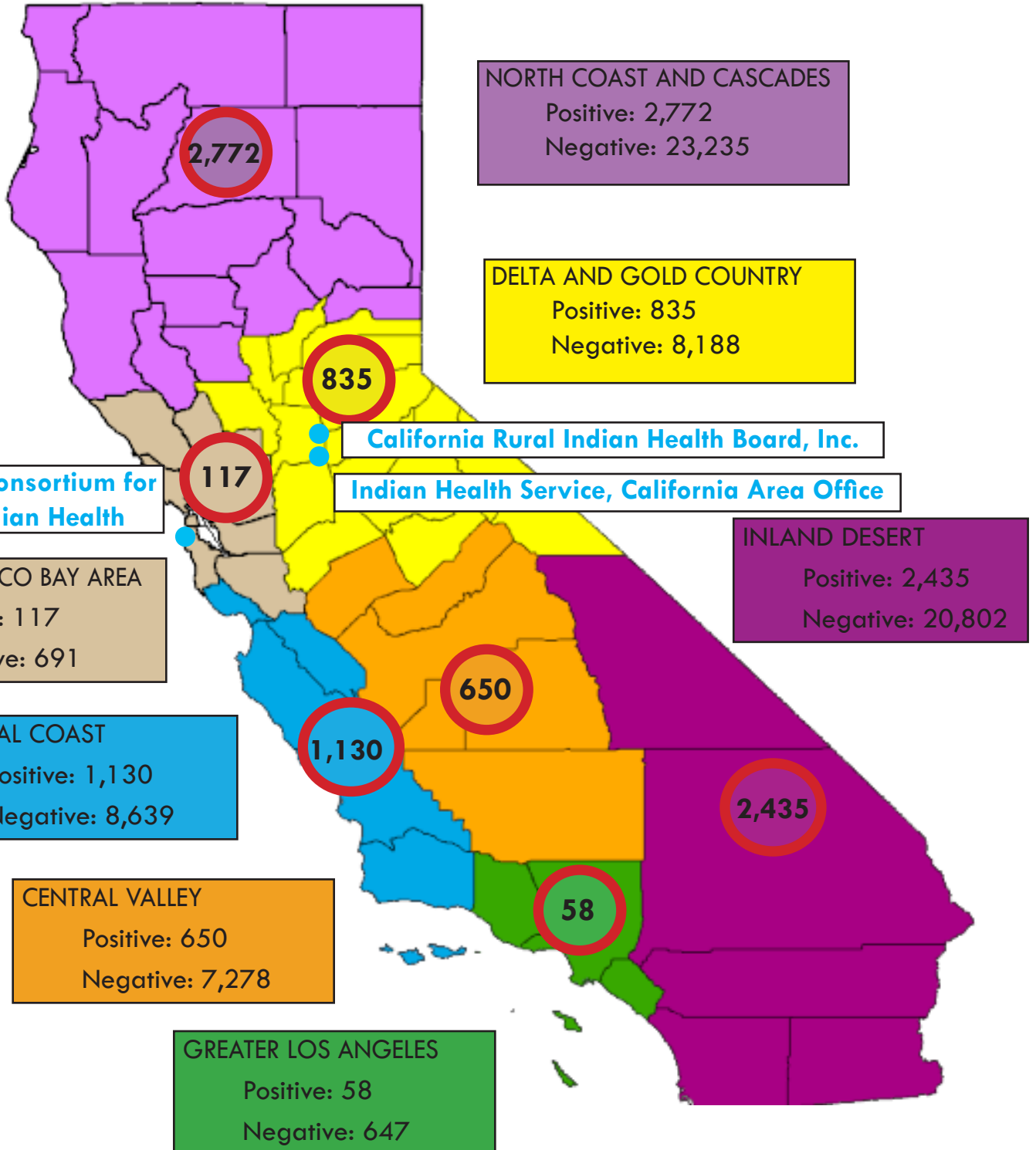

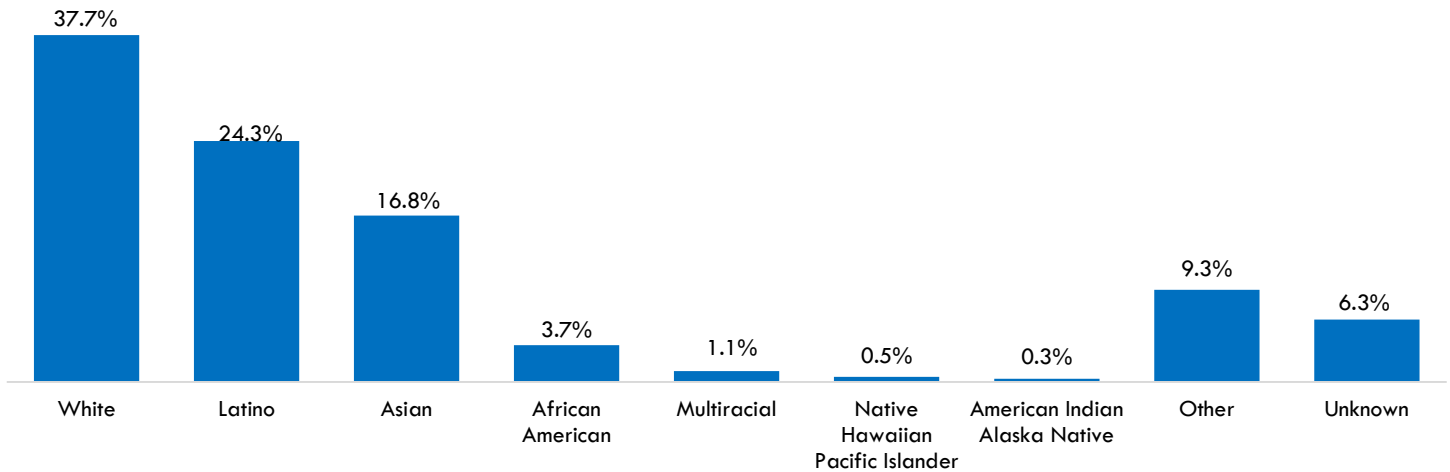

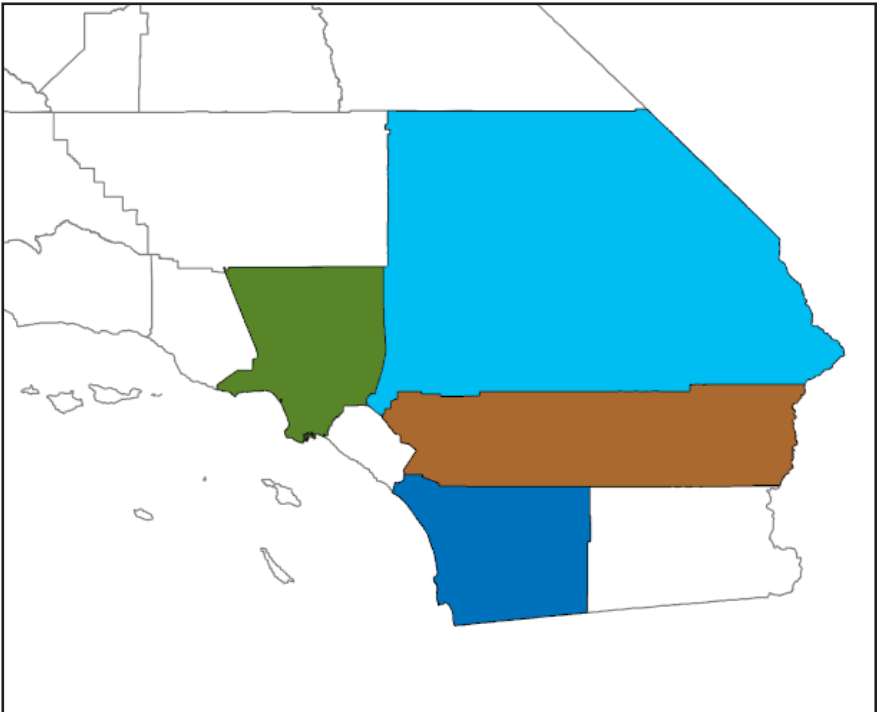

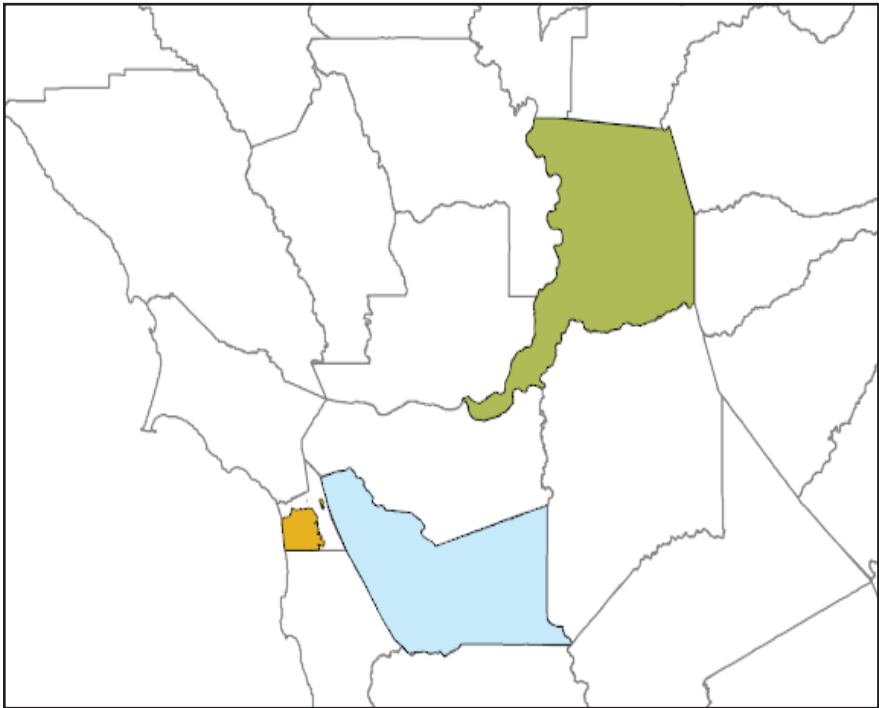

TRIBAL STATE OF EMERGENCY AND SHELTER IN PLACE DECLARATIONS



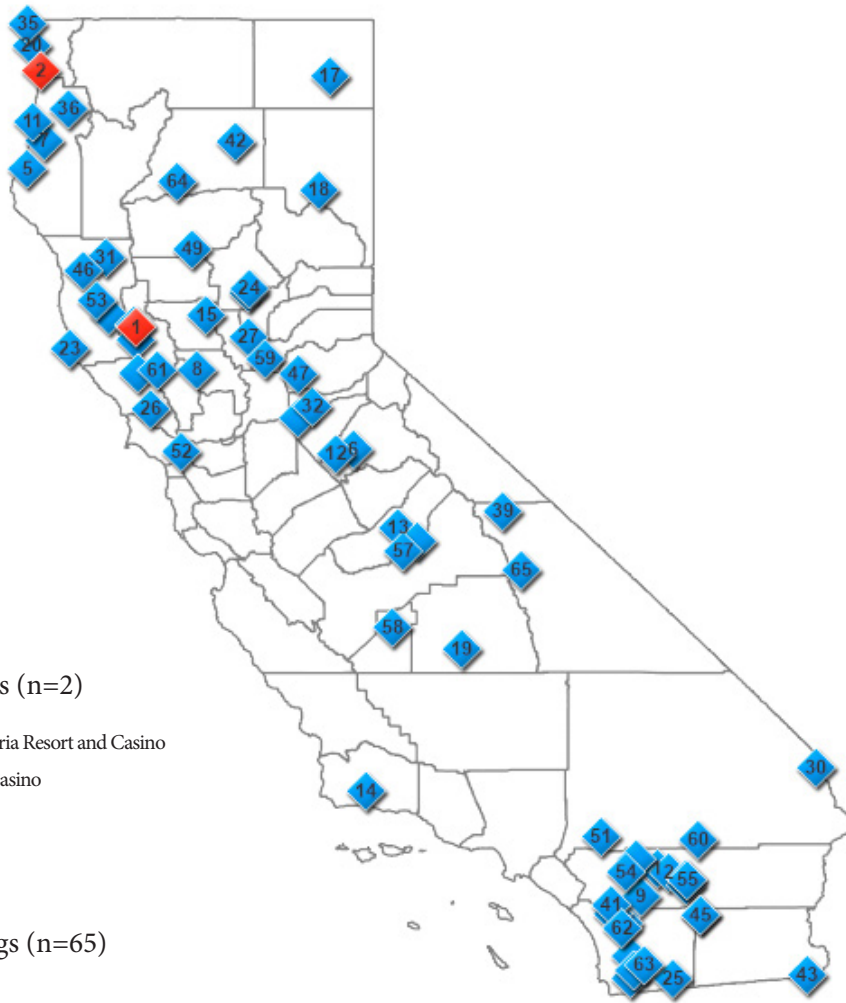
