DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 153.9 million with more than 3.2 million deaths.

In the United States as of May 3, the total number of cases stands at 32,313,016 and deaths at 575,491.

Data from six models indicate that with high vaccination coverage and moderate NPI adherence, hospitalizations and deaths will likely remain low nationally, with a sharp decline in cases projected by July 2021. COVID-19: U.S. at a Glance*

- Total cases: 32,313,016
- Total deaths: 575,491
- Jurisdictions reporting cases: 55 (50 states, District of Columbia, Guam, Puerto Rico, the Northern Mariana Islands, and the U.S. Virgin Islands)

*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

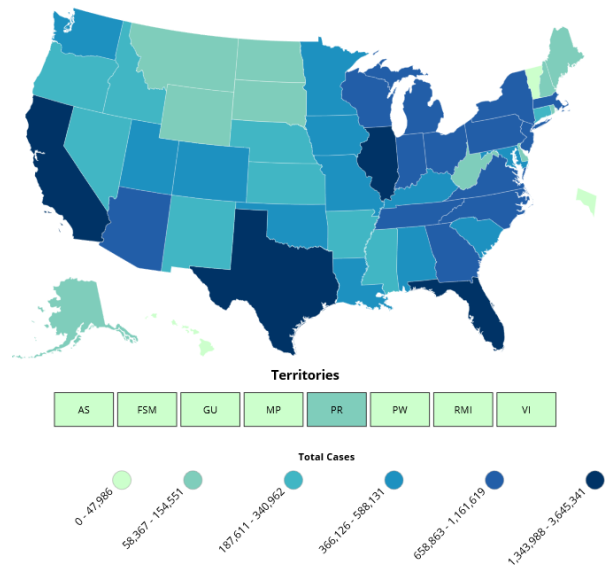
A probable case or death is defined by:

- i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.
- State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

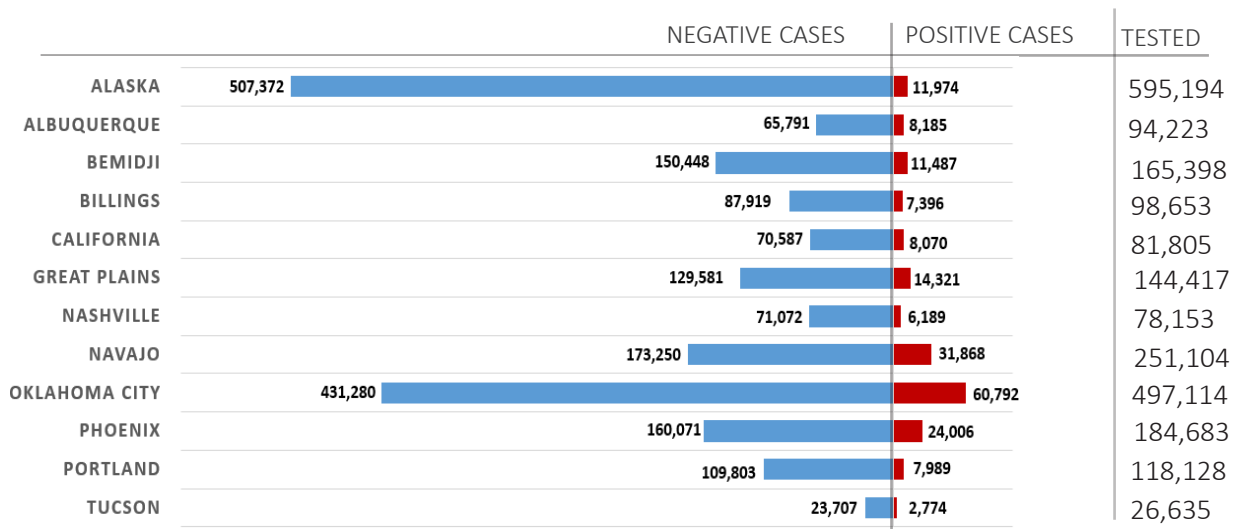


RISK FOR COVID-19 INFECTION, HOSPITALIZATION, & DEATH BY RACE/ETHNICITY, U.S.

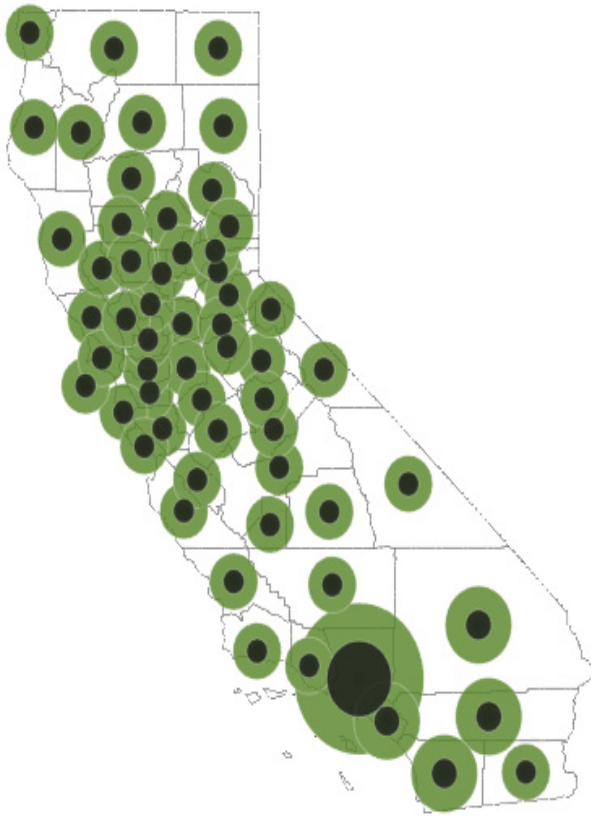

INDIAN HEALTH SERVICE CALIFORNIA AREA

81,805 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 5/3/2021.

Of these, 8,070 patients have tested positive for COVID-19 and 70,587 have tested negative for COVID-19.

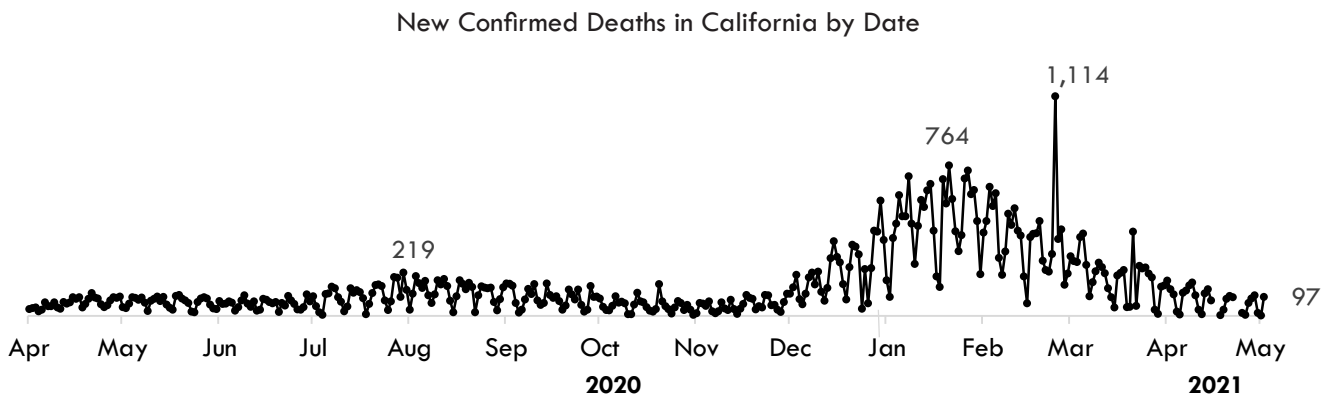
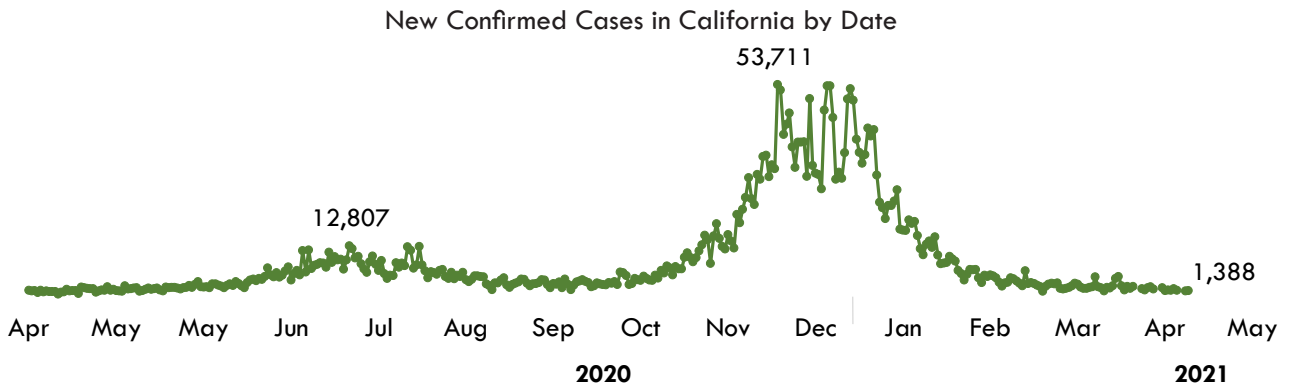

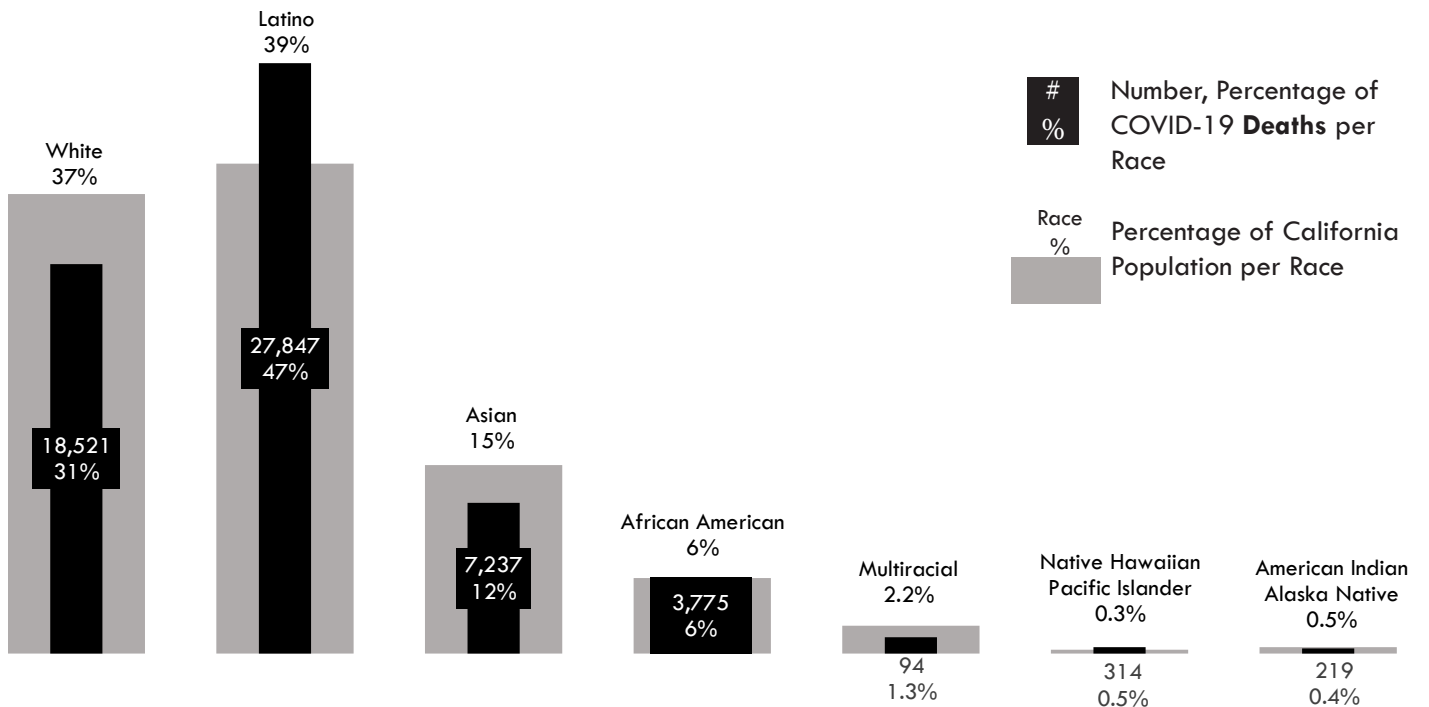
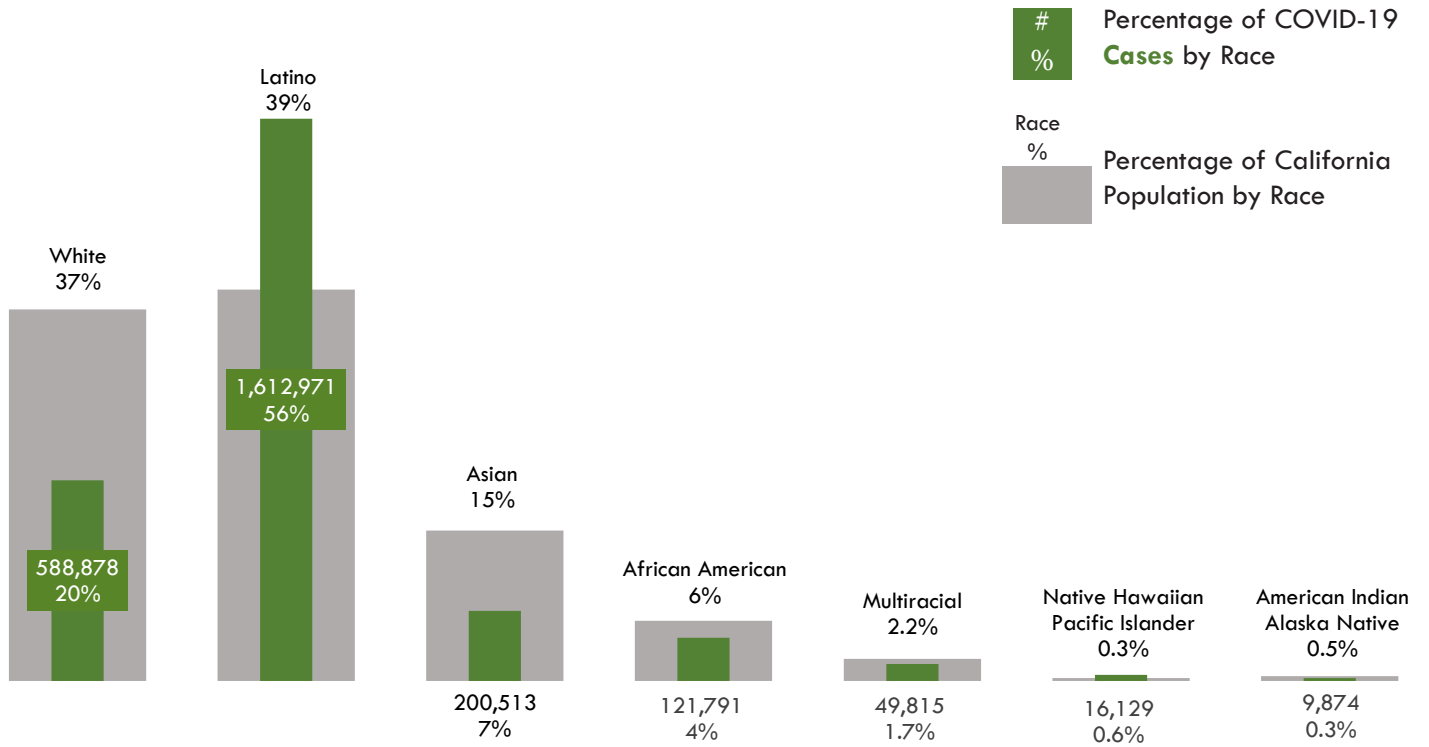

American Indians and Alaska Natives account for 0.5% percent of the population, **0.3% of COVID-19 cases**, and **0.3% of deaths** in California. This includes a total of **9,874 cases** and **219 deaths** among American Indian and Alaska Native people in California.

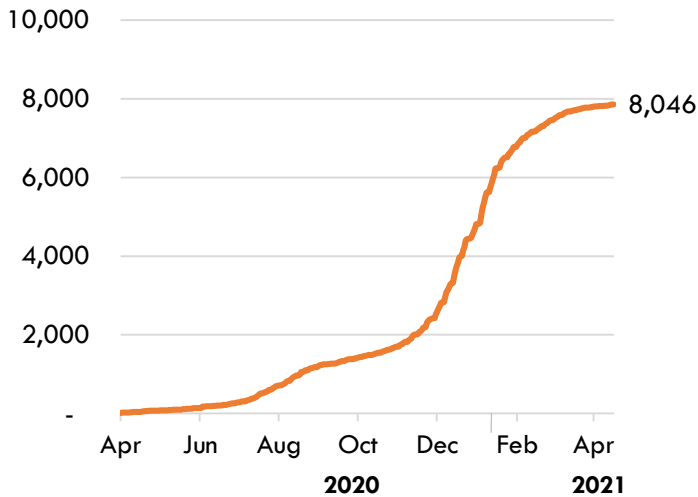

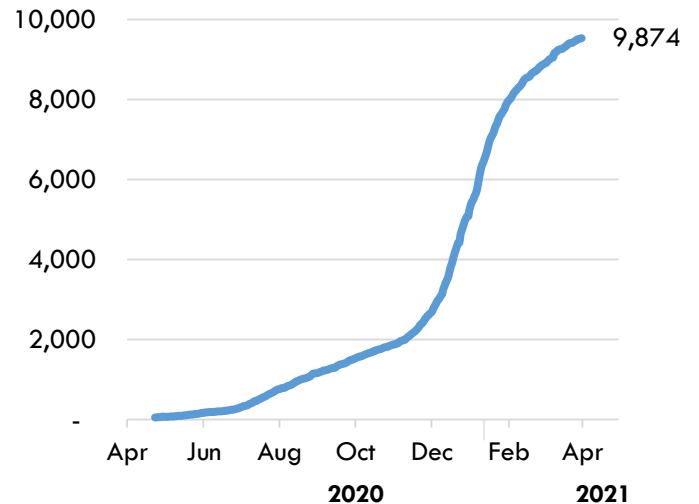

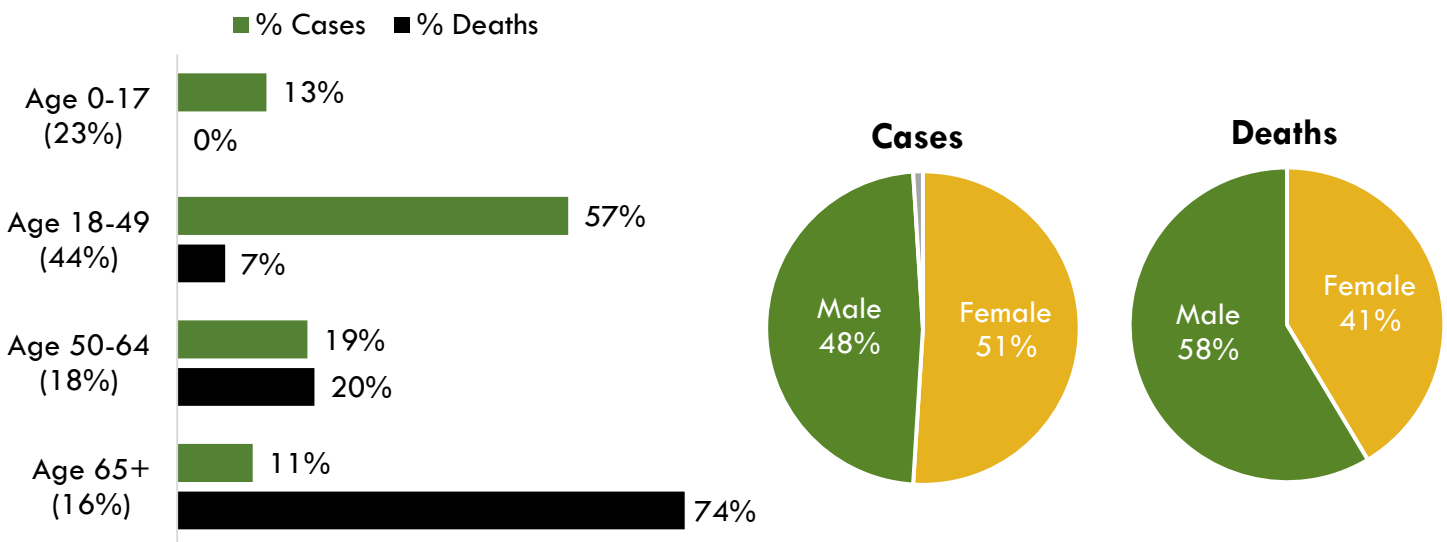

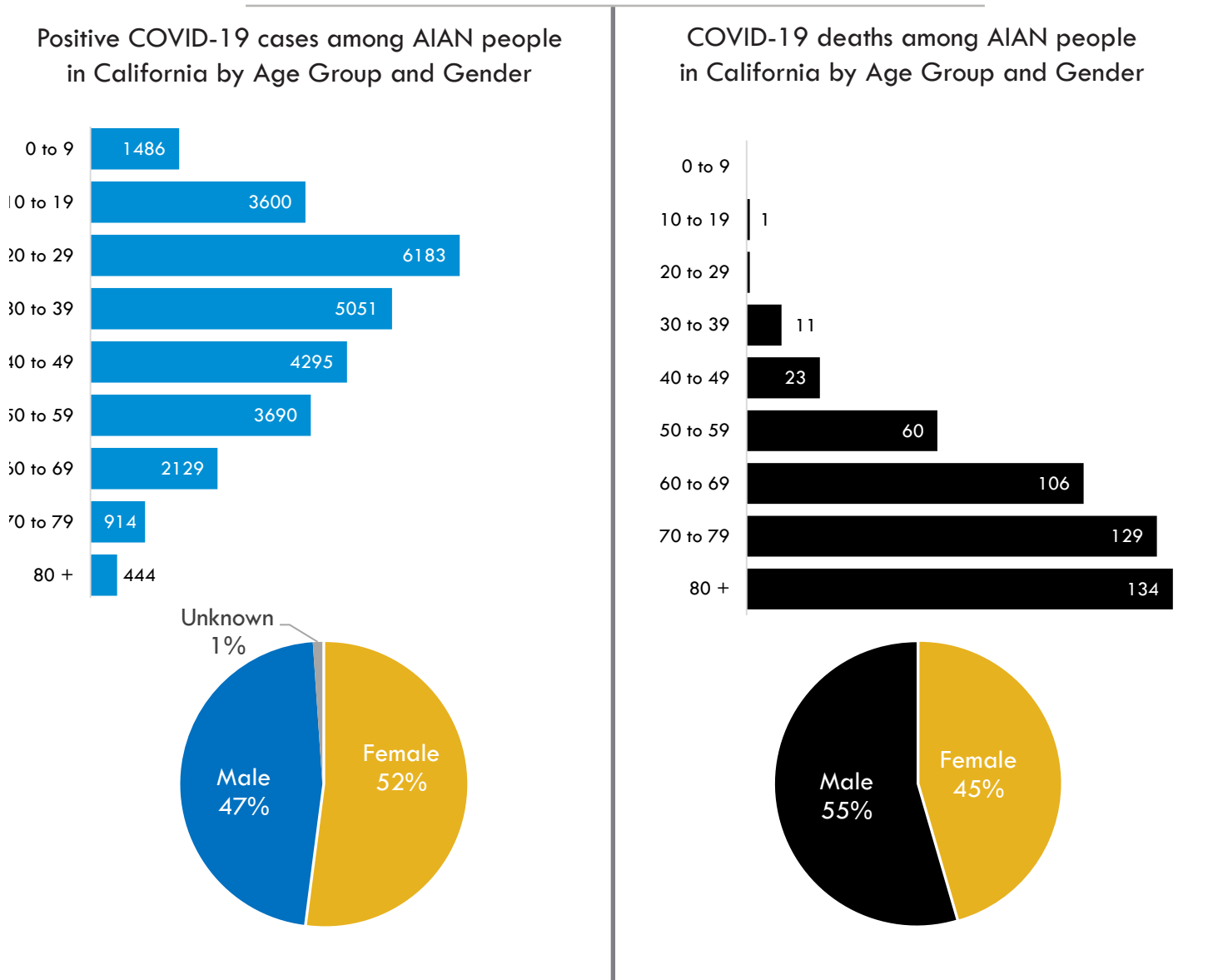

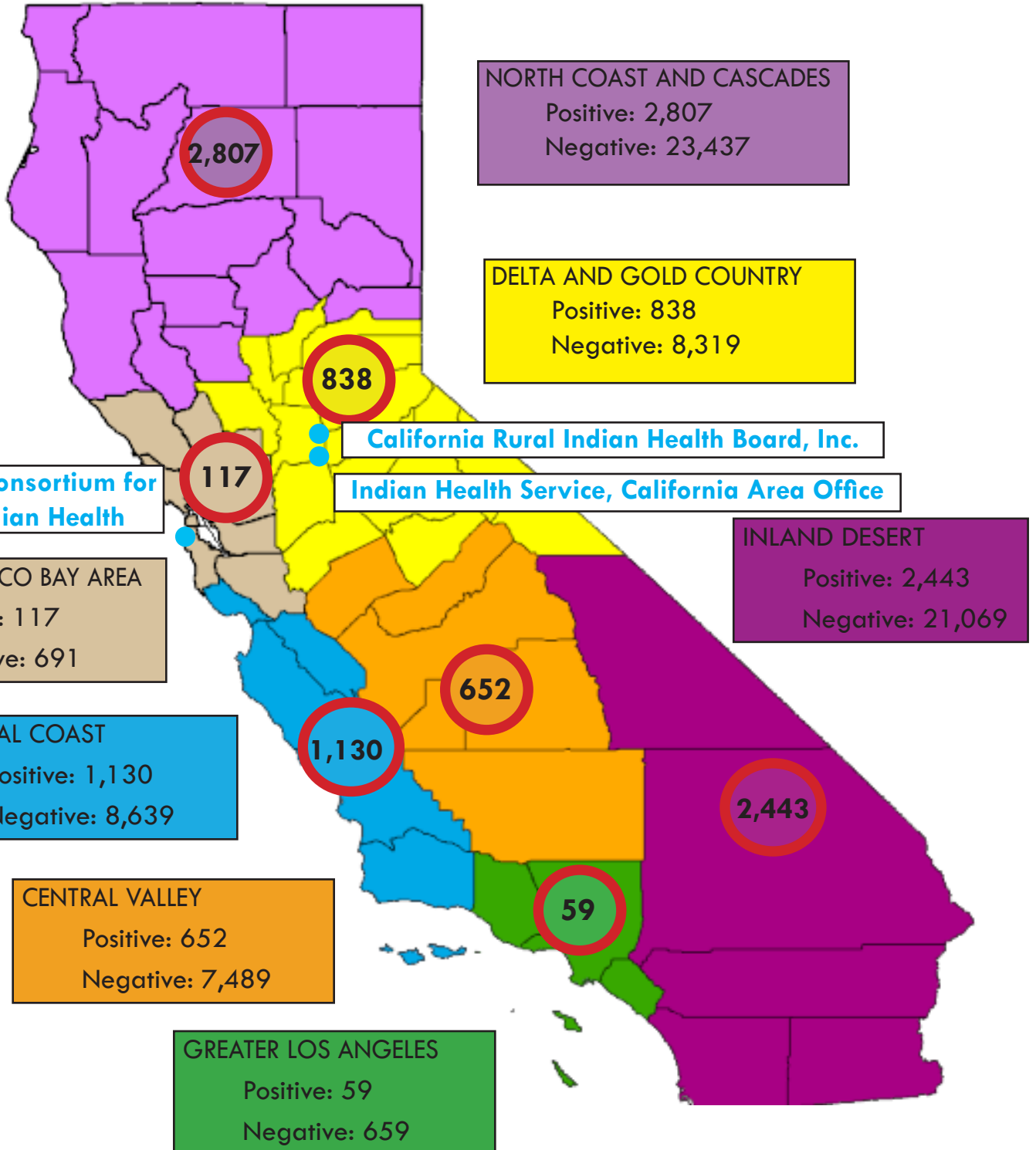

Note: This map shows patients by the regional location of the clinic where they were tested and NOT by the residence of the patients.

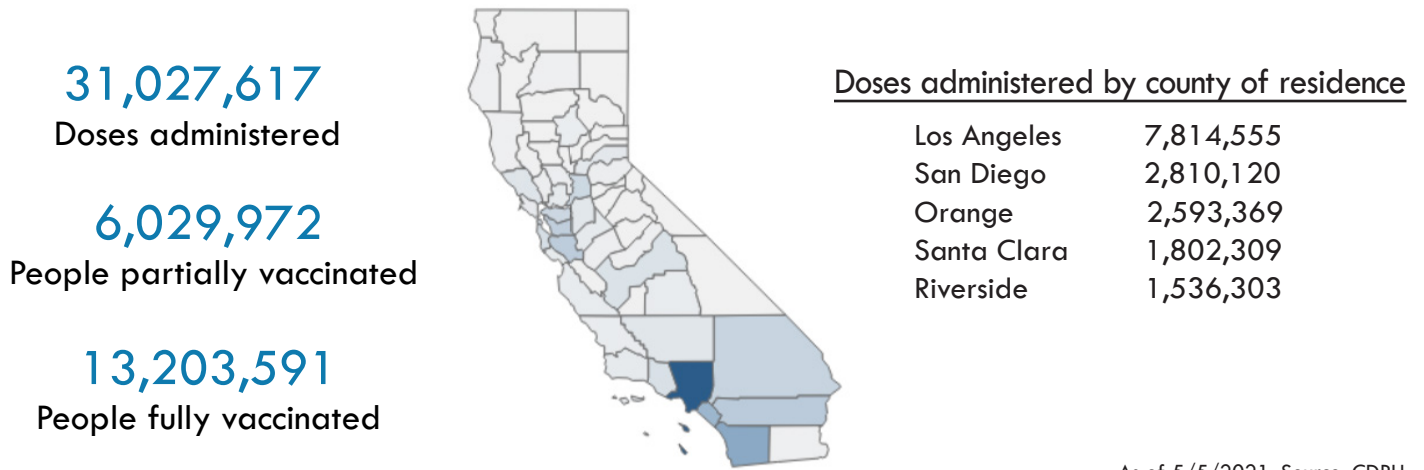


Number of positive cases identified by region



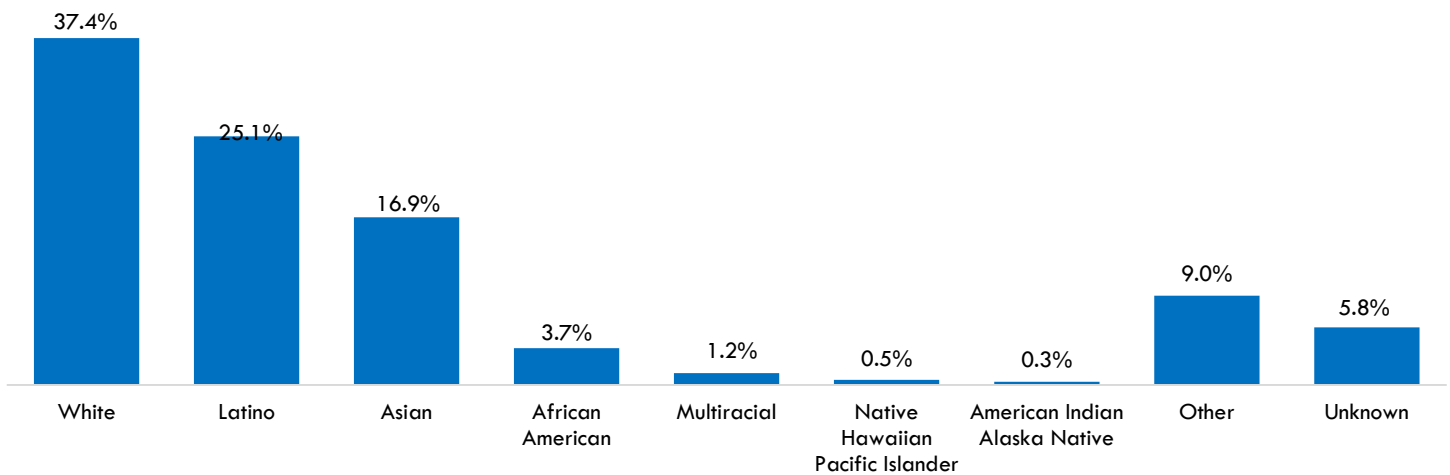

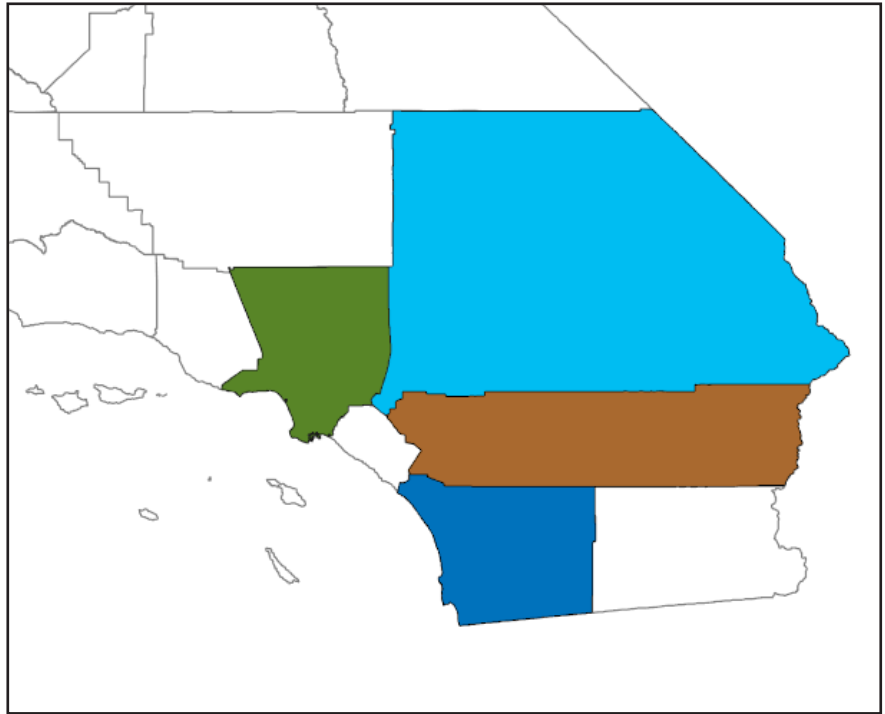

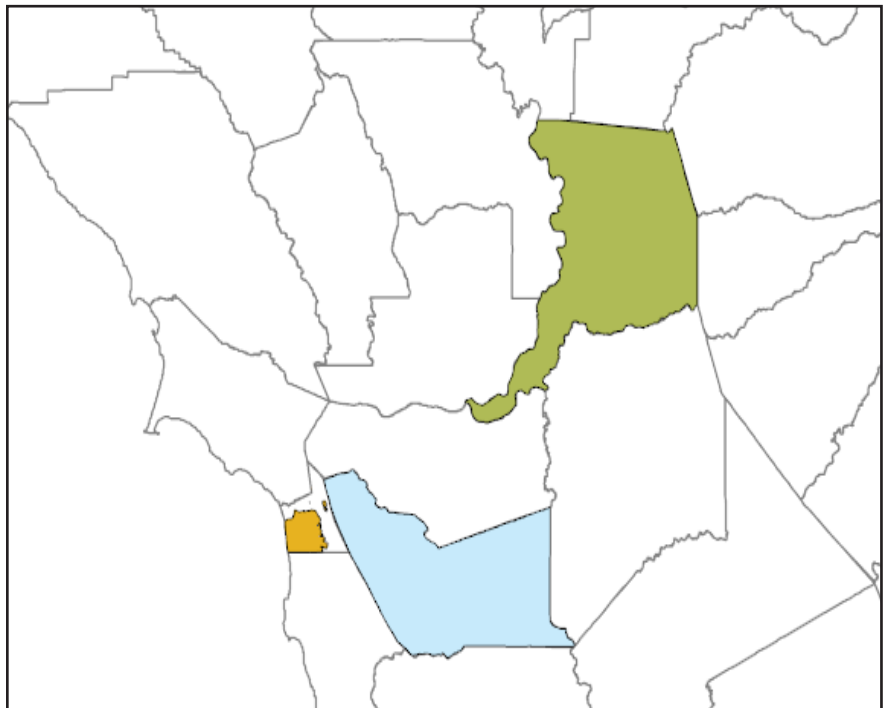

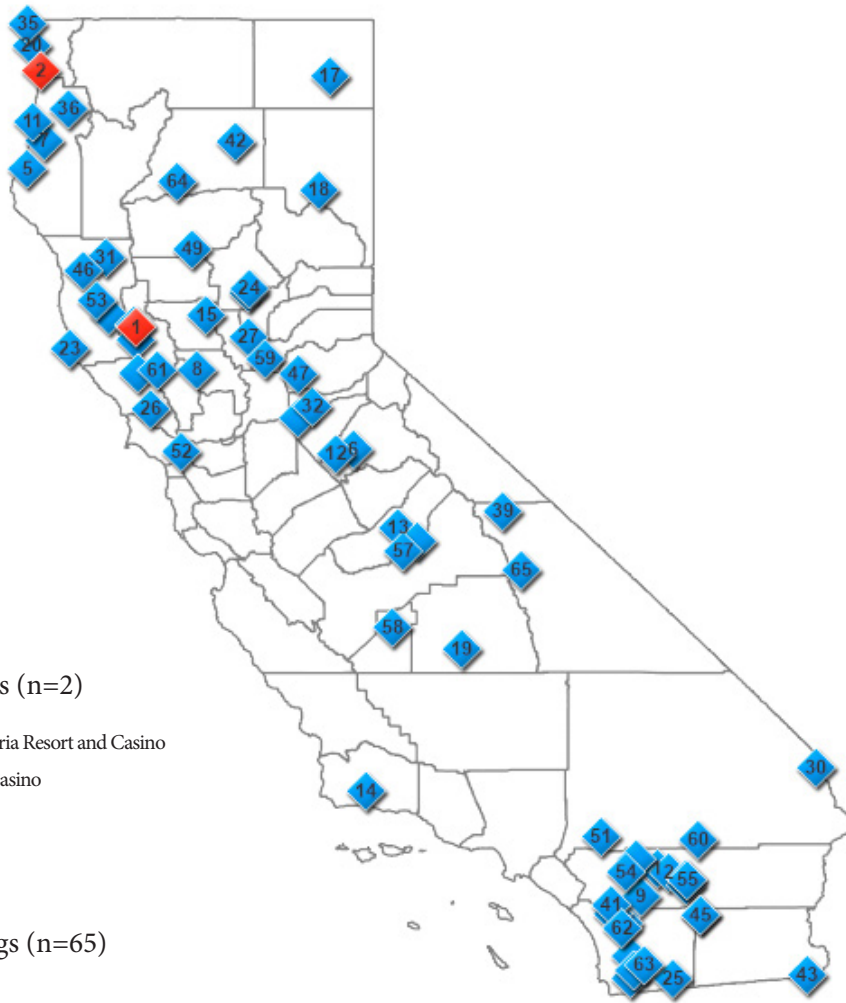
