## DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 159.3 million with more than 3.3 million deaths.

In the United States, the total number of cases stands at 32,608,287 and deaths at 580,073.

The total number of COVID-19 vaccinations administered in California has reached 30 million. See vaccination statistics statewide and broken down by county in their Vaccine Dashboard [HERE](#).

## UNITED STATES

### COVID-19: U.S. at a Glance\*

- Total cases: 32,608,287
- Total deaths: 580,073
- Jurisdictions reporting cases: 55 (50 states, District of Columbia, Guam, Puerto Rico, the Northern Mariana Islands, and the U.S. Virgin Islands)

\*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

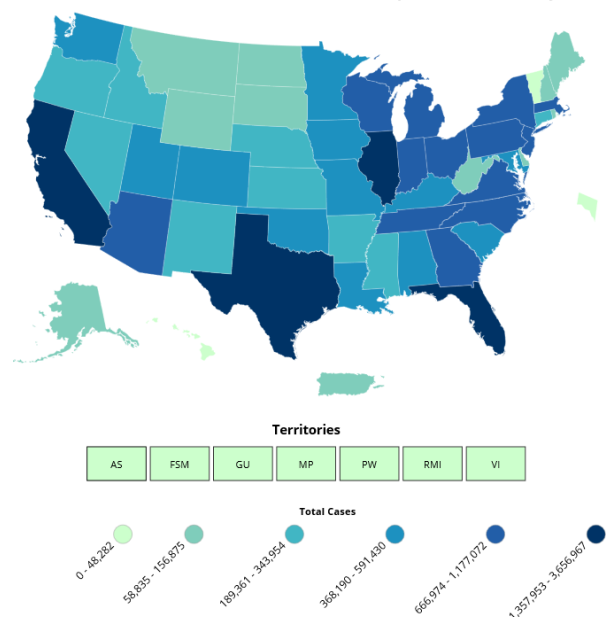
A probable case or death is defined by:

- i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.
- State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

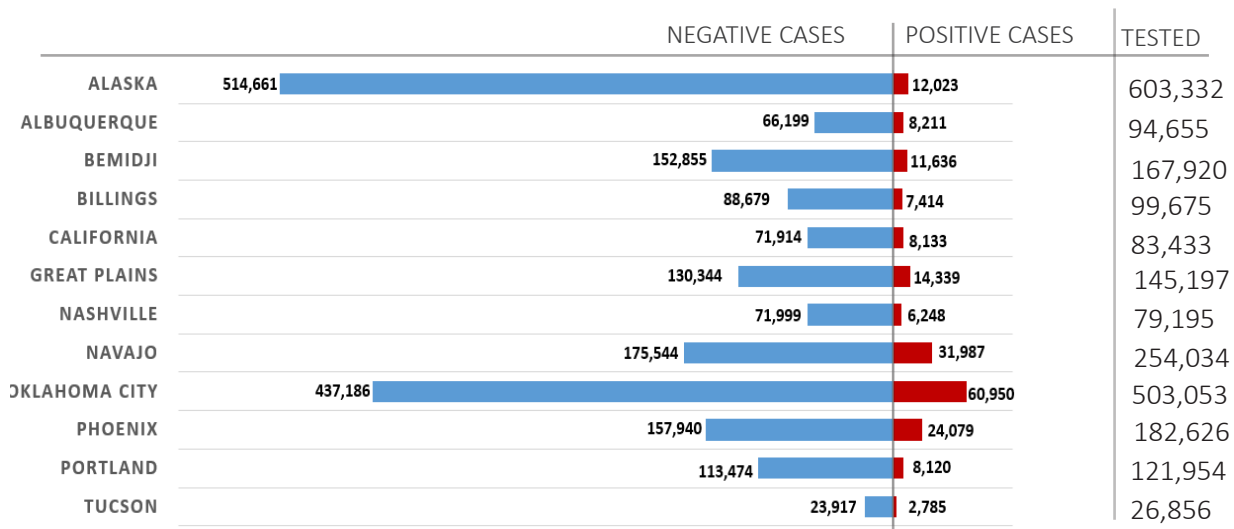


## RISK FOR COVID-19 INFECTION, HOSPITALIZATION, & DEATH BY RACE/ETHNICITY, U.S.

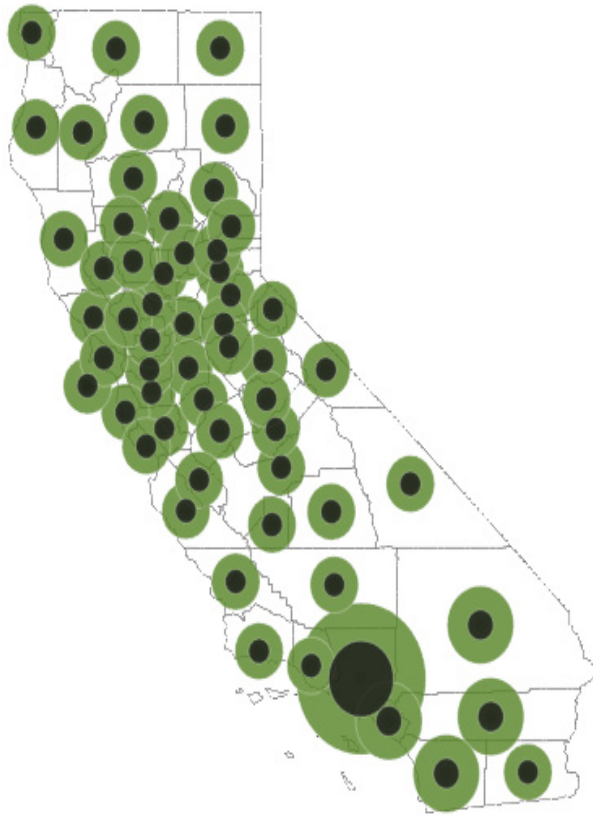

83,433 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 5/10/2021.

Of these, 8,133 patients have tested positive for COVID-19 and 71,914 have tested negative for COVID-19.

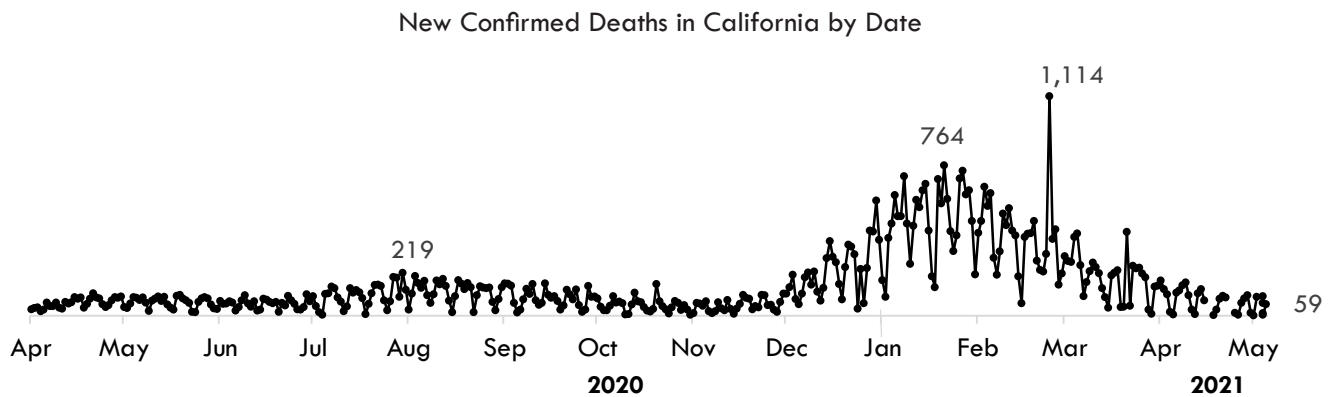
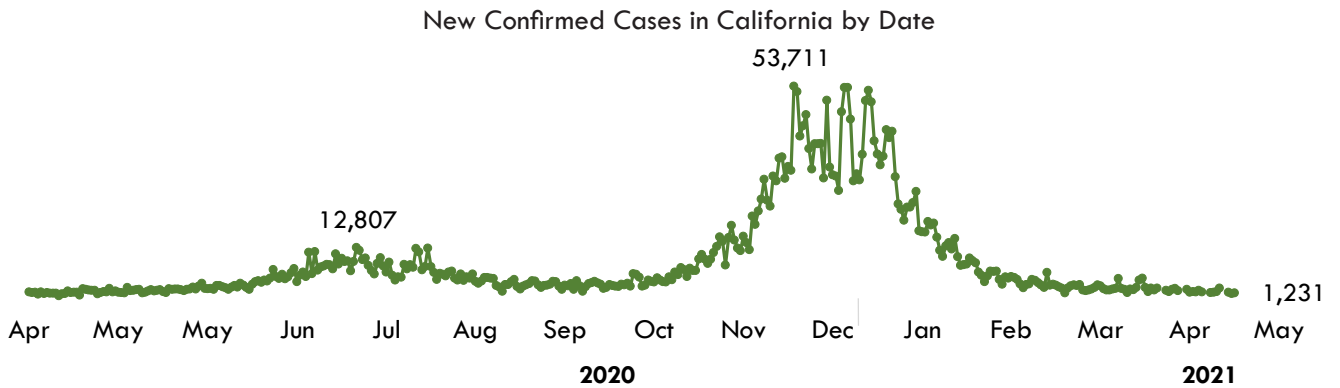

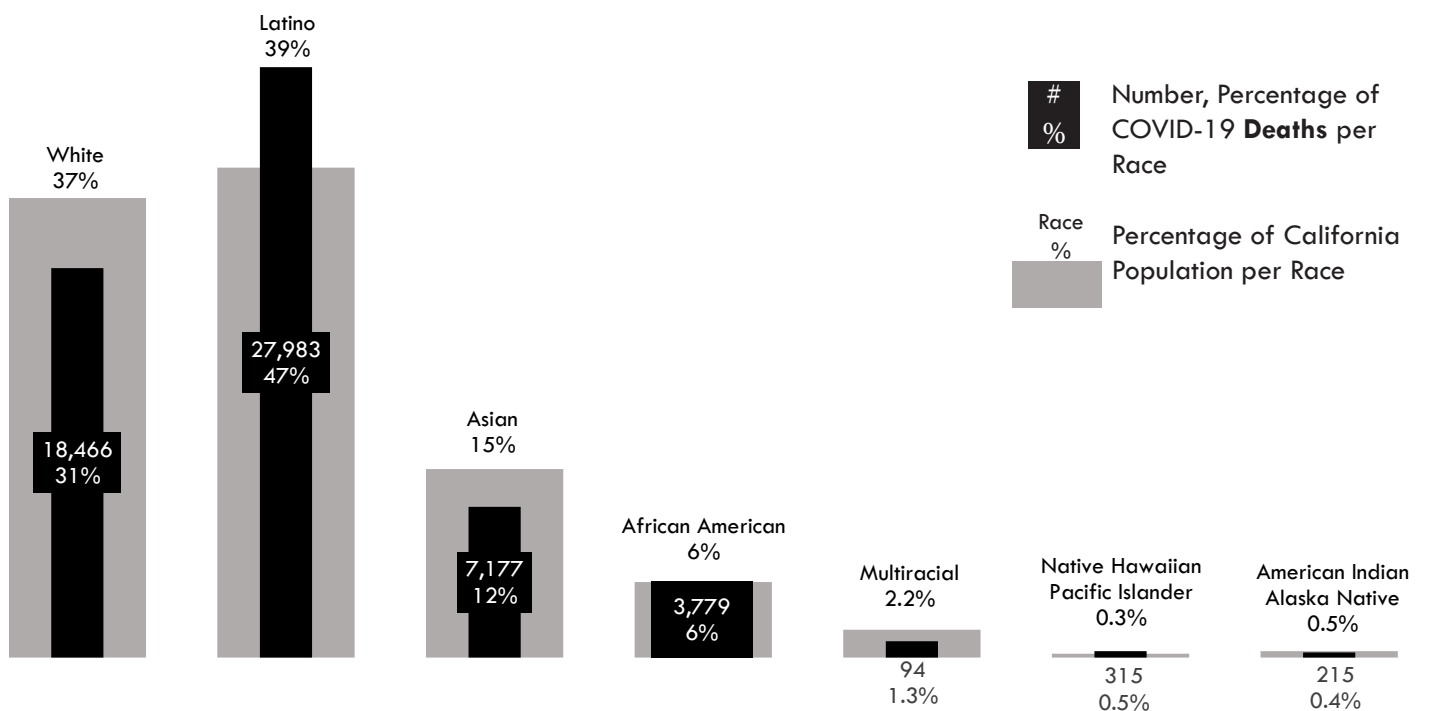
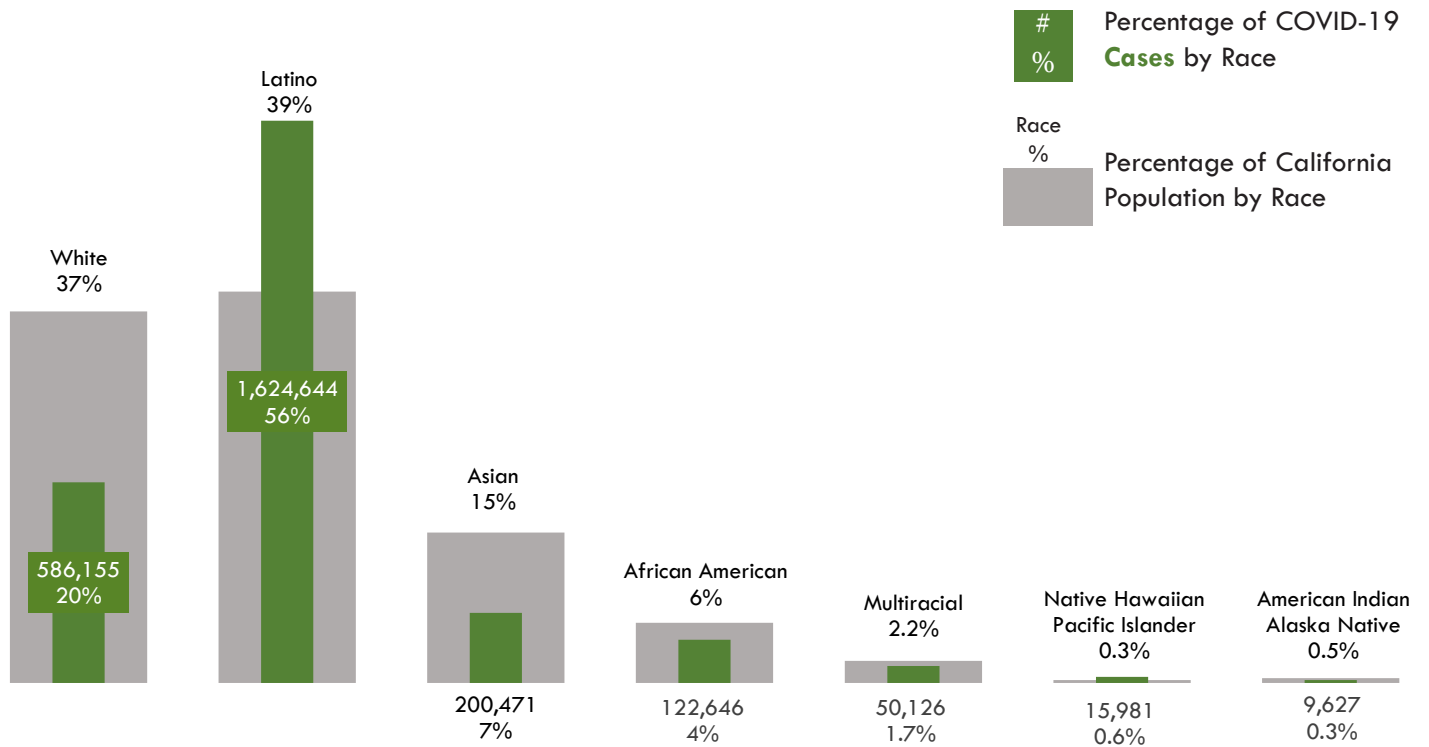

# Racial distribution of confirmed COVID-19 cases and deaths in California

American Indians and Alaska Natives account for 0.5% percent of the population, **0.3% of COVID-19 cases**, and **0.3% of deaths** in California. This includes a total of **9,627 cases** and **215 deaths** among American Indian and Alaska Native people in California.

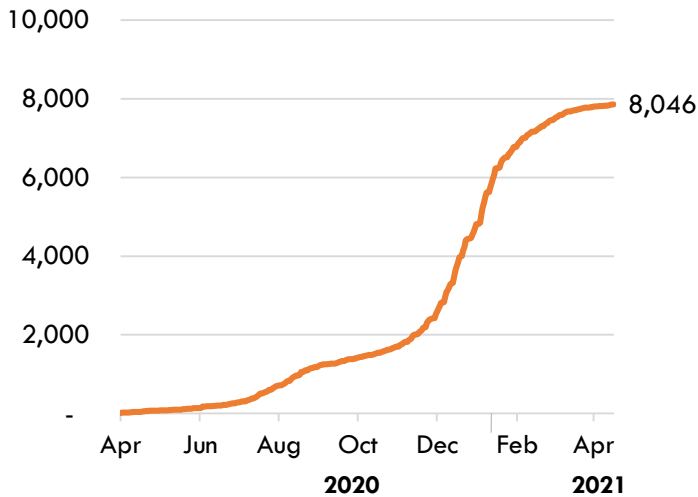

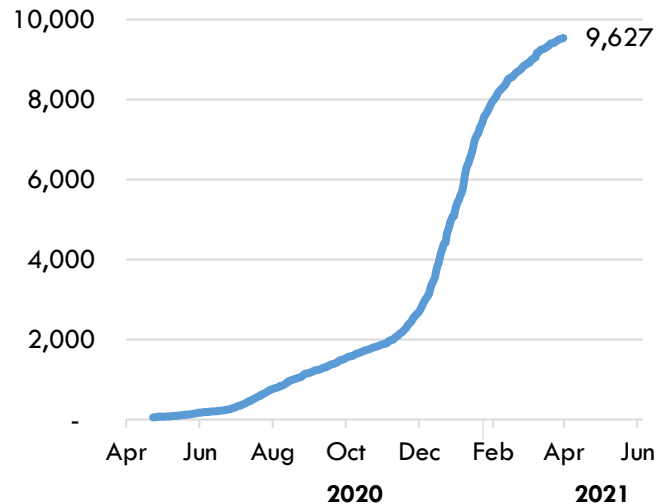

Data from **California Department of Public Health (CDPH)** include all positive cases of AIAN diagnosed in California.

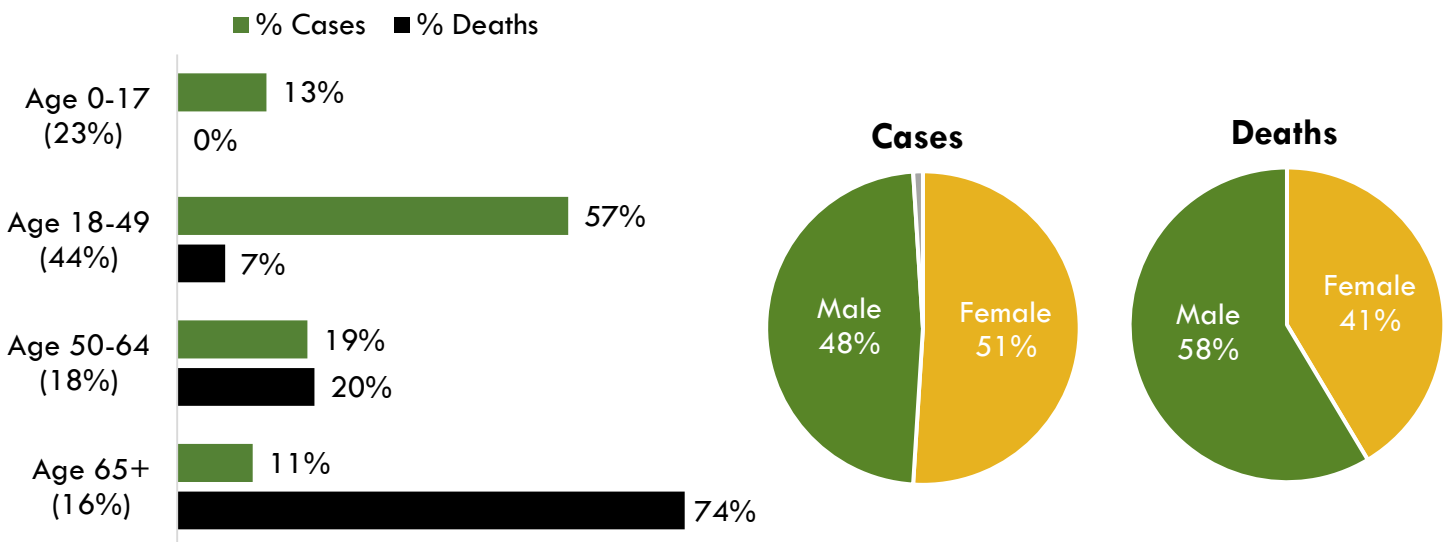

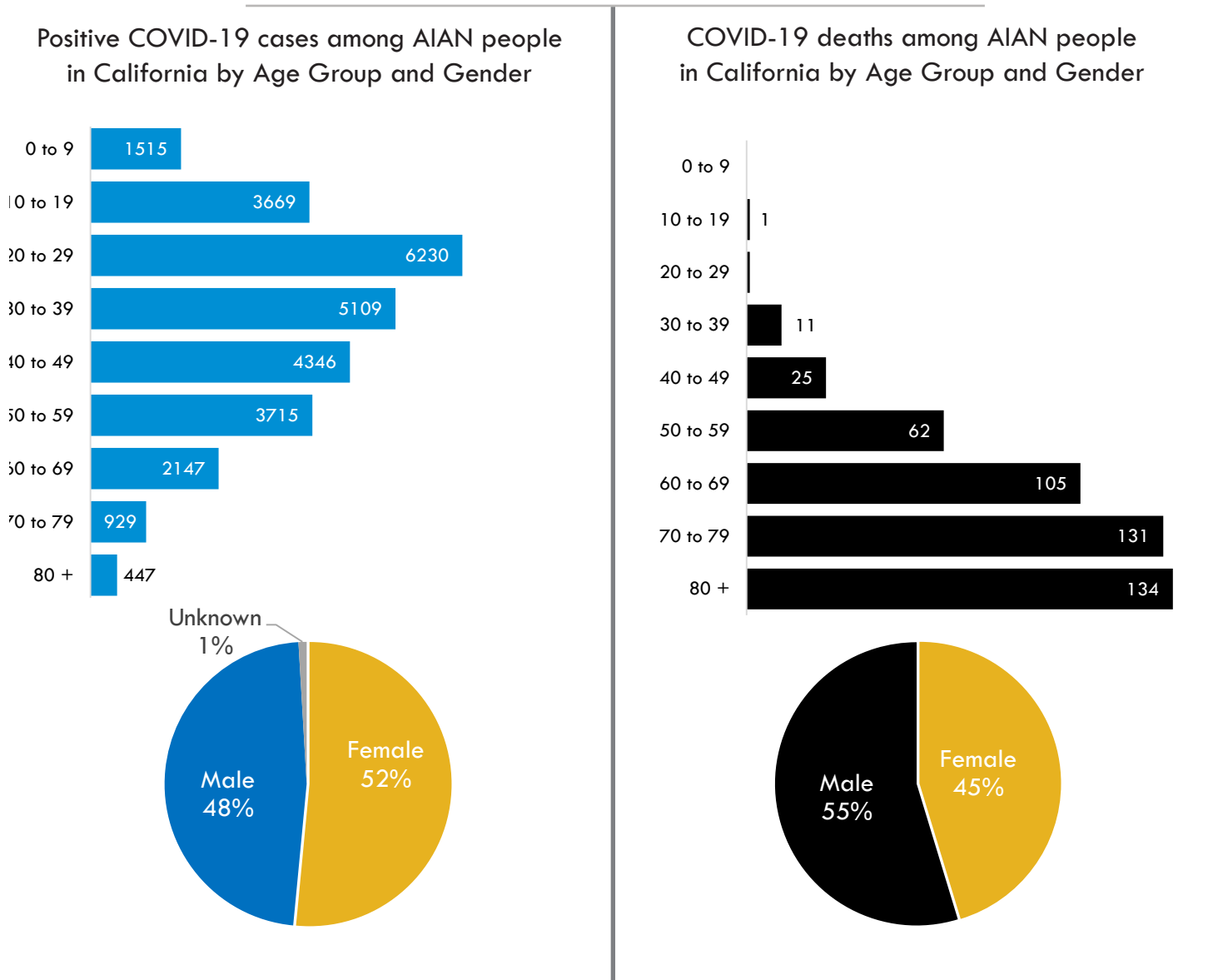

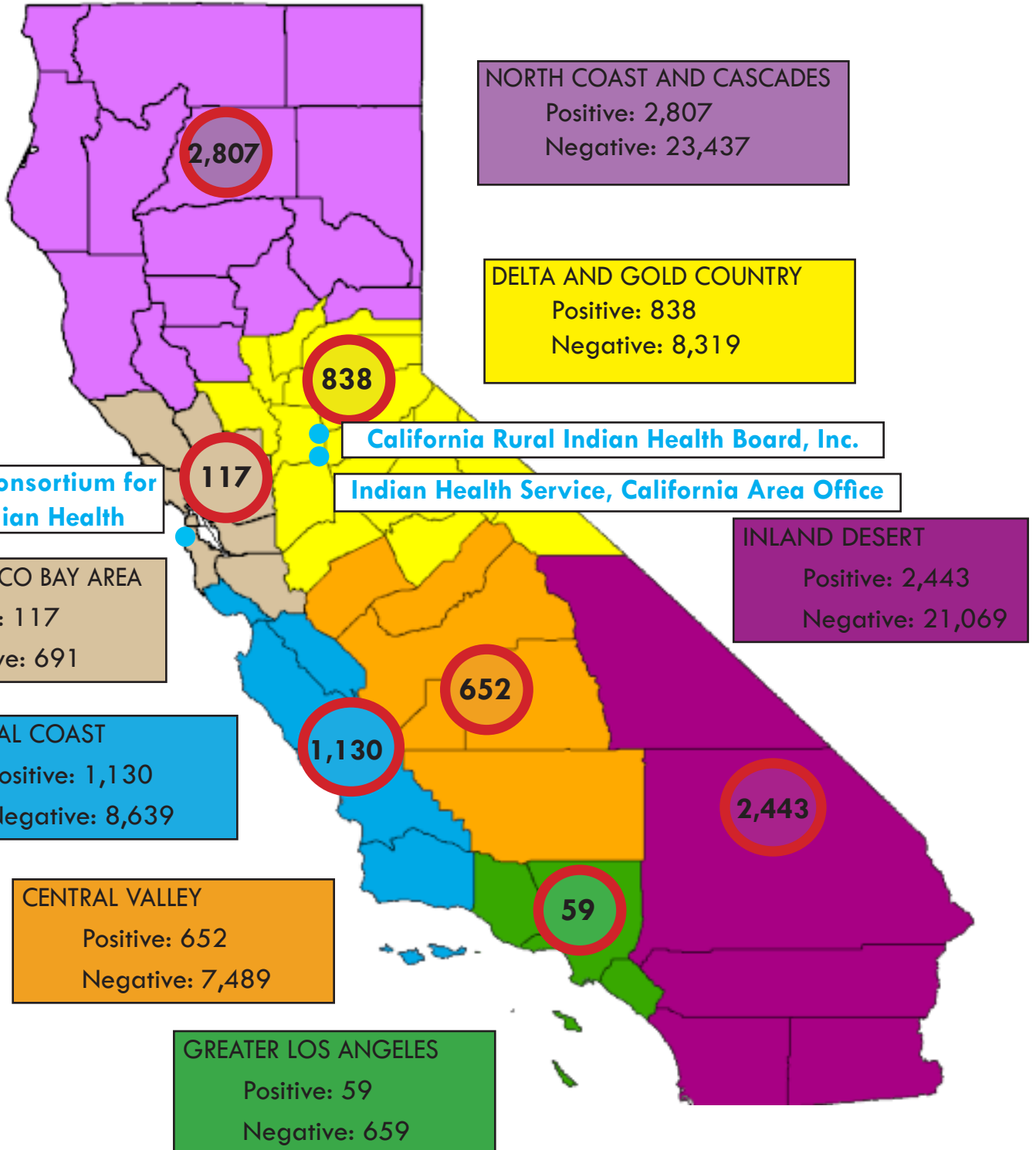

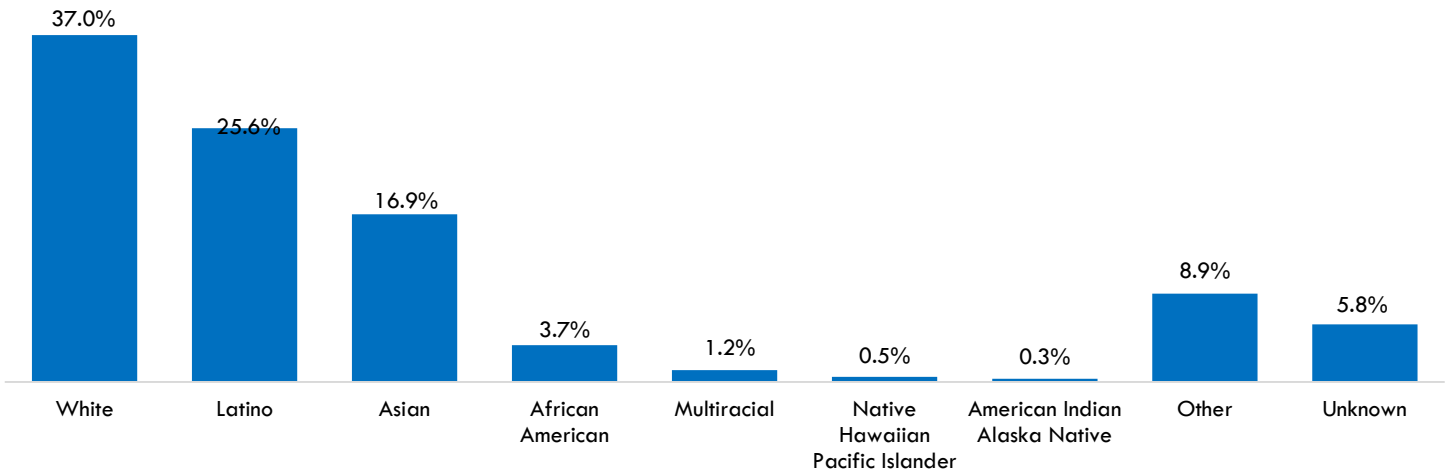

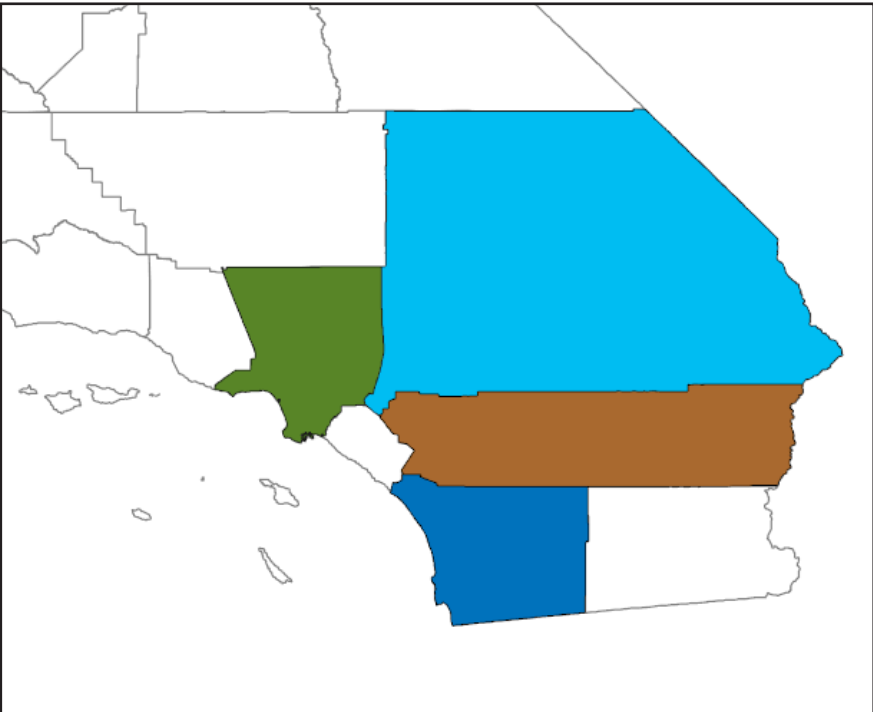
