DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 165 million with more than 3.4 million deaths.

In the United States as of May 20, the total number of cases stands at 32,855,010 and deaths at 584,975.

California has topped 35 million vaccinations. For three days in a row, California has had less than 1,000 new cases a day. Visit CDPH's COVID-19 website for more statewide statistics related to COVID-19.

California will keep existing mask guidance in place until June 15 when it aims to fully reopen the economy. After that, the state plans to allow fully-vaccinated Californians to go without a mask in most indoor settings. You will still have the option to wear a mask if you choose. Check the guidance HERE.

COVID-19: U.S. at a Glance* (as of 5/20/21)

- Total cases: 32,855,010
- Total deaths: 584,975
- Jurisdictions reporting cases: 55 (50 states, District of Columbia, Guam, Puerto Rico, the Northern Mariana Islands, and the U.S. Virgin Islands)

*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID19. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to




RISK FOR COVID-19 INFECTION, HOSPITALIZATION, & DEATH BY RACE/ETHNICITY, U.S.






New Confirmed Deaths in California by Date





Racial distribution of confirmed COVID-19 cases and deaths in California













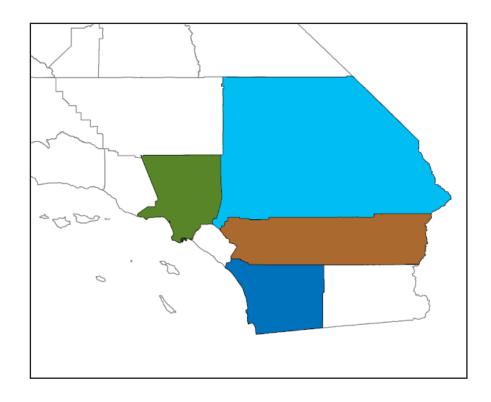


