

DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 171.7 million with more than 3.6 million deaths.

In the United States as of June 3, the total number of cases stands at 33,130,027 and deaths at 592,776.

Some rural counties in Northern California are falling further behind in COVID-19 vaccination rates compared with the rest of the state, causing cases to remain flat or, in some cases, to rise. Counties in rural Northern California and the greater Sacramento area fared worst, while Southern California and the Bay Area have fared best in terms of higher rates of vaccination and lower daily case rates, a Times analysis found. Among the counties of concern in the rural northern part of the state are Tehama and Siskiyou, the only two in California identified by the U.S. Centers for Disease Control and Prevention as having a “high” virus transmission rate. *As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

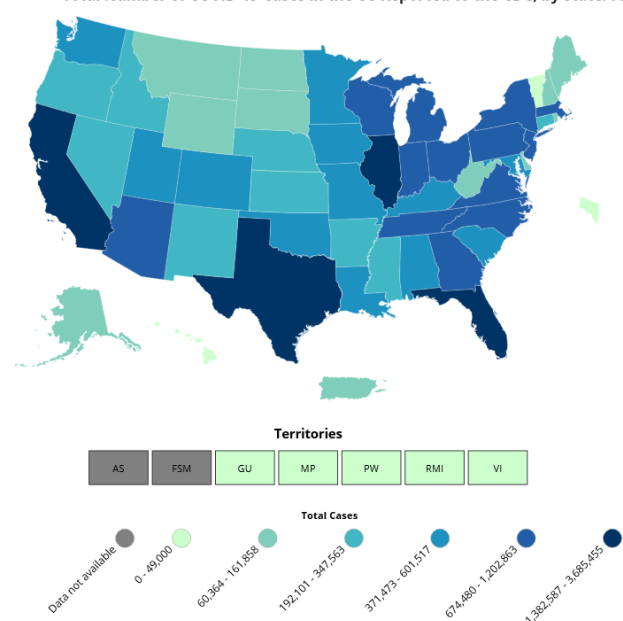
A probable case or death is defined by:

- meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or
 - meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or
 - meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.
- State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

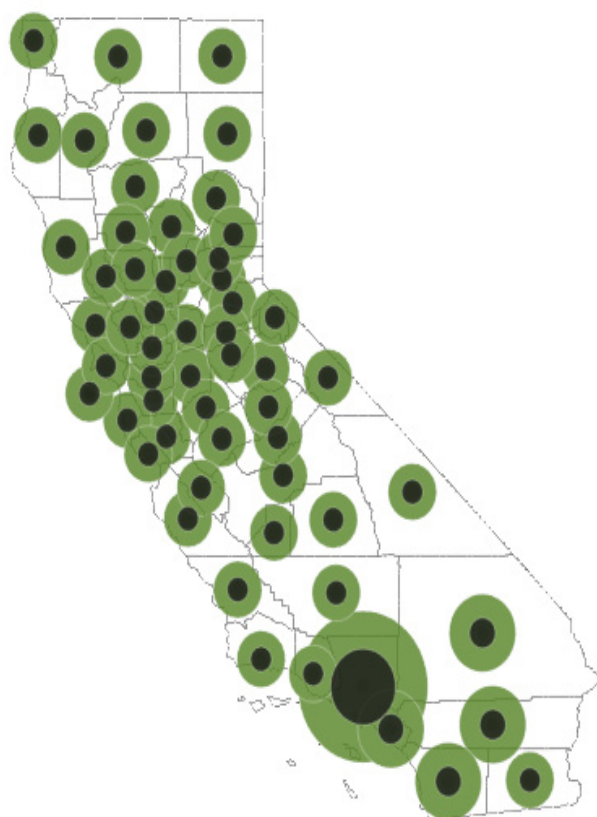

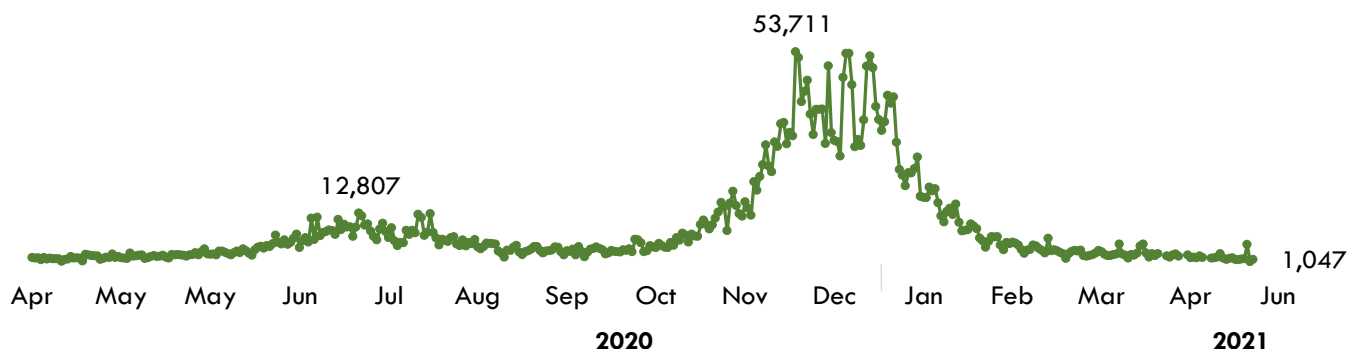

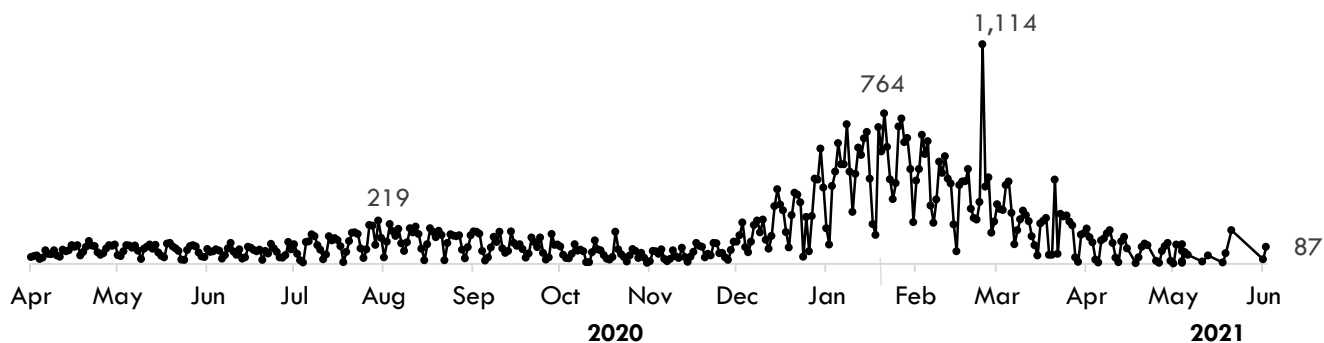

New Confirmed Cases in California by Date



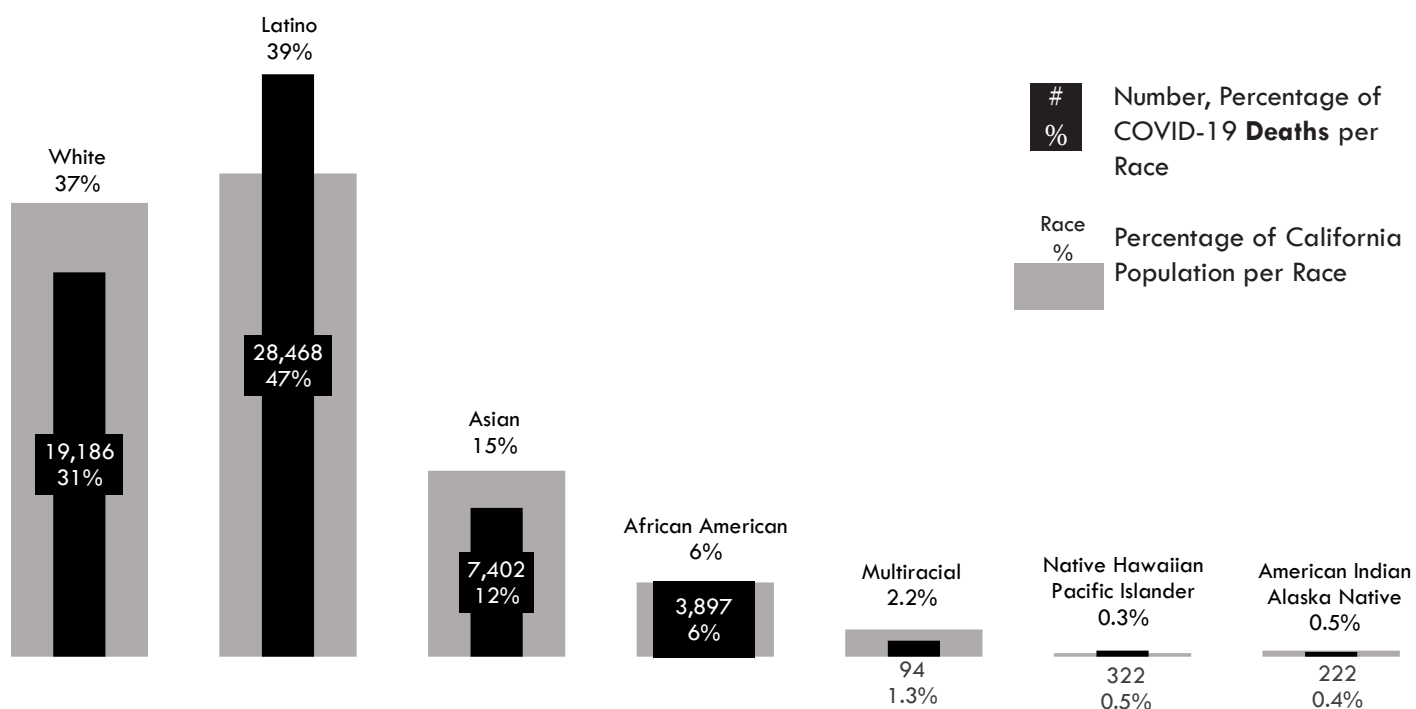
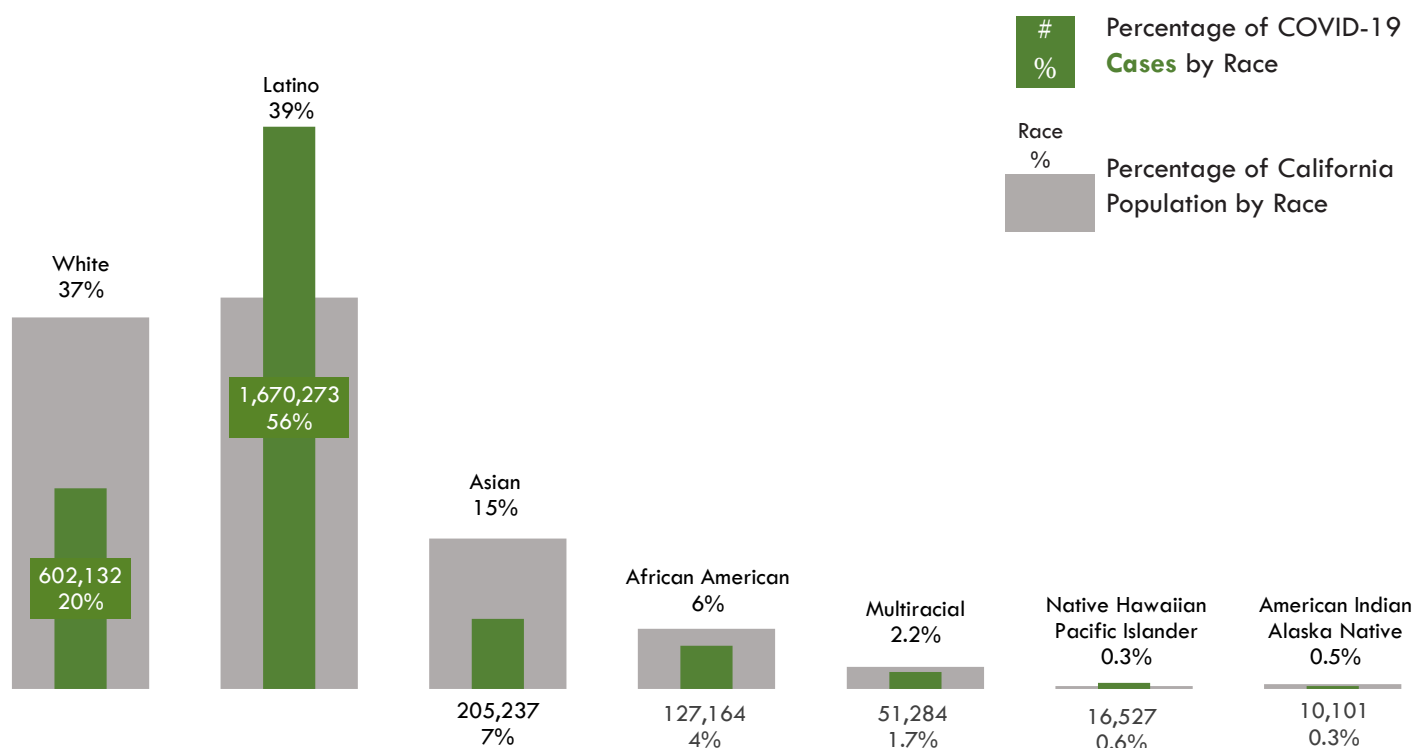
New Confirmed Deaths in California by Date

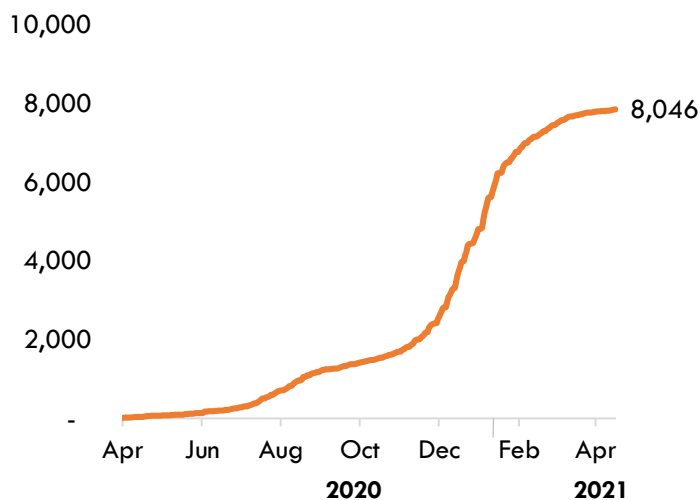

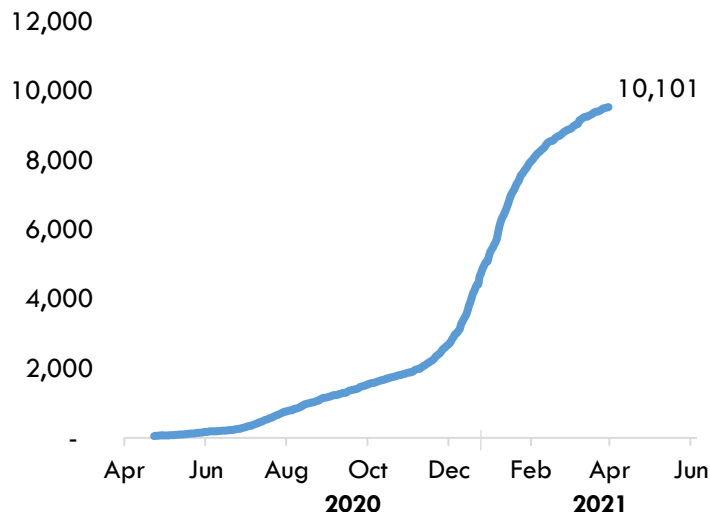

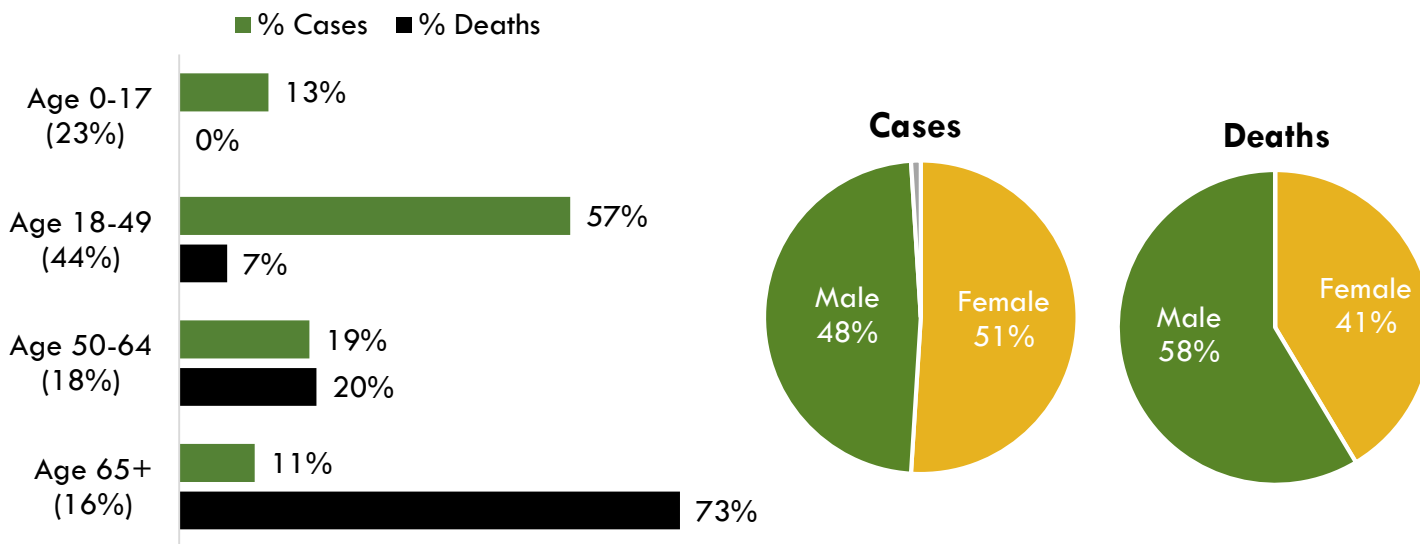

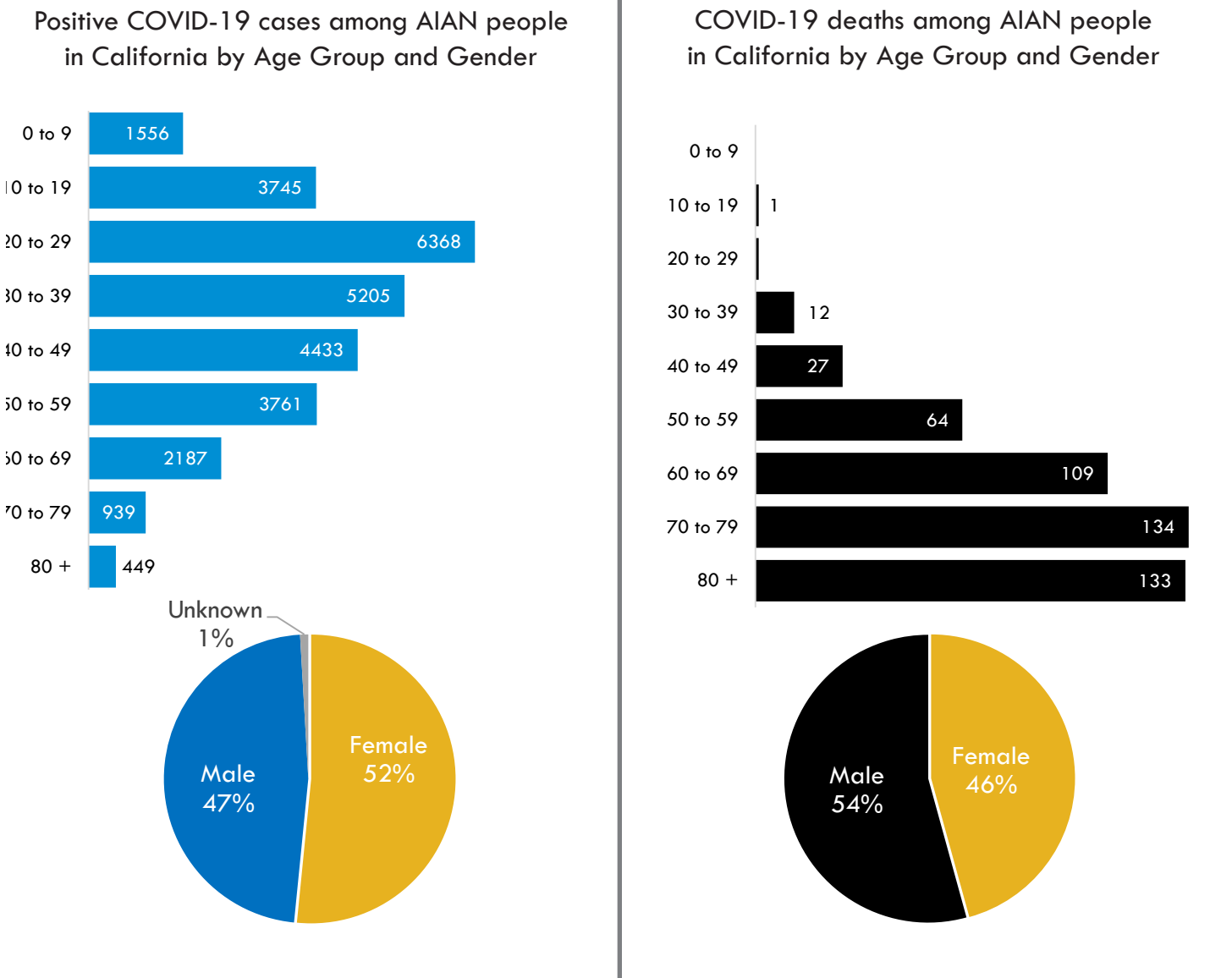

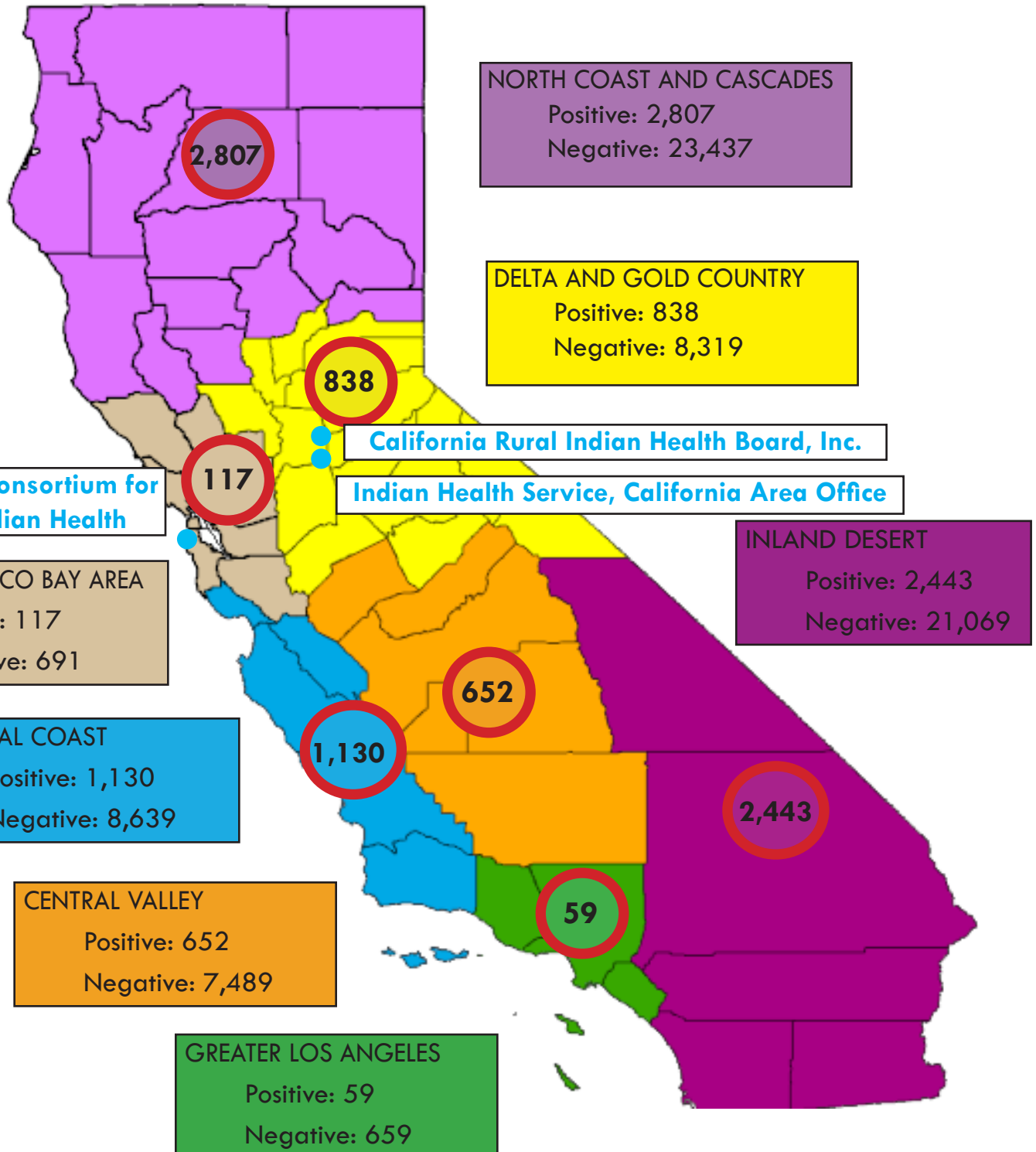

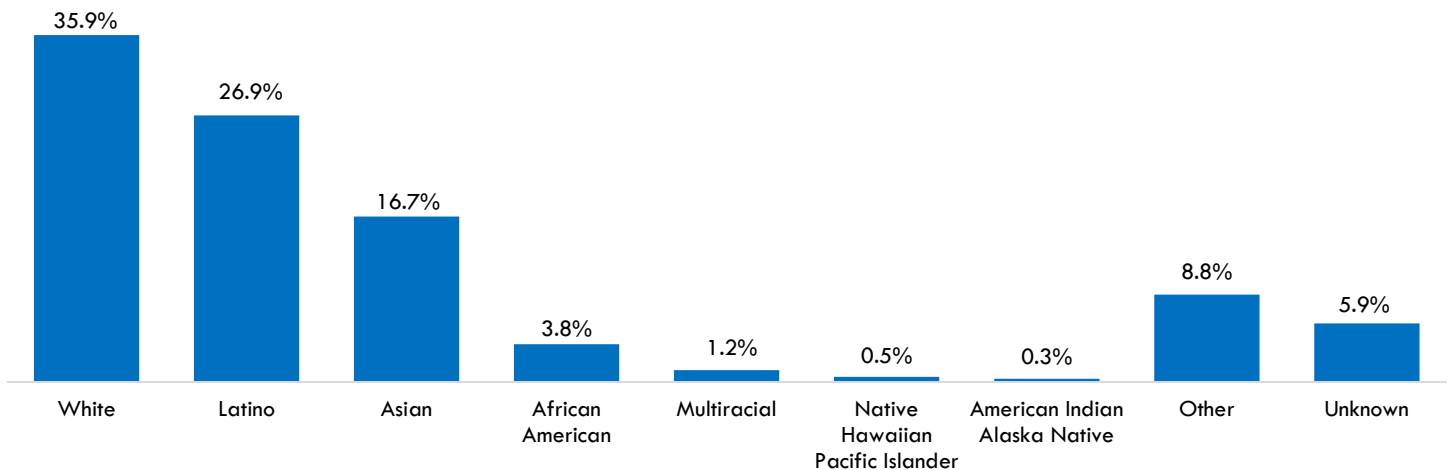

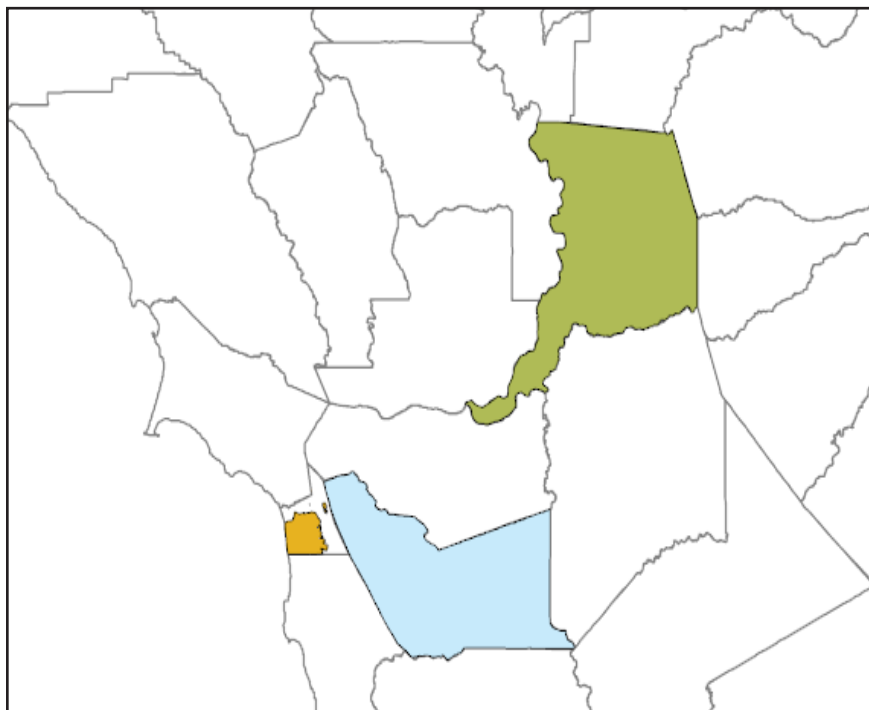

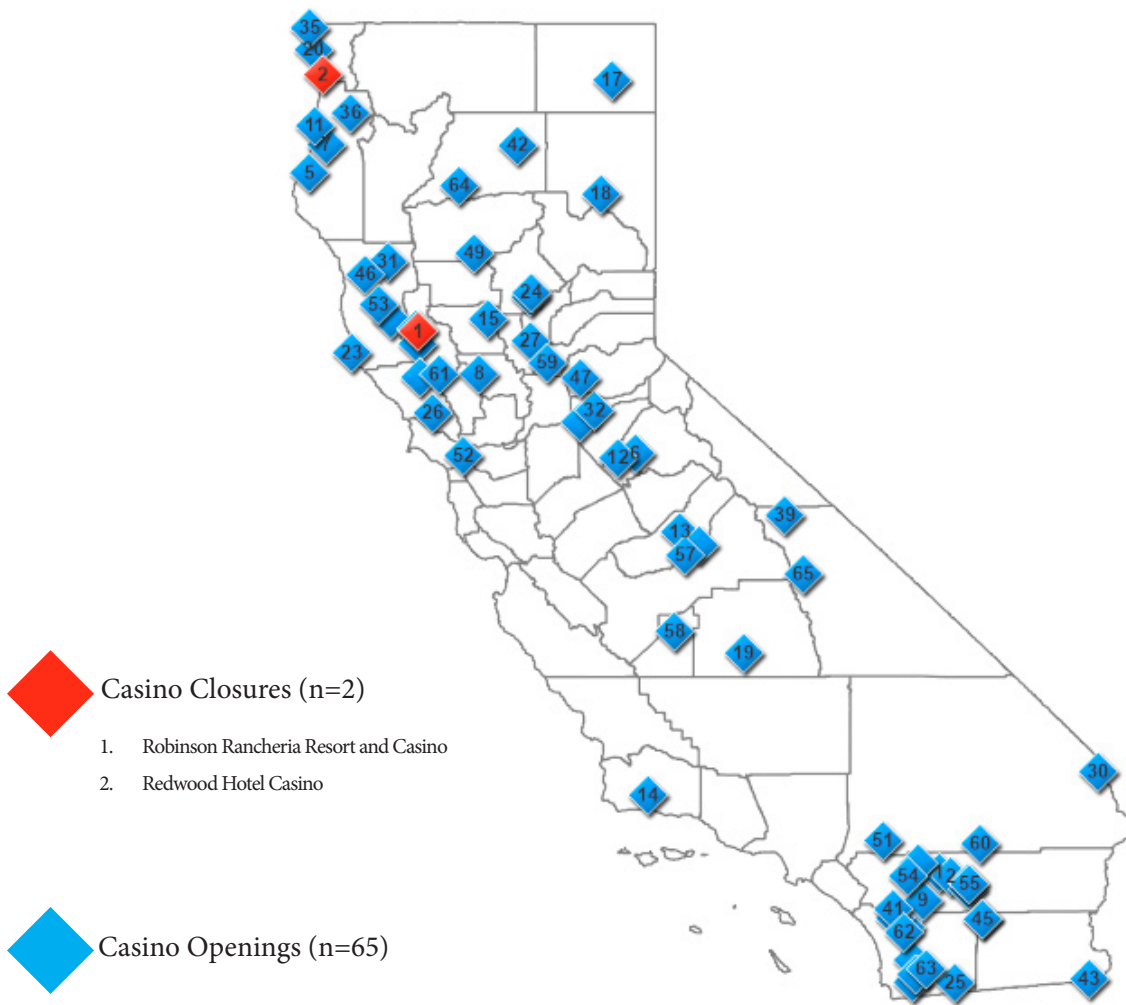
