



# CORONAVIRUS DISEASE 2019 (COVID-19) SITUATIONAL REPORT #314 JULY 12, 2021



## DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 186.6 million with more than 4 million deaths.

In the United States, the total number of cases stands at 33,672,474 and deaths at 604,710.

As of July 7, 2021, 70,670 samples have been sequenced in California. The delta variant makes up 42.9% of specimens sequenced that are variants of concern or variants of interest. The alpha variant makes up 30.6% and the gamma variant makes up 15.4%. You can view CDPH track these variants [HERE](#).

Join National Telecommunications and Information Administration (NTIA) Tribal broadband specialist team on July 21 and July 22, 2021, to hear more about the Tribal Broadband Connectivity Program (TBCP). The TBCP makes grants available to eligible entities, which include a Tribal Government, a Tribal College or University, the Department of Hawaiian Home Lands on behalf of the Native Hawaiian Community, including Native Hawaiian Education Programs, a Tribal organization, or an Alaska Native Corporation, for the deployment and adoption of broadband service on Tribal Land and for programs that promote the use of broadband to access remote learning, telework, or telehealth resources during the COVID-19 pandemic. On Wednesday, July 21, 2021, from 2:30 – 4:00 p.m. EST, NTIA will be hosting a webinar on the TBCP application process. During this webinar NTIA staff will guide potential applicants through the forms and documentation required for a complete TBCP grant application. ### COVID-19: U.S. at a Glance\*

- Total cases: 33,672,474
- Total deaths: 604,710
- Jurisdictions reporting cases: 55 (50 states, District of Columbia, Guam, Puerto Rico, the Northern Mariana Islands, and the U.S. Virgin Islands)

\*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020.

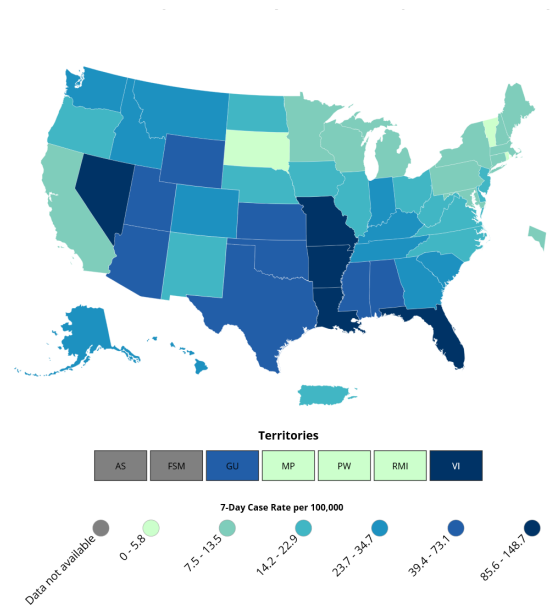
A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

- i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.
- State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

### National Laboratory Testing Data

- Total tests reported: 474,252,139
- Positive tests reported: 35,908,071
- Percent of positive tests (7-day): 3.6%

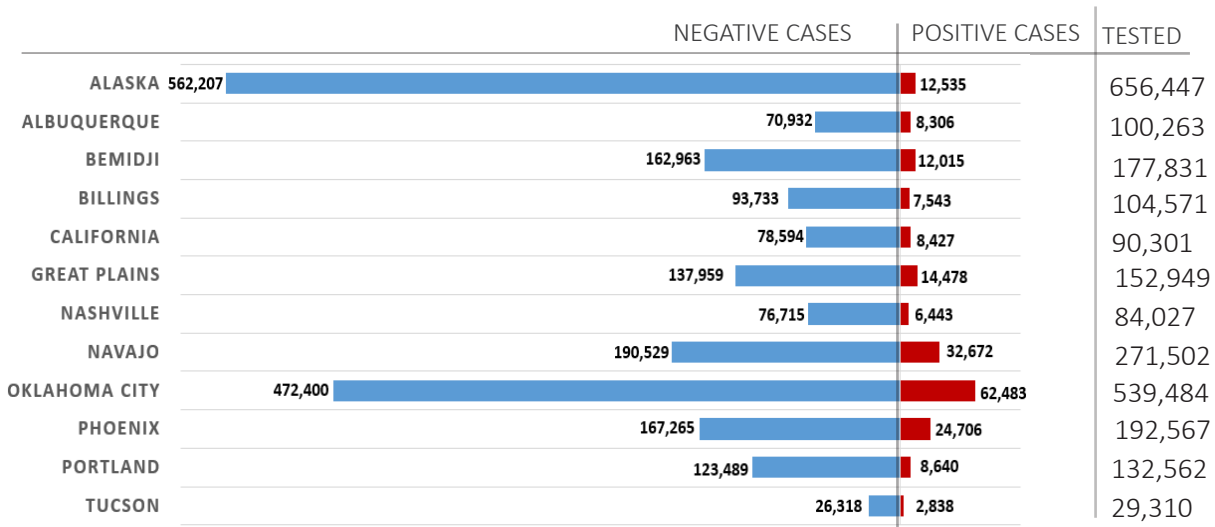


## RISK FOR COVID-19 INFECTION, HOSPITALIZATION, & DEATH BY RACE/ETHNICITY, U.S.

As of June 17, 2021, the table to the right shows that AIAN still have higher rates of COVID-19 infection, hospitalization, and death from COVID-19 than any other race/ethnicity group.

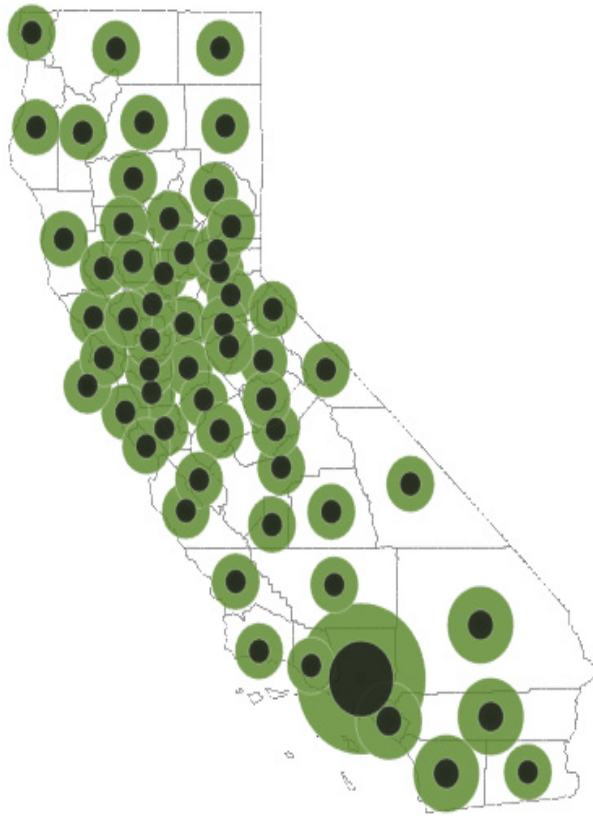

90,301 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 7/10/2021.

Of these, 8,427 patients have tested positive for COVID-19 and 78,594 have tested negative for COVID-19.

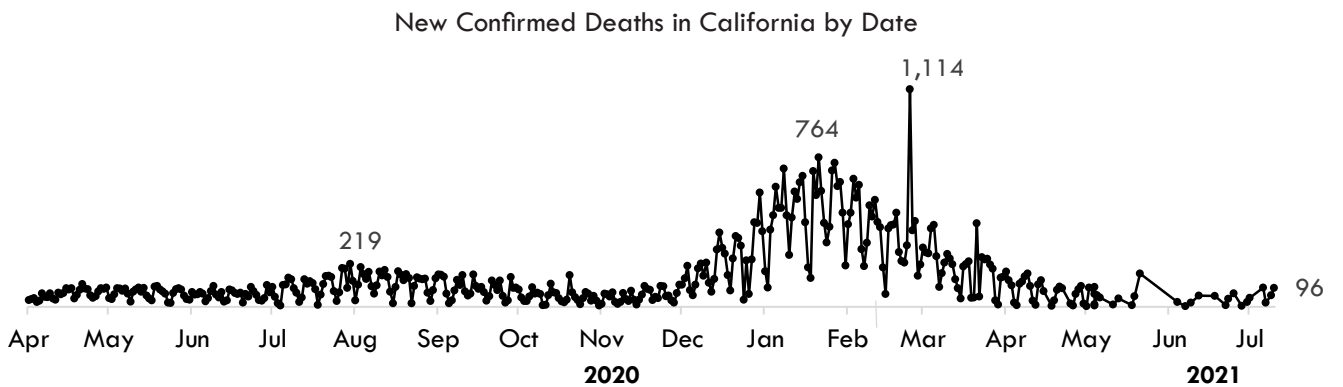
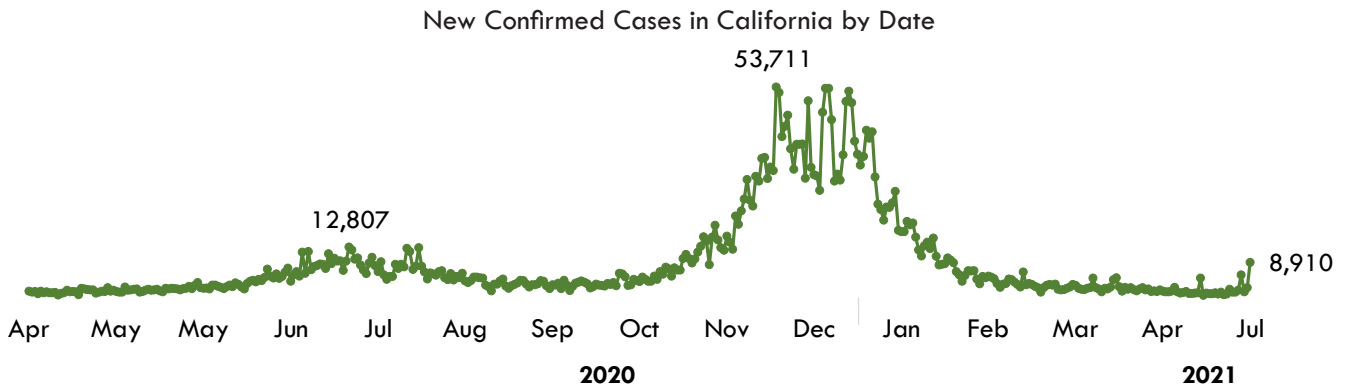

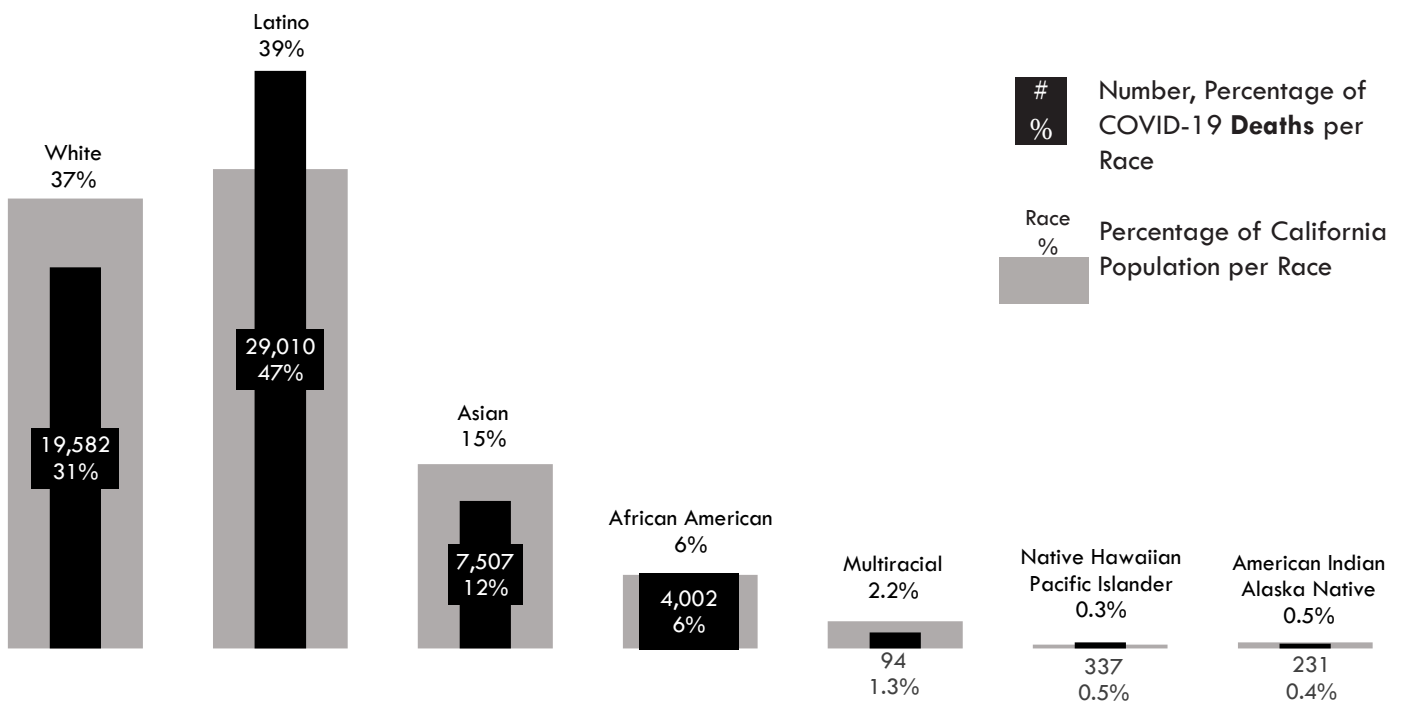
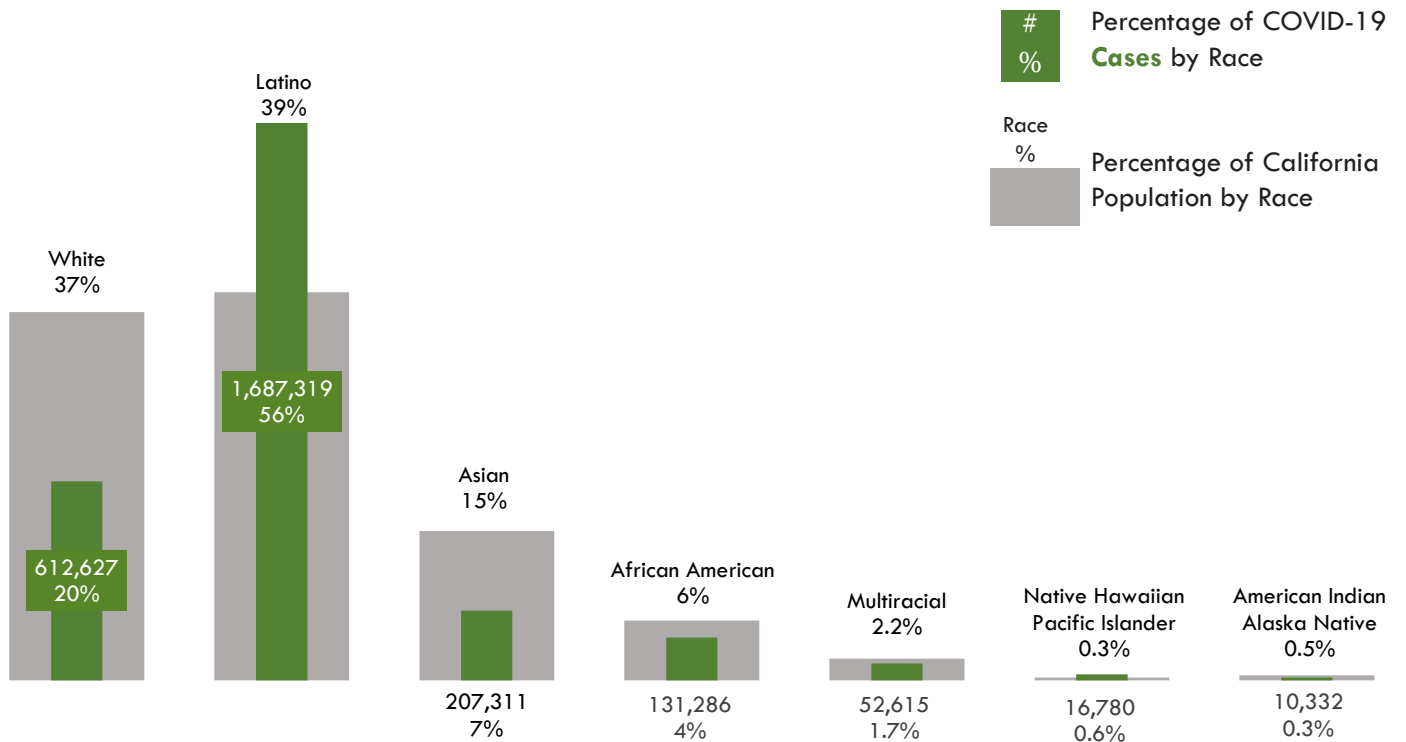

# Racial distribution of confirmed COVID-19 cases and deaths in California

American Indians and Alaska Natives account for 0.5% percent of the population, **0.3% of COVID-19 cases**, and **0.3% of deaths** in California. This includes a total of **10,332 cases** and **231 deaths** among American Indian and Alaska Native people in California.

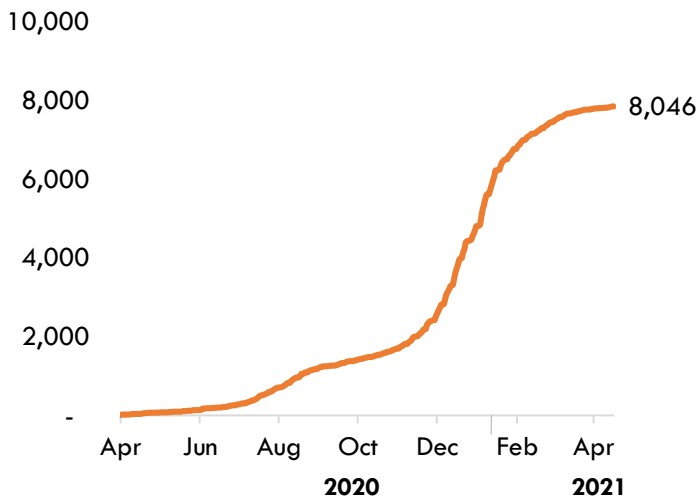

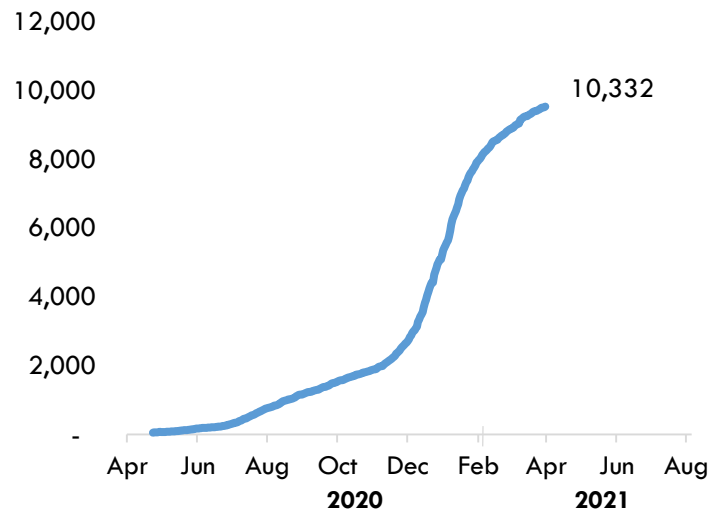
## Two sources for tracking American Indian and Alaska Native (AIAN) cases reported in California

Data from **California Department of Public Health (CDPH)** include all positive cases of AIAN diagnosed in California.

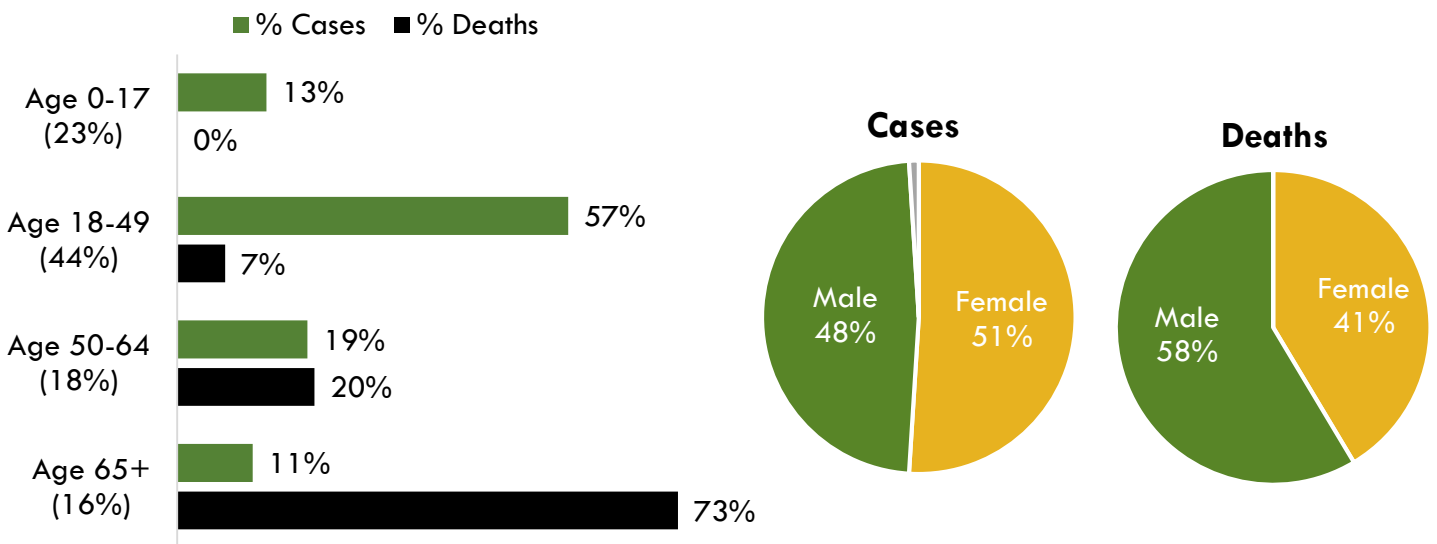

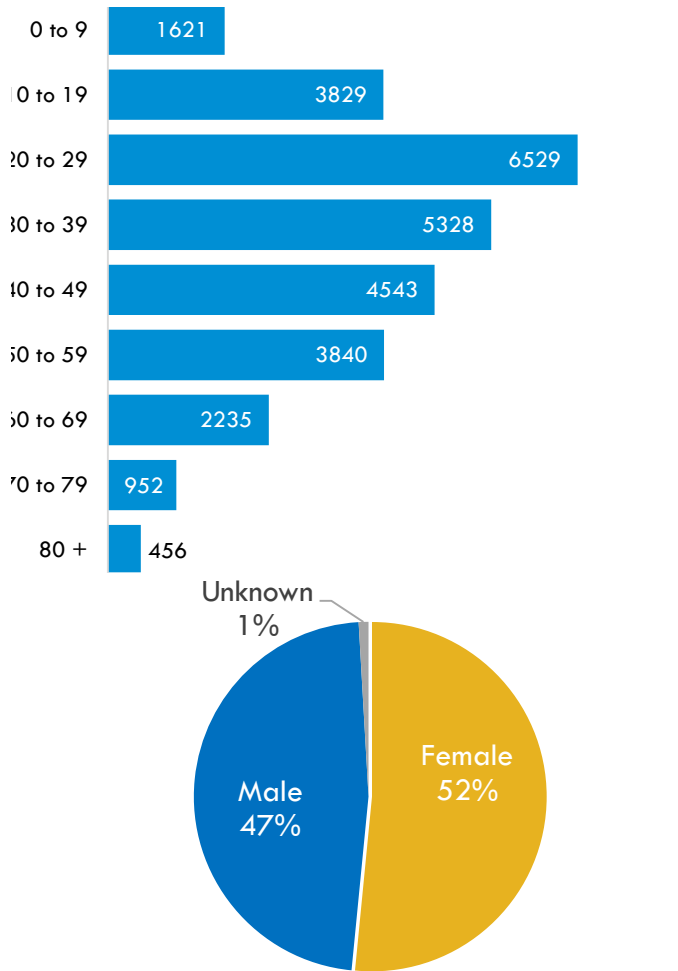

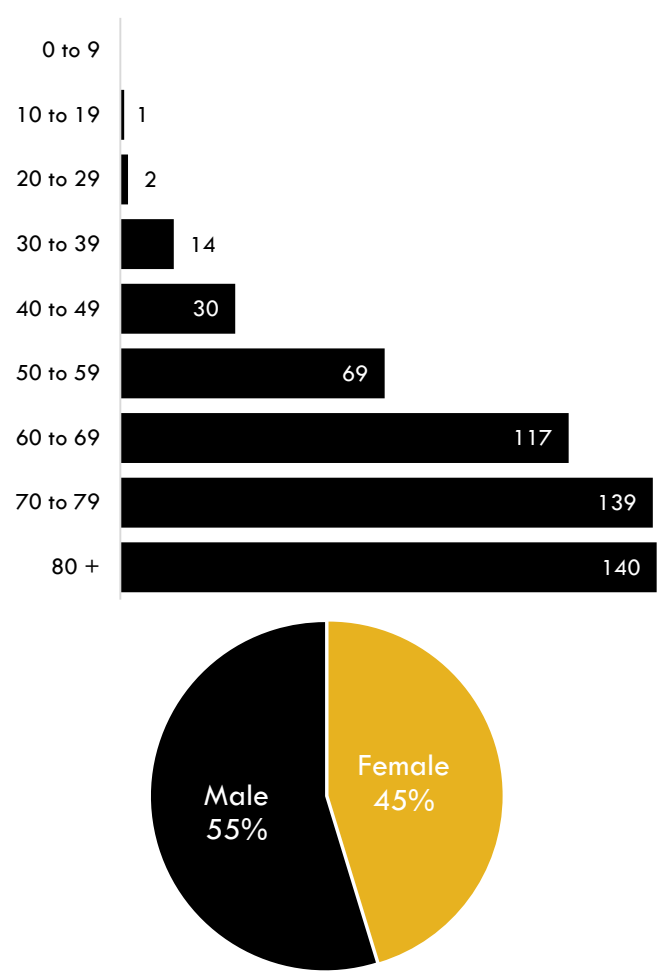

COVID-19 deaths among AIAN people in California by Age Group and Gender

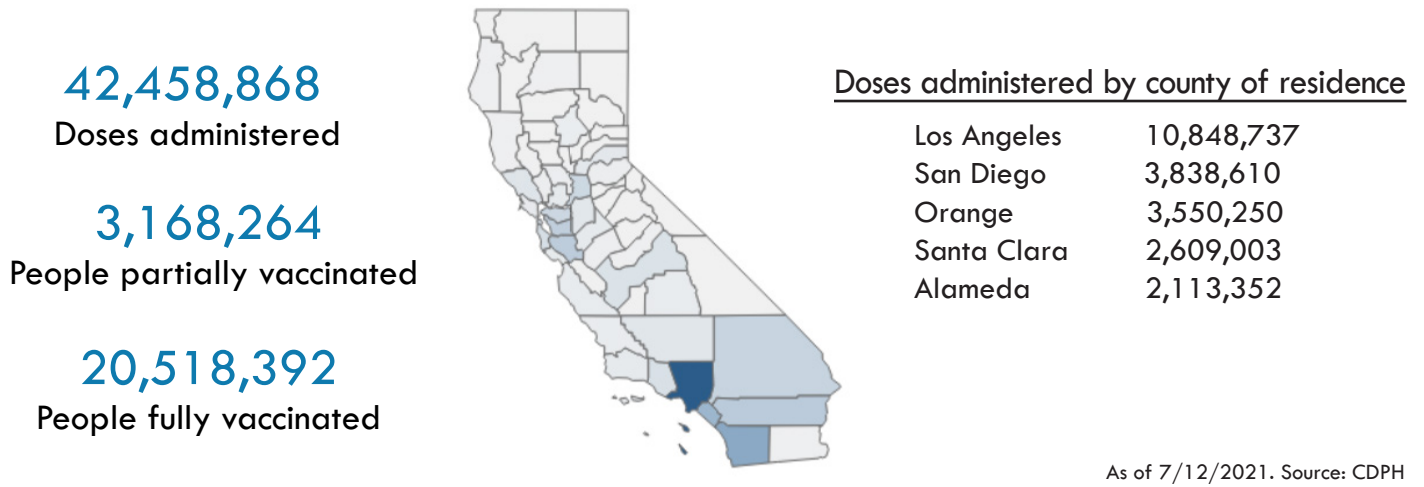

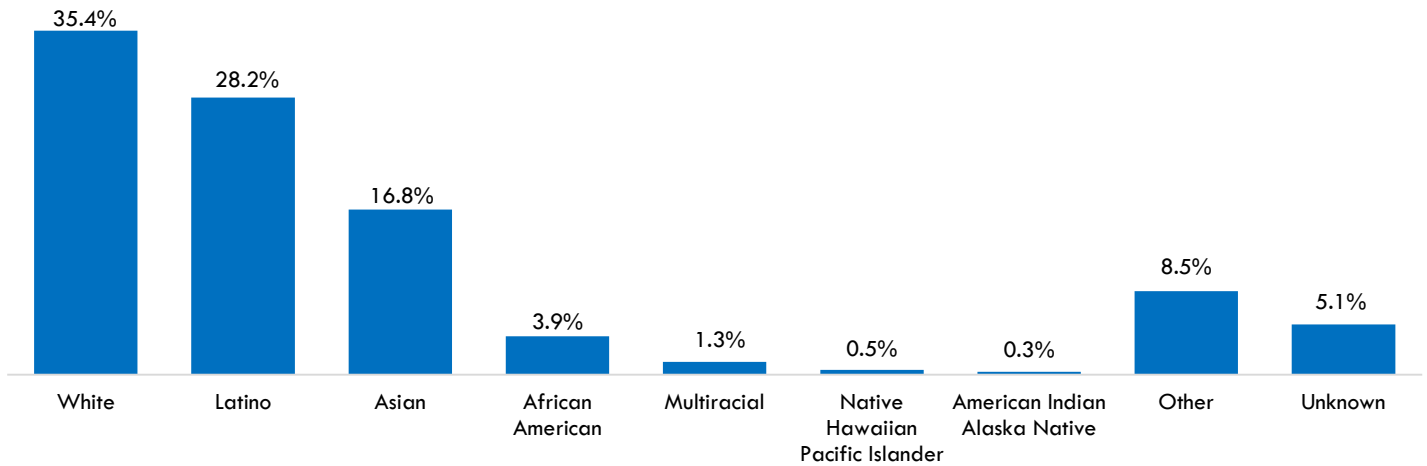

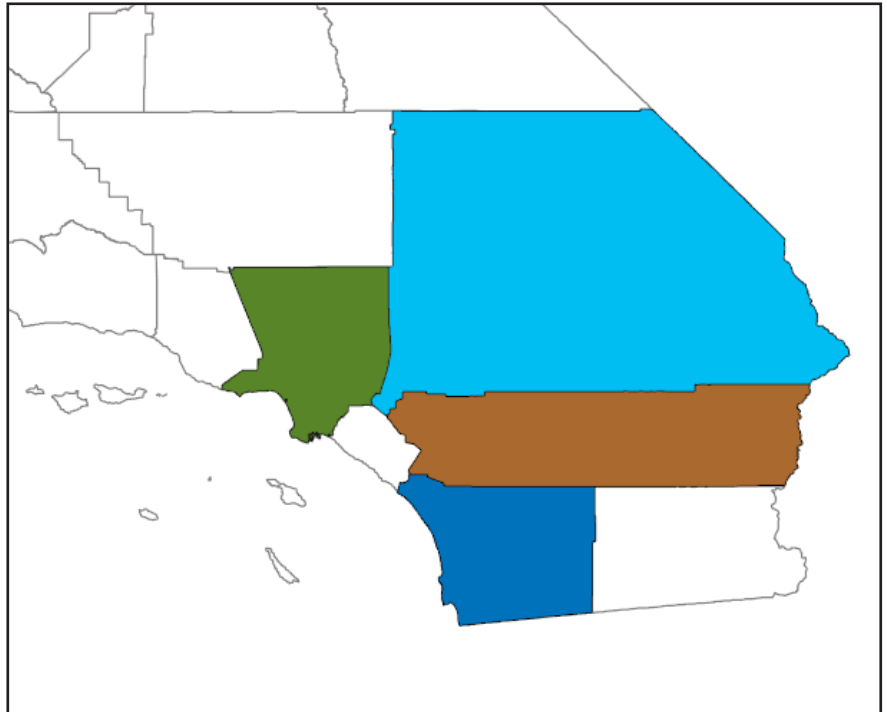
