DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 194 million with more than 4.1 million deaths.

In the United States, the total number of cases stands at 34,413,532 and deaths at 608,528.

As of July 21, 2021 in California, the delta variant makes up 82.8% of specimens sequenced that are variants of concern or variants of interest. The alpha variant makes up 7.8% and the gamma variant makes up 6.6%. You can view CDPH track these variants [HERE](#).

To combat surging cases and hospitalizations, California will now require healthcare workers and state employees to get vaccinated or receive regular COVID-19 testing. Learn more [HERE](#).

Those fully vaccinated with Pfizer are 88% protected against severe cases of the COVID-19 Delta variant, which is now the dominant coronavirus strain here in the US. Pfizer's two-dose protocol was initially found to be 94% effective against the original Alpha strain of COVID-19, the same as Moderna's version of the mRNA vaccine, whereas Johnson & Johnson's offers 66.3% protection. There has been little clear data on the strength of Johnson & Johnson's or Moderna's vaccines against the aggressive Delta variant. View the full study and it's results [HERE](#).

COVID-19: U.S. at a Glance*

- Total cases: 34,413,532


A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.







New Confirmed Cases in California by Date





New Confirmed Deaths in California by Date

Racial distribution of confirmed COVID-19 cases and deaths in California

American Indians and Alaska Natives account for 0.5% percent of the population, **0.3% of COVID-19 cases**, and **0.3% of deaths** in California. This includes a total of **10,555 cases** and **230 deaths** among American Indian and Alaska Native people in California.





Data from **California Department of Public Health (CDPH)** include all positive cases of AIAN diagnosed in California.







COVID-19 deaths among AIAN people in California by Age Group and Gender






