

## DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 198.2 million with more than 4.2 million deaths.

In the United States, the total number of cases stands at 34,972,532 and deaths at 611,051.

Confused about when to wear a mask? There are new guidelines that can help. Wearing a mask in indoor public places is now recommended for everyone, whether you're vaccinated or not. In early July, the Department of Health Care Services (DHCS) started publishing Medi-Cal COVID-19 vaccination data, compared with COVID-19 vaccination data for California as a whole, for persons 12 years of age or older. The data show marked disparities of COVID-19 vaccination rates in California, with Medi-Cal beneficiaries less likely to have received the vaccine than Californians as a whole. These disparities persisted across geographic areas of California, age groups, and persons of different race/ethnicities. The report shows that statewide, 51.3% of AIAN received at least one dose of the COVID-19 vaccine compared to only 29.5% of AIAN who are Medi-Cal beneficiaries. View the full report HERE.

### COVID-19: U.S. at a Glance\*

\*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020.


A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

i) meeting clinical criteria AND epidémiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID19. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.




## RISK FOR COVID-19 INFECTION, HOSPITALIZATION, & DEATH BY RACE/ETHNICITY, U.S.

As of July 16, 2021, the table to the right shows that AIAN still have higher rates of COVID-19 hospitalization and death than any other race/ethnicity group.


As of August 2, 2021, there were a total of 3,873,771 positive cases and 64,085 deaths in California.

## COVID-19 VARIANTS IN CALIFORNIA

As of July 29, 87,292 samples have been sequenced in California. In July 2021, 1% of cases in California have been sequenced so far. This percent is expected to increase in coming weeks as more data becomes available. In June 2021, 13% of cases in California were sequenced. The table below shows the percent of specimens sequenced that are variants of concern or variants of interest.



## INDIAN HEALTH SERVICE CALIFORNIA AREA

92,653 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 7/14/2021.

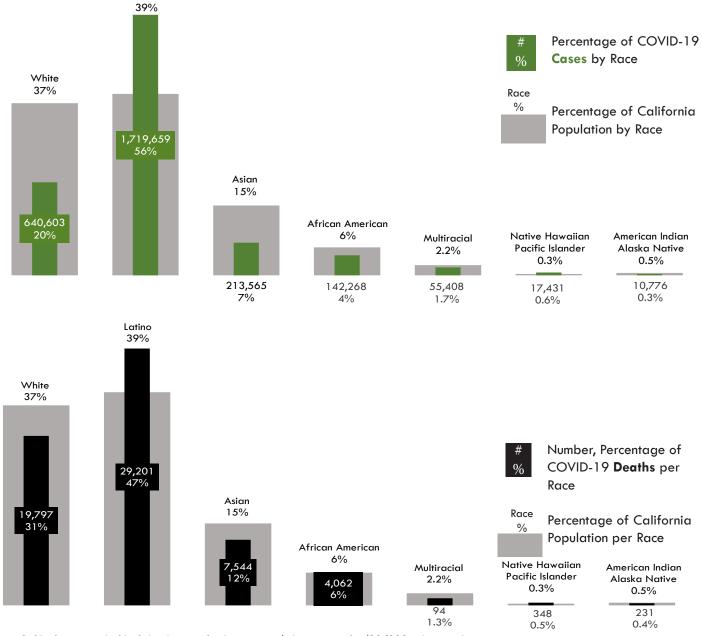
Of these, 8,654 patients have tested positive for COVID-19 and 80,545 have tested negative for COVID-19. The 7-day rolling average positivity rate is 10.7%.

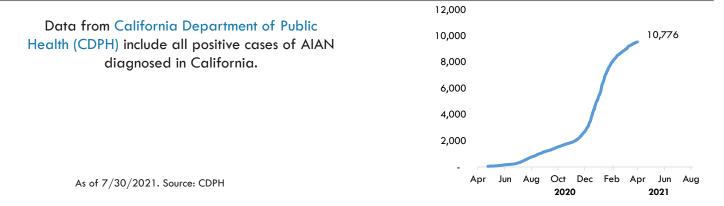


# Racial distribution of confirmed COVID-19 cases and deaths in California

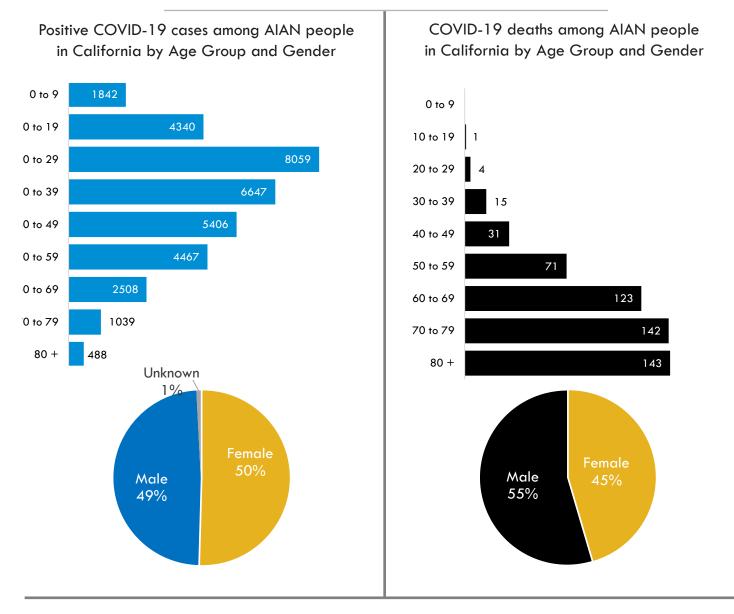
American Indians and Alaska Natives account for 0.5% percent of the population, 0.3% of COVID-19 cases, and 0.3% of deaths in California. This includes a total of 10,776 cases and 231 deaths among American Indian and Alaska Native people in California.




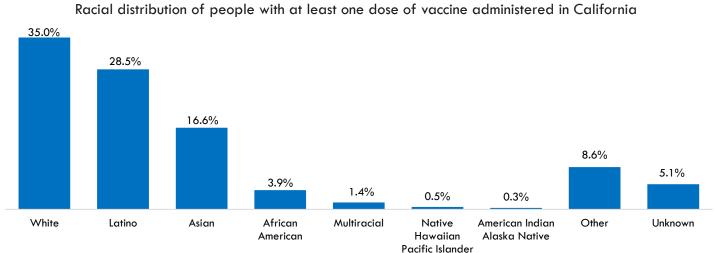


