

CORONAVIRUS DISEASE 2019 (COVID-19) SITUATIONAL REPORT #353 OCTOBER 15, 2021



HIGHLIGHTS

Globally, COVID-19 cases have surpassed 239.4 million with more than 4.8 million deaths.

In the United States, the total number of cases stands at 44,709,010 and deaths at 720,228.

On Thursday, the FDA's vaccine advisory committee unanimously voted to recommend authorizing booster doses of Moderna's COVID-19 vaccine for the elderly and younger people at high risk for developing severe COVID-19 symptoms. Following the vote, FDA must make a formal regulatory decision on Moderna's request to amend its emergency use authorization to allow for booster shots for that group. If they do, the CDC's Advisory Committee on Immunization Practices will meet to decide if it will recommend the boosters for these groups. On Friday, the panel unanimously endorsed a second shot of the Johnson & Johnson COVID-19 vaccine two months after the first dose under emergency use authorization. The company proposed the booster after two months for people at high risk, such as the elderly, and after six months for most people; however, the panel recommended the shot for everyone 18 and older who has received one dose at least two months prior. The panel's recommendation will be taken into consideration by the agency, which typically follows the advice of the advisory committee. Read more HERE.

Updated data from the California Department of Public Health (CDPH) shows that unvaccinated people statewide are 10 times more likely to be hospitalized, and 18 times more likely to die of COVID-19.

Data from the American Academy of Pediatrics shows that cases among children peaked in September. More than 6 million children have tested positive for Covid since the beginning of the pandemic, with more than 1.1 million new cases recorded from Sept. 3 to Sept. 30. Only a small proportion of young children with Covid get severely ill or die. CDC data shows that children under 12 years old made up less than 1% of all Covid deaths since January 2020.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.


A probable case or death is defined by:

i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID19. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

US COVID-19 7-Day Case Rate per 100,000, by State/Territory






RATES FOR COVID-19 HOSPITALIZATION BY RACE/ETHNICITY, U.S.

COVID-19 CASES BY IHS AREA





INDIAN HEALTH SERVICE CALIFORNIA AREA

124,448 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 10/13/2021.

Of these, 12,476 patients have tested positive for COVID-19 and 106,994 have tested negative for COVID-19. The 7-day rolling average positivity rate is 7.8%.






New Confirmed Deaths in California by Date






Racial distribution of confirmed COVID-19 cases and deaths in California









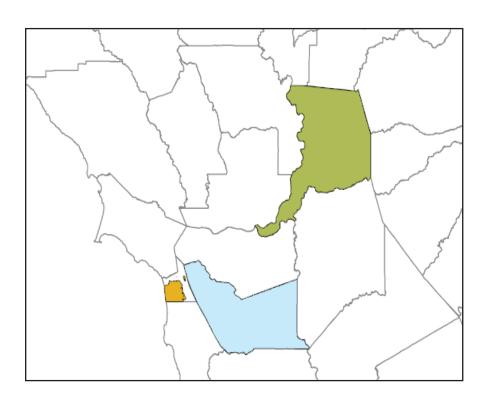
